--AND WE STILL HAVE NOT LEARNED HOW TO MAXIMIZE THE PRODUCTIVITY OF THESE LANDS.

↳ THE "THIRD FOREST" OF THE SOUTH IS ONE OF THE HOPEFUL SIGNS. ↳ IT MEANS THAT INDUSTRY IS REALLY BEGINNING TO LEAD; THAT IT IS EDUCATING THE PUBLIC TO THE MULTITUDE OF BENEFITS THAT COME FROM AN INVESTMENT OF MONEY, TIME, AND, YES, ENTHUSIASM, IN FOREST LANDS!

↳ BUT, WE NEED NATIONAL, STATE AND LOCAL LAND USE POLICIES THAT WILL MAKE IT POSSIBLE TO SORT OUT AND IDENTIFY THE VARIOUS DEMANDS BEING MADE UPON EACH PIECE OF LAND.

↳ WHERE TIMBER PRODUCTION IS MOST FEASIBLE, IT SHOULD BE PRACTICED.

↳ --WHERE WILDLIFE AND WILDLIFE HABITAT ARE ENDANGERED, PROTECTION SHOULD BE PROVIDED.

↳ THE NEED FOR FOREST PRODUCTS IN THE HOME BUILDING AND THE PAPERGOODS INDUSTRIES IS URGENT AND CRUCIALLY IMPORTANT, ↳ WE MUST PLAN WELL TO MEET THESE NEEDS.

↳ THE NEED FOR SPACE AND OUTDOOR RECREATION; FOR PRESERVING THE NATURAL ENVIRONMENT, IS EQUALLY IMPORTANT AND IT WILL MEAN WITHDRAWING SOME LANDS FROM ALL USES.

↳ AND SO WE NEED TO IMPROVE PRODUCTIVITY. ↳ WE HAVE DOUBLED, TRIPLED, AND EVEN QUADRUPLED THE PER ACRE YIELDS FOR MANY AGRICULTURAL CROPS IN THE LAST 50 YEARS. BUT NOT FOR OUR TREE CROPS!

↳ WE KNOW HOW TO INCREASE PER ACRE TREE YIELDS. ↳ WE KNOW ABOUT GENETICALLY IMPROVED SEEDS, BETTER FERTILIZERS, AND MORE EFFICIENT USE OF TREE SPACING AND THINNING TECHNIQUES. ↳ BUT, WE ARE NOT TAKING FULL ADVANTAGE OF WHAT WE KNOW.

↳ SILVICULTURE, LIKE AGRICULTURE, MUST BECOME MORE "INTENSE-MANAGEMENT" ORIENTED. ↳ THIS NATION CANNOT AFFORD TO CONTINUE ITS CURRENT "HIT-AND-MISS" FOREST LAND USE POLICY.

↳ WE MUST BE CONCERNED ABOUT NOT JUST TOMORROW, BUT MANY YEARS INTO THE FUTURE.
