 ONE SIMPLE EXPLANATION, ~~I BELIEVE~~, OF WHAT SCOUTING IS ALL  
 ABOUT. SCOUTING OFFERS A BOY THE CHANCE TO HAVE A BETTER  
 UNDERSTANDING OF WHAT IT MEANS TO BE RESPONSIBLE TO HIMSELF,  
 AND TO BE RESPONSIBLE TO OTHERS. -

Responsibility

"RESPONSIBILITY" IS THE KEY WORD. ~~A~~ SENSE OF  
 RESPONSIBILITY IS PERHAPS THE MOST VITALLY NEEDED THREAD

RECEPTION CHAMBER JUST OFF THE FLOOR OF THE UNITED STATES

SENATE.

WHAT WAS UNIQUE ABOUT THIS TROOP WAS THAT THE BOYS

WERE IN WHEELCHAIRS OR ON CRUTCHES, WITH VARIOUS FORMS OF

MENTAL OR PHYSICAL DISABILITIES. BUT THE TRUTH OF THE MATTER

WAS THAT THEY WERE THE SAME AS ANY OTHER BOYS -- THEY WERE

EXCITED; THEY ASKED SHARP QUESTIONS ABOUT MY JOB; ~~AND THEY~~

~~GRASPED HOLD OF THE FEW SOUVENIRS I HAPPENED TO HAVE IN MY~~  
*Government etc about my state, my family.*

L <sup>indeed</sup> YES, SCOUTING FOR THE HANDICAPPED PRESENTS A CHALLENGE,

BUT THE TIME HAS COME TO LOOK UPON THIS CHALLENGE AS AN

It IS AN OPPORTUNITY TO GIVE THEM HOPE WHERE THERE WAS ONLY  
 DESPAIR; TO OFFER THEM THE PROMISE OF CHALLENGE WHERE THERE  
 MAY ONLY HAVE BEEN SIMPLE EXISTENCE.

It WILL TAKE HARD WORK. THERE WILL BE MUCH TRIAL AND  
 ERROR AND ANXIETY OVER WHETHER YOU ARE GETTING THROUGH TO  
~~those~~ <sup>these</sup> BOYS. BUT IT CAN BE DONE! IT MUST BE DONE. FOR THEY ARE  
 ALSO GOD'S <sup>children -</sup> CREATURES. THEY ALSO CAN MAKE A ~~CONTRIBUTION~~  
 CONTRIBUTION TO OUR SOCIETY.

There IS SO MUCH BEING DONE TODAY IN MEDICAL AND  
 PSYCHOLOGICAL RESEARCH ON MENTAL AND PHYSICAL HANDICAPS. <sup>There is</sup>  
<sup>so much being done</sup> IN THE DEVELOPMENT OF NEW REHABILITATION TECHNIQUES, ~~that~~ <sup>the</sup>  
 BARRIERS OF IGNORANCE AND PREJUDICE ARE BEING OVERCOME AT AN  
 ACCELERATING PACE THAT IS TRULY INSPIRING.

THE HANDICAPPED BOY HAS A RIGHT TO BELONG, TO BE  
 ACCEPTED, TO WORK LIKE OTHER BOYS TO ACHIEVE SKILLS AND  
 DEVELOP AMBITION. HE HAS A RIGHT TO BE PROUD OF HIS  
 ACCOMPLISHMENTS, AND MOST OF ALL, TO EXPERIENCE THE DEEP  
 SATISFACTION AND NEW SENSE OF SELF-WORTH, IN PERFORMING  
 SERVICES FOR OTHER PEOPLE.

WHETHER IN A SPECIAL UNIT OR A REGULAR SCOUT TROOP,  
 THAT BOY DESERVES TO BE CHALLENGED! HE HAS A RIGHT TO HAVE  
 DEMANDS PLACED UPON HIM TO DO BETTER, TO EXPERIENCE WHAT IT  
 MEANS TO "BE PREPARED," TO LEARN ABOUT HONORING GOD AND  
 LOVING HIS COUNTRY, AND TO ACTUALLY PERFORM A GOOD <sup>deed</sup> ~~TURN~~ EVERY  
 DAY.

FOR THOSE OF US HEARING THESE WORDS SO OFTEN THAT WE ALMOST TAKE THEM FOR GRANTED, WHAT AN EXPERIENCE IT CAN BE TO SEE THEM GIVEN NEW MEANING BY BOYS WHO ARE MASTERING THEM AND THEIR SIGNIFICANCE FOR THE FIRST TIME. AND WHAT A DEEP SATISFACTION IT CAN BE TO WATCH A BOY LOOK UPON A FOREST AND LEARN THE SKILLS OF CAMPING -- OPPORTUNITIES THAT HE MIGHT OTHERWISE NEVER HAVE HAD.

IN RECENT YEARS, THE BOY SCOUTS OF AMERICA HAS ACCEPTED THIS CHALLENGE AND HAS REACHED OUT TO SERVE MORE OF THE THREE ~~THREE~~ MILLION HANDICAPPED YOUTH OF SCOUT AGE -- INCLUDING AN ESTIMATED 53,000 BOYS IN MINNESOTA ALONE.

AT THE OUTSET OF MY REMARKS I SPOKE ABOUT RESPONSIBILITY.

EACH OF US BEARS A HEAVY RESPONSIBILITY -- THE RESPONSIBILITY

OF COMPASSION AND OF RESPECT FOR HUMAN DIGNITY THAT

RESPONSIBILITY DEMANDS THAT WE RECOGNIZE AND ANSWER THE NEED

OF HANDICAPPED PERSONS FOR HELP TO HELP THEMSELVES. THEY ASK

NO MORE THAN THIS THEY CERTAINLY DESERVE NO LESS LET US

RESOLVE, HERE AND NOW, TO ACCEPT THIS RESPONSIBILITY TO CARE,

AND TO HELP.
