Carried. The Chairman reported that Mr. H. Oscar Beatty had accepted and was now a member of our Paris Depot's Committee, and further read a letter received from Mr. Beat's regarding our Paris Depot. The Chairman read a letter written by the Lakewood Committee to the London Committee of the French Wounded Emergency Fund. The Chairman reported that quite a few of the Branch Committees had written a similar letter to the London Committee of the French Wounded Emergency Fund. It was moved by Mrs. Chapin Seconder by Mr. Steinbrillere,

that Branch Committees who have not already written to the London Committee XXXX of the French Wounded Emergency Fund, regarding their allegiance to the American Fund for French Wounded. should be advised to do so. Carried.

The Chairman read a letter received from Mrs. Lathrop, regarding a consultation with Mr. Enrold E. Goad and the general conditions in our Faris Denot.

The Chairman authorized Mr. William Law Stout to draw up a resolution expressing the appreciation and thanks of the American Fund for French Wounded, for the work which Mr. Harold E. Goad had done for the American Fund for French Wounded.

The Chairman reported that Miss Mary Enc was unable to serve on the Committee.

The Chairman further reported that Miss Florence D. Murphy and Madame Louis Aubert had accepted the invitation to serve on the Board.

Dear Mrs. Chapin:-I have been trying to write you for two weeks past - but have been so busy with Red Cross - and A.F.F.W. that it has seemed impossible. There are several things important to us which I must consult you about. 1st. We sent over \$3000.00 to Mrs. Lathrop for the founding of our St. Paul Dispensary on March 16th. We sent it by mail care Morgan Harjes & Co., and have not vet heard of its receipt. Then when in N.Y. I put in an application as serving in that Dispensary two women eminently capable of the work and both of proper age (between thirty five and forty I believe). They were Miss Elizabeth McGregor and Miss Mary R. Clark. Mrs. Lathrop was entirely satisfied as to their capacity, and said that she would write or cable a demand for them as soon as she reached the other side. It was understood that they would not go over until April, and possibly not until May lst. No word came from the other side until two weeks ago about. Then an undated cable came :-38 Z M C Cable Paris 26 West Pub. Co. St. Paul, Min.. "Requesting Embassy Passports McGregor Clark and again asking Washington regarding rejected applicants " (This concerned two other St. Paul girls who were rejected because of being only 22 and 34 yrs. old) - - - - -(concerning other matters) Lathrop#

2nd Does the Red Cross now assume the expense of of transportation this side of N.Y.?

3rd What is the proper address for the boxes?
Is it care of Vacation War Relief, 26 West 23rd St?
Or what?

I hate to send you such a lot of questions for I know that you must be much over-burdened with the work of the A.F.F.W. Headquarters. I hope you can turn this over immediately to a secretary and let her answer it.

Mr. Ames has been away in the West for nearly three weeks. I do not know whether he has had time to write as he intended to do.

There are several other matters I want to write about, but I won't bother you with them now.

The two applications you sent me last week - for Miss Frances Rogers and Miss Felicite Oglesley reached me last week.

Miss Rogers has I believe already received her Passport through the Chicago Office. But I sent her the application you sent.

Miss Oglesley - I cannot find out anything about her. I think it must have been a mistake. So I return it to you. I telephoned up to Mrs. Rogers in Minneapolis - but she knew nothing of her.

My dear Mrs. Ames:

I received both of your letters this morning so am returning the duplicate copy in case you want it for your files.

About the three thousand dollars which you sent Mrs. Laturop for your St. Paul dispensary on March 16th. We have heard nothing from Mrs. Lathrop about it and I would advise you to write her for should it have been lost you ought to notify Morgan Harjes & Go. as soon as possible.

I have telegraphed you this morning about Miss Elizabeth McGregor and Miss Mary Clark. I wish I could help you, but feel that if I write to Washington it would only confuse them as of course all information should come from you, as both of them are St. Paul girls, but if you want me to write I shall be only too glad to do so. Of course you know the new rule is that no passports will be issued unless a cable comes from the American Embassy in Paris advising the War Department of Mrs. Lathrop's having applied there for a passport and mentioning the name of the applicant.

Now about your questions: we must change the size of our boxes and can only use the regulation Red Cross size 2 x 2 x 3. that is a definite order from the Red Cross and the Steam Ship

Mrs. C W A p 2 officials. I think you will have to take up the question of the expense of transportation with the Red Cross in St. Paul as that seems to differ in different localities. The proper address for all boxes to be sent is in care of the Vacation War Relief, 26 West 23rd Street. I am sorry to have bothered you about Miss Oglesby. I am sure it must be a mistake as I have not been able to locate her at all. Don't hesitate to write me at any time that I can be of any use. We also have a splendid Executive Secretary now, Miss Patchin, who is only too ready to answer any questions. With kindest regards, I am Sincerely yours Esther M. Olespin (Mrs. Charles M. My dear Mrs. Ames:

Thank you for your letter which came to me a few days ago.

In reply to your question regarding the use of Red Cross patterns for surgical dressings, I am glad to say that we can still use our own patterns. The only way in which we must conform to the Red Cross regulations is in the shipping question. We must ship in boxes This is absolutely required. 2 x 2 x 3 feet.

I am sure we have equally as good an opportunity as the Red Cross to get our supplies abroad rapidly and sometimes even better because of the help the French Line gives us in our shipping.

I am sorry you have not heard of the safe arrival of the boxes you have sent. I have spoken to Miss Goan of our Shipping Department and she tells me that because of the crowded conditon at our shipping headquarters, many of the boxes that came in had to be sent to a warehouse temporarily. We will soon have them at Headquarters and they will be acknowledged of course as soon as they arrive there.

At the last National Executive meeting Mrs. E. de Peyster Hosmer it was voted that all Committees shipping to Mr. Thomas Hastings Hon. J. Frederic Kernochan New York, therefore through the New York Branch, would be affiliated with the New York Branch.

I, as Chairman of that Branch, was told to write to all such Committees asking them if they could give an amount either monthly or quarterly towards the Paris Depot expenses. If they have in the past done this but have sent it directly to Paris, they are asked to change and send it through New York. The Chairman of the New York Branch (at present myself) would in turn notify Mrs. Van Rensselaer, now National President of our Mr. A. Parker Nevin Counsel Fund, the amount to be counted on from these Committees.

> It was thought best not to ask for any definite amount, as of course some Committees find it all they are able to do to finance themselves, but, feeling that every one would like the privilege of being asked to contribute something, no matter how small the amount, I am writing to all Committees both large and small.

> From this you will see that the National Council no longer solicits funds but only receives the funds to be sent for the Paris upkeep and the national administrative expenses. These funds must be collected in small amounts by the Branch through whom independent Committees ship.

I am therefore asking you whether your Committee will be able to share in this expense and if so what

amount you will be able to give.

From now on none of our committees will be able to send from their home towns to New York through the Red Cross. but will have to send independently their cases to our shipping Department, 531 Seventh Avenue, and after they arrive there we undertake to see that they reach France. This is the only change that the new relationship involves. and therefore should be no handicap for any of us to continue our splendid work.

I beg of you to remember that the needs were never greater and that it means not only taking care of all the little hospitals that have learned to look to us but also supplies for many of our own American boys who are now lying wounded in these same little hospitals. Could you not make an extra effort to send even more supplies to Mrs. Lathrop who is waiting anxiously for them?

Many of our Committees are asking what effect Germany's surrender will have upon the work of the American Fund for French Wounded.

I am sure you will be glad to know that at a meeting held yesterday, the National Council resolved to continue our work until it is clear that France no longer needs America's help.

While, as yet, we have received no word from Paris, we know that the French hospitals are still full of wounded and must be furnished with supplies from America. Although the signing of the armistice has stopped actual warfare, American troops will be serving in France for many months, and will need the comfort and cheer which the A.F. F.W. knows so well how to give. Let us also remember that our dispensaries and emergency work cannot be discontinued without great distress to thousands of refugee women and children who confidently look to the A.F.F.W. for help.

We are therefore asking our Committees not to relax their efforts, but to continue their generous support by sending money and supplies as usual. As soon as we hear from Mrs. Lathrop, I shall write to you again.

I hope you had a nice time in California with your boy. Indeed it will be wonderful to have them all home again with the feeling midd/that it is quite that they should be and that their splendid work has been accomplished. In Miss Vail's last letter she spoke of Mrs. Lathrop's feeling much better. She was back again in Paris so I think she is quite over the effects of her horrid influenza, but I quite agree with you that she has been under a dreadfully long strain and I do hope that, even should the American Fund for French Wounded take, up other work after the needs for hospital supplies are entirely over, it would mean that Mrs. Lathrop could have some time for play for I really think she deserves it, and it is not quite right to her family that we should ask her to give as much of herself as she has these last four years. # AN ALLIED THANKSGIVING DAY

Thanksgiving Day, this year more than ever, a time of rejoicing to all Americans, was celebrated, by the French and English as well, in honor of the visit of the King of England to France. His entry to Paris was a most impressive sight; as the long line of carriages and automobiles passed down the Champs Elysées to the Place de la Concord, both sides of the boulevard were lined with French soldiers. King George in the uniform of an English General and M. Poincaré were in the first carriage, the Prince of Wales and his brother following in the second. The procession drove slowly along, heralded by the enthusiastic greetings of the throngs, the waving of flags, and the blare of trumpets.

An impressive Thanksgiving Day Mass was held in the Madeleine under the patronage of His Eminence Cardinal Amette, Archbishop of Paris, the Cardinal of Paris, the Cardinal of Rheims, and Cardinal Bourne who came from England to deliver the sermon. The beautiful service opened with the Star Spangled Banner, and after a solemn Mass, sermon, and Te Deum, America was played, and the Archbishop of Paris gave his blessing from the portico of the cathedral.

The Soldiers' and Sailors' Club served dinner on Thanksgiving Day to 250 American soldiers who were invited to partake of their hospitality,—and turkey, cranberry sauce, and pumpkin pie acted as a magic carpet to transport them from France to America. Several Alcazar workers were among those who helped to serve, and if the proof of the dinner was in the eating, they can testify to its success.

Many hospitable French families invited American soldiers to dine with them on Thanksgiving Day, and throughout France, the day was one that can never be forgotten.

# A BRIGHT SPOT ON A DARK DAY

THIS has been a real Paris November day, one of the "melancholy-days-have-come" kind, when one awakens to find the rain pouring down as though it had every idea of pouring all day.

But a melancholy day it has not been, for business has been driving at the Alcazar, and when there is plenty to do, the usual cheerful atmosphere of our bureau becomes even more cheerful, and the place fairly hums with contentment.

One of the charms of the business of the Alcazar is that one never knows what is going to happen next, and a seemingly dull day may become very interesting. Some most unexpected friend may appear, a letter or a large order may change the program of our work in a moment, so we are constantly in the attitude of expectancy.

Thus it was with me this morning when I raised my eyes from a case of refugee clothing to see our manager standing before me with the request that two of us should go to a certain Italian Hospital after lunch and carry comfort bags to the blesses.

Now I have been making comfort bags more or less for the last three years and have received numberless letters from men of different nationalities telling me how much they had enjoyed receiving them, but never until today had I the privilege of bestowing them personally upon the soldiers. Any doubts as to whether grown men really did care for them were quickly banished as soon as we entered the hospital.

A pleasant Frech nurse quickly appeared and we were cordially welcomed and asked to go from room to room.

As my knowledge of Italian may be summed up in the two expressions meaning "Good-day" and "Farewell", I considered myself most fortunate in being asked to accompany Mme S\*\*\* who has charge of our bag department and who speaks several languages with equal facility, Italian among the number. The sound of their native tonge as she addressed them on entering the room was the awakening note, and when they saw the load of bright chintze bags on our arms, they looked much as children do, when Santa Claus appears at a Christmas celebration Pale faces brightened and weary ones were cheered and expectant.

Fortunately their tastes were as varied as the bags, and one after another they were chosen, from pale pink to deep violet.

A safety razor caused quite a sensation and both a doctor and an orderly were needed to explain its mechanism. It fell to the lot of a dark-eyed, pale faced boy with a complexion as smooth as a girl's, but he was none the less pleased.

A cordial English nurse begged us to stay for a while and talk to them, for she said they had but little company,—so we visited until the contents of the bags had been thoroughly explored and all announced in their child-like way that they were "bien content". I am sure you would never guess what amused them most,—it was a small black box which opened with a spring and released with a bound, a yellow snake! Such merriment as it caused! One of the nurses was duly alarmed, or pretended to be, and the doctor was summoned to diagnose the case.

Well, they were a merry lot for half an hour, some of them pathetically so. One poor fellow with only one leg, looked at his socks and said to me with a faint smile, "But I have only one leg". But when I suggested that it was two pairs for him, he saw the joke and laughed heartily.

Several of the boys were generously solicitous for some of their friends who being convalescent had gone out for a walk, so we placed their bags on the vacant beds for them to find on their return.

We left midst a sunny shower of pleasant wishes and I must say, we were suprised to find it still raining outside, for the cheer within had made us feel that the sun was shining.

They do say that every good tale has a moral. I am sure it is not far to seek. Two words will express it, and a little help when you have a vacant half hour will impress it in a very practical way: MAKE BAGS!

#### OUR HOME COMMITTEES

NOW that the war is over, we must express our deepest gratitude to more than five hundred faithful committees which have supported the American Fund for French Wounded.

Many committees which began as small centers have grown by leaps and bounds, and the increase both in money and supplies has been monumental.

Before our work is over we intend to publish the names of our committees and of the countless individuals who have supported this work.

This will make a very interesting record as our contributors in America can scarcely realize how broad is our acquaintance and how many states are represented in the gifts which come from America.

The New England and Chicago invoices should go on record. The figures of these important branches are so large, that we would like the people at home to know the extent of their work.

From New England has come an enormous quantity of pajamas and underclothes, just in time for the cold weather. We are delighted to find that they have sent thousands of women's and children's clothes which are now being sent up to the districts near Belgium and Alsace.

From Chicago have come large quantities of women's and children's clothes and rubber goods, the most coveted of articles. The George Washington Bags are being saved for Christmas, and the Martha Washington Bags are being sent to refugees. As the hospital demands are decreasing and those of the refugees are increasing, we hope that Chicago will go on with these generous supplies of CLOTHES FOR WOMEN AND CHILDREN.

For years we have received magnificent consignments and supplies of every kind accompanied only by modest little notes bearing the words "The Five Friends from Brooklyn".

The war, so gloriously won, is over and few people will ever know what these friends have done to aid the American Fund for French Wounded in its work for humanity.

To every cable that has been sent they have responded most lavishly and much of our latest work has been developed by the aid of their financial help.

The thanks of our entire organization are now offered to these devoted and generous friends.

Since sending you our letter of January 10th, we have had more definite information from Mrs. Lathrop. the American Fund for French Wounded is to cease all shipments by March first, we now write to ask you not to cut out any garments which cannot be finished and sent to us by February 20th, but to complete all garments already started.

Again we would impress upon our Committees the desirability of having our final shipments particularly large and to that end would ask them to redouble their efforts.

My dear Mrs. Ames:-

Since writing you on January 18th. we have gone over the list of our packing department, and find that it takes at least 4 weeks from the time the cases leave your city to the date of their arrival here. (This is the minimum length of time, they have often been on the road for a much longer time.)

Taking this into consideration, we find it necessary to limit the date of your final shipments to Feb. 1st.

After this date, should you have any garments on hand, they could be sent by Express or Parcels Post. In sending in either of these two last ways, Express or Parcels Post, we would ask you to keep in mind that all goods must reach us by the first week of March.

As you ship in regulation size cases, would you be willing to send each case as it is ready for shipment? We must also ask you not to put any more surgical dressings in cases ready for shipment abroad as we can no longer send them. If you have any on hand, could not your local hospitals use them? From now on we must dispose of any that come to us in this way.

Accept my hearty thanks for your telegram, repeating Mrs. Lathrop's cable received on the 27th. That confirms our
explanation of her delay in answering our cable regarding the hospital.

Work up here until April first instead of closing it March first, seems to involve us in a similar mental operation. I have talked the matter over with Mrs. Ames to see how the St. Paul Committee feels about it. She finds from her records that a large proportion of the shipments which we have made, including refugee garments, have not yet been reported as arriving in Paris. There must be thousands of cases still in transit, and doubtless many of those shipped last fall will be turning up from time to time during spring, when they will be just as welcome as ever for refugee emergencies. Under those circumstances it does not seem worth while to continue our shipments for another month, especially as we had made arrangements to close down about the middle of February. It is not easy to hold the interest of workers with these shifting plans. We can
