#### Constitution

## Attucks-Brooks Post #606 American Legion, Department 0f Minnesota

### Preamble

For God and country we associate ourselves together in order to promote, maintain and advance the principle of democratic freedom; to fight for and keep a vigilance for the maintenance of the Constitution of our United States of America in the light of the ideals which were set forth by our forefathers; to preserve the memory of those who gave life in defense of the nation in the Great Wars; to inculcate a sense of individual obligation to the community, state and nation; to combat all forms of autocracy; to make right the master of might; to safeguard and transmit to posterity the principles of justice, freedom and democracy for all, without regard to race, creed or color. These ideals we believe are man's God given rights.

### Article I Name

Section 1 The name of this organization shall be the Attucks-Brooks Post Number 606, The American Legion, Department of Minnesota. Its principal office shall be maintained in the City of St. Paul.

### Article II Objects

**Section 1** The objects and purposes of this post shall be to promote the principles and policies as set forth in the foregoing preamble, and the National and Departmental Constitutions of The American Legion.

### Article III Nature

- **Section 1** This post is a civilian organization and membership therein does not affect or increase liability for military or police service.
- **Section 2** This organization shall be absolutely non-political and shall not be used for the dissemination of partisan principles nor for the promotion or the candidacy of any person seeking public office or preferment.
- **Section 3** Rank does not exist in The American Legion. No member shall be addressed by his/her military or naval title in any meeting of this post.

### Article IV Membership

- Section 1 The Attucks-Brooks Post Number 606, The American Legion,
  Department of Minnesota is a post of and subject to the jurisdiction of
  the American Legion, Department of Minnesota.
- Section 2 Eligibility to membership in this post shall be as prescribed by the National Constitution of The American Legion. Further, membership in this post shall not be denied any honorably discharged veteran because of race, creed or color.
- Section 3 Application for membership shall be made in writing under such regulations as may from time to time be prescribed by the Post Executive Committee.
- Section 4 All applications for membership in this post shall be acted upon at the next Post meeting following the making of such applications, and shall at such meeting be accepted, rejected or referred for further investigation and consideration. Any applications duly made may be rejected by one third of the members present at said meeting voting against the acceptance of said application for membership, and said application shall be then recorded as rejected. No rejected

application shall again be considered until after expiration of six months from the date of such rejection.

- Section 5 Any member of this post may be expelled for cause by a two-thirds vote of the Executive Committee after charges are preferred under oath in writing, and a fair trial had upon the same. Charge shall be based upon disloyalty, neglect of duty, dishonesty and conduct unbecoming a member of the American Legion Post.
- Section 6 A member who has been expelled or suspended from this post for any cause may be reinstated to membership by a two-thirds vote of the membership present in a regularly scheduled post meeting, and the payment of any arrears in his dues at the time of his expulsion or suspension, and the payment of current dues for the year in which the reinstatement occurs.
- Section 7 No person who has been expelled by a post shall be admitted to membership in another post, without the consent of the expelling post, except that where such consent has been asked for and denied by such post, he may then appeal to the state Executive Committee of the department of the expelling post for permission to apply for membership in this post, and shall be ineligible for membership until such permission is granted.

### Article V Officers

Section 1 The administrative affairs of this post of The American Legion shall, except as may be otherwise provided by the By-Laws, be under the supervision of an Executive Committee which shall consist of three members in addition to the officers of the post. The term of office of members of the Executive Committee shall be for one year. This post, by its By-Laws, may provide for such other standing committees as the business of the organization may require.

- Section 2 Elected officers of this post consist of: Post Commander, Post Vice Commander, Post Second Vice Commander, Post Adjutant, Post Finance Officer, Post Historian, Post Chaplain, Post Sergeant-at-Arms, Post House Committee Chairman and such other officers as may be deemed necessary by this organization, who shall be nominated from the floor at the meeting preceding the annual election. All other officers are to be appointed by the Commander and ratified by the Executive Committee.
- Section 3 All officers and executive committee shall be elected annually and they shall hold office until their successors are duly installed or as otherwise provided. Any officer or executive committeeman may be removed for inefficiency by the Executive Committee, a two-thirds vote of said committee being necessary to effect such removal.
- **Section 4** Every member of this post in good standing shall be eligible to hold office, chair a committee or be a member of a committee in this post, providing he/she has attended at least three regular post meetings during the year.
- Section 5 The duties of officers and the executive committeemen shall be those usually appertaining to such officers or committeemen and are further provided in the By-Laws.

### Article VI Finance

- **Section 1** The revenue of this post shall be derived from membership or initiation fees, from annual membership dues and from such other sources as may be approved by the Executive Committee.
- **Section 2** The amount of such membership or initiation fees and the amount of such annual post dues shall be fixed and determined by this post.
- **Section 3** The post shall pay to departmental headquarters the national and departmental annual membership dues for every member of this post.

#### **Article VII Charter Members**

**Section 1** Members who joined this post prior to issuance of Permanent Charter shall be known as charter members.

### Article VIII Units of the American Legion

- Section 1 This post recognizes an auxiliary organization to be known as the Auxiliary Unit of Attucks-Brooks Post Number 606, The American Legion.
- **Section 2** Membership in the Auxiliary shall be as prescribed by the National Constitution of The American Legion Auxiliary.
- **Section 3** The post recognizes the formation of a squadron to be known as: Sons of the American Legion (SAL), A Unit of Attucks-Brooks Post Number 606, The American Legion.

### **Article IX Amendments**

- Section 1 This Constitution is adopted subject to the provisions of the National Constitution of The American Legion and of the department Constitution of the Department of Minnesota, The American Legion. Any amendment to said National Constitution or department Constitution which is in conflict with any provisions hereof shall be regarded as automatically repealing or modifying the provisions of this Constitution to the extent of such conflict.
- Section 2 This Constitution may be amended at any regular post meeting by a vote of two-thirds of the members of said post attending such regular meeting, providing that the proposed amendment shall have been submitted in writing and read at the next preceding regular meeting of said post, and providing, further, that written notice shall have been given to all members at least fifteen days in advance of the date when such amendment is to be voted upon, notifying said members that at

such meeting a proposal to amend the Constitution is to be voted upon. Such amendment to become effective as of the close of the meeting at which adopted, unless otherwise stated in the amendment.

### ARTICLE IX

#### Resolutions

Section 1. All resolutions of state or national scope presented to this Post by a member or reported to this Post by a Committee shall merely embody the opinion of this Post on the subject and copy of same shall be forwarded to the Department Headquarters for its approval before any publicity is given or action other than mere passage by the Post is taken.

### ARTICLE X

#### **Notices**

- Section 1. Every member shall furnish the Post Adjutant with his or her address for mailing purposes.
- Section 2. The Post Adjutant shall cause notice of the Annual Election to be given at least two (2) weeks prior thereto.

### **Amendments**

Article IV Duties of Officers, Section 5, Paragraph 1 has been amended to read:

Finance Officer: The Finance Officer shall be responsible for maintaining records of all monies deposited in a local bank or banks and shall prepare reports once a month for the Executive Committee on the financial condition of the Post, with such recommendations as may be deemed expedient or necessary for raising funds with which to carry on the activities of the Post. All checks for disbursement of funds shall be co-signed by the Finance Officer and the Commander, or in case of emergency, the First Vice-Commander. All checks shall require two (2) signatures.

These By-Laws were written in accordance to the directions given in the American Legion Officers Guide.

Any controversy or disagreement with these written By-Laws or any additional information regarding procedure will be resolved by the use of the American Legion Officers Guide.

SAC/OI conducted study of SAC Band appearances during the coming 60 days in order to divert the band to Minot AFB. Result was to schedule appearance for 7 through 10 February 1975.

27 January 1975

Follow-up action responsibility assumed by General Miller, 57AD/CC.

28 January 1975

CINCSAC/DP, General Cody's staff informed him of attempts to put together "package groups" of entertainment to tour northern tier bases.

2 February 1975

General Cody's inquiry team briefed local commanders and General Dougherty on their findings.

3 February 1975

General Fulcher's inquiry team using its own report and General Cody's findings, began immediate: corrective actions using the Management By Objectives (MBO) plan.

The airmen in the facility insisted on talking to Congresswoman Shirley Chisolm and/or other prominent black civilians (ie: Dick Gregory, Congresswoman Barbara Jordan, Julian Bond, etc.)

- 09:10 09:20 Dissidents left dining hall peacefully and returned to duty or the barracks with the exception of five who went with Colonel McCartney to talk.
- 10:00 11:30 Round-robin discussion with dissidents and Colonels McCartney and Eveland, 5BMW/CC.
  - 11:00 General Fulcher arrived at Minot AFB.
  - 11:15 Congresswoman Chisolm called again and talked with General Dougherty.
  - 11:30 Local radio and TV newsman held interview with the five black airmen leaving Colonel McCartney's office.
  - 14:00 Two inquiry teams headed by Generals Fulcher and Cody met at Minot AFB.

- TO COMBAT THE AUTOCRACY OF BOTH THE CLASSES AND THE MASSES;
- TO MAKE RIGHT THE MASTER OF MIGHT;
- TO PROMOTE PEACE AND GOOD-WILL ON EARTH;
- TO SAFEGUARD AND TRANSMIT TO POSTERITY THE PRIN-CIPLES OF JUSTICE, FREEDOM AND DEMOCRACY;
- TO CONSECRATE AND SANCTIFY OUR COMRADESHIP BY OUR DEVOTION TO MUTUAL HELPFUINESS.

A group of World War II Veterans held a meeting November 15, 1946, for the purpose of organizing an American Legion Post. This meeting was held at the Sterling Club of St. Paul, Minnesota. It was decided at this meeting to apply for a charter. Those present were: O. C. Hall, Jr., Stephen Maxwell, Andrew Hartshorn, George Mann, Charles W. Blackburn, Kenneth Wilson, Alvin Hannon, Jr, Samuel Reed, and Benjamin Perry.


A Temporary Charter was issued by the Department of Minnesota, American Legion. The names of the first officers were: O. C. Hall, Jr., Commander; Stephen Maxwell, Vice-Commander; Andrew Hartshorn, Finance Officer; Samuel Reed, Adjutant; Nathaniel L. Hardy, Chaplain. The name selected was Franklin D. Roosevelt. The date, January 16, 1947.

December 6,1947, a Permanent Charter was issued, and the name changed to Attucks-Brooks Post # 606. The membership was approximately 15. The Post functioned regularly through the years under the leadership of the following Commanders: 0. C. Hall, Jr. 1947; Alvin Hannon, Jr. 1948-49-50-51-53; Charles W. Blackburn 1952; Donald McAdams 1954; Marion L. Brown 1955; Martin O. Weddington 1956; Stephen Maxwell 1957; William J. Parker 1958; and presently, John L. Brown 1959.

The Post has an Auxiliary of approximately 60 ladies. They have been very helpful in every way.

The Post initiated the Club Room Project in March 1955. The Post Club Room was located at 709 Rondo Avenue for approximately one and a half years, after which the Post purchased the property located on the corner of Rondo and Chatsworth Avenues. The property has been improved, and has served as the Post Headquarters. A Recreation Room has been dedicated in memory of our first Commander, the Late O. C. Hall, Jr. The present membership is 140, \*\*\* AND GROWING.




