# Constitution and Bylaws

## ARTICLE I - NAME

This church shall be called PILGRIM BAPTIST CHURCH of St. Paul, Minnesota.

## ARTICLE II - COVENANT

Having been led as we believe, by the spirit of God, to receive the Lord Jesus Christ as our Saviour, and on profession of our faith, having been baptized in the name of the Father, and the Son, and of the Holy Spirit, we do now in the presence of God, and this assembly, most solemnly and joyfully enter into the covenant with one another as one body in Christ. We engage therefore, by the aid of the Holy Spirit to walk together in Christian love; to strive for the advancement of this church in knowledge, holiness, and in comfort; to promote its prosperity and spiritually; to sustain its worship, ordinances, discipline, and doctrines; to contribute regularly and cheerfully to the support of the ministry, the expense of the church, the relief of the poor, and the spread of the gospel throughout all nations. We also engage to maintain family and secret devotion; to seek the salvation of kindred and acquaintances; to walk circumspectly in the world; to be just in our dealings; faithfully in our engagements, and exemplary in our deportment; to avoid all tattling, backbiting, and excessive anger; to be zealous in our efforts to advance the kingdom of our Saviour. We further engage to watch over one another in brotherly love; to remember each other in prayer; to aid each other in sickness and distress; to cultivate Christian sympathy in feeling and courtesy in speech; to be slow to take offense; but always ready for reconciliation, and mindful of the rules of our Saviour, to secure it without delay. We moreover, engage that when we remove from this place, we will as soon as possible unite with some other church where we may carry out the spirt of this covenant and the principles of God's word.

## ARTICLE III - CHARACTER

## Section 1. Policy

The government of this church is vested in the body of believers who compose it. It is subject to the control of no other ecclesiastical body, but it recognizes and sustains the obligations of mutual counsel and cooperation which are among American Baptist, National Baptist, Inc. Convention Churches.

## Section 2.

It receives the Scriptures as its authority in matters of faith and practice. Its understanding of Christian truth as contained therein as in essential accord with Baptist beliefs.

#### ARTICLE IV - MEMBERSHIP

- (a) Members shall be received upon confession of faith, on statement of Christian Experience and Baptism; they shall be received by letter from any church of like principles and spirit, provided they shall previously have been baptized.
- (b) Requests for membership shall come before the church only on recommendation of the Board of Deacons presented at any regular meeting of church worship service. Candidates for membership shall be received only by majority vote of members present at any stated meeting of the church; or church worship service; or if Students of any denomination attending Colleges or Universities within the area, request affiliation, may be accepted as Student members with no voting status, by the majority of members present; the tenure of this affiliation may continue as long as they remain as Students.

## Section 2, Status

All members of this church who reside within an area admitting of regular attendance at church services and of pastoral visitation shall be deemed resident members; members too far removed for regular attendance and pastoral visitation shall be deemed non-resident members.

## Section 3. Duties

Members, first of all are expected to be faithful in all spiritual duties essential to Christian life; and also attend regularly the services of this church, to give regularly for its support, and its charities, and to share in its organized work. Members who ignore these duties for six consecutive months, shall on recommendation of the Board of Deacons, be placed on the inactive list. The Board of Deacons is authorized to restore those whose names are on the inactive list to regular standing upon their compliance with the specified requirements concerning active membership.

## Section 4. Rights

Such members as are in full and regular standing or who do not hold letters of dismissal and recommendation, or who are not Student members, and have attained the age of eighteen (18) years, such only may act and vote in the transaction of business of this church. By full and regular standing is meant those who are not on the inactive list or otherwise under discipline.

## Section 5. Termination

The discontinuance of membership shall be subject to the principles and useage of Baptist Churches, and especiall as follows:

(a) Any person in good standing who desires a letter of dismissal and recommendation to any other BAPTIST Church is entitled to receive it on written request from its date, unless renewed, and this restriction shall be stated in the letter to that church.

- (b) If a member desires to join a religious body with which this church is not affiliated, the church may at his request grant a "CERTIFICATE OF GOOD STANDING" and terminate his membership.
- (c) If a member of good standing requests to be released from his covenant obligations to this church for reasons which the church may finally deem satisfactory, after which it shall have patiently and kindly endeavored to secure his continuance in its fellowship, such request may be granted and his fellowship terminated.
- (d) The church may also, after due notice and hearing and kindly effort to make such action unnecessary, terminate the membership of such members who for the space of time not regularly worshipping with the church, or for the same space of time not contributing to its support according to the system prescribed by the church or in some way satisfactory thereto.
- (e) Should a member become an offense to this church and its good name by reason immoral or unchristian conduct, or by persistent breach of convenant vows, the church may terminate his membership, but only after due notice and hearing, and after faithful efforts have been made to bring such a member to repentance and amendment.
- (f) Membership shall only be terminated (except by letter) at the meeting when the recommendation for such action is made.
- (g) All requests for termination of membership or action thereto, shall be presented in writing, and considered first, by the Board of Deacons who shall make recommendations to the church at any regular meeting or church service.
- (h) This church in accordance with the usages and regulations of American Baptist Convention and National Baptist Convention, Inc. Churches, looks with dis-

(h) favor upon all social evils, and members are admonished to refrain from participation in all such acts of misconduct that are generally deemed unchristian.

## ARTICLE V - OFFICERS AND COMMITTEES

Section 1. The Officers and Committees shall be as follows:

- (a) A Pastor to be chosen and called by the church whenever a vacancy occurs. His election shall take place at a meeting called for that purpose, notice of which shall have been given publicly for two successive Sundays. The election shall be by ballot, an affirmative vote of two-thirds of those present who are eligible to vote being necessary for a choice.
- (b) A Clerk, to be elected by a ballot at each annual meeting, to serve for one year.
  - (c) A Board of Deacons, to be elected, at least one for every thirty (30) members, who when elected shall serve continually until removed by written recommendation of the Board and approved by the church or by his own written request.

Deacon and Deaconesses who have reached a state of partial incapacitation, shall be given the status of Deacon Emeritus or Deaconess Emeritus. There shall also be elected a number of Deaconesses corresponding in number to the number of Deacons, and in the same manner.

- (d) A Church Treasurer to be elected by ballot at each annual meeting to serve for one year.
- (e) A Treasurer of Denevolence, to be elected by ballot at each annual meeting to serve for one year.

- (f) A Financial Clerk, to be elected at each annual meeting to serve for one year.
- (g) A Board of Trustees, one third of whom shall be elected by ballot at each meeting to serve for 3 years.
- (h) A Superintendent of Sunday School, to be elected by ballot at each annual meeting to serve for one year.
- (i) A Church Council, consisting of the Pastor, Church Clerk, Chairman of the Board of Deacons, and two (2) Deacons, Chairman of the Trustee Board, Financial Clerk, Treasurer of the Church, President of Church Choirs, Chairman of Music Committee, President of Youth Groups and Chairman of all other Auxiliaries of the Church. See Section 2, Paragraph (1) for Council Functions.
- (j) A Music Committee, consisting of five (5) members and president of each singing unit shall be elected by ballot to serve for one year.
- (k) A Finance Committee consisting of nine (9) members including Chairman of the Trustee Board, Financial Clerk, Treasurer of Church, Chairman of C.I. Drive, Treasurer of Benevolences and four (4) members of the Church at large, appointed by the Pastor.
- (1) A Nominating Committee, consisting of nine (9) members to be appointed at the Third Quarterly Business Meeting.
- (m) A Pulpit Committee representing all church organizations, including no less than three (3) Deacons for a total of fifteen (15) members. The Pastor shall appoint a Pulpit Committee following notice of his resignation.
- (n) A Women's Missionary Society consisting of all women members of the church. The Chairman to be elected by ballot annually.

- (o) A Men's Fellowship whose membership shall be enlisted from the membership of the church. The Chairman to be elected annually.
- (p) A Couples Club, whose members shall be married or engaged, and enlisted from the membership of the church. The Chairman Shall be elected by ballot annually.
- (q) A Young Adults Group, whose members shall be enlisted from the church membership. The Chairman to be elected annually.
- (r) Baptist Youth Fellowship, Junior and Senior Groups, whose members shall be enlisted from the church membership. The Advisor to be elected by ballot annually.
- (s) A Board of Christian Education consisting of thirteen (13) members, to be appointed annually by the Pastor, or by vote of the church on recommendation of the Nominating Committee.
- (t) Such other organizations and auxiliaries for the spiritual and social welfare of the membership.

## Section 2. Duties

(a) Pastor: The Pastor shall have charge of the spiritual welfare of the congregation; he shall preach the gospel, shall have in charge the stated services of public worship and shall administer the ordinances.

The "duties common to pastors of evangelical churches" are all inclusive. He shall conduct funerals, perform marriage ceremonies, teach, call, represent the church at the meetings of the association, the State Convention, and the National Convention and serve on all community projects where deemed advisable. The Pastor shall have the option of presiding at all meetings except when relating to himself, and on any occasion when the Pastor

- (a) does not preside, the Chairman of Deacon Board shall preside. In the event that the Chairman is absent he shall appoint the presiding officer from the membership. The Pastor shall have direct supervision of the Ministerial Students in cooperation with the various seminaries; all church staff and personnel shall come under his supervision; he shall also have general oversight of all Christian education activities of the Church. He shall be Ex-officio Chairman of all committees and auxiliaries.
- (b) The Clerk shall keep a complete record of all transactions at all the business meetings of the church, which shall be read for approval at the next following church business meeting. He shall keep a register of all members, with the date of admission, and how, dismissals, and death records. together with a record of baptisms. He shall. notify all Officers, members of committees, and delegates, of their election and appointment. He shall issue letters of dismissal and reccommendations voted by the church. He shall preserve on file all communications and written official reports. He shall have charge of the correspondence with non-resident members and other people or organizations outside of the church on behalf of the church. He, in conjunction with the Pastor shall have charge of the church seal.
- (c) The Board of Deacons shall with the Pastor, have general oversight of the spiritual welfare of the church. They shall direct all matters pertaining to membership in the church. The Deacons shall examine and recommend candidates for admission, shall provide for the supply for the pulpit in the absence of the Pastor; shall decide on objects for special collections when the church has not acted thereon, shall have general charge of matters of discipline, as provided in ARTICLE IV, and shall direct the distribution of the Fellowship Fund and other monies given for the relief of the poor.

- (c) The Deacons shall provide for the Lord's Supper and assist its administration. They shall make a report at the annual meeting of the church on all matters under their care. They shall hold monthly meetings, The Deaconesses, as far as is compatible, shall work in conjunction with the Deacons, in all matters pertaining to the spiritual welfare of the church.
- d) The Financial Clerk shall keep a financial record of all monies received in the church treasury. He or shall keep a financial record of all members and contributions to the church. At the close of each Quarter, he shall send to each member and regular contributor a financial statement. By virtue of his office, he is a member of the Finance and ... Auditing Committees.
- (e) The Treasurer shall keep an accurate account of all monies received by him for support of public worship or any department of church work. He shall bank all monies received from the church, in the name of the church, in an account distinct from all other accounts and make payment by check only. He shall make a written report in detail at each Quarterly meeting, of all receipts and expenditures for the year, properly audited by the Auditing Committee of the Church. The Treasurer shall be bonded.
- (f) The Treasurer of Benevolence shall keep an accurate record of all monies raised for object of Christian benevolences, to be paid by him to the several persons or societies entitled thereto. He shall keep these accounts separate and apart from other accounts, and all checks drawn shall be in the name of the church. He shall make a written report in detail at each Quarterly meeting of the church, of all receipts and expenditures, and at the Annual meeting shall bring in a written report properly audited by the Auditing Committee. He shall make a monthly report to the Board of Deacons.

- (g) The Superintendent of Sunday School shall have general oversight of the work of the Sunday School and present in writing an annual report to the church on the condition of the Sunday School with recommendations for the ensuing year.
- (h) The Trustees shall hold in trust all property of the church. They shall have actual care of the church building and all other property of the church, but shall have no power to buy-sell, mortgage, lease, or transfer any property without specific vote of the church authorizing such action. They shall hold regular meetings monthly at a time specified at the first of the fiscal year.
- (i) The Church Advisory Council shall meet the Thursday prior to the Quarterly meeting, for action on such business as may come before it or upon recommendations of the Pastor, Deacons, Trustees, or any other Board or Auxiliary of the Church. The council shall have the power to fill all vacancies until the next succeeding election except as otherwise provided by the constitution.

The Council shall have authority to formulate measures of general policy and to recommend such to the church for adoption.

The council shall have authority to take such matters as are deemed of pertinent or emergency nature, these actions to be endorsed by the church at the next business meeting thereafter.

(j) The Music Committee shall have general oversight of the church music, and Senior, Youth, Children and Gospel Chorus, and it shall have power to enter in contract with musicians in accordance with the policy and budget adopted by the church.

It shall be the duty of the Music Committee to submit to the church at each Quarterly meeting recommendations concerning the music for the ensuing

- (j) quarter. The Music Committee will meet each Friday of the quarter prior to the quarterly business meeting.
- (k) The Finance Committee shall devise and put in operation ways and means for raising the necessary funds for the support of the church. It shall supervise the disbursement of funds as appropriated by the church, and shall make such reports to the Church Council or to the Church Corporation, as shall be required by either or both of them.

In cases where Committees or Auxiliaries of the church desire to draw on the Church Treasurer, a draft drawn by the Financial Clerk, Chairman of the Board of Trustees, or the Pastor of the Church.

The Finance Committee shall hold regular meetings on each Monday prior to the Quarterly business meet ing. Special meetings may be called when necessary

- (1) The Auditing Committee or professional auditors shall audit the books of all fiscal officers of the church, at the close of the fiscal year, and shall make a report upon the same at the Annual Meeting of the church, in January.
- (m) The Board of Ushers shall serve as a reception committee at the public services of the church, and shall have charge of seating the congregation, the collection of offerings and the ventilation of the building.
- n) The Nominating Committee shall present to the churc at the Special Meeting in December, a list of nomineed for all offices and committees in the church for which an election shall be due under the terms of this constitution. This committee shall adopt such methods as may to it seem proper to obtain from the different members of this church a general impression as to their preferences for persons to fill various offices; such expressions being intended to aid the Committee in making its report.

(n) In case any person nominated by the Committee shall refuse to serve, the Committee shall bring in other nominations at the January meeting when their election shall take place.

# ARTICLE VI - MEETINGS AS A CORPORATION

## Section 1. For Worship

- (a) Public services shall be held regularly, on the Lord's Day, special services afternoon and evenings on the Lord's Day. Prayer and worship services shall be held some evening of each week.
- (b) The Lord's Supper shall be celebrated on the first Sunday of each month.
- (c) Occasional religious meetings may be assigned by the Pastor, or on vote of the church.

## Section 2. For Business

- (a) At any regular meetings of the church for worship, the church may without special notice, act upon the reception of members, or upon the dismissal of members to other churches, and upon the appointment of delegates to councils or conventions, but not upon other business.
- (b) The Pastor may, and shall, when requested by the Deacons, Trustees, or any other Committee, call from the pulpit special business meetings, the particular object of which being clearly stated in the notice.

Special meetings of the church shall also be called by the Church Clerk upon written application of any five (5) adult members in full and regular standing, specifying the object thereof. This notice shall be read at the regular service of the Lord's Day next preceding the day fixed for such meeting. No special meeting shall be held on the same day on which the notice is given unless other-

- (b) wise stated in the Constitution.
- (c) On the Wednesday evening following the second Sunday in January, April, July and October, the church shall hold a regular Quarterly Business Meeting, at which time the Treasurer of the church and the Treasurer of Benevolence shall make an itemized report of all financial transactions for the Quarter which closed with the last preceding month. Their bank books should have been balanced to the satisfaction of the Finance Committee.

  Such other business may be transacted as the church may see fit.
- (d) A Special Meeting shall be called for the Wednesday following the first Sunday in December, at which time the budget for the coming year shall be adopted by the church. Also at this meeting the Nominating Committee shall make its first report. Such other business may be transacted as the church may see fit.
- (e) The Annual Meeting of the church as a corporation shall be held on the Wednesday evening following the second Sunday in January, at which time the annual report from all departments of the church shall be presented, and such Officers may be elected as may be brought in by the Nominating Committee. Such other business may be transacted at this meeting as may seem proper to the church. The Auditing and Nominating Committees shall be discharged at this meeting.
- (f) At the Annual, Quarterly and all Special meetings, twenty-five (25) members shall be necessary to constitute a quorum for the transaction of business.

#### ARTICLE VII - CORPORATE SEAL

Pilgrim Baptist Church (Organized 1863) legally incorporated under the laws of the State of Minnesota adopts as its corporate seal, a circle containing the words, "Pilgrim Baptist Church of St. Paul, Minn., May 25, 1867\*

The Corporate Seal of the Church shall be administered only by the Pastor or the Church Clerk on all offical church documents. In the absence of the Pastor and the Church Clerk, the church seal may be administed by the Chairman of the Board of Trustees or Deacons.

The Corporate Seal shall be kept in the vault of Pilgrim Baptist Church when not in use.

\*Incorporated as the Trustee of the Colored Pilgrim Baptist Church of St. Paul, Minnesota, May 25,1867.

Amended Articles date January 3, 1936. Filed January 13, 1936 to Amend the Articles of the Aforesaid Church to read: PILGRIM BAPTIST CHURCH.

## ARTICLE VIII - AMENDMENTS

This Constitution may be amended by two-thirds vote of members and voting at any Annual Meeting of the church, or at a meeting specially called for the purpose, the proposed amendment being inserted in the call; but no change shall be made in ARTICLE II or III, entitled "COVENANT" and "CHARACTER" except at an Annual Meeting, and by-two-thirds vote of all members entitled to vote, said proposed change having been laid before the church in writing at a business meeting not less than one month

before the Annual Meeting, and read from the pulpit on the Lord's Day next succeeding proposal.

The Church Council may draw up and add to this Constitution such By-Laws as it may see fit, the same to be presented to the church for adoption before becoming authoritative.

#### BY LAWS OF PILGRIM BAPTIST CHURCH

## ARTICLE I - RULES

The rules contained in Robert's Rules of Order, Revised, shall govern the Church in all cases to which they are applicable provided they are not inconsistent with the Constitution and By Laws of the Church.

## ARTICLE II - AFFILIATIONS

Pilgrim Baptist Church shall be affiliated with the American Baptist Convention, and may be dually aligned with the National Baptist Convention, U.S.A., Inc. or such other Baptist Bodies that promote the religious tenets of the faith.

The Church shall be affiliated with all Christian Bodies such as the Baptist World Alliance, National Council of Churches, State Council of Churches and Area Council of Churches as well as Baptist State Conventions whose world view and practice may be considered to be Evangelism, Social Concern and Action, and World Outreach and Ecumenism.



## **THANKSGIVING**

To The Presiding Officer, Other Officers, Fellow Christians, Ladies and Gentlemen:

It should now be our humble duty to pause before our God and just thank Him for the privilege of being alive and able to communicate, one with the other on this "Thanksgiving Day." It is a blessing more than I am able to express to have the high honor of addressing such an argus body as you, on such a significant occasion as this. As we stand here in the presence of the Almighty God, angels and this assembly, may we invite you to pitch your mental tents on the following Psalm:

"Bless the Lord, O my soul, and forget not all His benefits, who forgiveth all thine iniquities; who healeth all thy diseases; who redeemeth thy life from destruction; who crowneth thee with loving kindness and tender mercies; who satisfy thy mouth with good things." Ps. 103:2, 5.

From this passage of Scripture that comes to us drenched in the tears of a million contributions, steeped in the prayers of many a saint, stained with bloodshed in the sands of the Coliseum, exponded by the greatest intellects and worn with the fingers of agony and death. We finite creatures of a moment, we graveyard travelers, we the highest order of earth and the lowest order of heaven can readily see that God has done enough to employ and be rewarded with our thanks.

God has done so much for everyone of us in fact, that we should be able to write as Frederick Ozanam when told of his approaching death he said: "O God, if Thou shouldest chain me to the bed for the rest of my life, it would not suffice to thank Thee for the days I have already lived. If these words are the last I will ever write, let them be a hymn to Thy goodness.

We are assembled here today because we believe in God, and know that He is worthy to be praised. We are here because gratitude to the Almighty is a carry over from our fathers of old, and because it is our soul's sincere desire that this kind of celebration will be carried over to our children and our children's children.

In essence "Thanksgiving" is as old as the spirit of worship. There have for a long time been "Thanksgiving" celebrations among people, even the pagan races of mankind. The old Hebrew Feast of The Tabernacle goes back to the time when the first men started realizing their dependence on a higher power, and wanted to express thanks to that power for the fruits of the earth which kept them alive.

Our "Thanksgiving" is the oldest American holiday known and practiced. It dates as far back as 1620. "Thanksgiving started with the history of this great civilization. It was recognized and appreciated by the inhabitants of this country in the early morning of it's conception down to this present day.

The Pilgrim Fathers were thankful. If our nation has ever had a people that could be classified as being underprivileged people, the Pilgrim Fathers were those people. They had on homes, and all the transportation they had were their feet. They had but few clothing. Most of their food was secured from the forest and waters. They had no money that could be used here, they had no neighbors but savages. The only outside communication they had were letters which took months for delivery. But in spite of all the inconvenience, they were possessed with thankful hearts. We must be thankful for that courage. We are certainly a better people because of their faith.

They arrived too late the first year to make a crop, this caused them to have a doleful winter, they were forced to live on five grains of corn per day. We have come a long way from their richness in faith in the Almighty God despite their poverty in worldly good.

Before the first "Thanksgiving in this our America, the Pilgrim Fathers were among strangers and enemies. They had three thousand miles of ocean depths that separated them from their friends, familiarities, and the way of life. They were poor in things, but they were rich in the greatest of all human assets. They had the courage to think and the will to work, and an unshaken faith in the Almighty God. They had no governmental Social Security, but what they had was far better, they had glorious spiritual security.

The founding fathers of our country made so many noble contributions to our way of life until it is almost inconceivable to think of our even attempting to celebrate this day without them. May we too leave our footprints on the sands of time, that the generations that will follow us will not dare to call on their resources when giving gratitude to God and leave us off their program.

I think it rather befitting that we bear in mind that "Thanksgiving Day" is set aside only for the purpose of celebrating. "Thanksgiving" itself should be an unending attitude for all recipients of God's mercy. We all should assume the same attitude of one who said "I am desposed to say grace upon twenty other occasions in the course of a day beside my dinner. I want a form for setting out upon a very pleasant walk for a moon light ramble, for a friendly meeting or a solved problem. Why have none for books

those spiritual reports, a grace before Milton, a devotional exercise proper to be said before reading.

On this matter of "Thanksgiving" says Burton Hilles "I don't think the Lord wants Pompous proclamation of thanks on one Thursday in November as much as He wants a little humble service from us every day in the year. If we give this service every day, then and only then are we able to completely celebrate the "Thanksgiving festival."

We are considered to be great Americans upon our ability to be a generous people. I think we should take care that we do not fail to be generous in our thanksgiving to God as we are so productive in sharing with others the gifts He has shared with us. Are we then called on to be thankful Thanksgiving Day? No, we are called upon to be thankful 365 days in the year.

And now, as we bring this message to a close, let us consider a lesson that is to be learned from an illustration of a little old lady whose pastor visited her on "Thanksgiving Day", wondering if she was well taken care of. Knowing that she was deaf, the pastor knocked at her door and then stepped into her living room where he saw her bowed in prayer over a very meager meal. Just before she concluded she said, "I thank thee God, for all this and for Thyself besides."

On a snowy day in the nation's capital city, Washington, D. C. a very fair minister of one of the great denominations of this country was nervous and upset because of his inability to crank his new Cadillac automobile. Enroute by foot to his pulpit that bleak Sunday morning mad with the world and almost everything in it he reports having met a bum who was scraping morsels of food from the garbage cans on the streets, he said to the minister: "Chief, isn't it wonderful for us to have such a good God to serve like we have? These thankful words from the tramp caused the minister to rid himself of his frowns, cheer up and go to his pulpit with a heart filled with praise. How can I be downcast with a Cadillac that will not start, and this tramp grateful to God with no food to eat?

We have a community of glittering culture where our boys and girls are surrounded with a thousand opportunities.

The people of this community believe in making their own sunshine and then standing in it. This is a community that is doing its part in helping to make this a greater city, state and nation. We love to think of this community as a place of opportunity, sometimes we look at it as a May day, as it blossoms between two lakes, where the beautiful trees unfurl their foliage and spread their green assail and and where the carpet of the most beautiful green are thrown over her wide spreading floors. From this place where we are today may come some day the great leader of this great organization.

We welcome you here because we want you to relax while you carry on your deliberations. We welcome you because we believe a lot of good is coming from your visit with us. We welcome you because we want you with us.

When this welcome program is over, we plan to give you such a high entertainment until you will want to go back home and get the rest of your family and belongings and come and make this your home.

Lest I might bore you with a lengthy speech, I wish to express to you on behalf of this community in very simple language, you are welcome once, you are welcome twice, three times and forever you are welcome!

## **OUR CONFESSION OF FAITH**

- 1. The Authority of the Scripture --Baptists believe that the Bible is the Word of God in the highest and fullest sense, and is the sole authority in determining the faith and practice of God's people; that the sixty-six books of the Bible are divinely and uniquely inspired, and that they have come down to us substantially as they were under inspiration written. These Scriptures reveal God's plan of redemption and human duty. We deny the statement that other books are similarly inspired, and exalt the Bible to an unchallenged throne in our confidence. These Scriptures do not require the authorized interpretation of any church, and or council, priesthood or pope; but are divinely intended for personal study and interpretation, under the guidance of the Holy Spirit (2 Timothy 3:16-17; John 12:47-48).
- 2. The Sovereignty of God--Baptists believe in one true and living God, the Creator and Sustainer of all things, who is infinite, eternal and unchangeable in every spiritual excellence, and who is revealed to us as Father, Son and Holy Spirit--three in one and one in three, as the essential mode of his existence (John 4:24; Revelation 4:11).
- 3. The Deity of Jesus Christ-Baptists believe that the Son of the promised Messiah of the Old Testament, Jesus Christ, who was born of the Virgin Mary, given to reveal God, died to redeem man, rose from the dead to justify the believer, and is now at the right hand of God as our Advocate and Intercessor. He will return in visible, personal and bodily form for the final triumph of his people and judgement of the world (John 3:16; Philippians 2:6-7).
- 4. The Personality of the Holy Spirit--Baptists believe that the Holy Spirit is a person, not a mere influence, who has been sent from God to convict the world of sin, of righteousness, and of judgement, to regenerate and cleanse from sin, and to teach, guide, strengthen and perfect the believer, and that he is Christ's only representative on this earth (John 14:11--15:26).
- 5. The Depravity of Man-Baptists believe that man came into this world by direct creation of God and not by evolution, and that he was created innocent, but that being tempted by Satan, he sinned, and thereafter all men have been born in sin, and are by nature children

- of wrath. The original tempter was Satan, the personal devil, who with his angels has been since carrying his work of iniquity among the nations of the earth. The essence of sin is non-conformity to the will of God, and its end is eternal separation from God (Roman 5:19; Ephesians 2:1-3).
- 6. The Freeness of the Way of Salvation--Baptists believe that a way has been provided whereby men and women born in sin may be reconciled to God. That way is in Jesus Christ, whose death atoned for our sin and through union with him we become partakers of his merits, and escape the condemnation of God's holy law. The atonement becomes personally effective through the foreordination and the grace of God, and the free choice and faith of man. "I am the way, the truth, and the life: no man cometh unto the Father, but by me" (John 14:6). "For by grace are ye saved through faith; and that not of yourselves; it is the gift of God" (Ephesians 2:8).
- 7. The Evangelization of the World--Baptists believe that it is the first and greatest duty of Christ's people to give the whole gospel to the whole world, without regard to race or color or creed. "Go you, therefore, and teach all nations; baptizing them into the name of the Father and the Son and the Holy Spirit; teaching them to put into practice all things whatsoever I have commanded you and behold I am with you always, even unto the end of the age" (Matthew 28:19-20).

"Go you into all the world, and preach the gospel to the whole creation. He that believeth and is baptized shall be saved; but he that believeth not shall be condemned" (Mark 16:15-16).

"And he said unto them: Thus it is written, and thus it became necessary for Christ to suffer, and to rise from the dead the third day; and that repentance and remission of sins should be preached in his name to all nations" (Luke 24:46-48).

8. The Democracy and Independence of the Churches-Baptists believe that a New Testament Church is an organized body of baptized believers in Christ; equal in rank and privilege; administering its own affairs under the headship of Christ; united together in the belief of what Christ has taught; covenanting together to do what Christ has commanded; and voluntarily cooperating with other churches of like faith in carrying out the great commission of Christ; that it has Christ, and not the pope or some ecclesiastical body,

as its Head; that it had for its officers, pastors (also called bishops and elders) and deacons and not priests and prelates; that it has for its teacher and guide the true representative of Christ, the Holy Spirit; and that it is not only independent of all other churches, councils and conventions, but is separate from the state (Matthew 23:8-11).

- 9. The Integrity of the Ordinances--Baptists believe there are only two church ordinances--Baptism and the Lord's Supper. Baptists believe that personal believers are the only Scriptural subjects of baptism, and that immersion, or dipping, or burial in water, and resurrection there from is the only Scriptural act of baptism. They believe that the Lord's Supper is the partaking by the church of bread and wine, as a memorial of the Lord's death, and our expectation of his return. This bread typifies his body; the fruit of the vine typifies his blood. Baptists deny the actual presence of his body and blood in the bread and fruit of the vine, called wine (Romans 6:3-5; 1 Corinthians 11:17-34).
- 10. The Progress of the Saints-Baptists believe that the Christian life begins with conversion. Conversion has several aspects, including repentance, faith, regeneration and justification. Repentance implies a deep and sincere change of thinking, feeling and willingness toward sin and God, and faith is the surrender of the entire personality, of thought, feeling and volition to Jesus Christ as Saviour and Lord. Regeneration is the act of the Holy Spirit by which the sinner is born again, and his whole being is radically changed, so that the believer becomes a new creation in Christ Jesus. Justification is the judicial act of God by which the sinner is declared forgiven and freed from the condemnation of his sin, on the ground of the perfect righteousness of Christ, imputed by grace and power of God. The new life begun in regeneration is never lost but, by the grace and power of God and the faith in cooperation of the believer, is constantly brought nearer to that state of perfect holiness which we shall experience in heaven (1 John 2:19; Philippians 1:6).
- 11. Liberty of Conscience--Baptists believe that every human should has the inalienable right to approach and worship God for himself, and of his own free will and choice, and without any priestly meditation or parental proxy; that complete religious liberty and full self-determination, without any civil or ecclesiastical compulsion or

restraint, is the absolute right of every church of the Lord Jesus Christ and every individual worshiper of a Supreme Being, whether it be a child or and adult (Romans 14:12)

- 12. The Lord's Day-Baptists believe that the Lord's Day (under the old Jewish law called the Sabbath) is a Christian institution appointed for conscientious observance, and should be devoted to the nurture, development and training of the spiritual life, being freed as far as possible from worldly pursuits and amusements, the works of mercy and necessity only having the right-of-way on this day (Exodus 20:8; Hebrew 10:24-25).
- 13. The Destiny of Man--Baptists believe in the final resurrection of all men, both the just and the unjust; and that those who here believe unto salvation shall be raised to everlasting life in heaven, those who here disbelieve shall be raised to everlasting condemnation in hell (Malachi 3:18; Proverbs 14:32).
- 14. The Supremacy of Loyalty--Baptists stand for vital and distinctive truths, to many of which other denominations do not adhere, and that we cannot comprise these truths without disloyalty to the Scriptures and our Lord. They believe that they should cooperate with other denominations, in so far as such cooperation does not affect these truths, but no union with them is possible, except on the basis of acceptance in full of the plain teaching of the Word of God (Matthew 15:9; 1 John 2:20-21, 27).

## DISCIPLINE

The church will discipline its members by the following rules and principles:

## In Private Offenses

Private offenses, or such as one member may commit against another member, occasioning a grievance which does not affect any other person or persons, the course prescribed by our Saviour, in Matthew, 18th chapter, should be strictly followed.

1. **First Step**--The member who considers himself/herself injured must go to the offender, tell his/her grief, and between

themselves alone, if possible, adjust and settle the difficulty. "If thy brother shall trespass against thee, go and tell him his fault between thee and him alone." This must be done, not to charge, upbraid, or condemn the offender, but to win him. "If he shall hear thee, thou hast gained thy brother" (Matthew 18:15).

- 2. Second Step--If this shall fail, then the offended member must take one or two others with him, seek an interview with the offender, and, if possible, by their united wisdom and piety, remove the offense and harmonize the difficulty. "But if he will not hear thee, then take with thee one or two more, that in the mouth of two of three witnesses every word may be established" (Matthew 18:16).
- 3. Third Step--If this step should prove unavailing, then the offended member must tell the whole matter to the church, and leave it in their hands to be disposed of, as to them may seem wisest and best. "And if he shall neglect to hear them, tell it to the church; and if he neglect to hear the church, let him be unto thee as a heathen man, and a publican" (Matthew 18:17).

While this divine rule makes it obligatory on the offended member to go to the offender and seek a reconciliation, yet much more is it obligatory on any member who knows that a brother is grieved with him, to seek such at once, and try to remove the difficulty.

"If thou bring thy gift to the altar, and there rememberest that thy brother hath ought against thee, leave there thy gift before the altar, and go they way; first be reconciled to thy brother, and then come and offer thy gift" (Matthew 5:23).

#### In Public Offenses

Public offenses are such as are supposed to be a reproach or an injury to the church as a body, or to the reputation of religion. They are not against any one person, more than another.

The more common causes of public offense are the following; false doctrine, Galatians 1:9; 2 John 10; disregard of authority, Matthew 18:17; 1 Thessalonians 5:14; contention and strife, Romans 16:17; immoral conduct, 1 Corinthians 5:11; disorderly walk, 2 Thessalonians 3:6, 9; covetous spirit, Ephesians 5:1; 1 Corinthians 5:11; arrogant conduct, 3 John 9; going to law, 1 Corinthians 6:6.

The following is generally accepted as the proper course of treatment for public offenses.

- 1. The first member who has knowledge of the offense, should, as in the case of private offenses, seek the offender, ascertain the facts, and attempt to reconcile or remove the difficulty. Not until he/she has done this should he make it public, or bring it before the church.
- 2. But if no one will, or can, pursue this course of personal effort, or if such a course proves unsuccessful, then any member having knowledge of the facts should confer with the Pastor and Deacons, as to the best course to be pursued.
- 3. The pastor and deacons should, by the best method they are capable of devising, labor to adjust the matter, without bringing it in the church, or otherwise making it public.
- 4. But if their efforts fail, or if the case be already public, and a reproach and scandal to religion, then they should bring it to the church, and direct the course of discipline as seems wisest.
- 5. The church, thus having the case before them, should either appoint a committee to visit the offender, or cite him/ her before the body to answer the charge. He/she should be allowed to hear the evidence against him/her, know the witnesses and be permitted to answer for himself/herself.
- 6. If the accused disproves the charges, or if he/she confesses the wrong, makes suitable acknowledgment, and so far as possible reparation, with promise of amendment, in all ordinary cases, this should be deemed satisfactory, and the case be dismissed.
- 7. But if, after patient, deliberate, and prayerful labor, all efforts fail to reclaim the offender, then, however painful the necessity, the church must withdraw its fellowship from him/her and dismiss him

/her away from them.

8. If the case be one of flagrant immorality, by which the reputation of the body is comprised, and the Christian name scandalized, the hand of fellowship should be withdrawn from the offender notwithstanding any confessions and promises of amendment.

The church's good name, and the honor of religion demand this testimony against evil. He/she may be subsequently restored if suitably penitent.

- (a) all discipline must be conducted the spirit of Christian meekness and love, with a desire to remove offenses, and win offenders. It must also be done under a deep sense of responsibility to maintain the honor of Christ's name, the purity of his church, and integrity of his truth.
- (b) If any member shall attempt to bring a private grievance before the church, or other wise make it public before he has pursued the course prescribed in Matthew, 18th chapter, he/she becomes himself/herself and offender, and subject to the discipline of the body.

## MEMBERSHIP POLICY

The Constitution of the church establishes the basic membership policy at Pilgrim Baptist Church.

The following guidelines are intended to further clarify membership status and to update the membership rolls of the church.

- 1. Members are removed from the rolls at their death.
- Members are removed from the church rolls on written request from the member for transfer, resignation, or the joining of another church.
  - 3. If a member verbally indicated his or her intent to withdraw

from membership, a letter will be sent along with a return postcard asking whether they would like to remain members or be removed from the rolls. They will be removed if no response is received within 30 days of mailing.

- 4. No one shall be removed from the membership rolls until the removal is reviewed by the Pastor and approved by the Board of Deacons.
- 5. The Church Clerk shall, as necessary, recommend to the Board of Deacons a list of names of members to be removed (along with the reason for removal) in accordance with the church membership policy.
- 6. Any one whose name has been removed from the membership rolls without their knowledge:
- (a) Will be reinstated to active membership whenever they or a member of their family requests it in writing provided such reinstatement is not otherwise inconsistent with the church Membership Policy.
  - (b) Will be issued a letter of transfer upon request.

If a church mailing is returned with a forwarding address and the church staff cannot obtain the members current address. The member will be removed from the rolls. Any such removal however, is subject to both the Pastor's and Board of Deacons's review and to the reinstatement rules outlined above.

Section I. The Officers and Committees shall be as follows: 131 132 [a] A Pastor to be chosen and called by the church whenever a 133 vacancy occurs. The election shall take place at a meeting called for 134 that purpose, notice of which shall have been given for two 135 136 successive Sundays. The election shall be by ballot, an affirmative vote of two thirds of those present who are eligible to vote being 137 necessary for a choice. 138 139 The Pastor shall be the spiritual leader of the church, having 140 responsibility for the pulpit and its ministrations, the sacraments, all 141 public worship, the care and counsel of every member of the church 142 and the general administration of the programs of the church. The 143 Pastor shall be deemed to be a member of the church by virtue of 144 his\her installation as pastor. 145 146 The Pastor, when available, shall preside at all business meetings of 147

the church, except when the subject being discussed relates to the

Pastor. On any occasion when the Pastor does not preside, the Chair 149 of the Deacon Board or a designee of that Board shall preside. 150 151 The Pastor's term of office shall be specified in his\her employment 152 agreement and shall be subject to the mutual satisfaction of the Pastor 153 and the church membership. The Pastor shall be an ex-officio 154 member of all auxiliaries and committees of the church. 155 156 157 158 [b] A Board of Deacons (not less than 15 in number) who, when 159 elected, shall have been members of Pilgrim Baptist Church no less 160 than three (3) years, shall serve continually until removed by written 161 recommendation of the Deacon Board and approved by the church or 162 by his own written request. 163 164 There shall also be elected a number of Deaconesses corresponding in 165 number to the number of Deacons and in the same manner. 166

Deacons and Deaconesses who have reached a state of partial incapacitation, shall be given the status of Deacon or Deaconess Emeritus.

The Board of Deacons shall, with the Pastor, have general oversight of the spiritual welfare of the church. They shall direct all matters pertaining to membership in the church. The Deacons shall examine and recommend candidates for admission and shall supply the pulpit in the absence of the Pastor. They shall decide on objects for special collections when the church has not acted thereon ,and shall have general charge of matters of discipline, as provided in ARTICLE IV. The Deacon Board shall direct the distribution of the Mission and Benevolence Fund and other money given for the relief of the needy.

The Deacon Board shall, at least annually, review the compensation and benefits paid to the clergy and shall make adjustments, as appropriate, consistent with the guidelines established by the Personnel and Finance committees.

The Deacons and Deaconesses shall provide for the Lord's Supper and assist its administration. They shall make a report at the annual meeting of the church on all matters under their care. They shall hold monthly meetings. The Deaconesses shall work in conjunction with the Deacons in all matters pertaining to the spiritual welfare of the church.

[c] A Church Clerk, to be elected by ballot at each annual meeting, to serve a one year term.

The Clerk shall keep a complete record of all transactions at all the business meetings of the church, which shall be read for approval at the next following church business meeting. The Clerk shall keep a record of all members, with the date and method of admission, a record of baptisms, the date of dismissal, and death records. The Clerk shall notify all Officers, Members of Committees and Delegates of their election and \ or appointment and shall issue letters of

dismissal and recommendations voted by the church. The Clerk shall 205 preserve on file all communications and written official reports. 206 207 [d] A Church Treasurer to be elected by ballot at each annual 208 meeting to serve for one year. A Treasurer shall serve no more than 209 three (3) one year terms and shall not be eligible for re-election to 210 this position until he/she has been out of that office at least one year. 211 212 The Treasurer shall keep an accurate account of all Money received 213 by him\her for support of public worship or any department of church 214 work. The Treasurer shall bank all Money received from the church, 215 in the name of the church, in an account distinct from all other 216 accounts and make payment by check only. The Treasurer shall make 217 a written report, in detail, at each Quarterly meeting, of all receipts 218 and expenditures for the year, properly audited by the Auditing 219 Committee of the Church. The Treasurer shall be bonded. The 220 Treasurer shall serve no more than (three) one year terms, and shall 221 not be eligible for re-election to this position until he/she has been out 222

of this office at least one year.

eligible for re-election to this position until he/she has been out of office at least one year. [f] A Financial Secretary, to be elected at each annual meeting to serve for one year. The Financial Secretary shall keep a financial record of all money received in the church treasury along with a record of all members' contributions to the church. By the end of January of each year, the Financial Secretary shall send to each member and each regular contributor a statement of their financial contributions for the previous year. The Financial Secretary shall serve no more than three (3) one year terms and shall not be eligible for re-election until he \ she has been out of this office at least one year. 

[e] A Treasurer of Mission and Benevolence, to be elected by ballot at each annual meeting to serve for one year.

The Treasurer of Mission and Benevolence shall keep an accurate record of all money raised for Christian benevolence, to be paid to persons or societies entitled thereto.

The Treasurer of Mission and Benevolence shall keep these accounts separate and apart from other accounts, and all checks drawn shall be in the name of the church.

The Treasurer shall make a written report in detail at each Quarterly meeting of the church, of all receipts and expenditures, and at the Annual meeting shall bring in a written report properly audited by the Auditing Committee. The Treasurer shall make a monthly report to the Board of Deacons. The Treasurer of Mission and Benevolence shall serve no more than three (3) one year terms and shall not be

Financial Assistants The Church may also elect one or more assistants for Church Clerk, Church Treasurer, Treasurer of Mission and Benevolence and Financial Secretary. [g] A Board of Trustees, whose number shall not exceed 21, one third of whom shall be elected by ballot at each annual meeting to serve for 3 years. Any person elected to the Board of Trustees shall have been a member of the church no less than two years. The Trustees shall hold in trust all property of the church. They shall have actual care of the church building and all other property of the church, but shall have no power to buy-sell, mortgage, lease, or 

transfer any property without specific vote of the church authorizing 279 such action. They shall hold regular monthly meetings. 280 281 Trustees shall serve no more than two (2) three year terms and shall 282 not be eligible for re-election until they have been off the Board at 283 284 least one year. 285 [h] A Finance Committee consisting of nine [9] members including 286 Chair of the Trustee Board, Financial Secretary, Treasurer of Church, 287 Treasurer of Mission and Benevolence, Chair of the Deacon Board, 288 Chair of the Deaconess Board and three (3) members of the Church 289 at large, elected annually by the Church. The Finance Committee 290 shall hold regular business meetings and shall call special meetings as 291 the need arises. 292 293 The Finance Committee shall, after consultation with committees and 294 auxiliaries of the church, present to the church a proposed annual 295 budget for approval. The Finance Committee shall devise and put in 296 place ways and means of raising the necessary funds for the support 297

of the church. It shall supervise the disbursement of funds as 298 appropriated by the church and shall make quarterly reports to the 299 church. 300 The Finance Committee shall coordinate the activities of any 301 committee created for the fiscal support of the church. Any checks 302 drawn on the general account of the church must be approved and 303 signed by two of the following officers; the Church Treasurer, the 304 Financial Secretary, the Chair of the Trustee Board. 305 306 The Finance Committee shall, at least annually, review the 307 compensation paid to non-clergy staff and, along with the Personnel 308 Committee, make recommendations to the church for changes in the 309 compensation guidelines. 310 311 312 313 314 [i] The Auditing Committee or a professional auditing firm, 315

appointed by the Trustee Board, shall audit the books of all fiscal

officers of the church, at the close of the fiscal year, and shall make a 317 report upon the same at the Annual Meeting of the Church. 318 Beginning with fiscal year 1998, the financial records of the church 319 shall be audited by a professional auditing firm at least once every 320 third year. 321 322 [j] A Superintendent of Sunday School, to be elected by ballot at 323 each annual meeting to serve for one year. 324 325 The Superintendent of Sunday School shall have general oversight of 326 the work of the Sunday School and present in writing an annual 327 report to the church on the condition of the Sunday School with 328 recommendations for the ensuing year. 329 330 331 [k] A Music Committee consisting of five (5) members at large and 332 the President of each singing unit shall have general oversight of the 333

Church music and all of the Church choirs.

The "at large" members of the Music Committee shall be elected by the Church each year at the annual business meeting. Members of the Music committee shall elect a chairperson each year to serve a one (1) year term. The Church may contract for the services of a Minister of Music as the need arises. The responsibility of the Minister of Music shall be to coordinate the music ministry of the church in consultation with the Music Committee and the Senior Pastor. The Senior Pastor, after consultation with the Music committee, may recommend a person to the Board of Deacons and upon approval by this Board, the Pastor and the Board of Deacons shall jointly present the recommendation to the Church at any regularly scheduled Church 

business meeting.

358 [l] A Nominating Committee, consisting of nine [9] members to be
359 elected at the Third Quarterly Business Meeting. No less than five of
360 the members elected shall have been members of Pilgrim Baptist
361 Church at least two (2) years at the time they are elected to serve on
362 the committee.

The Nominating Committee shall present to the church at the Special Meeting in December, a list of nominees for all offices and committees in the church for which an election shall be due under the terms of this constitution. This committee shall adopt such methods as may to it seem proper to obtain from the different members of this church a general impression as to their preferences for persons to fill various offices.

In case any person nominated by the Committee shall refuse to serve, 372 the Committee shall bring in other nominations at a subsequent 373 meeting, when such nominees shall be considered by the church. 374 375 376 [m] A Board of Christian Education consisting of thirteen [13] 377 members, to be elected annually by vote of the church on 378 recommendation of the Nominating Committee. 379 380 The Board of Christian Education shall provide for programs which 381 introduce and promote spiritual growth of persons into the life and 382 mission of Christian faith. 383 384 385 (n) A Pulpit Committee of fifteen (15) members, representative of a 386 cross section of church membership, including no less than three (3) 387 Deacons and three (3) Deaconesses shall be appointed by the Deacon 388 Board upon notice of the resignation or termination of the Senior 389 Pastor. 390

393	[o] A Board of Ushers shall serve as a reception committee at the
394	public services of the church, and shall have charge of seating the
395	congregation, the collection of offerings and the ventilation of the

398	[p] Such other organizations and auxiliaries as the Church may

400	membership, so long as the purpose of the organization is not
401	inconsistent with the constitution of the Church.

410	[a] Public services shall be held regularly, on the Lord's Day, special
411	services afternoon and evenings on the Lord's Day. Prayer and

414	[b] The Lord's Supper shall be celebrated on the first Sunday of each

420	Section 2. For Business
421	
422	[a] At any regular worship service, the church may, without special
423	notice, act upon the reception of members, or upon the dismissal of
424	members to other churches, and upon the appointment of delegates to
425	councils or conventions, but not upon other business.

427	[b] The Pastor may, and shall, when requested by either the Deacon,
428	Deaconess or Trustee board, call from the pulpit special business

meetings, the particular subject of which shall be clearly stated in the notice.

Special meetings of the church shall also be called by the Church
Clerk upon written application of any twenty five (25) adult
members. The written request shall specify the subject of the meeting.
This notice shall be read at the regular service of the Sunday next
preceding the day fixed for such meeting. No special meeting shall
be held less than 72 hours from the time the notice is given.

[c] The church shall hold a regular Quarterly Business Meeting, at which time the Treasurer of the church and the Treasurer of Mission and Benevolence shall make an itemized report of all financial transactions for that Quarter which closed with the last preceding month. Their bank books should have been balanced to the satisfaction of the Finance Committee. Such other business may be transacted as the church may see fit.

[d] A Special Meeting shall be called in December, at which time the 447 budget for the coming year shall be acted upon by the church. Also at 448 this meeting the Nominating Committee shall make its report. Such 449 other business may be transacted as the church may see fit. 450 451 452 [e] The Annual Meeting of Pilgrim Baptist Church shall be held in 453 454 January, at which time the annual report from all departments of the church shall be presented. At this meeting, Church Officers shall be 455 elected from the list of nominees presented by the Nominating 456 Committee, or from members nominated from the floor by the 457 congregation, at the special meeting in December. Such other 458 business may be transacted at this meeting as may seem proper to the 459 church. The Auditing and Nominating Committees shall be 460 discharged at this meeting. 461 462 The annual meeting in January shall also serve as the first quarterly 463

This Constitution may be amended by two-thirds vote of eligible 502 503 members present at any Annual Meeting of the church, or at a meeting specially called for the purpose, the proposed amendment 504 being inserted in the call; but no change shall be made in ARTICLE 505 II or III, entitled "COVENANT" and "CHARACTER' except at an 506 Annual Meeting, and by two-thirds vote of all members entitled to 507 vote, said proposed change having been laid before the church in 508 writing at a business meeting not less than one month before the 509 Annual Meeting, and read from the pulpit on the Sunday next 510 succeeding proposal. 511

The Church may appoint a committee to recommend changes to the Constitution. Such recommendations shall be presented to the church for consideration and adoption before becoming effective.
