### November 12,1966

The Council of Deliberation A.A.S.R. of Freemasonry, Orient of Minnesota, N.J. was opened at high noon in the Valley of St. Paul with S.P. James D. Granville 32° presiding and the officers of North Star Consistory in the stations for the purpose of receiving and welcoming the 1966 Council of Deliberation, A.A.S.R. N.J. (PHA).

Grand Inspector General, John R. Lawrence 33', Overseer of the Work, was escorted to the East by G.I.G. Lapercell Greene 33', and was presented the gavel. He ordered the other Grand Inspectors General to be escorted in by the Ill. Grand Master of Ceremonies, and presented. Those present: G.I.G. Leonard Madden, G.I.G. Chalmer Lawson, and G.I.G. Lapercell Greene. The Grand Inspectors General were escorted to the East and given honors.

The G.I.G. John R.Lawrence 33' ordered the Peers to escort and present our distinguished guest, Deputy at Large, and representative of the Sovereign Grand Commander, Ill. Leland D. French 33', who had sent him to visit this 1966 Council - S.G.I.G. Charles S. Casterman 33' of Cleveland, Ohio. Ill. Casterman was received with the honors befitting his office, as the Sovereign Grand Commander would be received - 11 lights, 11 swords clashing in am arch of steel, and mallets beating.

Ill. Casterman was escorted to the East and introduced by Ill. Lapercell Greene, Ill. Grand Secretary of the Council and Grand Master of Minnesota Jurisdiction. The Welcome Address to Ill. Casterman and the Council of Deliberation was given by Ill. L. Greene.

A brilliant response and remarks were then offered by Ill. Casterman.

The Overseer, Ill. Lawrence asked the Ill. Grand Secretary to call the roll of the Council to ascertain whether a quorum was present.

### Illustrious Sir and Dear Brother:

North Star Consistory # 14 adopted a "Death Benefit Plan" which was effective May 1,1948 when Attorney Raymond Cannon 33' was Deputy. It provides that upon death of a member, in good standing, payment from the Death Benefit funds of fifty dollars (\$50.00) to the legal representative or representatives within ten (10) days upon receipt of proof of death.

One dollar from each member's dues each year is paid into this fund, which is earmarked as a separate account and totals one thousand four hundred fifty dollars at present (\$1450.00).

Since adoption the program has operated successfully and smoothly. We did not know that such programs were not favorable to the Supreme Council.

However, Ill. John R. Lawrence, our Overseer of the Work, reported to us your ruling, during the 86th Annual Session of the Supreme Council, re such plans.

Therefore, Illustrious Sir, may we have a statement from your office re disposition of this program ?

Dear R. E. G. C. Cason:

I am herewith attaching a Motion for dismissal of the Complaint or charge against Sir Bess which you have filed. I am his attorney.

Frankly, I have been surprised by your Charge and your procedure which is unconstitutional and unlawful and which has seriously damaged the good name, fraternal standing, the property and civil rights of Sir Bess.

It appears to me that the Grand Commandery is crumbling. Whenever times get desperate, it appears that it is NOT the times or circumstances which cause decay but the members began to bettle each other and thus there is battle from without and from within. We do NOT need this type af leadership nor do we need our membership incited by accusations by you or by Sir Bess. Thus I have filed the Motion.

My suggestion is that you and Sir Bess find some manner in which to resolve your difficulties and disagreements fraternally and amicably and in a spirit of brotherly LOVE. Prince Hall Grand Commandery cannot afford the luxury of charges and recriminations which ought to be settled within the confines of the fraternity in a spirit of true Knighthood. I shall not count it my victory to be compelled to resort to the civil courts where matters can and should be resolved before they grow all out of proportions. As the leader, the blood will fall upon your head IF this is not done immediately.

## MOTION TO DISMISS COMPLAINT AND CHARGES

Now come's, R. E. SIR, W. N. BESS, duly elected Grand Instructor, by R. E. SIR, LEVI H. MORRIS, his attorney, respectfully moves that the Charges and Complaint signed by Sir Joseph Cason against him be dismissed or in the alternative that Special-fications, detaining the Charges be filed and served in accordance with the Constitution and BY- Laws of Prince Hall Grand Commandery, Knights Templar of the State of Illinois and for grounds for the same says:

1. The Complaint and Charges are void of any SPECIFICATIONS. In support of this Rep ondent cites Section 1 of Article III of the Chapter III, Page 65 of the Penal Code of Prince Hall Grand Commandery which provides: " All Charges of Offenses shall be made in writing WITH REASONABLE CERTAINTY, the CHARACTER OF THE OFFENSE of the offense alleged to have been committed and the TIME AND PLACE OF THE COMMISSION..... The Charges MUST BE EXPLICIT that the accused shall have a fair understanding of what he shall have to answer. ..... " The Section also provides that the Charges where they are too vague for the accused to answer, "he shall REFUSE TO PROCEED TO TRIAL." The Charges merely cite the rprovisions of Section 9 and 10 on page 7 Art. VIII. The charges are a STATEMENT OF THE CONSTITUTION stating the wording of Section 9 and 10 and DO NOT IN ANY MANNER, FRAME OR FORM RECITE when, time, date on what occasion and in what manner or HOW the Respondent, W. N. Bess violated his oath and obligation. The Charges recite the wording of the Constatution w ich gives power to the Grand Commandery to bring such charges. The Charges are therefore VAGUE, UNCERTAIN, UNREASONABLE, NON EXTENT and are NOT properly framed. NO ANSWER CAN BE MADE TO THEM. Anyone and everyone can only agree that the Charges are NO CHARGES at all but a mere statement and recitation of the existing law and do not refer to any SPECIFIC violation by R. E. Sir Bess.

Moreover, Section 9 of Article VII page 7 which the R. E. Grand Commander cites gives the GRAND COMMANDERY power and original jurisdiction and does not give the Grand Commander any right, power or authority to assume this power and authority over or from the Grand Commandery.

2. The Charge recites the remaining part of Section 3 of Article IX on page 8 and the Grand Commander Cason sets this out in hac verba, word for word but the charge says nothing about the Respondent Bess committing any offense. It doesn't give any date, time or any place or any manner or what the Respondent Bess did or said or what criminal or moral offense was committed and when or where. The Charge merely RECITES THE SECTION 3 on Page 8. All Sir K ights know and can read this law but WHAT DID SIR BESC DO; when where and in what manner? The Charge therefore states that Sir Bess is removed from office for violation. WHAT VIOLATION? WHAT WAS DONE, WHEN OR WHERE? Section 3 gives the Grand Commander the power to remove any officer from office for this (WHAT) violation. Thus the Charge is vague and VOID and in fact is no Charge at all but it is only a recital of the Constitution and laws of the Grand Commandery. Moreover, Sir Bess IS NOT NAMED IN ANY CHARGE AT ALL, But in the lower part of the letter to him is typed this:

"Sir. W. Bess you or remove from offices, tell Trial at your Subordinate Commandery" 2/21/75"

Thus the "Charge" or Complaint is NO charge against Sir Bess and is ridiculous because no one can PRESUME OR IM GINE ANY ACT OR DEED COMMITTED BY SIR BESS- NONE BEING SET OUT.

3. Section 2 of Article I, Page 62 of the Penal Code of the Grand Commandery gives the Subordinate Commanderies the right to try its members for an offense BUT it express excepts the RIGHT EMINENT GRAND COMMANDER AND ALL ELECTIVE OFFICERS and it only has this power when the GRAND COMMANDERY DOES NOT ASSUME JURISDICTION. Thus no elective officer of Prince Hall Grand Commandery can be tried by his subordinate Commandery. See Sec. 2 of Article 1, Page 62.

By a STRONGER REASON AND GROUND FOR DISMISSAL, Respondent shows that he has been ordered removed from office until trial by his Subordinate Commandery. This is unlawful for the above reason stated. NO SUBORDINATE COMMANDERY CAN TRY AN ELECTIVE OFFICER OF THE Grand Commandery. Sir Bess has been and is now the ELECTED GRAND INSTRUCTOR and he therefore cannot be tried by the Subordinate Commandery. Respondent is surprised to be compelled to review the law which the Grand Commander should KNOW.

4. For a further ground to dismiss the "Charge" if it can be called a Charge, Respondent cites Section 4 of Article I at Page 63 of the Penal Code of Prince Hall Grand Commandery thusly:

In ALL CASES, which charges are preferred against any Eminent Commander OR an ELECTIVE OFFICER of this Grand Commandery, except the Right Eminent Grand

Commander, the CHERGES SHALL BE REFERRED TO IND HEARD BY A COMMISSION as provided by Section 3 of this Article. "(Section 3 provides for the composition of such a Commission.)

It therefore seems EVIDENT that NOT ONLY are the "CHARGES" unlawful, void and vague and without any SPECIFICATIONS, but they stand out as an abuse of the power of the Hight Eminent Grand Commander who has no power or right to have any trial of any ELECTEL OFFICER except by a Commission appointed by him. Such a Commission and its composition is set our plainly in Section 3 on page 62. Moreover Section 2 further recites:

...... A Subordinate Commandery has no power or authority to discipline the Right Eminent Grand Commander or Eminent Commanders or ANY ELECTIVE OFFICERS OF THIS GRAND COMMANDERY

referring this matter to "trial at your Subordinate Commandery on 2/21/75" is VOID ab initio and of no effect and must be held for naught. IF THIS ORDER IS NOT HELD FOR NAUGHT.

AND A BREACH OF THE CONSTITUTION AND PLNAL POWERS on page 62, THEN THE RIGHT EMINENT GRAND COLMANDER has wilfully committed a violation of the Constitution and Laws and the Respondent cannot believe that he would wilfully disobey the same. Sir Bess being an elective officer of the Grand Commandery cannot stand trial in his Subordinate Commandery nor can the Right Eminent Grand Commander order him so to do.

5. FOR THE REASONS and grounds stated and same being supported by the citations in the Constitutions and the Penal Code of the Grand Commandery the "Charge "if it can be so designated should be immediately withdrawn, stricken and dismissed. Even though the "Charge "is dismissed or withdrawn, the Right Eminent Grand Commander will have to report his actions to the Grand Conclave next. It therefore does not appear WHAT Sir Bess has done BUT IT IS VERY OBVIOUS that the Right Eminent Grand Commander has violated the Constitution and Laws of the Grand Commandery and for this Respondent has not preferred any Charge.

MOREOVER, it becomes increasing more difficult for Respondent to be charged by the Grand Commander and Prosecuted by him also upon an illegal, unconstitutional and unlawful charge and in such unlawful manner which breaches the rights of Respondent. Respondent also has a civil right and a property right and a Fraternal right for his Character NOT to be abused or held to scorn or miducule falsely and could if he chooses seek proper compensation from the Grand Commandery or from whomsoever is guilty of pressing such unlawful charges.

WHEREFORE, Respondent, W. N. Bests respectfully asks that the "Charge" be dismissed or that in the alternative proper Specifications be made and the Constitution and Penal Code followed precisely to preserve his fraternal, property and civil rights.

We further extend congratulations to the other five men from Illinois who were also coronated  $33^{\circ}$ .

The St. John's Grand Lodge of Perfection #28, will convene at 8:00 p.m. on Wednesday, May 23, 1973 at the Temple, 809 East 42nd Place. All Grand Elect, Perfect and Sublime Masons are expected to be in their places at that time.

Ancient and Accepted Scottish Rite of Freemasonry has been present in Minnesota, at least, since 1870. James K. Hilyard, Saint Paul, Minnesota, was readmitted into African Grand Council in 1870. The second lodge among Minnesota men of color was organized in Minneapolis, Minnesota September 5th or 7th 1871, known as J. K. Hilyard Lodge U. D.. Its charter was granted Tuesday July 2, 1872.

There were Consistory members in Minnesota from Missiouri, Iowa and Illinois long before North Star Consistory was organized. The first records of North Star Consistory show it was first under the Supreme Council Southern and Western, Washington, D. C.. North Star Consistory, as we know it, was organized on April 9, 1993.

Our present charters are dated January 23, 1906. They were signed by J. D. Kelley, S.G.C., William H. Miller, S.G.H.E. and J. F. Richards, H. C.. The Consistory met in Minneapolis, Minnesota.

The charter was surrendered during the late 30's. In 1944 a Brother Joseph Josa Sherwood, living in Saint Paul, Minnesota, who had been a leader in the United Supreme Council, gave instructions on how to go about reorganizing the Consistory. North Star Consistory No. 14 was reorganized on October 28, 1945, in Saint Paul, Minnesota. It now meets in Minnesotia, Minnesota again.

Constitutions and General Regulations changes Sovereign Grand Commander, Officers and Deputies:

1. Article III, Sec. 3a reads: The Supreme Council shall meet annually on the second Monday in May at such place within the Jurisdiction as it shall determine. etc.

To be amended as follows: [delete the word second, insertthe word first.] (effective 1989?)

2. Article IV, Sec. 12 reads: There shall be no more than 60 Active Members of the Supreme Council, including Deputies. As nearly as practicable, there shall be at least one Active Member of the Supreme Council from each State in its Jurisdiction where there are subordinate bodies, etc.

To be amended as follows: [delete the word one, insert the word two.]

3. Article IV. Sec. 13 reads: In the event that an Active Member of the Supreme Council is suspended from his symbolic lodge, and such suspension has continued for six months or more preceding the annual meeting of the Supreme Council, his office as an Active Member shall be automatically deemed to be permanently vacated.

To be amended as follows: [delete the word shall, insert the word can.]

4. Article IV, Sec. 22 reads: Honorary Members shall be entitled to sit in the Supreme Council, excepting during Executive Sessions, and a shall have the privilege of joining in debate, but shall have no vote.

To be amended as follows: [delete the words, but shall have no vote, insert the words, One Honorary Member from each Consistory present shall have one vote.]

5. Article XXIX, Sec. 109 reads: Such Councils of Deliberation shall be composed of all Sovereign and Grand Inspectors General of whatever grade resident in the State; duly elected officers of said Councils; all Past Commander-in-Chief of Consistories in the State; the first three officers for the time being of Consistories; the first three officers of Chapters of Rose Croix; and the first four officers of Lodges of Perfection.

Add Sec. 109a [In Jurisdictions or States with only one or two Consistories, Past Most Wise and Perfect Masters and Past Thrice Potent Masters shall be voting members of their Council of Deliberations.]

6. Articles XXX, Sec. 119, Article XXXI, Sec. 127 and Article XXXII, Sec. 133 read basicly the same: A dispensation or Charter for a Consistory of Sublime Princes of the Royal Secret may be granted in the manner elsewhere provided in these Constitutions to not less than forty-five Sublime Princes of the Royal Secret in good standing in this Jurisdiction.

Add Sec. 19 a [A dispensation or Charter for a Consistory of Sublime Princes of the Royal Secret may be granted in the Manner elsewhere provided in these Constitutions to less than forty-five new members, by the Sovereign Grand Commander, but not less than thirty-five new members and ten members of other Consistories or Consistory.]

7. Article XXXI, Sec.130, The last sentence of the paragraph reads: The officers of Chapters of Rose Croix shall be elected at its meeting held on Maundy Thursday, or at a meeting held within fortyone days thereafter, as its regulations may prescribe.

To be amended as follows: [The officers of Chapters of Rose Croix may be elected at its meeting held during the month of March, April or at its Maundy Thursday observance.]

8. Part TWO of our General Regulations, Sec. 27, bottom of page 58 reads: No subordinate body shall appropriate any of its moneys to defray the expenses of any member to the Council of Deliberation of its State except the <u>railroad</u> transportation by the shortest traveled route of the presiding officers of the Consistory, the Chapter of Rose Croix and the Lodge of Perfection, when by the body deemed necessary; nor shall any subordinate body contribute any of its moneys for the expenses of a member of the Supreme Council for attendance upon its sessions except upon the approval first obtained of the Deputy for its State.

To be amended as follows: [ delete the word railroad.]

We could not forsee the resistance, the attitude, the negative conversations and statements that were forthcoming.

The C.C.F.C. did not publicize the reaction and resistance to this action. This committee could have requested information, opinions and recommendations from other Jurisdictions who have faced similar situations. Suggestions from others might have helped us resolve our problem. We have too much invested now to let our membership drop.

Poor advise can hurt. Winnipeg should not have put themselves in the predicament they now find themselves in. We all should learn from others mistakes.

Masonry is supposed to be a progressive science. Masonry needs a substitute word for the word assessment. That word would have the same thought as assessment but would allow some exceptions. Government agencies use abbreviations such as; V.A.R. for Volunteered Additional Revenue or A.R.T. for Additional Revenue Tax. V.A.T. etc.

If we who are members of this Grand Lodge can not think of some way to raise money, some future generation will have to. Some organizations make money to support their homes from the public.

Maybe a Black community like St. Paul needs to join together and build a Black American Center. We should look at what other ethnic groups have done. Have you seen the building that the Ukrainans have built on North East Main St. in Minneapolis? Blacks can do the same. I can visualize a building at the other end of the parking lot owned by the St. Paul Gopher Elks Lodge.

We know who the enemy is, and it us. We must learn to love one another. We must learn to help one another. Black Masons should stand out from the mass. We should be like a candle on a candlestick. "let your light so shine before men, that they may see your good works and glorify your Father which is in heaven." Mathew 5: 16.

The office of C.C.F.C. stands ready to assist the Grand Master in communicating with other Prince Hall Grand Lodges. We can exchange information and assist his office for the advancement of the Order.

This office received no money. The Grand Lodge depleted its stock of envelops. I used my own. I am submitting an expense of \$22.00 for stamps. I used more than a roll of stamps.

This means, it is possible to elect the officers of the Chapter after the Supreme Council meeting in May. I believe this should be amended to read:

(The officers of Chapters of Rose Croix may be elected at its meeting held during the month of March, or at its Maundy Thursday observance.)

Article XXXII, Sec. 136 reads: The officers of a Lodge of Perfection shall be elected annuall. The election shall take place at a stated meeting to be held in the month of February. Additional meetings shall be called as the Thrice Potent Master shall direct.

It has been stated: "no one should be an officer in two houses."
You can't bleme a member from accepting the nomination and
election to an office in the Consistory even though he might be
an elected officer in the Chapter or the Lodge of Perfection.
All want to be a permanent member of the Council of Deliberation.
Permanent membership status is obtained by being a Sovereign
or Grand inspectors General or being a Past Commander-in-Chief.
One answer to this problem would be to make Past Most Wise and
PerfectMasters and Past Thrice Potent Masters members of the
Council of Deliberations. This might be an acceptable idea, if
it applied only to Jurisdictions with one or two Consistories.

8. Under Part Two of our General Regulations, Sec. 27, Bottom of page 58 reads: No subordinate body shall appropriate any of its moneys to defray the expenses of any member to the Council of Deliberation of its State except the railroad transportation by the shortest traveled route of the presiding officers of the Consistory, the Chapter of Rose Croix and the Lodge of Perfection, when by the body deemed necessary; etc.

The word "railroad" is near obsolet.

I suggest we delete the word railroad.)
