

Perfect Ashlar Lodge #4 opened in form on the third degree with all present master masons.

The Most Worshipful Grand Master and his cabinet were then escorted in and Grand Honors given.

Rollcall of all Grand Officers was read by the Grand Secretary Chalmers L. Lawson #2.

This was followed by the reading of the credentials by Brother William M. Davis #2, assistant Grand Secretary, and a sufficient number of representatives from the necessary number of lodges were present to open the 79th annual communication.

The Most Worshipful Grand Master Robert Johnson #7 declared this Grand Lodge open in ample form, and instructed the Grand Marshall Arberry Turner #4 to declare it so in the south, west and the Grand East.

Reading of the rules governing this session was by Brother Morris Miller #1, Grand Parliamentarian, who moved for adoption and was seconded. A break in the session was calked to admit the mayor of St Paul, Larry Cohen who brought greetings to the session. After timely remarks from the mayor, response was given by P.G.M. Lapercell Green, who stated that we have a lot of good men in the area who were masons and were potential men to be selected for promotions and appointments that would enhance better living conditions and relationships in the St Paul area. The mayor was then escorted out and the session was resumed.

On the question of the motion to adopt the rules there was considerable misunderstanding in regards to the rules that stated@(when a motion was made, only the name of the maker should be recorded and the name of the seconder was not necessary to make the motion legal as long as there was a second), after much discussion P.M.M. Lapercell Greene to ammend the rule in question by adding that the name of one seconder only would be entered into the records. Move for adoption of the rules was then passed.

The Honorable Grand Master Glanton Dawson and the Honorable Deputy Grand Master Oscar Baker of the Michigan jurisdiction were escorted to the east and Grand Honors given. Grand Master Dawson brought greetings from his jurisdiction and wished us a harmonius session.

This was followed by the reading of the committees appointed with the Grand Master filing the nexessary vacancies.

This was followed by the reading of the proclaiming of the Grand Master by P.G.M. Chalmers Lawson, Grand Secretary.

Greetings were read from The Honorable Wendell Anderson, Governor of Minnesota, Prince Hall Grand Chapter, O. E. S., United Supreme Council and Council of Deliberation of North Star Consistory, and all of the Golden Circle.

It was moved by Merrill Taylor #4 and seconded by Clarence Smith #7 that the greetings be received. Carried.

The gavel was turned over to the Deputy Grand Master Merrill Taylor, as the Most Worshipful Grand Master delivered his annual address of his stewardship for the year. Moved by P.G.M. John Mc Hie #7 that the address by the Grand Master be received and the recommendations be turned over to the proper committees. Seconded by P.G.M. Chalmers Lawson #2. Carried

The session was then called from labor to refreshments to resume at 1 30 P. M.

September 18, 1973 P. M.

The Grand Lodge was called from refreshment to labor at 1 45 P.M. by the sound of the gavel in the east.

We then heard the report of the Grand Treasurer Dan McAdams #7. It was moved by Clarence Smith #7 that the report coming from the Grand Treasurer be received and placed with the proper committee. Seconded by Harold Johnson #4. Carried. A rising vote of confidence was given by the body for the extremly detailed report.

We then heard the report from the Grand Secretary P.G.M. Chalmers L. Lawson #2. It was moved by Samuel Mitchell #2 that the report be received and placed with the proper committee. Seconded by Harold Sylvia #5. Carried.

Report of the Investment committee was given by Dan McAdams #7 and his committee. It was moved by P.G.M. Lapercell Greene #4 that this report be received. Seconded by Harvey Moss #7 P.G.M. Carried It was then moved by Carl Griffen #1 and seconded by Clarence Duke #4, that this report also be given to the proper committee. Carried.

The report of the C. C. of F. C. by P.G.M. Lapercell Greene was then heard. Moved by Conway Bolling #1 and seconded by Samuel Mitchell #2 that the report of the C. C. of F. C. be received. Carried. A rising vote of thanks for a job well done was given by the body.

The report of the committee on Grievances and Appeals was heard from Chairman Samuel Mitchell #2. Motion to receive by Nathaniel Hardy #1 and seconded by Lawrence Henderson #2. Carried.

The report of the Rt. Worshipful Deputy Grand Master. Merrill Taylor #4 was read. Motion to receive by George Taylor #4 and seconded by John Spencer #12. Carried.

A report from the past master,s council was given by the president, Arbery Turner #4. It was moved to receive by Merrill Taylor #4 and seconded by James Lynn #4. To be placed in the archives. Carried.

The report of the annual spring conference was read by Merrill Taylor, Deputy Grand Master. It was moved by Lawrence Henderson #2 and seconded by Clarence Duke #4 to receive and placed with the proper committee. Carried. A rising vote of thanks was given to the Deputy Grand Master, for carrying out this chore in a fine manner.

A floral gift was brought in and many thanks were given by the body For this gift from the Grand Chapter O.E.S.

Report was now had from the District Deputy Grand Master Clarence Duke #4 of District #1. It was moved by William Davis #2 and seconded by Charles Agnew #1 that this splendid report be accepted and placed on file. Carried

We now had the Worshipful Master,s hour conducted by the Most Worshipful Grand Master Robert Johnson #7.

First report came from Charles Agnew, W. M. Pioneer #1, It was moved by Carl Griffen #1 and seconded by Nathaniel Hardy #1 That this splendid report by accepted. Carried

Report of Morris Miller W. M. Anchor Hilyard #2. Moved by William Daves #2 and seconded by Samuel Mitchell that this splendid report be accepted. Carried

Report of Charles Stalling, W. M. Doric #3. Hoved by Nathaniel Hardy #1 and seconded by Lawrence Henderson #2, that this splendid report be accepted. Carried

Report of Harold Johnson W. M. Perfect Ashlar #4. Moved by Clarence Duke #4 and seconded by Brother Pequet #4 that this splendid report be accepted. Carried.

Report of Kieth Parsons W. M. Regent #5. Moved by Theodore Blakey #14 and seconded by Conway Bolling #1 that this splendid report be accepted. Carried.

Report of James K. Ash W. M. Palestine #7. Moved by P.G.M. Harvey Moss #7 and seconded by James A. Kinney that this splendid report by accepted. Carried.

Report of Don LaFayette W. M. Pride of Alberta #9. Moved by Hayward Hinton #9 and seconded by Lawrence Henderson #2 that this splendid report be accepted. Carried

Report of James Winder W. M. Mosaic Lodge # 11. Moved by Maurice Mitchell #11 and seconded by James Ash #7 that this splendid report be accepted. Carried

Report of Jesse James W. M. Acacia Lodge #12. It was moved by John Spencer #12 and seconded by William Lacy #12 that this splendid report be accepted. Carried

Report of Henry Lee Martin W. M. of Boaz Lodge #14. It was moved by Willie Johnson #14 and seconded by Theodore Blakey #14 that this splendid report be accepted. Carried

A rising vote of confidence was given for these young masters for a job done in the epitomy of perfection.

We then had the report of the resolutions committee by Brother Morris Miller #2 It was moved by Morris Miller #2 and seconded by Charles Agnew #1 that this report be accepted. Carried.

The Grand Lodge was now called from labor to refreshment to reconvene at 6 30 P. M.

The Most Worshipful Grand Master called the craft from refreshment to labor at 6 45 P. M.

The report of District Deputy Grand Master Chares Snargrass of District #2 was now heard. It was moved by James Adams #1 and seconded by Conway Bolling #1 that the report be received and placed with the proper committee. Carried.

District # 3 report was now given by Charles Stalling for the absent District Deputy John Hamilton #3. It was moved by Charles Snargress #7 and seconded by Clarence Duke #4 that this report be received and placed with the proper committee. Carried.

The report of District Deputy Grand Master Herbert Carvery #5 was read, by Kieth Farsens. It was moved by Harold Sylvia #5 and seconded by John Spencer #12 that the report be received and placed with the proper committee. Carried

The report from Willie Johnson District Deputy Grand Master of District #5 was then read. It was moved by Henry Lee Martin #14 and seconded by James Adams #1 that the report be receved and placed with the proper committee. Carried.

The report of District Deputy Grand Master Maurice Mitchell of district #6 was read. It was moved by James Winder #11 and seconded by Jesse James #12 that this report be received and placed with the proper committee. Carried.

The report of District Deputy Grand Master Barry F. Boyd of district #7 was read. It was moved by James Adams @1 and seconded by Kieth Parsons #5 that this report be received and placed with the proper committee. Carried.

Report of the committee on printing, by Dan Mc Adams #7. Moved for acceptance by William Davis #2 and seconded by Nc Clinton Webb #7. Carried.

Report on publicity by P.G.M. Joseph Patterson. Moved to receive by Charles Snargrass and seconded by Charles Stalling # 3. Carried.

Report of Transportation committee by Mc Clinton Webb #7. It was moved by James Ash #7 and seconded by Kieth Parsons # 5 that the report be received. Carried.

Report of the Obituary committee, which opened with a song, Precious Lord and a prayer by Brother Milton Henry # 1. Moved by James Adams #1 and seconded by Clarence Duke #4 that report be received and resolution be sent to proper committee. Carried.

Introduction of the Pythagoras Youth Group Organization with Curtis Whitlock #7 Master Counsellor.

Report of the Grand Lecturer Willie D. Gray. Moved for receiving by John Spencer #12 and seconded by Clarence Smith to be placed in the hands of the proper committee. Carried.

It was then the minutes for the day were read for corrections. It was moved by Nathaniel Hardy #1 and seconded by Milton Henry #1 that the minutes be received as corrected. Carried.

The craft was then called from labor to refreshments until the sound of the gavel in the Grand East.

September 19, 1973

The craft was called from refreshment to labor at 9 40 A. M.

The Most Worshipful Grand Master Herman E. Smith of Wisconsin was escorted to the east and given grand honors. M. W. G. M. Smith gave a short congratulatory speech on our 79th annual communication.

The report of the Rt. Worshipful Grand Junior Warden was then heard by Harold Sylvia #5. Moved by Keith Parsons #5 to receive and placed with the proper committee and seconded by Lawrence Henderson # 2. Carried.

The report of the Rt Worshipful Grand Senior Warden, Brother Eubanks # 11 was read by James Winder #11 in the absence of the Grand Senior Warden. Moved by John Spencer #12 and seconded by Jessie James #12 that the report be received and placed with the proper committee. Carried.

Report of the committe on petitions by Chairman Willie Johnson #14 was read. Moved by George Taylor # 4 and seconded by Parnell Davis #2 that the report be received. Carried.

The Grand Librarian, Clarence Smith #7 was presented. The motion to receve was made by James Kinney #7 and seconded by John Spencer #12. Carried.

Report of the Trusttees was made by Dan McAdams #7. It was moved by Harold Johnson #4 that the report be received. Seconded by Don Layfette. Carried.

Brother Thedodore Blakey gave a short reume on the bi-centennial in South Dakota for 1974. He said that he hopes the Grand Lodge could participate, and solicited the P.H. family to direct participation.

The report of the resolutions committee was given by the chairman, Morris Miller #2. It was moved by Brother Miller that the report be accepted and secomded by Henry Lee Martin #14. Carried.

The resolution to ammend the by-laws in regards to representation, page 131, to read (No brother shall be representative of his lodge as a proxy except he be a duly elected officer). Moved to adopt by John Spencer #12 and seconded by George Taylor #4 that this change be instituted. Carried.

The report of the committee on works and returns was given by Ted Blakey #14. After unreadnesses by Maurice Mitchell #11, James Winder #11, and Henry Lee Martin #14, it was moved by Willie Gray #4 and seconded by Charles Agnew #1 that the report of this committee, with the necessary corrections be accepted. Carried.

Report of the committee on the Grand Masters address, read by Martin Weddington P.G.M. #4. It was moved by Charles Agnew #1 and seconded by Clarence Duke #4 that this report be recieved and placed on file. Carried.

Grand Master Dawson and Deputy Grand Master Baker of the Michigan jurisdiction were escorted to the east and accorded Grand Honors.

The committee on place gave their report, Nathaniel Hardy #1, chairman reading. Of the offers to host Grand Lodge in 1974, the offer by Regent Lodge #5 was accepted. Assuring the 80th communication will be held in Winnepeg Manitoba, Canada. Moved to accept by Henry Lee Martin #14 and seconded by Dan McAdams #7. Carried.

A communication from the United Supreme Council A.A.S.R. was read. It was moved by C. W. Smith #7 and seconded by Eugene Lewis #1 that the communication be received and placed on file. Carried.

The report of the scholarship committee was read by P.G.M. Martin Weddington #4. Moved by Floyd Tiller #5 and seconded by Barry F. Boyd #9 that the report be received and properly disposed of. Carried

The grand lodge was called from labor to refreshment at 12 05 P.M. to resume at the sound of the gavel in the Grand East.

September 19, 1973 P. M.

The official visitation of the Grand Chapter O.E.S. was received by Grand Master Robert Johnson. The reception was most cordial and remarks by the Grand Master were followed by remarks from the Grand Matron and the Grand Patron and also the visiting Grand Masters. Next was presented the Order of the Golden Circle. Greetings were brought by Morris Miller #2 representing the Commander in chief of the North Star Consistory #14 Greetings were also extended by Lawrence Henderson M.W.P.M.

Greetings were then extended by Omar Chapter Heroines of Jerico U. D. State of Illinois by Merrill Taylor Grand Joshua.

Greetings were also extended by Fezzan Court # 7 Daughter of Isis by Daughter L. Bradford, second Lt Commandress.

The auxilliaries of the several bodies were then escorted out to some beautiful music by Brother William Davis #2 at the organ.

The report of the masonic awards committee was read by P.G.M. John Mc Hie #7 chairman. The Mason of the Year Award went to Mike Cates #7 and the giant gavel went to Mosaic Lodge #11 as having the highest proportionate increase in membership. Anchor Hyliard Lodge #2 received the Booster Club award. It was then moved by James Ash #7 and seconded by James Scott #11 that this report be received. Carried.

The report of the non-Prince Hall Mason committee was read by James Adams #1. It was moved by James Ash #7 and seconded by Conway Bolling #1 that this report be received and placed on file. Carried.

The report of the auditing committee was read by Charles Snargrass #7, chairman. It was moved by P.G.M. Lapersell Greene #4 that the report be accepted. seconded by Charles Agnew #1. Carried.

The report of the committee on Grand Officers reports was then heard. It was read by Clarence Duke #4, chairman. It was moved by James Adams #2 and seconded by William Davis #2 that the report be received. Carried

The report of the committee on jurisprudence was read by P.G.M. John Mc Hie #7 chairman. It was moved by P.G.M.Lapercell Greene #4 that the report be received but that the recommendations be acted upon separately. Seconded by Morris Miller #2.

Recommendation #1 in re (Tenure of office) Moved by Charles Agnew #1 and seconded by P.G.M. Aaron Arradondo #7 that this recommendation be accepted.

Recommedation #2. in re (publication of proceedings) Moved by John W. Spencer #12 and seconded by James Scott #11 that this recommendation be accepted. Carried.

Recommendation #3 in re (Wardens proffiency test) Moved by Charles Agnew #1 and seconded by Jessie James #12 that this recommendation be accepted. Carried.

Recommendation #4 in re (Rituals) Moved by Morris Miller #2 and seconded by J. W. Henderson #4 that this recommendation be accepted. Carried. Recommendation #5 in re (Honorary Past Grand Master Title) Moved by William Miller and seconded by P.G.M. John Mc Hie #7 that this recommendation be not accepted. Carried.

Recommendation #6 in re (age of applicants) Moved by Morris Miller #2 and seconded by P.G.M. Joe Patterson that this recommendation be accepted. Carried.

Recommendation #7 in re (financial allocation to regional conference of Grand Masters) Moved by P.G.M. Martin Weddington and seconded by P.G.M. John Mc Hie #7 that this recommendation be referred to the budget committee. Carried.

Recommendation # 8 in re (Fiscal year) Moved by Morris Miller #2 and seconded by P.G.M. John Mc Hie that this recommendation not be accepted. Carried.

Recommendation # 9 in re (Tax Increase) The committee did not concur, but offered a substitution of \$ 2.00. It was moved by Clarence Duke #4 that the substitute recommendation by the committee be accepted. Seconded by Morris Miller #2. Carried.

Recommendation #10 in re (lodge club funds) Moved by Dan McAdams #7 and seconded by Eugene Lewis #1 that this recommendation be accepted. Carried

The report on the youth group was then read by P.G.M. Aaron Arradondo #7. Moved by Charles Agnew #1 and seconded by James Ash #7 that this report be received. Carried.

The report of the budget committee was then heard. It was moved by Charles Agnew #1 and seconded by Henry Martin # 14 that this report be adopted. Carried.

The R. W. Grand Secretary then made a motion that the acting assistant secretary W. Lacey #12 by given a \$10.00 tiken. This was seconded by the R. W. D. G. Master Merrill Taylor. Carried.

The report of the committee on correctingthe constitution and by-laws was read, by P.G.M. Aaron Arradondo #7, chairman. It was moved by Aaron Arradondo #7 and seconded by James Smith #1 that the report be turned over to the Grand Secretary then turned back to P.G.M. LaPercell Greene for distribution to the field for \$1.00 each copy, and such monies received be turned over to the scholarship fund. Carried. A resolution from this committee was presented by P.G.M. Aaron Arradondo #7 and seconded by Charles Snargrass #7 to allow an investment of our monies in debentures at 9.75%. After a lengthy discussion on unreadyness this motion was defeated.

A resolution was presented by the obituary committee to erect a monument over the grave of our first Grand Master. Moved by P.G.M. Lapercell Greene #4 and seconded by James Kinney #7 that this resolution be adopted. Carried.

It was brought to our attention that Brother Ted Blakey had been voted to received the Mason of the Year award some time back but had never been presented with it. It was moved by James Ash #7 and seconded by Merrill Taylor #4 that the award be presented this session. Carried.

The election of officers for the ensuing year was now held. Election was conducted by senior Past Grand Master John L. Mc Hie.

Report of the committee on rules.

Rule 1 The credentials committee, directly after the opening ceremonies of the meeting, shall report the number of delegates and or proxies registered as present with proper credentials, and shall make a supplementary report after the opening exercise at the beginning of each day that business continues.

Rule 2 A resolution offered by an individual member shall be in writing, signed by the maker and seconder --each of whom shall be voting members of the Grand Lodge -- and shall be sent directly to the desk of the Grand Secretary.

Rule 3 All resolutions except those proposed by committees, and all recommendations made in reports of officers or committees that are not in the form of a resolution, shall be referred without debate to the Resolutions committee. Recommendations made by the Most Worshipful Grand Master shall be presented to the committee on Grand Officers Annual reports.

Annual reports.
b) Each member who offers a resolution shall be given an opportunity to explain it to the Resolutions committee if he so requests.

- c) The resolutions committee shall prepare suitable resolutions to carry into effect recommendations referred to it, and shall submit to the Grand Lodge with the committees own recommendation as to appropriate action, these and all other resolutions referred to the committee except questions which the committee by a vote of two-thirds of its members may decide not to refer or report.
- d) The Grand Lodge can by a majority vote suspend this rule 3 and can consider a question, or can order the resolutions committee to report at certain time, even if the committee voted not to report it.

Rule 4 No member shall speak in debate more than once on the same question on the same day. or longer than three (3) minutes without permission from the Grand East.

Rule 5 All reports and other materials for the permanent record or printed proceedings shall be in typing and immediately on presentation, shall be sent to the Grand Secretarys desk.

Rule 6 Only the name of the mover of the motion will be recorded in the minutes NOT the name of the seconder.

ADDRESS OF THE MOST WORSHIPFUL GRAND MASTER ROBERT H. JOHSON

R. W. Deputy Grand Master, R. W. Senior and Junior Grand Wardens, Grand Lodge Officers, Past Grand Masters, Past Grand Officers, Visiting Dignitaries, Brethren of the Craft.

Since the beginning of time a citadel or fortress has stood as a place of refuge from harm or evil, a protection from invasion of enemies or a haven of rest for the weary. Although great efforts were expended in building these massive physical structures, nevertheless, most of them have been destroyed by the ravages of war and time. There is a citadel, however, that is invulnerable above and beyond all attacks and circumstances. "A Mighty Fortress is our God,"assuring all fellow Masons that the Supreme Architect is a refuge and help in trouble and affliction.

The Most Worshipful Prince Hall Grand Lodge, standing for 10 79 years, depicts the citadel of Masonry here from all over the globe:

I am grateful for this opportunity to stand on this hallowed ground, to recount to you my stewardship for the past twelve months. This year indeed has been a unique experience, it has provided for new facets which have proven helpful. Likewise, it has caused many to put forth a greater effort to reevaluate our image and for us to require a strict adherence to the basic tenants of our Order to make Prince Hall Masonry a perpetuating reality. Our year started with faith in God and a determination to do our best.

Today, I am here somewhat battered, slightly buffeted, a little grayer, thinner at the temple, very tired, but still confident that bread cast upon the water"by many faithful brothers, whom I have attempted to bolster and sustain, is coming to fruition. This year our exposure to people af many religious faiths, encouraged greater sesitivity in inderstanding the human needs and values of the craft. My faith in each of you is a personal expression of my belief in the fatherhood of God and the brotherhood of man."

The sand of time have swiftly passed into eternity carrying with it some pleasant memories and some heartaches. But we are assembled to deliberate upon the accomplishments of a cycle and then walk up to the threshhold of a new Masonic year. Whatever was or has been accomplished was through the Divine guidance and the support of the faithful craft. We are told, and I believe, that prayer is the Souls sincere desire unuttered or expressed, the burden of a hidden fire that burns within the breast, it is the Christians vital breath, the Christians native air, his watchword at the gate of death—he enters heaven with prayer. The opportunities to blend many voices and ideas; to share in the fun and sorrows of brothers and sisters; to applaud the talents and services of all of our groups in public and private performances—are all now a portion of this Jurisdiction's history.

It was the hope of this administration to inculcate self help and support, as well as community participation; assuring the appreciation of each others' differences. Our membership come from all corners of the globe; they represent various faiths, communities and strata of life. They have joined to form a vital, working jurisdiction. This is our Grand jurisdiction, this year--"Unity from Diversity". This Grand Lodge represents the bonds of common experiences and significant relationships among individuals. On September 18, 1973, the light at the crossroads turned "Green"--we slowly, accelerated into a new era

OBSERVATIONS

In the light of today's explosive world, Masonry cannot be confined to our lodge rooms alone. Today's generation cries "Become Involved!" and create according to your own standards! There is a need for a vibrant cultural learning experience in Masonic life to complement the dogmas of our regular communications. The fight for survival by long established fraternities and sororities entails a battle for the minds of the younger generation. But hark ye! In seeking their own truths, youth approaches the formidable, questions the contradictions and hypocracies and—judges. To those of an older generation, there is a reluctance to turn over the reins to the younger innovators. It is not always easy to think unselfishly, but the time has come for all of us to think and act big! The wider we open the doors of our thinking for creative expression from the "new breed", the more progressive our fraternaity will become. "Remember—some mighty important people are watching every move we make; they are our kind; the leaders of tommorrow."

NECROLOGY

The questions is asked in the Holy Writ "What man is he that liveth and shall not see death?" .Coming down through the ages we get the answer, "Not one".

Let us pause for a few mements to reflect and take note of the vacant seats arround us—Softly and tenderly. Death has invaded our ranks and made our hearts heavy. The mystery of death, like the mystery of birth, continues to defy understanding; we are never quite ready when the day has ended. There is not one in this assemblage who does not have a personal interest in our brothers upon whom the seal of finality has been placed. Being members of our great fraternity places us all on a common ground. Those who passed, all were men who squared their actions as they went about their earthly labor. The young may die; the old must die; the wiseth knoweth now how soon. We think today with reverence of those brothers who have disrobed, retired, and sought solace in that Grand Lodge above. There is no work, nor knowledge,

nor wisdom in the grave. But after the strong hand of death has alarmed the tiled door and leveled all in the humiliation of the grave, the Almighty hand of the Supreme Grand Master shall prevail and exalt every brother in that Grand Lodge above. There the unfinished designs upon the Trestle Board will be completed; there the scales of doubt and procrastination shall fall from our eyes and the purpose of the Divine Plan shall be viewed in all its splendor.

Those of us who took time out from our daily tasks to attend the last sad rites of our deceased brothers did so--not just because he was our fraternal brother, but because as they lived, they had so let their stars shine by their daily actions that we were proud to have known them and were glad to do so. It is of great import that our departed brothers were members who attended their respective lodges, so that when their summons came they were known as members, not just names. They were brothers whom we met "on the level"; watched them as they "acted by the Plumb", and saw them as they departed "upon the Square".

While going about their earthly labors, some contributed more than others; some had more to offer. As Masons, all are equal. So it has been this year; we have returned to mother earth, restored to the bosom of nature, many of our fraters. Among them William B. Lewis #1, Ellis G. Harris #2, John Nealy #5, David Reese #1, Woodrow Reed #4, Floyd Manson #1, and Lee Wiley #3, and so many from other lodges who were properly eulogized during our Lodge of Sorrow. Let us resolve that as we continue to benefit from their labors their memory shall remain with us forever.

STATE OF THE NATION

The urban-racial crisis in America is viewed as a far more dangerous threat to the stability of the nation than any other problem--foreign or domestic. The fact is that the gap between the whites and blacks has not been closed. In today's affluent society there needs be a prompt and effective effort to provide everyone with a minimum income. America must give credibility to the rights of minority groups to determine their own destiny by supporting the concept of community participation in the control of educational and other institutions as other ethnic groups have done.

Walther P. Reuther, President of the United Auto Workers, professed profound sympathy for youngsters' disenchantment with things as they are. He cited three things as main factors at the root of this disaffection:

- 1. "A large gap of hypocrisy in our present 'mass culture' that has left youth 'alienated from a sense of human community'."
- 2. Society has been unable to translate its rapidly expanding technology into human terms and make it serve human needs.
- 3. "Things are in the saddle and things are getting bigger. Meanwhile, man is getting smaller and smaller."

Another point of view was expressed by Astronaut Walter Cunningham who labeled our as a Permissive Society. He said we were "sicker" than the younger generation because we permitted the wild behavior of the young. Cunningham further stated that "our generation is sicker.because we tolerate the tearing down of our places of learning and the disrespect of our Government."

- To Black America, the white man, like everyone else, has accepted things as they have been over the years. The impetus for change, if the community is to progress, will have to come from the Black communities. Despite the strides that have been made on the economic level in recent years, there still is not the necessary acceptance of the principle of integration.
- But the white world and the black world between--people who are neither capitalist nor revolutionaries--are not communicating. The anti-white rhetoric among black extremist has died down considerably, but there is a feeling of urgency in the context of a black America moving toward one of the highest pitches of activity of this century. In support of many of these approaches, I suggest to Prince Hall Masons that many of us have become middle class and forgotten the people we were designed to serve.

THE STATE OF THE CRAFT

The time honored custom of concluding a tenure with a renumeration of the achievements of such period might cause one to be expansive, bragging and obstentatious. While this may be a perogative of ledership, I do not consider it completely necessary if the lines of communication and the interest of the membership have remained stimulated.

We feel there has been a moral re-birth in our ranks this year which will enable us to build even more solidly the real foundations which underlay our Masonic life. We are and have been challenged, as members of this great fraternity, the Masonic order to give living reality to our principles and make proud the countless members and well-wishers whose names have emblazoned our history. We are not content to live in the past, however satisfying. They were plied by Masons of another day. We must live Masonry. We cannot pause at merely knowing grips, words and signs. We must exhibit signs that indicate a desire to do what is right. Our signs should indicate Faith; they should stand for Hope, and they should suggest Charity.

The leaders of 1973 in our jurisdiction accepted a great challenge—and in the face of our own misgivings at times, followed our direction to advance many times in the faces of our enemies. But we, like Gideon, did approach our tasks with humility, by dignity. In the spirit of humility we have refused the advantages of specialized honor and many supposed pre—require—ments of this high office. To those Masters, Wardens, and brothers, with whom I have labored this year, I ask you to continue to be the Joshuas of our times and be willing to lead our hosts of Masons around the walls of our Moral Jerichoes—blowing the trumpets of Justice and Duty so loudly until the walls of lethargy, complacency and self—aggrandizement come tumbling down in the face of the rhythm of our resistance to wrong doing. If we attempted to do any—thing—it was to make Masonry here in the Jurisdiction of Minnesota a living reality. We asked you to address your purposes to the permanecy of our Masonic temple as a bastion or world brotherhood.

One approach in the program plans of this administration was to develop, through discussions, mutual exchange of ideas, strong, knowledgeable Masters and Wardens who had or would develop what we call <u>Drive</u> or <u>Leadership</u>. We felt such <u>charisma</u> would cause the membership to rise above routine or average performance. Throughout 1973 we have hailed the Masters as the leaders of this Jurisdiction; this was not a fallacy. Some attempts were made to usurp their authority, but in the majority of these instances, issues were resolved without the official intervention of the MW Grand Master. In all of the approaches to procedures we have not, I repeat, have not ordered nor proclaimed innovations in the governmental structure of the Craft.

We have insisted upon a reaffirmation of those principles which are paramount in all Masonic jurisdictions. The fact that many tangibles had not been enforced over a period of time is irrelevant. We cannot, we must not condone those who would defy constitued leadership or authority.

When our joint Masters and Wardens, council first met, I was asked what I expected of them; my reply was a simple answer: "Their very best performance". They cannot succeed alone. We hope they have created an environment that stimulates progress through the personal touch, their own enthusiasm, their receiptiveness to new ideas, their own spirit to set challenging goals for their units and courage to welcome appraisals of their own progress toward these goals.

CONCLUSION

Let us redouble our efforts to become involved and be aware of the magnitude of our operation here; it requires the support of all of us. We do not propose nor do we support any effort to destroy any group; we would insist that any and all information relative to the involvement of the Lodges and Chapters in this renovation program be documented. This Masonic complex does not belong to any one individual or group; it represents the sweat and toil of all our Jurisdiction. We will not see your efforts dissipated futher.

Allied bodies and subordinate units, all are an integral part of any complete Jurisdiction. This premise does not pre-suppose that all are equal stature. The Grand Lodge, your Grand Lodge, is as it has been for 79 years the supreme authority in this Jurisdiction. It permits and extends to other groups the privilege to practice their forms of Masonic dogma, as forces for good, in its environs. But this permissiveness does not mean that the Grand Lodge relinquishes its authority to insist that the basic principles of Masonry be adhered to. Likewise, the Grand Lodge must remain the authority to determine what innovations, literature, new bodies or visitors, compatible to our Jurisdiction are permissible. This is not a new approach; it is a reaffirmation of a time honored principle. As your Grand Master I have a responsibilty to assure that all of the Blue Lodges remain strong. The practice of brothers advancing, many times in less than a year, to the other branches of Masonry leaves much to be desired. Many times, despite the glamour of these degrees, we have not put Masonry into these men, we have put these men into Masonry.

God has been our Co-Pilot; he was with us all the way; it was my plea..."Jesus Savior Pilot Me".

RECOMMENDATIONS

1. While our present by-laws do not show a tenure for the office of the Grand Master; at the 1963 preceedings the Grand Lodge accepted a recommendation from the M.W.G.M. Lawson to make that tenure two years (which is as it presently stands). However, I recommend that the tenure be now changed to four years, beginning with the election of the next Grand Master.

I believe the reasons for this change is obvious as it will provide for management-by-objectives.

2. That Grand Lodge proceedings should be available to the membership not later than 90 days after adjournment, at an amount not to exceed cost; and that there be included a summary of all new laws.

Warden's Test

- 3. Recognizing that the Warden's Test is inadequate ...
 - 1. I recommend that ARTICLE VII Sec 7 para 2 (bottom of page 95), be amended, by inserting the words: "and demonstrate administrative capabilities, with some knowledge of the" after the word: "masonry".
 - 2. That public relations, management by objectives, and leadership skills be included in the test, but not limited to those areas mentioned;
 - 3. That greater emphasis be placed on the administrative capabilities of the candidate. Suggested percentage rating:

- 4. That the office of the R.W.G.L. be charged with the responsibility of compiling the test, the substance of which shall be solicited with the help of the Grand Master, and other available sources;
- 5. That the revised test be put into immediate effect after its completion, but not later than three (3) months after this session is adjourned.
- 4. Because of the now high cost of our present ritual (an increase of about 110% in 14 years); and also because of the difficulty the code imposes on the masters of the lodges to find instructors for candidates; I conferred with other Grand Masters and found a majority of these jurisdictions favored using the open ritual. I therefore recommend that this jurisdiction adopts the Look of the East by Lester as its official ritual.

- 5. The office of the M.W.G.M. exists not because of the Grand Lodge or the Constitution, but because of the Land marks. The uniqueness of this office is such that it will exist even if the Grand Lodge does not exist. After one year in this office I believe that my experiences in it could never have been had outside of it. Therefore I believe that no one should be awarded the title of Honorary Grand Master with all rights and privileges pertaining thereto; and I according make that recommendation.
- 6. I recommend that the age limit be lowered to 18 for membership into our Subbordinate Lodges in the Jurisdiction of Minnesota.
- 7. I recommend that \$25.00 be allocated to the Midwest Regional Conference of Prince Hall Grand Masters and Masons, to held defray expenses of this very worthwhile organization.
- 8. Many Cabinet Members, Past Masters, and Subordinate Lodge officers have brought to my attention the very short period of time elapsing between Grand Lodge Annual Communication (third Tuesday in September) and Grand Lodge Fiscal Year (August 31). Quarterly Returns of lodges are often in the hands of the Grand Secretary for the August 31st Quarter but the Treasurer does not have ample time to make the deposit of monies in order to close his books for his yearly report.

The Auditing Committee is not able to perform its functions in the short period before Grand Lodge Session; the Finance Committee and Budget Committee work's are difficult due to incomplete financial reports from which they gather meaning figures.

Being cognigant of aformentioned difficulties, I recommend that Grand Lodge Fiscal Year be changed to August 1st through July 31st.

- 9. I recommend an increase in the Grand Lodge tax from eight dollars to thirteen dollars to be distributed in the following manner:
 - 1. One dollar (\$1.00) to be paid into the Scholarship Fund. This fund will be administered by a special committee with responsibility to design programs and or competitions which will attract the contestants. The awards MUST be made annually, and must not exceed two hundred dollars (\$200.00), beginning with the 80th Annual Communications.
 - 2. Two dollars (\$2.00) shall be earmarked for a "self-help" program from which subordinate lodges may borrow for the purchase of real property or such other causes as they may deem necessary. A special committee comprised of one representative from each lodge shall be appointed to administer this fund. No loans will be made until the fund has reached five thousand dollars (\$5,000.00).

- 3. The last two dollars (\$2.00) shall be applied to the general fund to offset the rising cost of operations of the Grand Lodge.
- 10. I further recommend that Article XXXVII Section 5 Paragraph 2 (pp 144-145) be amended by striking three hundred dollars (\$300.00) after the words "in excess of"and insert one thousand dollars (\$1,000.00). This should make it possible for the clubs to attempt larger projects and hopefully, enhance their treasuries by even more. It should be kept in mind that at any given time the parent lodge has the right to demand all or any part of such funds if its financial situation so dictates.

ANNUAL REPORT PAST GRAND MASTER - LAPERCELL P. GREENE, 33° CHAIRMAN OF COMMITTEE ON FOREIGN CORRESPONDENCE OF THE SEVENTY-NINTH (79) ANNUAL COMMUNICATION

Most Worshipful Grand Master, Grand Wardens, R. W. Grand Officers

I take pride in reporting that Minnesota enjoys harmonious relationships with all Jurisdictions. I am grateful to Prince Hall Grand Lodges, Secretaries, and C.C.F.C.'s for dispensing and distributing the information and invitations that we have received.

Many jurisdictions are concerned with declining memberships and lack of subordinate lodge attendance. They are stressing more interest in the matters that concern our communities, Urban Leagues, N.A.A.C.P., Housing and development and others. But first we as Prince Hall Masons must do a good public relations job, and each individual P.H.M. must sell Prince Hall Masonry and we as Masons need good relationship and publicity, More news of our activities brought to the public in newspaper articles and the news media.

The chairman of Committee on Foreign Correspondence throughout the Prince Hall Jurisdictions of Freemasonry are trying to bring to the craft in a condensed form an account of the unusual and interesting happenings of the Masonic World. To compare procedures of other jurisdictions and to send to other Jurisdictions the rosters, proceedings and other matters.

To follow all these detailed duties to fellow C.C.F.C. s is an outline of extent to Prince Hall Jurisdictions which is as follows"

1. Many jurisdictions have reduced the age of applicants for lodge membership to 18 years. Some are changing the use of the black-ball, requiring more than one for rejection. Physical qualifcations are being examined for some changes.

2. Death has invaded our sister jurisdictions, taking some we have known and worked with, and who have contributed much to the progress of Masonry.

July, 1973, the Grand Master of Kansas, the Honorable: P. G. Poter, 33° and many others.

The Northern Supreme Council Scottish Rite Masons the Honorable: Leland D. French, 33°, one of Americas outstanding Masons. Condolence was sent to its headquarters and the family.

3. The Southern Supreme Council Scottish Rite Masons conducted its Annual Session in the Republic of Liberia, October 28th, 1972. I was an invited guest on the list of events. Dinner by special invitation of President and Mrs. William Tolbert Sr. at the Executive Mansion. This was a wonderful affair.

I would like to give some highlights of this affair if we have the time.

Proceedings have been received from Colorado, Indiana, Michigan, New York, Ohio, Pennsylvania, Texas, Virginia and Washington State. Publications received from Ohio, the Lamp; Va. Bee Hive; Texas, Quarterly; N. Y. Prince Hall Sentinel. Pa. the Light; Michigan, Voice of Prince Hall; Indiana Informer; Trestleboard Delaware and "Prince Hall Free Mason Journal" of Illinois.

A review of some of the jurisdictions is brought to your attention.

COLORADO reports 746 members. 12 Lodges. 95th Annaul Communication, assets \$56,215.00. They report 11 deaths, paying \$300.00 donations. They possess Stocks, Mutual Funds, U.S. Bonds, totaling \$40,692.00. The Grand Lodge education tax is .50 cents per quarter, for scholarships. Minimum are 18 years adopted. Donations to National Urban League \$200.00. Shrine Hospital for Crippled Children, \$200.00; Conference of Grand Masters \$140.00. The Grand Historian made one report at the 93rd Annual Communication and a second report at the 95th, showing history from 1882 to 1956, then from 1956 to 1971.

INDIANA, proceedings for the 111th, 112th and 113th Communications. Membership, 3,324. Deaths 75. Foundation that was established 1957 now has cash value of \$57,150.00 and Market value of \$93,163.00. Deputy Grand Master plans and programs State workshops for each District. Grand Senior and Junior Wardens report to the Grand Lodge each year. Grand Lecturer is appointed. Five (5) Past Grant Masters present at this session.

IOWA, Reports 535 members. They donate one Scholarship of \$250.00 to deserving student. Their Grand Lodge program is underwritten by a firm that gets the ads, and as a contract agreement, is made returns to the Grand Lodge quite a sum. Eight (8) deaths reported. The Deputy Grand Master is appointed. Eight (8) Past Grand Masters attended the last session. Vernon H. Baker, who had served as Deputy Grand Master, was elected Grand Master.

MICHIGAN, Reports 3,969 members. Forty eight Lodges; 82 Deaths, 106th Annual Communication. Twenty Three (23) Scholarships have been reported since 1967 for a total of \$18,500.00.

NEW YORK. 7,039 members reported; 84 deaths. Total assets \$562,497.00. Grand Lodge officers made a trip to Barbados where they brought into Prince Hall family 85 Brothers with a Dispensation for 3 Lodges. Thirty (30) members of U.D. Lodge in St. Lucia acquired the French Temple, complete in every detail costing \$38,000.00. At this session, Past Grand Master, Louis Fair Jr., was granted an annual donation of \$480.00 for long distinctive services. A code of procedure for the Grand Lodge was adopted, regulating all activities of the Order. A memorial fund was proposed that would provide financial assistance for every Master Mason to assist in burial, starting at \$200.00 and increasing \$100.00 each year until a maximum of \$500.00 is reached. The tax will be \$1.00 per month. Donations were made to N.A.A.C.P., \$1,000.00, Negro College Fund \$400.00, S.C.L.C., \$400.00 and Sickle Cell Anemia \$500.00.

OHIO, reported 5,939 members, 107 deaths, total assets \$258,423.00. Awarded 3 scholarships \$300.00 each. Benefits of Charity increased from \$250.00 to \$300.00. Established a continuity of Grand Lodge programs. Adopted a uniform Burial service. A Protocol Manual and the enforcement of proper Masonic Dress for each occassion. Invitations for future Grand Sessions received for 4 years in advance. It was reported that the Dayton Housing Project was 100% occupied. The Sunset Hills Apartments in Springfield had 47 tenants. September 8, 1971 was the final closing of Columbus project \$1,503,000.00. Mortgage payments on each project paid on time in each case. Another project in Cincinnatti in operation.

PENNSYLVANIA. Meeting same time as Illinois. Quarterly executive sessions are held each year. District Deputy Grand Lecturers report to Grand Lodge on progress of each district, efficiency of Lodges, and preparation for Leadership. D.D.G. Masters report to Grand Lodge and acquaint Lodges with Grand Lodge program. To report on procedures and compliance. There is maintained a division of the Grand Lodge activities by special committees. Total assets \$858,695.00. Cash in Mortuary Fund \$119,771.00. Two Hundred Forty two (242) deaths. State Director of Youth reported that there were 113 members of the Knights of Pythagoras in the Grand Council. District Deputy Grand Master, P. I. Gorvalla for the district of Capetown S. Africa and wife were present. Grand Lodge agreed to change name of Lodge #75 from Ethiopia to Southern Cross. A U.D. Lodge in Kimberly S. A. was charted St. Patrick #76, September 25, 1971. These Lodges submit Annual reports with all assessments paid. Donations made to N.A.A.C.P. \$1,000.00. Negro College Fund \$1,000.00; March of Dimes \$1,000.00; Urban League \$25.00; Grand Masters Conference \$500.00. There was established a Henry M. Baysmore Jr. Fund for the purpose of granting scholarships and Financial assistance for students with ability at Institutions of Higher Learning. Initial Grant of \$20,000.00 and Annual Grants of \$1,000.00 for 10 years. Brother James C. Swinson, who served as C.C.F.C. for Penn for more than 28 years passed March 11, 1971. Nominations for Office are made Monday at 11:00 A.M. and Election is held by ballot Tuesday at :00 P.M. Publication "Light" Magazine published 4 times each year costs \$5,500.00

VIRGINIA, reports membership 15,415. Assets \$356,458.00 Two hundred thirty five (235) Lodges. Mortuary balance \$264,195.00; Deaths 275. Interest and investments \$15,253.00. Paid Charity \$6,365.00. Education \$9,947.00. Bee Hive Magazine \$11,415.00. Donated to N.A.A.C.P. \$700.00; Va State Conference N.A.A.C.P. \$250.00. United Negro College Fund \$1,000.00. Norfolk Hospital \$300.00. Heart

Fund \$2,250.00. Knights of Pythagoras, \$500.00. Conference of Grand Masters \$300.00. Virginia has a tax of .60 cents magazine, .40 cents charity, education .40 cents \$1.50 quarterly endowment. To improve public relations each Lodge obtains a dispensation to appear as a Lodge in Sunday morning Worship in the various Churches.

TEXAS. Membership 25,557; 554 Lodges; Deaths 635; Relief checks of \$200.00 are paid as first payment. Later checks of \$320.21 paid to beneficiaries. Total \$502.21. Donations made to N.A.A.C.P. \$1,000.00, Conference of Grand Masters \$500.00; Scholarship grants \$5,575.00. Texas sponsored 7 housing units Crockeet, 70 units, Ft. Worth (2); 110 and 76 units. Navasota 60 units, Silsbee 100 units. Houston 160 units; Dallas 192 units. Total 8,628,554.00 dollars. Texas has Lodges in Tucson, Ariz., West Temple #425, 1 in Salt Lake City Beautiful #395 and 2 in Nevada Omega #556 and Mizpah #206, Reno. P.G.M. J. T. Maxey installed the Grand Master, I. H. Clayborn; then Grand Master Clayborn installed the officers of Grand Chapter, O.E.S. and the officers of Grand Court Heroines of Jericho. All meetings same time.

WASHINGTON STATE, Membership 1,548, 27 Lodges, Assets \$1,077,348.00. Lodges in Phillippines Japan, Guam and Okinawa, and Taiwan. Four building projects, Tacoma self sustaining; Seattle, Spokane and Okinawa. They maintain a strong credit union. The Grand Lodge voted on accepting 18 year olds for initiation. Scholarships totaling \$800.00 awarded.

KANSAS. A copy of the address of Grand Master P. G. Porter calls attention to the decision rendered by the United Supreme Court November 19, 1956, which outlawed the St. John Scottish Rite A. & A. Masons in Kansas. This group attempted to operate again and were arrested and fined and forbidden to parade or hold any meetings in the State. Cash securities and property of the Grand Lodge \$152,371.00. Scholarships \$1,900.00. Donation to the Dr. Martin Lutheran King Jr. Hospital \$5,000.00.

Based upon information obtained from reports, publications and other sources, I find that there is a definite need for:

- 1. Masonic Education Program to prepare men for leadership. An Officers training school established by the Grand Lodge.
- 2. More time taken with candidates to instruct, to inspire, to inform and develop their understanding of benevolence charity, friendship, morality and brotherly love.
- Inovations in the third degree for amusement of those on the side lines that teach nothing but puts the candidate in a frame of mind exactly opposite of that desired.
- 4. Investigate Lodges whose officers are unable to confer degrees or administer leadership. Lodges that exist in name only.

After getting over the pleasurable shock of my election as Master, I took an inventory of my inheritance and found that there were fifty-two members on the roster; hardly any money in the treasury; and no visible means of support. In addition, apathy was high, morale low, and members participation almost non-existant. Looking at myself, I was a relative unknown to most members on that roster, and a mere acquaintance to a few. This made the task to govern even more difficult since I had to sell myself as well as the programs I may offer.

Objectives. I established the following objectives and presented them to the Lodge at our first meeting in November

- 1. To stimulate active participation within the Lodge
- 2. To create Pride in belonging among the members
- 3. To provide opportunity for greater fellowish, and
- 4. To give depth, meaning and stability to the craft.

The program was accepted as presented, and implementation started that same night. To carry out objective no. one "To stimulate participation," I printed some identification cards, and used them whenever I called on members who did not know me. I called every name on the roster that could be reached by telephone, many of whom I spoke to monthly. I have kept a register of attendance which serves as a guide when calling for our monthly meetings. The response was good. Compared to the year immediately preceeding when from March to September (nine meetings) we were only able to raise a quorum for two of those nine meetings; from October to February (a similar number of meetings), the attendance averaged twelve per meeting with a range of from twelve to nineteen; an increase of over twenty-four percent.

For my no. two objective—"To create pride in belonging," I had certificates made at my own expense, so that every Master Mason will receive one. Presentation was made at a party on February 18, 1973, attended by seventy (70) persons—members and their wives. Channel 9 T.V camers were there, although they were not able to show any of the scenes that night. At that party I reported on the progress that was made thus far, and laid all the cards on the table. The response was favourable.

Objective no. three..."To provide opportunity for greater fellowship," has been attempted through the efforts of one of our auxilaries which provides the refreshments we enjoy after meetings. In addition, the same auxilary functions as a membership committee so as to provide continuity between the lodge and the membership. In fact, I see unlimited use for this very willing group of workers, as response to their efforts have been most favourable.

In the mean time, our financial situation was less than desiriable. The rate of our expenses far exceeded the snail-like trickle of our income, so that the successful collection from the member carried a breathing spell of preparation for transfer to the Grand Lodge, or to pay the month's rent. Logically, we had two options: (1) To increase membership, and (2) Raise funds. Beginning with the latter, this was clearly a matter for an auxillary; looking at our existing Hi-12 record and its present function (including the last three years), this is what I saw: "A small reticent group of proud men, proud of their past performances. Some voiced noble sentiments about their loyalty to the lodge, yet remained tacit. Many members did not attend lodge meetings, although those same members seldom missed the club's meetings. My own impression was that the club had set its social functions as higher priority than the lodge's financial abyss. I summized that this could well be due to the club members lack of awareness of the lodge's needs, after all, if they do not come to meetings of the lodge they will not know what's going on. Conversely, I am equally convinced that the officers of the club knew full well the club's responsibility to the lodge, as they continued to function within the framework of the laws. You might well ask why then did I permit them to continue to function? There were some unique features in the make-up of this club which I considered to be potential strengths if they could be properly directed. (1) There was a strong sense of identification with the club and its past, and (2) The nucleus spoke the same language and understood each other. Because of these and a few other traits which I considered to be valuable, I elected to leave the Hi-12 as it was and to create a new club that will be more sensitive to the needs of the lodge. The new club is called the Booster, and one of the many ways in which it differs from the Hi-12 is that it is designed to be used as a vehicle through which we may communicate meaningfully with our community, and hopefully make ourselves visible. (By ourselves, I mean masonry, not just Anchor Hilyard members).

M.W.G.M, I am pleased to announce to you and this Grand Lodge that our Booster Club has made great strides since its beginning, and that it has contributed in no small way to our success this past year. Because of the gratitude I feel for the help they have given to Anchor Hilyard's Lodge, it is fitting that I should publicly thank the officers and members of that club. I can think of no better place, and ask your indulgence to introduce those men at this time. They are: (elected)

Pascol Todd......President

Lawrence Henderson....Vice President

William Scott......Treasurer

Chalmer Lawson.....Secretary

Will all other members of the booster club present please stand..applause!! Special thanks must also go to Brother Albert J. Briscoe Jr. for his invaluable contributions to the club. Anchor Hilyard surely has benefited.

The second option was to try to increase membership. For this, we obtained a dispensation to confer the three degrees for half of the normal price. The dispensation was granted for 90 days from March 1st. to June 30th., and in that period we processed ten petitions, six of whom are now Master Masons. From October to August we initiated nine men, passed nine, and raised nine. We admitted two members by demits, healed tun, and reinstated five. Total number of names added was eighteen (18). Unfortunately we lost three to the grim reaper-death. (1) Brother E. G. Harris October 6, 1972 (2) Bro. Floyd E. Manson July 3, 1973, and Brother Wallace Partee on August 16, 1973. We suspended three for non-payment of dues. Therefore, the total number of names added to our roster was ten (10). Our membership now stands at sixty-two (62). The significance of this addition is best realized when you know that in the last three years we have not added one Master Mayon. In addition.

we have conferred the title of honorary member on Brother Charles Gaskins from Jephthah Lodge No. 89 in New York on June 5th, 1973.

Summary

- 1. Taking up where we left off in February, attendance from March to the first meeting in September shows an average seventeen members (17) per meeting. The range was from 12 to 20, This represents an overall increase in membership participation for this last year to over 40 %
- 2. The increase in participation may have several interpretations. However, there could be little doubt that this has the potential of also increasing membership awareness of Masonry. Just looking at our last raising of thirty men, and the motivation they manifested as a group, suggested that these kinds of atmospheres could be stimulating. Activally, a few of our newly made members are fired-up and ready to go.
- 3. Objective # 4 is more philosophically oriented, and its success or failure has to be measured by different yardsticks. Since the record speaks for itself, I will like to direct your attention to one of the tools which may be used to appraise the effective of objective # 4...

 "To give depth, meaning and stability to the craft." But before we look at the tool let me say that I know that the problems which I inherited as Master are not peculia to Anchor Hilyard's Lodge. If that is true, then we must ask: "How many other lodges have had a similar problem, and how did they overcome them?" also we would do well to ask "How many masters could go back into their records and find the solutions which worked for them?"

The point of this line of questioning is to demonstrate that one must be able to predict the outcome of his plan of action if he is to obtain desired results. That is how history is written—by design. Speaking to many masons, I get the impression that many they are of the opinion that the craft is declining. If there is any truth in that belief, then one possible reason might well be that we have not prepared ourselves to cope with the changing times.

Every organization has the need to periodically take stock of itself, as they grow, gearing their programs and structure to the changing needs of the people they serve. Therefore, we ought to begin with an evaluation of the organization as one tool which is accessible.

I believe that this could best be attained through a process of self-evaluation conducted by individual lodges, and that it will be more useful if it were designed to show the relationship between lodges and their programs, as these may relate to the Grand Lodge's objectives.

We should keep in mind that the effectiveness of an organization depends upon many factors, not only conscientious adherence to accepted rules of good administrative practice, but also on the <u>spirit</u> of the membership which, when coupled to cohesiveness in purpose and mutual respect forms the core of an organization. An organization with good external methods which lacks the full spirit of cooperation and dedication to purpose, will fail, but one with a flourishing spirit of cooperation and active pursuit of a common purpose will certainly overcome organizational defects and methods.

Because of these beliefs, I therefore recommend to this Grand Lodge

- 1. That it should define its objectives through which its visibility in the community may become apparent, and that those objectives be made available to all Masters.
- 2. That all masters be directed to include one or more of those Grand Lodge objectives in their own plans for possible execution in their term (s) of office.
- 3. That the office of the R.W.G.L or some other appropriate body such as the Past Master's Council or both be charged with the responsibility of being resource persons to the masters as they work towards these goals.

Before I close this report, I must thank all the members of my lodge for:
their fine support. If in the execution of my duties I have stepped on any
toes, I am sorry. To those who feel that I should harness my zeil I say:

I reap small grains of Masonry with all I have of skill;

Some say I mow them very well, and some, that I.do ill.

And those who say that I do well, speak from their brotherhood;

Much better those criticize could do, if they but would.

But whether I reap well or ill, I know not, nor much care;

I bind my sheaves as best I know, and more no man may dare.

Of the people checked, a total of ten showed traits of Sickle Cell Anemia.

- 5. Nov \$25.00 presented to the Base Chaplins Thanksgiving Basket.
- 6. Nov \$50.00 presented to Operation Christmas Basket.
- 7. St. Johns the Evangelists day was observed by a contingent from Acacia #12. In Dec at Base Chapel #1.
- 8. A proposal to the base for the initiation of a lottery for the purpose of awarding a scholarship fund to a deserving dependent was disapproved.

 However alternate means of raising funds for this purpose are being considered.
- 9. The Tuskeegee Institude Choir gave a concert at the Base Theatre.

 Approx 80 people were in this entourage. Brethren of Acacia Lodge #12 were instrumental in providing lodging for choir members.
- 10. A contingent of Acacia Lodge #12 visited Moseic Lodge #11 on 31 Mar 73 and helped in raising 2 brothers to the subline degree of a Master Mason.
- 11. Apr 73: Degree teams were appointed to increase the proficiency of the JW & SW and to prepare them for ascending to the East.
- 12. May 73: Past Master Aprons were presented to Past Masters Jones and Pleasant in conjunction with a dinner. The lodge was opened and closed in public for this occasion.
- 13. St. John the Baptists Masonic Day was observed by Acacia #12 enmass at Base Chapel #2 on June 24, 1973.
- 14. July 73: Grand Lodge visitation was held at the Holiday Inn.

 Warden proficiency tests were administered SW Spencer, Acacia #12 and SW

 Scott of Mosaic #11 of Grand Forks. That night a welcoming dinner was given'

 for the Grand Master, his cabinet and visitors. In attendance was the

successful and gratifying.

- 15. August 73: A record hop was sponsored for the youth of MAFB. The hop was highly successful and we've had many inquiries as to when another would be held.
- 16. The following is a brief synopsis of how Acacia #12 fared with membership during this past year:
 - a. 8 brothers initiated, passed and raised.
- b. 7 members suspended for non-compliance in their financial oblication to lodge.
 - c. 3 brothers demitted from Acacia #12.
- 17. Overall I feel that Acacia progressed admirably even though we had many key members to transfer from Minot AFB to fulfill their military committments elsewhere around the world. With the winddown of crisis in Southeast Asia our members should be stationed herelonger. We of Acacia proudly predict that 1974 will be the year that Acacia will stand-out above all other lodges in this jurisdiction.
