

Be it known, that I, Morris S. Miller, Grand Master of Masons in and for the Jurisdiction of Minnesota, by virtue of the authority vested in me according to Article III of the Constitution of the M. W. Prince Hall Grand Lodge, F. & A.M., Jurisdiction of Minnesota, do hereby SUMMON all of the aforementioned brothers, to convene for the Ninety-Eighth Annual Communication, beginning on Tuesday, September 15, 1992, at 8:30 A.M. sharp, and adjourning Wednesday, September 16, 1992.

All officers will make their annual reports, we will review the state of the Order, and dispose of all other business which may be properly brought before us during that time.

HOUSING

SEPTEMBER 15, 1992.

To: The R. W. D. G. M. Brother James K. Ash, All Elected and Appointed Grand Lodge Officers, Past Grand Masters, visiting Grand Masters & other Grand Lodge Officers, Worshipful Masters, Wardens, Worthy Grand Matron and W G. Patron of Prince Hall Grand Chapter, O.E.S., Past Grand Matrons, Past Grand Patrons, Brothers and Sisters. Good morning

Pursuant to, and in obedience to the Constitution of this Prince Hall Grand Lodge, we are assembled here today to reflect on our past and plan for our future. Our burdens are heavy, but we are taught to ask, and it will be given unto us, seek and we will find. With those promises, let me ask the Grand Chaplain to lead us to the throne of grace where we may find solace and comfort, and become spiritually refreshed for the journey through this Ninety-Eighth Annual Session. Brother Grand Chaplain, please lead us!!

NECROLOGY

In the words of John Mason Brown...

"There is a shrine in the Temple of ages Where lie forever enshrined, the memories of such as have deserved well of their country and their race."

Unity - a quality of oneness.

Once again, we mourn the loss of our brothers, and we are painfully reminded of the brevity of our lives. This past year we closed the records on 5 of our members who started on their celestial journeys. Who among us will be the next? How will you like to be remembered? Brothers and sisters, even as we contemplate our mortality at this very moment the fabric of that mortality is being re-arranged so that in a flash, the silver cord may snap or the golden bowl be broken and our vital signs cease.

Let us take a small time-out to ponder the question If your name was called at this very moment are you ready? What would you like to be said of you by a best friend, your wife or husband, your minister, a person with whom you work, and a family member? Do you think that you will be remembered more for what you did than did'nt do?

The necrology committee will formally close the records on those brothers when it gives its report tomorrow morning.

STATE OF THE NATION

For the first time in thirty-three years I feel that I can speak to you as an American, I doubt that you will see any difference in what I say but there will be a difference in how I feel when I say We the people of the United States, in order to form a more perfect Union, establish justice, insure domestic tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our prosperity.... This year being a year for

Presidential election we have some choices to make, and I hope that we will spear no effort on our part to exercise the privilege to vote in November.

Robert Browning said: "Whenever men are NOT obliged by necessity to fight, they fight for ambition." Permit me to share with you one of my concerns. I am worried about the high cost of health care, and wonder whether or not we will be able to afford quality health care. Are you concerned? Let me share some facts with you, they come from the American Cancer Society's 1992 report in which they discuss the Incidence of cancer in Minorities. (Blacks, American Indians, Chinese, and Japanese, and Hispanics).

They found that in cancer from all sites, black males were 45% (30,321 cases), and black females were 23,647 or 35% of all minorities. Thus black males and females made up 80% of all cancer. They also found that we were first in a number of other specific areas like lung cancer 10,112 cases in black males compared to 197 in American Indians and 127 Japanese. Lung cancer in black women was 83% of the total, 4019 compared to 111 American Indians and 64 Japanese. Breast cancer in black women was 81% (4,467), compared to 66 American Indians and 62 Japanese women.

Prostatic cancer is the number one killer among black males. They reported 4,582 compared to 64 in American Indians and 43 in Japanese. The report said: "For reasons not currently known, black Americans have the highest incidence rate in the world." Additionally, the five year survival rate for cancer in blacks diagnosed from 1981 through

1987 was 38 % compared to 53% for whites. A considerable part of this difference in survival can be attributed to late diagnoses. Many cancers are more frequently diagnosed in a localized stage among whites than among blacks. Most of the sites represent cancer from which screening tests are available or which represent symptoms early in the disease process. Early detection and timely treatment can increase survival and halt the disease progression.

I believe that we can make a difference if we want to, we can become partners with organizations like the American Heart and American Cancer to help them reach the poor, minority, and the under-served. We know that there are some socioeconomic factors such as lack of health insurance or means of available transportation which can impede access and lead to late diagnosis and poor survival. I challenge this Prince Hall Family to stand up and be counted. It is said that some men have many reasons why they cannot do what they should, when, all they really need is ONE reason why they can. WE CAN MAKE THE DIFFERENCE, I HOPE WE WILL TRY.

STATE OF THE ORDER

I can report that HARMONY prevails in our Jurisdiction and I thank all of you for your part in preserving the peace.

Ninety-Eight years ago this organization was born when Brothers Thomas H. Lyles was elected Grand Master, John L. Neal, D.G.M.; E. T. Rhome, G.S.W.; Daniel Roy, G.J.W.; Joseph Adams, Grand Treasurer; James Woodfork, Grand Secretary; W. A. Hilyard,

Brother Johnny O. Greene of Acacia Lodge # 12 for demonstrated commitment to Prince Hall Masonry in all areas, W. Brother Thomas Henderson of Perfect Ashler Lodge # 4 for his effort to keep the craft together despite tremendous odds, My W. M. Brother Hugger for constantly trying to find opportunities for P. H. Masons to make their mark in the communities, he made several referrals to my office, brothers Lawrence Henderson, P.M. of Anchor Hilyard Lodge for his help at the Hub and trying to keep the building clean and in shape, brother Robert Jackson for his leadership at the Hub and for his patience, brother Jack Barbary of Regent Lodge # 5 in Winnipeg and his officers for their constant striving and Brother James Winder, D.D.G.M. of that district for his coaching and support to that lodge. I want to acknowledge the work done by the W. M.'s in the Province of Alberta, Brother Charles Miller # 9, Brother Fitzroy Clarke # 15, & Brother Clinton Smith # 16 for their efforts to keep P. H. Masonry in the forefront of their communities. These brothers were guided by brother Dan LaFayette, D.D.G.M., brother Raphael McClain. Administrative Assistant, and brother Barry Boyd, P.G.M.

Additionally, I must acknowledge publicly the work done by brothers Dave Collins, Grand Lecturer, and Cornelius Davis, R.W.G.S.W. They never missed a meeting unless the roads from Grand Forks were impassible. Finally, I thank all those who contributed in any way towards the continuance of our order. I am concerned that if we, today's leaders do not heed the clarion call, we will have failed our mission, tainted our legacy, and dishonored our heritage. WE MUST NOT FAIL!!

Deputy Grand Secretary; and George Duckett,
D.D.G.M., along with twelve other appointed
officers. Those brothers represented six lodges:
Pioneer No. 1, Minnesota No. 2, Wm H. Stevens No.
3, Perfect Ashlar No. 4, Doric No. 5, and J. K.
Hilyard No. 6. The organization was then styled
The Most Ancient Free and Accepted Masons, and
remained so until 1907 when, under Worshipful
Brother Harry Howard the 5th Grand Master, the name
was changed, "Ancient" was deleted and we became
known as the M. W. P. H. G. L. (F.& A.M.).

I have heard it said that:

"Men are like trees, each one must put forth the leaf that is created in him."

Those brothers struggled then as we do now, we have been in and out of intensive care. That we are here today celebrating 98 years of continuous existence is a measure of our "durability." Take notice, WE WILL SURVIVE!!

The time has come for us to try some new ideas, we have used up those in the old cupboards. "He who never walks save where he saw men's tracks, makes no discoveries." J. G. Holland

There are two important muscles that do not operate under direct control of the brain, they are the tongue and the heart. We have had a number of big hearts making tall promises until it came time to deliver and they did not remember...the brain disconnected from the tongue. However, there were a few who went beyond the call of duty, and I will like you to meet them.

FRATERNAL RELATIONS

We have continued to enjoy good fraternal relations with our brothers. On February 24, 1992, accompanied by the D.G.M. and the Grand Secretary, we witnessed a Masonic Raising in Minneapolis Lodge No. 19, A.F.& A.M. M. W. Brother Charles Baltos and I were received with honors. Then on Wednesday the 26, I again attended another historic event, this time I was accompanied by brothers and sisters of the Prince Hall Family to a Special Table Lodge presided over by brother Kenneth W. Carroll, W.M. I received a lovely gift and we were all very delighted with the opportunity for fellowship.

June 11-13, 1992, I attended the Grand Lodge of N.D 103 Session accompanied by Brothers Weddington, P.G.M., Cornelius Davis, G.S.W, Dave Collins, Grand Lecturer, and Buckley, Dean of Instructions. We had an enjoyable fellowship.

Our fraternal relations with other Prince Hall
Bodies is exemplary. As Chairman of the Steering
Committee for the Conference of Prince Hall Grand
Masters, I am in touch with every P.H. Grand Lodge
and I was re-elected for the fourth year by
acclamation. Operating from a position of
strength, I have been moving the conference toward
a sense of oneness instead of the 44 individual
jurisdictions we have always been, I can happily
report that the conference will hold a Summit in
Jackson Mississippi on October 23-25, 1992, to
begin strategic work in that direction. It is my
firm belief that our survival into the 21st Century
will depend on how well we can adjust pro-actively,
it is a slow process, but an attainable goal.

Some of the benefits of this plan are to pool our resources...health care, credit cards, self-insurance, and banking opportunities. All of which are possible if we can work together. Monday of last week I saw a show on T.V. where the "bloods" and the "creps" had signed a truce, and pledged themselves to stop the violence against each other and work together for the good of their neighbourhood, they were very resolute, and one of the questions which they were frequently asked was "will the truce last." That made them indignant. If they can come together why can't we?

MY RECOMMENDATIONS...

- 1. I recommend that we should continue to support the Midwest Regional Conference of Grand Masters and Masons.
- 2. I recommend that we should continue to support the Conference of Prince Hall Grand Masters.

IN CONCLUSION

I want to gratefully acknowledge all courtesies that have been extended to me this past year, and, in her presence, I take this opportunity to thank sister Miller for her tolerance of my mode swings. Those experiences are all priceless, and I shall not forget them. And now, I will use the words of St. Francis of Assisi to bring closure to this epistle:

"Lord, make me an instrument of your peace, Where there is hatred, let me sow love, Where there is injury, pardon Where there is doubt, faith Where there is despair, hope
Where there is darkness, light
And where there is sadness, joy.
Grant that I may not so much seek to be consoled, as to console
To be understood as to understand
To be loved as to love
For it is in giving that we receive
It is in pardoning that we are pardoned
And it is in dying that we are born to
eternal life." Amen

ANNUAL REPORT

To the Most Worshipful Prince Hall Grand Lodge, Free and Accepted Masons, Jurisdiction of Minnesota Inc. Most Worshipful Grand Master Morris S. Miller, Grand Lodge Officers, Past Grand Masters, Past Grand Lodge Officers, Honor Guest and Bretherns.

First, I give thanks to the Supreme Architect of the Universe for my beings. I thank Grand Master Miller and all the Brothers who placed their trust and confidence in me. I have been truly blessed to have had the opportunity to serve and represent this Grand Lodge this past year.

I believe this year, your Grand Lodge has made progress. The Prince Hall Foundation has been revived and we are expecting positive results in the future. As of this date we have numerous pledges and we have the possibility to significantly lower the principal on our mortgage. We have also had other fund raising projects to assist in supporting the Grand Lodge operational expenses.

As I think of some of the barriers that prevent this Grand Lodge from becoming the best it can be, there are three main factors that readily come to mind:

- 1- Communication: The Grand Lodge must be kept informed about what is happening within Subordinate Lodges. At the same time the Grand Lodge must meet with the Subordinate Lodges to insure that they are aware of the Grand Lodge purpose and activities. This is necessary to gain their support.
- 2- Morale: Members must be integrated into the Grand Lodge so that their cooperation can be assured and opposition is kept to a minimum.
- 3- Motivation: Motivation is the third essential problem to overcome. A desire to work harder, better, longer and be happy with what they are doing, is a must, if we are to be successful.

In my opinion, the only way for growth, each Brother must respect each other. Where there is mutual trust, there is growth. As Masons, hypocrisy and deceit should, and I repeat should be unknown to us. There is nothing to gain by false pretenses. I believe that this Grand Lodge has attempted to overcome these barriers, through the Grand Master's Visitations, Leadership workshops and monthly Cabinet meetings.

As I look around this room, I am amazed at the potential leadership that exist. The questions is why can't we channel our energies and knowledge in the direction that will bring about positive changes and attitudes. Then and only then, will we become the role models that is so badly needed within our communities.

In closing, I read somewhere, "A winner sees an answer for every problem, a loser sees problems in every answer. A winner says, let me do it for you, a loser says, that's not my job. A winner says, it may be difficult, but it's possible, the loser says, it may be possible, but it's too difficult."

I have no doubt that we have nothing but, winners in our organization. Remember, "You have not done enough, you have never done enough, so long as it is still possible that you have something to contribute." DAD HAMMARSKJOLD

There is no time for refreshment and pleasure. "How goes the hour" can be heard. A question that is asked as we reach out and become concerned enough about others. The state of Masonry with its challenges and opportunities demands that Prince Hall Masons see themselves as Master Builders -- building character and morales in mankind. The twenty-first century is just around the corner.

In closing, I wish to thank the Most Worshipful Grand Master for the opportunity to serve him in this District. For this I am most grateful.

It is on the level that we most patiently labor, on the square is to the world. May brotherly love prevail and every moral virtue cement us.

Dear M.W. Brother Henry:

I enjoyed meeting with you and having the opportunity to renew old acquaintences during the opening of the 139th Annual Communication of the Grand Lodge of A.F. & A.M. of Minnesota this past week. It has been a long time since our last meeting in July, 1975, when we met with you and a group of your Grand Lodge Officers, at your request, to discuss the subject of the Recognition of Legitimate Masons. Since that time, a lot of progress has been made. I know we both share the hope that progress will continue until the question is fully resolved for the best interests of Masonry.

You expressed an interest in learning what I have done since our 1975 meeting regarding the question of Recognition. I am enclosing two copies of the pages of my Annual Report to the Grand Lodge of Minnesota relevant to our meeting in 1975. It was taken from pages 26 and 27 of the PROCEEDINGS, THE GRAND LODGE A.F. & A.M. MINNESOTA, dated 1976, and is headed, "Non-Recognized Grand Lodges". Should you wish to copy these pages, you are most welcome to do so. I apologize for not having listed the names of the Grand Lodge Officers who accompanied you, but quite honestly, I failed to write them down at the time, and couldn't remember them at the time I wrote the report. I do remember that I was most favorably impressed with the high caliber of men you were, and have spoken about that many times, and on many occasions, when the subject was discussed.

Until recently I served as Chairman of our External Relations Committee. In that capacity I was kept informed of the actions and reactions taken by the various Grand Jurisdictions within the United States on the question of Recognition. I kept my Grand Masters informed of the progress being made, and the problems arising therefrom. In 1989, the Grand Master, Ward C. Sonsteby, formed a committee, including me, to study the question in depth. Because of serious health problems, and a lengthhy convalescence, I was unable to attend these meetings. I agree fully with their recommendation to extend recognition to Prince Hall Masonry. I do not approve of some of the shortcuts they took in the legislation they proposed to effect the recognition, but these are "legalistic", and will be resolved without effecting in any way the timing of the Recognition.
