

GRAND MASTER WILLIAM A. RICHARDSON SR. ADDRESS TO THE NINETY - NINTH ANNUAL COMMUNICATION OF THE PRINCE HALL GRAND LODGE, F & A.M. MINNESOTA AND ITS JURISDICTION

SEPTEMBER 21, 1993

To: The R.W.D.G.M. Brother Charles E. Milliner, All Elected and Appointed Officers, Past Grand Masters, visiting Grand Masters and other Grand Lodge Officers, Worshipful Masters, Past Masters, Wardens and Brothers; HELLO.

According to the guidelines handed down by our By - Laws and Constitution of this Prince Hall Grand Lodge, we are gathered here today to assess the past and make plans for our future. I stand before each of you today to bring you my address, but before proceeding further, I would ask the Grand Chaplain to come forth and ask for the blessings of the Grand Architect of the Universe.

Would you please come forward Grand Chaplain;

NECROLOGY

To my regret, we lost a sitting Worshipful Master; Brother William Gordon, after serving just two months of his term. We also regret the loss of nine additional Brothers throughout our jurisdiction to the "Supreme Grand Warden" of the Heavens.

I quote to you the following:

"Let me admonish you, in the most serious manner, in reference to the close of life, that, when the cold winter of death shall have passed, and the bright summer morn of the resurrection appears, the Son of Righteousness shall descend and send forth His angels to collect our ransomed dead; then, if we are found worthy, by the benefit of his "pass" we shall gain a ready admission into that celestial Lodge above, where the Supreme Architect of the Universe presides, where we shall see the King in the beauty of holiness and with him enter into an endless eternity".

The Necrology Committee will also give their report on our deceased Brothers later.

STATE OF THE NATION

As many of you have seen and heard through the eyes of television and reading the newspaper, the world is besieged by war, famine, murder, economic strife and human deprivation.

This year the United States was struck with terrorism by the bombing of the World Trade Center, the massacre in Waco, Texas and the massive flooding of the Midwest States.

Though mentioned in a low breath, the recession that has a hold on Americans these past four years, was supposedly to have ended earlier this year. When telling this to the low income to middle class Black Man, I hear their perception that the recession is still gripping their pocket books....

As much as we would like to help bring peace and unity throughout the land, our efforts are limited. I say to each of you, keep the faith in our government, stand upright as a Man and a "MASON".

This year our country saw a change in the Presidency. The problems this new leader encountered were enormous. A nation with national deficit in the Trillions of Dollars. A split Congress and Supreme Court.

With our faith in the Deity, we can over come all of the above mentioned problems.

STATE OF THE ORDER

When elected to the Office of Grand Master one year ago, my cabinet and I were faced with several financial crisis concerning the Grand Lodge Building. There was a deficit of approximately \$13,000.00 owed in Accounts Payable by the Grand Lodge. The Hub Club Manager had not been paid since February of 1992 which was included in the above amount. Several Subordinate Lodges per Capita Taxes and Assessments were outstanding. The Grand Lodge building was found to be in a deteriorated state and the building expenses were far exceeding its revenues.

We also discovered a Reserve Account at which time not knowing its original purpose, I directed the R.W. Grand Secretary to close. I have attached a copy of that Reserve Account at the end of this address for the Crafts review.

The Cabinet and I after tedious hours of study, were able to catch up on the Grand Lodge finances along with the long over due payment to the Hub Club Manager. It gives me great pleasure to report that the Grand Lodge at this time is caught up with its creditors and is returning to a sound financial state.

Through my visitations and Cabinet reports from my appointed District Deputies, I have heard encouraging information concerning the Subordinate Lodges and their efforts in keeping up with our Masonic tradition. My concern at this point, is on the the Masonic Rituals and the several different types being used in the Lodges. This is because the "DAGGART" I understand is no longer published or available on a quantity basis and I have chosen to address this matter later under my recommendations.

In July 1993, this Grand Lodge was notified by the I.R.S., requesting copies of Income Tax returns for the years 1991 and 1992. Investigation by the Officers and I revealed that in fact no tax returns had been filed since 1987. Grand Lodge secured the services of Bob Cyza; a "Certified Public Accountant", to assist in the filing and representation for the organization. The estimate cost for his services is \$1,000.00 and is expected to take approximately 6 months. This does not include any monies the Grand Lodge might owe in penalties and assessments due, for the non-filing of those years listed.

PERSONAL OBSERVATIONS

On March 25th through the 27th, I attended the Midwest Conference of Grand Masters which was held in Louisville, Kentucky and hosted by Grand Master; James I. Montgomery. This man and his cabinet deserve high praise for their hospitality and warmth to those in my cabinet and myself. He truly is second to none.

The conference itself was well organized, with useful ideas being expressed from its members.

One recommendation important to our jurisdiction was the elimination of "Blood Lines" requirements for membership in the Order of the Eastern Star. It was learned that those jurisdictions who had implemented this change, have experienced an increase in membership in both the "Star" and Masonic Lodges.

On May 6th through the 8th, I attended the conference of Grand Masters which was held in Sommerset, New Jersey. Impressed with the opportunity to meet the Grand Masters through out the country, my concerns were as follows:

1. We were unable to agree on a mutual "DEMIT" document that would be used by all the Lodges chartered under Prince Hall.

2. Due to all the Grand Masters being Sovereign in their respective jurisdiction, we were actually powerless in any decision making process. This too was observed during several discussions where I witnessed power struggles.

I want to also express my sincere gratitude and appreciation to Grand Master Junior L. Young of Wisconsin and his cabinet for their hospitality extended to me during my visit to their Annual Grand Lodge Communications and Elections this past June.

The relationship with our A.F & A.M. Masonic brothers appears to be progressing well. I attended one of the A.F. & A.M. Brothers visitation to Anchor Hilyard Lodge earlier this year. I was asked to give insight at that meeting on the history of Prince Hall the man. My presence and words on the subject seemed well received by all those in attendance. Correspondence was also received from both North Dakota and Minnesota A.F. & A.M. Grand Lodges, requesting my attendance to their Annual Communications and Elections. Unfortunately, I was not able to attend either due to already committed Prince Hall functions falling on the same dates.

GRAND LODGE OFFICERS

R.W.D.G.M. Charles E. Milliner

My Brothers, I appreciate your electing this man to his post. His supportive efforts and dedication to the Fraternity is unquestionable. He was the only Officer that accompanied me on all my official visits this past year. I could not have asked for a stronger individual to occupy this elected position. I thank you my Brother again for your efforts.

This Brother was the "Pillar of Strength" in his duties. He constantly reminded me that I was elected by the Craft for who I am and how proud he was of their selection. I too want to thank this Brother for a job I consider well accomplished.

One of my District Deputies went that extra step. Not only did he serve in that capacity, but also as my Administrative Assistant. His support was seen in both the Brochure and Banquet Committees. This person is none other than P.M. Robert Huggar who also happens to be my Nephew.

C.C. of F.C. P.G.M. Martin O. Weddington

I want to thank this Past Grand Master for his support and splendid job as Adviser all year long.

P.M. Fred Scurry

Brother Scurry has done an outstanding job with regards to this Grand Lodge Registration. He took on this responsibility back in May of this year. We all are reaping the benefits of his dedicated efforts.

Lastly, I want to thank my wife for her support in allowing me to fulfill my duties as Grand Master. She accompanied me to the Midwest Conference of Grand Masters, extended courtesies to all who called or visited our home and for the respect shown for the privacy of our Fraternity. She performed the duties of a personal Secretary when ever asked. I now understand the statement "Where there is a successful man, he has a good woman in the background".

RECOMMENDATIONS

After long and serious thought, conversations among the members of my cabinet and observations made throughout this past year, please note the following recommendations for the benefit of our Fraternity. They are as follows:

1. Tenure of the Grand Master to serve no more than three (3) one (1) year terms in succession.

- 2. This Grand Lodge to adopt the Ritual "STANDARD FREEMASONRY ILLUSTRATED" for use by all Subordinate Lodge Members.
- 3. All Rules and Regulations not covered in the By-Laws and Constitution of this Jurisdiction, be referred to Mackey's Jurisprudence.
- 4. That the Per Capita Tax for each Subordinate Lodge Member be increased \$8.00 beginning January 1994.
- 5. Eliminate the "BLOOD LINE" requirement for the Eastern Star membership.
- 6. Delete the requirement that a Brother must be a Past Master before he can serve as the "Head" in the Scottish Rite, York Rite and Shrine houses.
- 7. All monies owed to the Grand Lodge in Assessments and Per Capita Taxes, to be paid in U.S. currency only.

CLOSING

After several years of having a joint banquet and sharing the same ocation for Grand Lodge and Grand Chapter annual communications, the adoptive body of the Order of the Eastern Star has chosen to meet at a different location. To clear the air on this matter, the decision for our annual communication held here at the Comfort Inn was based strictly on cost savings, convenience and hospitality.

In January of this year, I wrote a Proclamation to all Lodges informing the Fraternity that all monies recieved from assessments or donations, would be applied towards the principle of the building. In August of this year, \$2,000.00 was applied to the outstanding principle of the Grand East building.

Finally, I want to thank all of you for electing me to the position of Grand Master. It has been an honor for me to serve each and every one of you in this capacity. As we proceed to complete our work at this 99th Annual Communication, may the blessing of the "Deity" preside over us. May peace and harmony prevail.

Greetings!

I would like to take this opportunity to thank you for electing me as your Most Worshipful Grand Master. I am asking for your support. I would like for you all to please take heed to the following information:

- 1. Please contribute to the building fund whatever you can afford. I am promising to you that these funds will go directly toward the principal, and that a proper accounting will be available. Please make all checks payable to Prince Hall Grand Lodge Building Fund, and mail to the Grand Secretary, Charles J. Snargrass, Sr., at 1708 Oak Park Avenue North, Mpls., MN 55411.
- 2. We are in need of volunteers who will contribute four hours a month of their time to help clean up and do needed repairs at Grand East. Please contact Brother Lawrence Henderson at 588-8767.
- 3. I am granting a dispensation to confer more than one degree at a time, and upon more than five candidates at a time. This dispensation runs from November 1, 1992 to January 1, 1993.
- 4. The Grandmaster's Annual Visitation for Districts 1 & 2 will be held on November 27, 1992, at 8:00 p.m., at 3832 Fourth Ave. So. Palestine Lodge # 7 will be the host Lodge.

- 5. Reinstatement will be granted to Brothers who have not paid their \$200.00 assessment. They will be required to pay \$50.00 with the petition, and to pay the remaining balance within 90 days. These Brothers will then be restored to their previous Masonic status.
- 6. All new candidates who petition the Lodges must pay \$50.00 of the additional initiation fee, and must have the remaining \$150.00 paid within 6 months. The secretaries of the Lodges are responsible to collect these monies and forward the same to the Grand Secretary.
- 7. Saint John the Evangelist's Day will be December 27, 1992. It will be hosted by Palestine Lodge # 7. District 1 & District 2 should attend the Church that is chosen by the host Lodge. You will be notified at a later date by the Worshipful Master of the host Lodge as to time and place. All other Districts should attend the Church of their choice.
- 8. For this year, I am waiving the requirement that you must be a Past Master to be elected to head the Shrine, Consistory, or the York Rite.
- 9. Installation of officers will be done on the next meeting night following the annual elections. No Worshipful Master-Elect can assume any of the duties of his office until he has been legally installed, and he cannot be legally installed until he has received the Past Master's Degree. (Constitution & By-Laws Article VII, Section 6) The election and installation to be done by the D.D.G.M.
- 10. Past Master Degree for District # 1 & District # 2 will be at the Grand East, 1708 Oak Park, on December 12, 1992, at 2:00 p.m. In all other Districts, the D.D.G.M. should summon as many Past Masters as possible and give the Past Master's Degree to the newly elected Worshipful Master.
- 11. Worshipful Masters, I would like to have your up-to-date roster of your members including addresses and phone numbers with area codes. Send a copy of your roster to:

Brothers;

We were informed by the membership that more information was needed in order to formulate a decision to keep or sale the Grand East. A study was done on the cost to maintain the building. This is when a recommedation to sale was presented to the craft.

In 1983 the approximate amount of assets Grand Lodge had was \$79,000 dollars. Since that time Grand Lodge has spent the the per capita tax and the assessment to maintain the building. \$110,000 dollars was paid for the building. The approximate amount that has been paid to maintain the building was \$326,000 dollars from May 1983 thru the present. \$92,000 dollars is presently owed on the building.

Our study showed even if the building was paid in full, without the questionable operation we have in the basement, we would still not be able to afford the building with the per capita tax that is presently being received from the membership. This building does not meet our needs to host Grand Lodge or any other function, other than a meeting place for the officers. We find it is not appropriate to ask our membership to supply us with a \$3,500 dollar a month office.

Brothers, if each one of you had to pay your share to maintain this building the approximate cost would be an additional \$84.00 dollars on top of the per capita tax you are presently paying.

Brothers, next I would like to bring to your the attention the following: The 18th edition of Daggott is out of print. We will officially be using Look to the East as our ritual until Grand Lodge convenes in September. A vote will be taken at that time to determine if we should continue the use of that ritual.

This has created a fertile field in which I have personaly grew thru great leadership that taught me the virtue of Strength (hearing), Wisdom(seeing), and Beauty(feeling). At this 99th session I stand before you has your Grand Junior Warden, I thank you for your trust and say to you as a body tcb (take care of busniess).



My brethren, four years ago, eight vigorous young men of age seeking eternal peace of mind, wishing to place themselves amongst the elites, also wishing to follow the paths of their ancestors and other great men of courage, whom they valued and admired for their uniqueness, benevolence, and unlimited contributions to the society and their community, came together and petitioned some members of the Prince Hall jurisdiction of the state of Minnesota to join various lodges within the jurisdiction. The move was unanimously and wholeheartedly embraced by the brothers involved. Upon their advises, and realizing their wisdoms and sagacity in the doctrine of masonary, we were advised to become a lodge of our own. The news of independence brought immense joy and enthusiasm to the eight petitioners. Thus, on August 6, 1989, the lodge THETA LIBERTUS was born.

The zeal and enthusiasm of the brothers were demonstrated both in deeds and actions as the membership grew to be doubled. Two years later, the change of administration and various unkind treatments of individual members and the lodge as a whole by our lighters and brothers of the jurisdiction, the dream, enthusiasm and zeal began to gradually shatter and vanish.

Currently, Theta Libertus Lodge #17 has a total membership twelve including one past master. Five of the twelve members mentioned have been summoned to appear before the lodge and state just cause why they have not

attended the lodge's regular communication for the past three months or more.

Theta Libertus has been engulfed by many problems. As many may be internal, others are due to disappointments in some actions of the Grand

Lodge itself.

- 1. Theta Libertus Lodge #17 has been victimized by some fraternal disintegration amongst the brothers of the jurisdiction. It is evident that every brother within this edifice is aware of its existence, but choose to neglect the reality.
- 2. Theta Libertus Lodge #17 is a chartered and due paying lodge of this jurisdiction and therefore should be accorded all due respect and accommodations. The lodge presently does not have place to congregate except in the banquet hall on the first floor of the Grand East Building which is also opened to the public for use. We have to clean up every night throwing away beer bottles, cans and other leftovers from the hall before convening.

After the birth of Theta Libertus, we were allowed to share a room with Jethro Lodge and others, but being the owner of the furniture in the room, some lies were fabricated about Theta Libertus smoking and leaving dirts in the hall. Every brother that has been or come in contact with Theta Libertus knows that no member of our lodge smokes. Action which in itself shows that the allegations were baseless. To satisfy the other lodges convening in the hall, Theta Libertus was immediately evacuated regardless of the plea of innocence by the Grand Lodge Officer assigned, who has always been in our meetings.

Our move on the ground level also brought numerous accusations against the lodge again. Ones making us to feel less than men of sense and dignity. This time we were accused of stealing meat, drinks and other things from the refrigerator. Our accusers neglect to acknowledge the fact that the hall is used by outsiders for financial gains to the jurisdiction.

- 3. Theta Libertus Lodge # 17 does not have due cards for her members. On this account, I have made numerous calls to the Grand Secretary, even put notes with payments of dues under his office door, yet we get nothing. Some brothers of the lodge also gave some funds to the Grand Secretary for personal supplies almost a year ago; yet no supplies, no information and above all no refunds.
- 4. Problem four gives the conclusion as to why members of Theta Libertus have been treated in this fashion. The main core of the matter is that Theta Libertus Lodge #17 has been considered and referred to as the "African Lodge". This is very unfortunate for those considering Theta Libertus as the "African Lodge", probably masonic history needs to be taught within the jurisdiction. The "African Lodge" referred to in masonic history was established in 1775 in Boston. It is believed that Prince Hall was initiated in the "African Lodge". The term "African Lodge" was used because the lodge was solely composed of free men of color from the continent of Africa which is the ancestral root of every black person living in this hemisphere of the globe. Theta Libertus Lodge #17 is not an African Lodge, and will not appreciate been called or addressed in that manner. It is unfortunate that at the time the lodge was established, it only had brothers from the country of Liberia. Our doors are opened to all men of age regardless of race, nationality, or place of origin who have profound faith and belief in God.

It is evidence from the problems in this report that the brothers of Theta Libertus Lodge #17 have not being accorded due friendship, brotherhood, and respect, thus giving rise to poor performances, disgruntledness, and disappointments in the ethics of masonary.

In conclusion, I appeal to this august grand body and its members that in order for me to resuscitate Theta Libertus Lodge #17, I will need a place at the Grand East to congregate since we are paying rent to the jurisdiction. Secondly, I will need due cards for the members, and finally, that Theta Libertus Lodge #17 be given all due respect as a lodge, and the brothers be addressed brotherly and fraternally.

Let me conclude now with these words from the renown English Writer, William Shakespear from his play "Hamlet". He said " To thine ownself be true and it must follow as the night follows the day, thou canst not then be false to any man". We should also be mindful that if there is righteousness in the heart, there will be beauty in the character; if there is beauty in the character, there will be harmony in the home; if there is harmony in the home, there will be order in the nation; if there is order in the nation, there will be peace in the world, and the blessings of heaven will rest upon all regular masons in the universe.

Thanks for the opportunity and may God bless us all.

Audit Committee Report

of

Grand Lodge Secretary and Grand Lodge Tre asurer Financial Records

Prince Hall Foundation

Funds received and dispursed were in order on 30th accounting records. The Secretary shows \$25.00 over the Treasurer, which was simply deposited after August 30, 1993.

Relief Fund Account

The Secretary's records indicate \$1,200.00 in disbursements, while an additional \$300.00 is recorded in the Treasurer's records due to a benefits being paid August/September, 1992.

There was an additional amount of \$438.00 in revenue showing in the Treasurer's records above the Secretary's. \$370.00 of that amount is funds transferred by the Treasurer from the General Fund.

General Fund Account

This account has never been reconciled between the Secretary and

Treasurer from last Grand Lodge. They began with 2 different starting

balances. The Treasurer and bank indicate \$1,904.39 more in income than

the Secretary. This was due to money received/deposited by the Treasurer

in the Secretary's absence.

The Treasurer's records reflect \$4,765.72 in expenditures, again, due to payment of bills by the Treasure in the Secretary's absence.

Audit Committee's Recommendations

Whereas, Some irreconcilable differences exist between the Secretary and

Treasurer's entry system, due in part, to exchange rates, nonsufficient funds and service charges.

Resolved: 3. That both Secretary and the Treasurer be <u>obligated</u> to use the Auditor's ending balance as their beginning balance.

- 4. That both officers must reconcile their records monthly, and maintain all invoices and vouchers.
- 5. That the Secretary and Treasurer be encouraged to record all designated funds in the same manner.
- 6. That the Secretary and Treasurer's duties be monitored so that any corrective action can be appropriately taken.
- 7. That the Grand Master and Deputy Grand Master be reimbursed their out-of-pocket expenses incurred this past year. The Grand Master \$2,500, the Deputy Grand Master \$1,400.
- 8. That the Grand Secretary should audit the Building Fund records and with help of the lodges, verify any outstanding balance owed by any brother. These findings must be reported to the Grand Master by December, 1993.
- 9. That the Building Manager should get estimates for the necessary repairs to be made to improve the market value. Further, that all monies owed the relief fund and loans made by members be repaid when the building is sold.

This committee considers #'s 4 and 5 on the list of recommendations as rhetorical questions and statements. Therefore, no resolutions were prepared for them.

Whereas, It is generally accepted that recorded history provides opportunity for the organization's work to be judged long after completion, and

Whereas, This Grand Lodge has not been albe to record its history for the last ten years; and

Whereas, Several futile attempts have been made to gain access to the records from 1985 - 1992

Be it resolved, that this Grand Lodge should order those records to be made available to Past Grand Master, Morris Miller, as soon as possible.

To: The M. W. Grand Master, Past Grand Masters, Grand Lodge Officers and Members of the M. w. Prince Hall Grand Lodge, F. & A.M. of the State of Minnesota at this 99th Annual Communication.

GREETINGS:

When we are born it is the sunrise of the morning. Some of you are living in the noon day sun. A few of us are siting on the back porch watching the setting sun. We sometime ask, who will be next?

We do not receive many proceeding like we once did years ago. Maybe it is because we have not sent proceedings to other jurisdictions like we use to. Maybe it is because of the cost of printing and mailing proceedings.

We are not the only jurisdiction who have had problems. A Grand Lodge has a case in litigation. Some have Grand Master problems. A Grand Lodge called a Unity meeting. Some do great things. A Grand Lodge collected for charity more money and spent more money than we collect in per capiti tax. I found one Grand Lodge that charges \$1.00 for reinstatement when dropped for non payment of dues. We have a Grand Lodge who has a book value for property is \$4,878,315.00 with estimated cash, services and assets 6/30/93 of \$8,315,667.00. A Grand Lodge loss by death almost as many members as we have in our Grand Lodge. (294) What Jurisdiction loss 547 members in 1990? What city has 13 Lodges? Can you imagine a Grand Lodge Session with 954 registration. One Grand Lodge has a voluntary assessment program. The Southern Jurisdiction of the United Supreme Council is working to solve some problem with the District of Columbia.

The Knights of Pythagoras are doing well in some Jurisdictions.

I have for display 64 communications from other Jurisdictions.

I hope when we print a proceeding that it will include a list of the elected Grand Lodge officers from the beginning of our Grand Lodge.
