

REPORT ON 1945 MINNESOTA GRAND LODGE SESSION TO PERFECT ASHLAR #4

BY THE SENIOR WARDEN JOHN R. LAWRENCE



The Fifty-first Annual Communication of the Most Worshipful Grand Lodge, Free and Accepted Masons of Minnesota and its Jurisdiction, met at Perfect Ashlar Lodge Hall, St. Paul, Minnesota on Tuesday and Wednesday, August 21 and 22, 1945 A.D. 5945 A.L., with Pioneer Lodge #1 as host.

At 9:30 a.m. on Tuesday, the Most Worship-ful Grand Master George L. Hoage, Sr. opened an Occasional Lodge for the reception of the report from the Credentials Committee. They reported a constitutional number of Representatives present. Their report was then accepted.

By order of the MWCM the Grand Lodge was then opened in Ample Form and the Grand Marshal was ordered to proclaim the same. The committees were then appointed and the MWGM made his address which was timely, encouraging and forceful. His address was accepted and referred to the Committee on Grand Officers' addresses.

Allegiance to the American and Canadian flags was then pledged.

Report of the (rand Lecturer was given in which he outlined the recommended Masonic Funeral Rites for our Jurisdiction and a requested Burial Service that PGM Rev. Edward Thomas had written for himself for his own burial. This service to be performed by the incumbent Grand Master at that time, a Past Grand Master or a Past Master. The report was accepted. (The adopted Masonic Funeral Service is outlined later.)

The report of the Grand Secretary was presented by Brother Lawrence E. Tarver: Relief Fund

Lodge books. Report adopted.

The Committee on Resolutions reported: That a "Masonic Evening" be held when three-fourths of the Brothers in the armed services return home. This event to be under the auspices of the Grand Lodge and a committee formed from the subordinate Lodges with ten dollars of the expense to be allowed from the Grand Lodge funds. The other usual compliments were extended to the host, Pinneer #1 and the Elks Lodge Restaurant for the fine meals. Adopted the report.

After calling off from Labor to Refreshment for lunch, the JGW, by order of the MWGM called on at 2:00 p.m. at which time a Lodge of Sorrow was conducted by Brothers Lynn and Ransom. Eulogies for the deceased brothers were given. It was indeed very impressive.

At 3:00 p.m. the Worthy Grand Matron of the O.E.S., Mrs. Queen Ransom, and her cabinet of Grand officers were escorted in by the Brothers and courteously received by the MWGM. The very worthwhile visit exemplified the strong bond of association in the Masonic family.

The report of the Committee on Visitors revealed that a good number of Brothers had visited the sessions thereby showing an interest in the proceedings of our fifty-first Communication. Report adopted.

At the sound of the gavel, the JGW called the Craft from Reireshment to Labor. The Grand Chaplain offered prayer. It was 10:05 a.m. on Wednesday. August 22.

The Jurisprudence Committee reported:

1. Upheld ruling on last rites at Masonic funerals.

- 2. Gave Bro. Edward Thomas permission to have his especially written funeral service used when he passes.
- 3. Concurred in the official acts and rulings of the MWGM.
- 4. No new laws or rulings adopted. Report accepted and adopted.

The Committee on Youth reported. Their report was rejected and the committee dismissed. They had recommended that the work of the committee continue under a new Chairman and personnel selected by him (one member from each subordinate Lodge).

The Finance Committee reported that they had examined the books of the Grand Secretary and Grand Treasurer and that they were correct and well-kept. \$8.25 overpaid by the Secretary of Perfect Ashlar #4 was credited on the Grand

Balance in Relief Fund \$607.34 5 death claims had been paid - 1 remained to be paid.

The report of the Grand Secretary was accepted and referred to the Finance Committee.

The Grand Treasurer's report was read and corroborated that of the Grand Secretary. It was accepted and likewise referred to the Finance Committee.

The Masters' Hour was represented by the response of the Masters or representatives from six (6) subordinate Lodges. All Lodges of the Minnesota Jurisdiction were reported in good condition with the exception of Doric #3, Duluth. This Lodge was reported as facing a hopeless future, as there are so few of our people remaining in Duluth and not much chance of the population of our group increasing, even after the war's termination.

The MWGM then recommended to the Grand Lodge that we adopt the original Public Grand Honors to be given to all except the MWGM or Past Grand Masters. This is given by crossing the arms over the breast with the left over the right arm; raising the arms over the head with palms facing; then clasp hand and drop arms to the sides. This recommendation was adopted.

The report of the Chairman of the Committee on Foreign Correspondence was very interesting. Exchanges were made with other Grand Jurisdictions via: Georgia, Nebraska, Ohio, Indiana,

Colorado, Massachusetts, Wisconsin and Virginia. The following Grand Lodges noted their Annual Communications as follows: New York celebrated its 100th; Michigan its 79th; Kansas its 69th; Mississippi, 66th; South Carolina, 76th; and Tennessee its 74th.

18 Grand Lodges have begun to affix PHA (Prince Hall Affiliation) to their Jurisdictional name which makes the total 29 Grand Lodges that use such designation.

At 12:30 p.m. the Grand Junior Warden called the Craft from Labor to refreshment. At 2:30 p.m. the MWCM sounded the gavel in the Grand East and the Junior Grand Warden called the Craft from Refreshment to Labor. We enjoyed an excellent lunch prepared by the Elks Restaurant.

The Printing Committee reported that to print the Proceedings of the past 10 years would have cost eight hundred to 900 hundred dollars; therefore, they had had printed the 1944 Proceedings at a cost of \$182.00. Accepted.

The Committee on Grand Master's Address reported that it was a worthy document; they concurred in the official acts and dispensations of the MWGM and referred the same to the Jurisprudence Committee. Acepted.

The Committee on Grand Lodge Regalia reported that the same had been repaired at a cost of \$48.00. Accepted.

At this time recognition was paid the Past Grand Masters, who were present; namely, Brothers Simpson, Sherwood, Hunter and C. A. Johnson. The Grand Master paid tribute to them as "the backbone of this Jurisdiction," and we sang "Shall We Meet Leyond the River?" as a song of tribute. This was very touching, inspiring and well-deserved.

Report of the DDGM for the 1st Masonic District (Brother Lynn) was then read. He admonished brothers about handing Rituals to candidates while preparing for their proficiency tests for degrees. He reported that one Warden's proficiency test had been given and successfully passed.

The reports of the other DDG Masters were brief and reported their visits made to the Lodges of their respective districts. All adopted.

A request for masonic charity was received from Brother George Peel of Anchor Hilyard #2. As Grand Lodge funds are not used for individual charity ca cases, a collection was lifted from the brothers for Brother Peel. \$25.00 was raised on Tuesday and \$4.76 on Wednesday, which was presented to the grateful Brother at the altar.

Report of the Grand Lecturer and the Special Committee of Masters on recommended form of Mason ic Funeral Service for this Jurisdiction.

As adopted the Service is as follows:

- 1. Service in the Lodge Room. (Simon's Monitor pp. 200-203)
- 2. Service at Home or Church. (Simon's Monitor pp. 204)
- 3. Service at grave. Short Form. (Simon's Monitor pp. 222.)
- 4. End with Benediction. (Simon's Monitor pp. 234)
- 5. Grave honors to be used to commit the body at the grave.

Also adopted was this ruling that "Masons shall not hold a service if the deceased brother's family desires a military funeral, because Masons cannot thereby have the last rites."

By order of the MWGM, the JGW called the Craft from Labor to Refreshment until the sound of the gavel in the Grand East. Time, 6:00 p.m.



Worshipful Master, Wardens and Brethren again I have the high honor to report to you as Master of Perfect Ashlar Lodge #4, F & A.M. (PHA) for the year beginning 10 December 1946 and ending 25 November 1947.

First, I feel that we should give fervent thanks to Almighty God for his bassings that have continued to fall upon us and our leved ones. Likewise, He has been the Grand Artificer, who has shaped and molded us to be living stones in His spiritual temple not made with hands eternal in the heavens.

I am proud to report that peace, harmony and prosperity/in Perfect Ashlar. Further, we have overcome the situation existing in the Secretary's office, that I had the unpleasant duty to discuss at length in my 1946 report. We are proud that the offices of our Secretary and Treasurer were conducted so well that our funds and investments are in good shape and every brothers' dues are so well paid up to date that none are in danger of suspension in the near future. Further, each brother's status on the books has been squared to his and our satisfaction.

We have held 24 regular communications and 7 special communications of which 2 were with Palestine #7 and 1 with Pioneer # 1. Our attendance has averaged about 21 per meeting. We were unable to get the Telephone Committee to function as we hoped. This work was carried on by Senior Warden Lee Gwynne and the Master of the Lodge himself. If this committee had functioned properly perhaps many of our new brothers would have attended. Herein lies our greatest weakness. The attendance of brothers raised to the sublime degree of Master Mason during 1946-47 has been very, very poor with very few exceptions. In many instances these absences are not due to the usual vocations. Brothers, who become Master Masons, and never return to the Lodge either had mercenary, selfish desires in seeking Masonry or we are not doing a good job on our trestle board to retain their interest or create an interest. While I have no solution for this problem and old members infer that it usually exists in all Masonic lodges, I feel that it merits our consideration and some attempt to decrease the percentage of delinquency in attendance not only on the part of new brothers but of all brothers.

Our growth has been commendable. Last year we had 103 members; today we have 121 members or a gain of 18 during 1947. Our statistics recapitulated:

Simen Entered Apprentices remain on our trestle board as unfinished work, namely: Bros. B. Patrick, E. Faulkner, D. Gibson, J. Todd, E. Williams and H. Howland, and W. Reed. There are two Fellowcrafts, namely: T. Wickman and Z. Monson. Most of these men have been notified several times to appear. In some of these cases the 6 month rule of our Constitution

Brothers called to that land from whose bourne no traveller ever returns included, John H. Hickman Jr. and Andrew Coble who were laid to rest with appropriate and dignified Masonic services. On Feb. 26, 1947, upon the request of Prince Hall #52 of Chicago, we conducted Masonic rites for Bro. George Parker of this city for which we received full and complete expenses from said lodge.

We voted at last meeting to send Xmas, cheer to our widows of Perfect Ashlar's deceased brothers. We have W widows this year. For them we pray God's choicest blessings.

This year we granted Life Memberships to Bro. John C.Gray of Oakland California and FGH George L.Hoage. This action provides us with 8 Life Members, namely: Bros. Tra Ashe, George Brooks, Edward Robinson, Huron Shelton, Sr., Frank Simpson, Firston White, W.D. Carter, George Hoage and John C.Gray.

It was again the privilege of the officers and members to visit and work with other lodges. Herein, we set a notable example for our candidates and new brothers, example for jurisdictions, the cementing ourselves into a sacred band or society of friends or brothers among whom no contention exists. Likewise, we have been proud to have been host many times to brothers not only from this jurisdiction but also from other states. Yet, we are also justly proud to have exercised diligence and discrimination in no association with clandestine Masons, many of whom are active in the Twin Cities. It is our hope that our practice of brotherly love and friendship with all regular lodges will continue and prosper.

With our two Wardens, I represented Perfect Ashlar at the 53rd Amnual Communication of the Grand Lodge. Perfect Ashlar was the host to this 1947 session and the brothers wrought well in their preparation and entertainment of the visiting brothers. Our reception on Tuesday evening August 19 was considered a worthwhile social affair in our planned program of entertainment. Other than the achievments of the sessions, which have been already reported, the most important features for Perfect Ashlar, were the retirement of Bro. Lawrence Tarver as Grand Master and his succession by Bro. Charles Doty both members of Perfect Ashlar.

St. John's Day found us participating in large numbers at the service at St. James Charch, Minneapolis. We were very proud of the record that our new brothers made at this service; they attended in large numbers. The sermon by PGM Rev. Thomas was a jewel.

Some of the brothers of Perfect Ashlar not only assumed the leadership, but also heartily supported the Joint Masonic-Eastern Star Dinner held November 11 at Pilmim Church, which was a social success and we hope a financial success.

We reported \$40.00 to the Grand Lodge Scolarship Fund being the onle lodge to report anything. Since August we have collected \$3.15 which our Treasurer, Bro. Butler, holds.

As Worshipful Master, I have tried to maintain such a standard of craftsmenship guided by the square, level and plumb. I have tried to make the lessons, symbolism, allegories and ritualistic instruction impressive and conducive to upright living. I have tried to prove that this speculative art predicated upon an operative system makes for real living and will make a better man and a better citizen out of you. I am really proud of the brother, who says that Masonry has done something for him—that he feels that he must lead a different life. If, at least 10 of the 32 brothers, who have either been raised or re-affiliated with Perfect Ashlar during the two years of my administration, feel that the above standards desribbe them, then I feel that our efforts have been rewarded with the wages fortunish adding assist farive.

Finally, I again report that we are financially and numerically strong and will become potentially stronger, as our numbers increase. And increase we should, not by solicitation, because true Masons do not solicit, but in a community of 3,000 persons a lodge of 2 or 3 hundred men should be possible, if we so live and practice our art, that men will be attracted. If they once ask or reveal interest, then we should leave no stone unturned to invite their membership. We can not become inorganic, static or stagmant—passive Masonry does not exist—Masonry is a progressive science—it is living, vital and must be so practiced. We must enhance that growth, that is essential, ourselves. Those of us, who are more active must bear the share of the brother, who is not so active. We, who man the ramparts of Perfect Ashlar, must be the ones to spread this gospel of growth. The time is so short. We must do all of this before the wheel is broken at the eistern, before the dust return to the earth as it was, and the spirit shall return to God, who gave it. This is our task—our whole duty, brithern. Let us assume it nobly.

As I conclude my two year tenure of office, I am grateful to my officers, members, committees and brethren of the craft from other lodges for support, co-operation and pleasant memories as well as the glorious opportunity to serve in the highest office that a symbolic lodge can offer. May you serve your future officers as you have served this administration. It is my prayer that peace, harmony and concord continue and that all disputes and differences be relegated to the rubbish heap of the Temple. With profound and humble gratitude, I submit this report.



Dear Bro. Wordington

It is with regret that I have to again approach the "membership" of the Prince Hall Masonic Building Corporation for financial assistance.

Up until November, 1967 we we were on the road to solvency. We had all but caught up our arrearages in rent, were almost paid up on our oil bill, and the roof repair bill. Our insurance was added to our mortgage account so that we could pay monthly and not be faced with a \$700.00 bill every year. Through the efforts of the "100 Square Men" werwere able to redecorate our Lodge Hall.

However, this was not to last. The oil burner "broke down" beyond repair. This occured on one of our sub-zero days during the early winter. It was necessary to obtain a new one. Estamates revealed that a new burner would cost about \$1,200.00. Our credit and cash balance could not stand such an expenditure. Our tenant offered to pay for a burner and bill us \$100.00 per month - to be deducted from his rent. On this basis I, as president and in view of the emergency, authorized this as an economical way out of our dilemma. Thereafter, because of the efficiency of the new burner leaks developed in our pipes and radiators causing water to leak out. As a result our oil consumption increased greatly. We were spending almost another \$100 per month in to the burner was constantly heating a fresh takk of water).

The result of the above "disasters" reduced the amount of money which went toward the mortgage payment, thereby causing a deficiet of about \$1,400.00.

To reestablish ourselves we will have to raise a substantial sum of money toward this deficiet and revise our budget to reflect the increased costs caused by the furnace payments and escrow payments toward insurance and taxes.

These are the times which try men's souls and put your sincerity as masons to the test. I only hope that we can rise to the occasion.


