It is fitting that one of our first acts, as we prepare to transact our business, should be to remember those members who have departed this life. Try to visualize; Pascal A. Todd, James D. Granville, Thomas H. Jenkins, Charles A. Spencer, James R. Lynn, Alvin Angrum and Harvey A. Moss. Let us not forget any of our departed Sublime Princes. We shall perform our duty to the dead. SUPREME COUNCIL SESSION

The Annual Session of the United Supreme Council of the Northern Jurisdiction PHA convened in Freeport, Grand Bahamas. Your Deputy attended the Conference of Deputies, all official events and all sessions. The Memorial Service, The Elevation and the Banquet were impressive. The officers of the United Supreme Council did an outstanding job in the opening and conducting the business of the session. At the breakfast with the Grand Masters, I introduced our Most Worship Grand Master, Ill. Morris S. Miller. On Sunday morning, Ill. Cleo W. Wooten and his wife were seated beside my wife and I at the Annual Fellowship Breakfast. Sunday evening, Ill. Wooten was hospitalized due to a stroke. Ill. Wooten departed this life, Saturday, June 12, 1982. Our Grand Master was present and was escorted in the session as part of the Delegation of Most Worshipful Prince Hall Grand Masters. On Monday afternoon, the 1982 Class was admitted for elevation which was conducted by the Grand Master of Ceremonies. They were all duly elevated with proper ceremony, to the 33° and last degree. The class numbered 54. The class selected the name of the late Joseph G. Le Count. Ill. Le Count became an honorary member of the United Supreme Council on May 13, 1929 and an active member and Deputy for Rhode Island on May 9, 1938. At the time of his passing on October 4, 1981, he was the oldest active member in the Northern Jurisdiction. The Minnesota Delegation was distressed by the elevation of S.P. Paul V. Best.

Sublime princes, as we assemble here today at our 37th Annual Council of Deliberations, let us remember those refreshing lines, "Behold how good and how pleasant it is for brethren to dwell together in unity."

My utterance today will be in the form of an address rather than a report. There is an old West Indies adage, which says, "Teeth and tongue will meet sometimes." But the teeth and tongue will have to work or operate within the same perimeter, so be it with us who are members of this August Body Northstar Consistory.

There will be many conflicting thoughts and ideas, which may lead to heated controversies, but we must make sure that when all these misunderstandings are over, we will bury them and let them stay buried.

Everything that is of this earth is subject to faults, or we may sin. Even the food we eat. Because the earth is of gravitation, and gravitations have a tendency of pulling things down, we must be certain that whenever we fall, or if we fall, we will fall on our knees praying, not on our face. (Bless be the ties that bind our hearts in Christian love).

Milton. Lawrence Henderson was the Commander-Chief. There were three sublime princes, now illustrious peers. They are Illustrious Peer Morris Miller, Illustrious Peer James Kenny and Illustrious Peer Marion Brown. The Roydal Diadem of the 33rd was recently pinned on them. They were called upon to give a resume of their experience. I listened with all the ardor that I possessed. To me it was a lesson of humility and gratitude. With all their glory, they were saying, "We have received, we have done, we the Northstar Consistory." Not once did they use the word "I". These peers knew that they could not have gotten or reached the zenith of masonry without the help of someone (Northstar Consistory). Someone has to know, or share, our merits before we can ever be acclaimed for our worth. (We cannot, if we could live or die wholly to ourselves)

This was not an easy year for us in Northstar Consistory. I think that we have hurdled all the obstacles. Let us rekindle that feeling of togetherness in our fraternity. Let us strive to practice those solemn and sincere words that we have received in the charge.

I recall on April 10th, there was an elevation in Grand Forks, North Dakota. The day was Saturday. Thursday, the 8th, was our Maudy Thursday observance. Five of us left St. Paul Friday night and reached Grank Forks in the wee hours of the morning. There was a drought of hotel and motel accommodations. When we finally found one, it was about 3:30 a.m., just enough time to take a shower and lay across the bed.
