AMENDMENTS TO THE CONSTITUTIONS AND GENERAL LAWS OF THE SUPREME COUNCIL

You are hereby notified that the following Amendments were adopted at the 85th Annual Session of The Supreme Council 10 May 1966:

CONSTITUTIONAL CHANGE OF TITLE - MOST PUISSANT SOVEREIGN GRAND COMMANDER

That the title of Most Puissant Sovereign Grand Commander be changed to read "Sovereign Grand Commander" and that the title of Puissant Lieutenant Grand Commander be changed to read "Lieutenant Grand Commander" wherever the same appears in The Constitutions and General Regulations of The United Supreme Council and the Official Rituals of The Rite.

ARTICLE XXIX

Section 110: is amended to read as follows:
At least one meeting of all Councils of Deliberation belonging to this jurisdiction shall be held annually and during the months of October, November and December at the call of the respective Deputies. Special meetings may be called at any time by the Deputy when in his judgement the same is necessary for the welfare of the Rite or upon written request of at least five members of the Council of Deliberation. Eight members besides The Deputy shall constitute a quorum for the transaction of business. The Deputy shall give thirty days notice before the date of an Annual Meeting of a Council of Deliberation and fifteen days notice before the date of a special meeting of a Council of Deliberation.

ARTICLE XXIX

Section 117: is amended to read as follows:

Section 117 (a) The choice of fraters to be recommended for elevation to The Thirty-third Degree shall be made by a two-thirds vote of The Council of Deliberation and by Secret ballot. Fraters to be so chosen shall be nominated from the floor in open meeting of the Council, and not otherwise.

Section 117 (b) In the event that there are more than two nominees and a two-thirds vote has not been attained on the first ballot, succeeding ballots may be cast. If, after three ballots, the two-thirds vote has not been attained, the two candidates receiving the highest number of votes cast shall then contest for the two-thirds vote. Other candidates shall be automatically eliminated. If neither of the two nominees shall receive a two-thirds vote after three additional ballots have been taken; then the name of no nominee shall be presented for elevation.

EXECUTIVE ORDERS

FUNDS FOR EDUCATIONAL PURPOSES

Councils or other Scottish Rite Bodies which have accumulations of substantial funds for educational purposes, that regulation shall be spelled out to protect such trust funds to wit: Investments must be approved by The Sovereign Grand Commander. Only earnings of such funds may be allotted annually for scholarships or educational purposes or administrative expense. As a further safeguard, these funds cannot be "borrowed" to bolster other depleted operating funds of the Council of Deliberation or other Scottish Rite Bodies.

The Committee or Trustees of such funds must report to the Supreme Council in addition to the report rendered to the Council of Deliberation or other Scottish Rite Bodies and a copy of auditors report must accompany the same.

Memorandum To All Deputies of the United Supreme Council Ancient and Accepted Scottish Rite for the Northern Jurisdiction

Illustrious Sirs and Dear Brothers:

Take due notice of the following amendments to the Constitutions and General Regulations of the United Supreme Council for the Northern Jurisdiction voted at the 85th Annual Session at the holy sea May, 1966.

Article XXIX, Section 110 be amended to read, "At lease one meeting of all Councils of Deliberation belonging to this Jurisdiction shall be held Annually during the months of October, November, and December at the call of the respective Deputies. Eight members besides the Deputy shall constitute a quorum for the transaction of business.

The remainder of this section remains unchanged.

Article XXIX, Section 117 be amended as follows; "In the event that there are more than two nominees for the thirty-third degree and a two-thirds vote has not been attained on the first ballot, succeeding ballots may be cast. If after three ballots the two-third vote has not been attained, the two candidates receiving the highest vote shall then contest for the two-third vote. Other candidates shall be automatically eliminated."

"If neither shall receive a two-third vote after three additional ballots have been taken, the name of no nominee shall be presented for elevation."

Executive Order No. 3

Illustrious Sirs and Dear Brothers:

The rising cost of food services in established hotels and catering firms make it uneconomical for the Supreme Council to continue with its custom of complementary banquets and noonday luncheons at its sessions to members of the Supreme Council.

Our records indicate that the Supreme Council has subsidized the banquets and noonday luncheons during the sessions since 1951, having expended an approximate total of \$52,500.00 or \$3,500.00 per session.

I think you will agree, based on precedents set by other organizations particularly our Scottish Rite counterparts, that a modest registration fee be charged each Peer to cover the cost of the services indicated above.

It is not the intent or purpose of this ruling to profit in any amount from these registration fees, which will fluctuate from year to year after menus and services are contracted for at the Holy Sea or various places in the jurisdiction where we may meet.

Illustrious Sirs and Dear Brothers:

It has been brought to the attention of this office, through correspondence and a review of the tape recordings made at Milwaukee at the annual Conference of Deputies, that it is being advocated that Illustrious Peers shall preside at subordinate Consistory meetings.

Please be advised that this is in error and not promulgated from this office.

Subordinate Consistories have the inherent right to choose its officers from the ranks of Sublime Princes, and the right to discipline its own members.

Illustrious Peers of any grade are amenable only to the Supreme Council, who alone may sit in judgment, if necessary.

It is perfectly obvious that to permit an Illustrious Peer to be elected as a Commander-in-Chief of a subordinate Consistory, suggests that only Illustrious Peers may be elected to this office.

Only the Deputy of the respective orients may preside at his pleasure in the subordinate Houses of the Rite, unless the Deputy delegates a Peer for this service.

This brings about another observation when Deputies or other officers make an official visit to a subordinate Consistory.

Courtesy dictates that the Commander-in-Chief shall offer the gavel to the visiting officer. Common sense and courtesy also dictates that the visiting officer shall return the gavel and direct him to preside over the meeting until such time that the purpose of the official visit is made known, i.e. elections, installation of officers, or other official business.

Violation of the above, when brought to the attention of this office, shall result in appropriate action against any Illustrious Peer, of any grade who intrudes himself in the internal affairs of any subordinate Consistory in an arbitrary or dictorial manner.

It is obvious that the respective Deputies are responsible to this office for violation of this directive.

This directive, at the present time, is directed to the office of Commander-in-Chief only.

There are many instances where there are secretaries and treasurers of subordinate Bodies who hold the rank of Sovereign or Grand Inspector General and are serving efficiently.

However, it can readily be viewed that a Consistory is handicapped, if discipline of these Peers who hold subordinate office may become necessary.

The only legal redress would be to not return them to office at the next annual election.

It is constitutionally correct that an Illustrious Peer of any grade may speak without rising from his seat, or enter or leave without saluting in subordinate Consistories. (exception, when an officer of equal rank is presiding)

Illustrious Peers of all grades are to see to it that the Laws & General Regulations of the Supreme Council are observed, and to give advise when requested by the Commander-in-Chief, nothing more.

Flaunting of rank, in a subordinate Consistory, by an Illustrious Peer of any grade will not be tolerated by this office.

If it comes to my attention, this office knows exactly what to do in the premises, and will not hesitate longer than it takes to dispatch a communication to the offending Peer.

Take due notice of this memorandum and be governed accordingly.



Some will be placed in the treasury of the Council of Deliberation and some will be placed in the general treasury to be used as needed.

During the year, the Grand Architect of the Universe called 2 of our fraters. Our Pillar of Beauty Chapter of Rose Croix has performed the burial services with dignity.

Dear Fraters:

It is imperative that we give attention to our rate of per capita taxation at the coming session of the Supreme Council.

Our present rate of per capita taxation was adopted at the annual session in May, 1952 which, according to the present Constitution, was \$3.00; with \$1.00 payable in May of each year and \$2.00 payable in September of each year.

The following is one example to support an increase in the above mentioned per capita tax schedule: In 1952, when the present rate was adopted, the cost of operating and maintaining the Cathedral building [heating, lighting, custodial salaries, taxes, insurance etc.] was approximately \$4,000.00. In 1968, the cost of these items has spiralled to over \$12,000.00.

I am, therefore, issuing this memorandum as a blanket dispensation to permit the so-called ('midnight services'') to be conducted following the usual ceremonies of symbolic Masons which should be held no later than 9:00 p.m.

To comply with this directive and special dispensation, you will eliminate the words of the official Ritual on page 4: ''It is midnight and a new day begins for us.'' This directive will be in full force and effect until the Supreme Council shall determine otherwise.

Deputies are charged with the responsibility of promulgating to all Commander-in-Chiefs and most wise and perfect masters in their respective Orients who will be responsible for the conduct of these services.
