

The Accustomed census of our Illustrious dead has been completed and an appropriate inscription has been placed beside each name in the archives of this Grand Lodge. We stand with bowed heads to mourn the passing of staunch friends and stalwart men, instinct fills our hearts with sorrow and we celebrate these rites in the spirit of the mourner, and yet ours is not a melancholy task, we are merely taking a census of those whose loss we mourn. We are making an inventory of the deathless estate they have left behind them and appraising the heritage they have fashioned for us. When death takes a friend and brother there is but anguish in the hearts of those of us who knew and loved him. But the scroll before us is the record of a full year. Months have passed since we stood on the brink of the abyss, bitter anguish has turned to mellow reminiscence. Each of us knew more than one of those whose names we inscribe today on our scroll of honored dead names of those who sat in the oriental chair and contributed in the proportion of their powers to the honor of Masonry and to the welfare of the Craft. We remember them and honor them for the work of their hands and the qualities of their minds which live beyond them.

We desire to call attention to the great loss the Craft has sustained in the passing of R. W. Bro George Taylor, Past Grand Auditor. Brother Taylor served this Grand Lodge faithfully and sincerely for many years. Still another great loss was sustained in the passing of W. Brother Elton P. Hodo a member of the Jurisprudence committee and Past Worthy Grand Patron of Eureka Grand Chapter. He will be missed by the Fraternity.

Let us remember that it is the dead that govern, the living only obey, and if the soul sees, after death, what passed on this earth and watches over the welfare of those it loves, then must its greatest happiness consist in seeing the current of its beneficent influences widening out from age to age, as rivulets widen into rivers and aiding shaping the destines of individuals, families, states and the world and its bitterest punishment is seeing its evil influences causing mischief and misery, and cursing and afflicting men long after the frame it dwelt in has become dust, and when both name and memory are forgotten, we knownot who among the dead control our destinies. The universal human race is linked and bound together by those influences and sympathies which in the truest sense do make the fate of men. Fumanity is the unit of which man is but a fraction. What other men in the past have done, said, thought, makes the great iron network of circumstance that environs and controls us all.

The Masonic institution suffers its greatest loss through the death of its Past Masters they are the men who have given the order its leadership, perpetuated its ideals, protected its landmarks, initiated its apprentices, and guided its master workmen. It is their work which largely constitutes our heritage. From those we pause to bonor this hour. Each of us in our turn will join their ranks and be recorded on the scroll before us. It is at such a time as this that we may fittingly re-dedicate ourselves to the task of carrying forward the work of the Fraternity with equal zeal and fidelity and so let us return to our Lodges in the spirit of re-dedication, let us emulate the good work of those who have relinquished to us the responsibility of leadership, let us recall the spirit of them to sit with us, council, and by their wise judgements and proper precepts, to help us preserve the ideals of the Fraternity.

No attempt has been made to record here the virtues or the work of individuals among our distinguished dead, each has had his fitting masonic tribute with a record that is eternal in our archives and with a recollection in the hearts of brothers and friends that will live so long as we who knew them shall survive. We stand uncovered at the universal shrine of Masonry grateful that our own lives have been enriched by our fraternal relations with those who have departed and confident that each of them have won a cherished place in eternity. It is impossible for us to even attempt to indulge into the just praise they so well deserve, but to those brethren who have departed from our midst the past year we may pause to say this:

This committee, under the capable leadership of Bro August A. Abadie, Chairman, and Bro Joseph J. Blount, Co-Chairman, has exemplified unusual understanding in the constitution and By laws. If there is something you do not know, or wanted to know, this committee has been available. The other members have worked untiringly with the committee. Since our last Grand Session, it was our misfortune that Bro Elton P. Hodo, a member of this committee, answered the call of the Grand Architect of the universe, Many thanks to this committee for the way they conducted these classes.

OFFICIAL VISIT AND OFFICIAL ACTS

It is my pleasure to report to you that for a few instances, there was no cause necessitating disciplinary action. This demonstrates that our District Deputy Grand Masters have continued their helpful supervision and that most of the Masters are cognizent of their duties.

On April 8, 1971, we assembled the Past Masters and Officers of R. E. Moore Lodge #109 and Grand Lodge Officers. We assembled a Lodge and conferred the Degrees of Entered Apprentice, Fellow Craft and Master Mason upon Albert J. Deloney, III. This young man being desirious of following in his father's footsteps as a Mason, is serving his country well, was wounded in Vietnam, was being shipped out again and was assigned to R. E. Moore Lodge #109.

NEW MASONIC TEMPLE

My Brothers, we inherited a Resolution passed and approved by this Most Worshipful Prince Hall Grand Lodge in its 103rd Annual Session to assess each member \$100.00 for a New Masonic Temple Building Fund. In our 104th Annual Session, we extended this resolution for one (1) year, until August 31 1971. These are facts, now let us examine the record. At the close of our 104th Annual Session, we had collected and had on hand Seventy One Thousand (\$71,000.00) Dollars. As of August 31, 1971 we have on hand Eighty Six Thousand, Five Hundred Sixty Eight (\$86,568.00) Dollars deposited as follows. Service Federal Savings & Loan Association, Twenty Three Thousand, Two Hundred Sixty Nine Dollars and Sixty Four (\$23,269.64) Cents, Independence Bank of Chicago, Twenty Three Thousand, One Hundred Six Dollars and Seventy One (\$23,106.71) Cents; Drexel National Bink, Twenty One Thousand, One Hundred Twenty Eight Dollars and Seventy Three (\$21,128.73) Cents; Highland Community Bank, Nineteen Thousand, Sixty Three Dollars and One (\$19 063.01) Cents. These figures indicate that in the year just closed we collected Fifteen Thousand, Five Hundred Sixty Eight (\$15,568.00) Dollars or an increase of Twenty Two (22) per cent. This figure also indicates that less than Fifteen percent of our Membership has paid the One Hundred Dollar Assessment, further, it indicates that we are just Thirteen Thousand Four Hundred Thirty Two (\$13,432.00) Dollars shy of the One Hundred Thousand Dollars we set as our Goal.

With this Goal clearly in sight we are going to launch our attack NOW. We appointed the Honorable Corneal A. Davis, our own Worshipful Grand Chaplain & State Representative Right Worshipful Brother O. G. Gist, Grand Trustee, Emeritus Brother James B. Lockhart, Attorney; Past Grand Master Henry G. Fort, Past Grand Master O. E. Vanderburg Worshipful Brother Levi H. Morris, Grand Attorney; Worshipful Prother Thomas C. Taylor; Brother Charles Clark, Superintendent of Robert Taylor Homes, C.H.A.; Brother Oswald Champagne, Jr., Urban Renewal Brother Prince E. Marshall, Secretary Right Worshipful Brother James H. Black, Grand Senior Warden as Members of the New Masonic Temple Building Commission. This Commission will begin work immediately in this area. All projects that they propose will become an operation. For instance, a Drive will be launched to raise funds for Operation Architect. We will have a report from this Commission during this 105th Annual Session.

MASONIC & O.E.S. RIVERVIEW APARTMENTS

Words are inadequate to compliment our Fast Worthy Grand Matron, Sister Hazel B. Walker, for her superb manner in handling the affairs of Eureka Grand Chapter O.E.S., as Vice President of the Frince Hall Masonic & O.E.S. Village. She has given us all the cooperation and support desired. meetings have been most harmonious and productive as one could expect, her ability, courage and judgement was rewarding and a spirit of inspiration to this office. We are happy to report that we have a wonderful spirit of cooperation and understanding with our Sisterhood. On Sunday, December 6. 1970, pursuant to the Articles of the Corporation, the annual meeting of Riverview Apartments was held at the Masonic Temple, 809 E. 42nd Fl. There were 27 members present, the summary reports of our Attorney and detailed report of the Secretary was received and approved. The following officers and directors were elected for a term of one (1) year to comprise the Executive Committee John A. Perkins, President Hazel B. Walker Vice President Bessie Howard, Treasurer, George W. Harris, Secretary, and directors: Daisy Slaughter, Rufus Starks Hazel Stillwell, O. B. Vanderburg and Henry G. Fort. Because of his extreme interest, devotion and untiring work with the Masonic and C.E.S. Riverview Apartment, we were prompted to appoint Most Worshipful Bro Vernon L. Earker as Executive Secretary for the Riverview apartments. Bro Barker has done a tremendous job. As you know, we began the year without a rental agent, we cannot pay him for the interest he has shown. He deserves your thanks and another who deserves our warmest praise is Sis Ethel Schurlock, Associate Grand Matron. Without a rental agent the corporation agreed unanimously to give to Sis Schurlock the power to rent the Riverview Apartments and she did. At the beginning of 1971, all not completely rented of the 152 units, 130 rented and 22 vacancies. We are happy to report to you as of August 31, 1971, we have 150 rented and 2 vacancies. Thanks to Sis Schurlock and her staff and the sincere efforts of M. W. Bro Vernon L. Parker. Yes, we have problems, many of them the important one is money. At the final closing with F. E. A. of the Riverview Apt, we found out we needed \$30,000 before closing. The Corporation started negotiations with Independence Bank of Chicago, the loan was secured. On February 12, 1971, we met with Mr Nelson and made final arrangements for the payments of loan. This Corporation has met monthly to review the financial transactions of the Biverview Apts. We have received monthly financial statements from Rock Island of all monies collected and disbursed we have managed to pay our note monthly and necessary bills. In March we were notified of a suit filed against us by the Per-Mar Guard Service for services at the development of which our Grand Attorney, Levi H. Morris, made appearances in our behalf and the situation was resolved. We have many problems, but you are not to get alarmed over them because we are taking them day by day and attempting to solve them with the help and advice of our attorneys James Robinson of Urban Fast and Ralph D. Beal of Rock Island and our own Grand Attorney, Levi H. Morris. Let us say here that God has been good to us, he has guided us in all our transactions. As long as we keep Faith in Him, WE SHALL OVERCOME.

On July 10, 1971, we received a letter from the Federal National Mortgage Association, that we were in default. The reason for the default was due to the imposition of Real Estate Tax of \$46,632.94 on the development by Rock Island County Assessors office wherein the loan was processed as tax exempt.

The income and analysis of this development did not provide for this imposition of tax. F.N.M.A. advanced the tax payment due of \$47,099.27 that included a penalty of \$466.33. On the first installment, F.N.M.A. billed us for the tax payment made, and increased the monthly installment payment on the mortgage from \$7,415.22 to \$11,776.22 effective August 1, 1971. The regular installment of \$7,415.22 was paid for August 1971. When the balance for the increase and taxes was not paid the default notice was initiated, these are the reasons for the default notice. We immediately sent all documents to Attorney James Robinson. We also met with the Honorable James Haymaker relative to our tax problem. He could not take any direct action, but advised us and referred us to the assessor and Board of Reviews Office. We were able to secure the procedures for payment under protest. On legal advice from our attorneys, we have withheld payment until they have co-ordinated what ever action is necessary with F.H.A. county assessor, and F.N.M.A. Initially we felt that this project had the good blessing of the Rock Island structure, but it is not that way everything indicates that they are prejudice, non cooperative and wants us to remain in default. But we are fortunate to have the best legal attorneys in James Robinson, Ralph D. Real and Levi H. Morris who can advise us in the proper way and fight the circumstances engulfing us now, this is where we are at the present time.

The record, however, should reveal my acknowledgement of the unselfish devotion and untiring efforts of those with whom we have worked so closely and constantly. We have worked together harmoniously as a unit with but one purpose in mind, the good of Masonry in Illinois. We have enjoyed the cooperation and support of all Grand Lodge Officers, Committee Chairmen and Committee members. Especially noteworthy is the theme we established at the beginning of the year "Unity. The great central truth of Masonry is that God lives, that all

mankind are His children and as such, are members of the same family. Brothers everything in Masonry revolves around the existence of God and mans dependence on him. It is not secret words or signs or ritualistic ceremony that makes a Mason, but it is the living and eternal truth, applied in a mans own life and among his fellowmen that makes him a Mason. True Masonry has two main goals, the development of Character and the realization of brotherhood, for it is in this spirit that we trust and Pray for a harmonious session, remembering that those who work best are those who can agree.

My Brethren, this year is completed and the record made and we are returning to you the emblem of authority entrusted to our keeping for the past year without a blemish, nothing to mar the good name of the Craft of Illinois. The business of this Grand Lodge is yours.

As we enter into our deliberations let us remember these thoughts on the Lord's Prayer:

You cannot Pray the Lords Prayer and not include another
And you cannot ask for daily bread and not include your brother
