The following information comes from Spofford Canfield, Administrative Assistant to Rockefeller in the Senate who has held that position for Agnew. Ford and Rockefeller.

I. Salaries and Staff

The Senate clerk-hire allowance in currently \$654,000. The maximum salary on this payroll is \$41,750. There is no limitation on the number of positions that can be filled at or below that limit at levels within the Senate salary schedule. (EOB funds provide for only one position at the Executive Two level -- \$44,600, the rest at or below GS-18 currently \$39,600. All these salaries will be subject to revision in January or February when Ford recommends increases under the pay adjustment act for all government employees above the GS-15 level.)

Eight of the current thirty-eight Vice Presidential staff on the Senate payroll work in the Senate. The rest at the EOB. These eight consume \$150,000 of the \$654,000 clerk hire allowance.

II. Housing

There is a five-room suite in the Dirksen Building, two very large, one medium and two very small. Except for one Rockefeller staff person working on a specific project, these rooms are now vacant. With Susan Herter's permission we could probably move in there very shortly. There are two rooms in the Capitol. a ceremonial room right off the Senate Floor which Rockefeller, himself, uses and S-212, about the size of WFM's current office now used by Canfield and two secretaries. S-212 is next to the Taj Mahal.

III. Legislative Liaison

. This seems to be mostly a behind the scenes, eyes-and-ears operation, keeping track of legislation for the VP and his EOB staff, but also serving as the principal central meeting place where White House and Executive Agency legislative liaison people meet with Senators. Canfield is very careful not to exercise any "line responsibility" for legislative liaison and does not himself in any way lobby for the administration's legislative program.

IV. Casework

Four of the eight staff members do casework, 15% of which comes from New York. This seems to be mostly an agency buck slip

operation. "Casework" includes what we call "requests" or constituent services. Since the Vice President is part of the Executive as well as the Legislative branch, Canfield believes that it is important that caseworker be facilitators rather than advocates. He sees this as a different kind of operation from that in the Senate office.

V. Mail

The Vice President's Senate Office handles all "public" mail, mostly legislative mail, about 5-600 letters a day, keeping about one and a half people busy full time.

VI. Ceremonial and Official Functions

The President of the Senate is the official receiving agent for all communications to the Senate including reports from Executive Agencies mandated by law, petitions and memorials, and communications from state and local governments. This occupies one full-time staff person. Letters of transmittal are logged in, referred to the Senate Parliamentarian and an acknowledgement letter prepared. There are between ten and thirty of these a day.

Ceremonial functions involve such things as the authorization of demonstrations on Capitol Hill grounds, tree plantings and the like, arrangements for Foreign Policy luncheons, meetings with heads of state, joint sessions of Congress and other ceremonies in which the Vice President participates on Capitol Hill.

Resolved, That in the case of the resignation of a Senator during his term of office, his clerical and other assistants on the payroll of the Senate on the date of such resignation shall be continued on such payroll at their respective salaries for a period of not to exceed thirty days, such sums to be paid from the contingent fund of the Senate: Provided, That any such assistants continued on the payroll, while so continued, shall perform their duties under the direction of the Secretary of the Senate, and he hereby is authorized and directed to remove from such payroll any such assistants who are not attending to the duties for which their services are continued: Provided further, That this shall not operate to continue such assistants on such payroll beyond the expiration of their Senator's term of service.

\$392,298 if the population of his State is less than 2,000,000; \$404,076 if such population is 2,000,000 but less than 3,000,000; \$432,464 if such population is 3,000,000 but less than 4,000,000; \$469,006 if such population is 4,000,000 but less than 5,000,000; \$498,904 if such population is 5,000,000 but less than 7,000,000; \$530,312 if such population is 7,000,000 but less than 9,000,000; \$564,438 if such population is 9,000,000 but less than 10,000,000; \$590,712 if such population is 10,000,000 but less than 11,000,000; \$625,140 if such population is 11,000,000 but less than 12,000,000; \$651,414 if such population is 12,000,000 but less than 13,000,000; \$684,936 if such population is 13,000,000 but less than 15,000,000; \$718,458 if such population is 15,000,000 but less than 17,000,000; \$751,980 if such population is 17,000,000 but less than 19,000,000; \$777,050 if such population is 19,000,000 but less than 21,000,000; \$802,120 if such population is 21,000,000 or more.

In any calendar year in which a Senator does not hold the office of Senator at least part of each month of that year, the aggregate amount available for gross compensation of employees in the office of that Senator shall be the applicable amount contained in the

(B) The aggregate of payments of gross compensation made to employees in the office of a Senator during each calendar year shall not exceed at any time during such calendar year one-twelfth of the applicable amount contained in the table included in subparagraph (A) of this paragraph multiplied by the number of months (counting a fraction of a month as a month) elapsing from the first month in that calendar year in which the Senator holds the office of Senator through the end of the current month for which the payment of gross compensation is to be made.

(2) Within the limits prescribed by paragraph (1) of this subsection, Senators may fix the number and the rates of compensation of employees in their respective offices. The salary of an employee in a Senator's office shall not be fixed under this paragraph at a rate less than \$1,057 per annum or in excess of \$24,160 per annum, except that (i) the salaries of five employees may be fixed at rates of not more than \$34,881 per annum, and (ii) the salary of one employee may be fixed at a rate of not more than \$38,000 per annum. A Senator may establish such titles for positions in his office as he may desire to designate, by written notification to the disbursing office of the Senate.

- (1) Subject to the provisions of paragraph (3), the professional staff members of standing committees of the Senate shall receive gross annual compensation to be fixed by the chairman at not to exceed \$33.975.

Dear Senator Mondale:

This is in response to your letter dated November 11, 1976 posing certain questions relating to the Office of the Vice President and yourself when you assume the Vice Presidency on January 20, 1977.

Your questions are answered in the order in which presented as follows:

- 1. There is no allowance for or any provision of law that authorizes funds for (1) per diem and/or travel expenses for employees paid from the Senate appropriation for Clerical Assistants to the Vice President; (2) subscriptions to newspapers, magazines, periodicals, news clippings or similar services; (3) office space in the home State, or (4) home State office expenses.
- 2. Section 111 of Title 3, United States Code entitled Expense Allowance of Vice President reads as follows: "There shall be paid to the Vice President in equal monthly installments an expense allowance of \$10,000 per annum to assist in defraying expenses relating to or resulting from the discharge of his official duties, for which no accounting, other than for income tax purposes, shall be made by him."

This provision was enacted by Public Law 2, 81st Congress, approved January 19, 1949. The Committee report accompanying this legislation made no reference to or placed any restrictions on the use of this allowance by the Vice President. It would be my interpretation that the language "***to assist in defraying expenses relating to or resulting from the discharge of his official duties, ***" provides the Vice President with unlimited latitude in the use of this allowance so long as the expenditures relate solely to the ordinary and necessary official functions of his office.

Except for the accountability of this allowance for income tax purposes, the use of this allowance by the Vice President cannot be questioned by anyone.

3. As Vice President, your monthly gross compensation, deductions and net salary will be as follows:

4. The present value of your life insurance coverage is \$47,000 and will be the same when you assume the office of Vice President. This amount is the current maximum life insurance coverage for anyone in the service of the Federal Government.

- 5. As Vice President, you will continue participation in the Civil Service Retirement program with the same deduction (8%) and benefits as you now enjoy as a Member of the United States Senate.
 - a. Your total contributions to the retirement fund as of December 31, 1976 will be \$36,039.05.
 - b. Enclosed are tentative computations of your annuity entitlement as of January 20, 1981 and January 21, 1985. Please note that as of January 20, 1981, you would have a deferred entitlement at age 60 and as of January 20, 1985, you would have an immediate entitlement.

I am looking forward to a meeting with you and if I can be of further service to you in the meantime, please call on me.

Dear Senator Mondale:

Please accept my congratulations on your election as Vice President of the United States.

As Financial Clerk and Budget Officer of the United States Senate, it is my privilege to inform you of certain prerogatives of your office.

Your salary, at the annual rate of \$65,600, will begin on January 20, 1977 and is payable monthly in the same manner as your Senatorial salary.

The expense allowance of the Vice President, at the rate of \$10,000 each fiscal year, will also commence on January 20, 1977 and is payable monthly.

As Vice President, you will be entitled to the mileage allowance for attending each session of the Senate, computed at 20¢ per mile by the nearest usual route from your residence city to Washington, D. C. and return. I will continue to use your certified mileage from Washington, D. C. to Minneapolis, Minnesota, unless you advise me to the contrary.

The allowance for clerical assistance to the Vice President is \$654,700 each fiscal year. This allowance accrues at the rate of \$54,558.33 per month and any unused part is cumulative for use in subsequent months through the close of each fiscal year. There is no limit as to the number of employees you may appoint and there are no restrictions on position titles. The maximum salary that may be paid to any employee in your office is \$41,750 per annum and there are no restrictions as to the number of employees at this maximum rate.

As President of the Senate, you will be entitled to an allowance of \$4,500 each fiscal year at the Senate Stationery Room and I will be able to provide you with air mail and special delivery stamps at the rate of \$1,215 each fiscal year. Both of these allowances are pro-ratable from the day you take office to the end of the fiscal year.

You may send unlimited official telegrams which will be paid by the Office of the Sergeant at Arms in accordance with regulations issued by the Committee on Rules and Administration.

Your long distance telephone call charges will also be paid for by the Office of the Sergeant at Arms in accordance with regulations issued by the Committee on Rules and Administration.

Funds are appropriated annually to the Sergeant at Arms to provide and maintain an automobile for your use.

Funds are also appropriated each fiscal year to provide you with a Driver-Messenger at a salary not to exceed \$15,364 per annum. This is a statutory position under the jurisdiction of the Sergeant at Arms but is subject to your control. Therefore, at any time you wish to fill this position, you should notify the Sergeant at Arms who will then make the appointment.

With respect to your compensation and mileage, there are certain papers that must be executed by you. Therefore, I would appreciate it if I could meet with you at your earliest convenience to take care of these items.

In the meantime, if I can be of further service to you, please do not hesitate to call on me.
