OF COURSE, PARTNERING IS NOT EASY. IT IS COMPLEX, IT IS CHALLENGING, AND UNLESS BOTH SIDES ARE CAREFUL IT CAN FAIL. THEREFORE PARTNERSHIPS MUST BE CAREFULLY UNDERSTOOD AND SHAPED TO SUCCEED. THIS CONFERENCE WILL HELP EVERYONE HAVE A BETTER IDEA OF HOW TO MAKE CORPORATE ALLIANCES WORK AND WORK WELL.

I WISH I COULD BE THERE IN PERSON TO BE A PART OF THIS EXCITING NEW EFFORT, BUT AT LEAST I WILL BE THERE IN SPIRIT.
