Dear Dr. Glennan:

You will recall that my communications with you started when you failed to allow Dr. Robert (Kelly) Acosta to speak at the San Angelo Conference on September 18, 1973. The major emphasis of that conference, you will remember, was to expose the past and anticipated future of the education of Mexican Americans in Texas. A grasp of NIE's overall activities was not part of the overall criteria for the selection of any of the three Mexican American speakers. However, a grasp of the past and future of the education of Mexican Americans was necessary for our selection of those speakers. Hence, Dr. Acosta was selected. You must know that I have had much difficulty understanding as well as communicating to the Chicano community the reasons as stated in your letter of December 20, 1973, for disapproving Dr. Acosta's presence at the conference. Nevertheless, I appreciate your reply to my letter.

I am pleased to hear that NIE is very much interested in the education of Chicanos. I must admit, however, that the inclusion of "Chicano Education and the National Institute of Education" by Dr. Aragon, Dr. Guzman, Dr. Arciniega, Dr. Galarza, Dr. Ramirez, and Dr. Ramos confused me some. The point of my confusion is simple and must be expressed directly since I have no political notions or complications. That is to say, if it is true that NIE is very much interested in the education of the Chicano, why is it that:

- The planning papers by Chicano authors were not included in your Planning Report No. P101 - Program Planning for the National Institute of Education: A Summary of Four R & D Analysis?
- 2. Did the Chicano authors receive planning funds for such input as other planning groups did? Please notice that page 1 of the paper states: "The papers were written quickly without time and without funds."

Would you not agree that "equal opportunity" as specified in the NIE Legislation, means giving the Chicano authors equal time for the write-up task as well as equal funding for such task? Which reminds me, when you say in your letter that "Mr. Acosta has currently not had the opportunity to grasp NIE's overall activities.." do you mean that Dr. Acosta has not been invited to participate in overall activities of NIE, or do you mean that you as the Director

of NIE has not facilitated an equal opportunity for Dr. Acosta to grasp NIE's overall activities? Would you not agree that when you failed to allow Dr. Acosta to speak at the San Angelo Conference that you actually deprived him of the opportunity to grasp NIE's overall activities, since we consider the education of the Chicano one of NIE's most important overall activities? Perhaps I do not understand what you mean by a person grasping the overall activities of an agency. Therefore, if you feel that I am wrong would you be so kind to elaborate. What are the overall activities you are talking about? Specifically, who within NIE has grasped NIE's overall activities? Definitely, a list with the names and titles of those who have grasped NIE's overall activities would be extremely helpful to us. Could you please provide us with such a list?

In addition to the above questions, why is it that:

- 1. NIE invited Chicano individuals to attend a February, 1973 Conference on Career Education and a Mesa Directiva was formed to assist NIE in interpreting the educational needs of the Chicano community. Yet NIE repeatedly postponed meetings with the Mesa Directiva, and when finally a meeting was held, none of the Mesa Directiva's recommendations on career education were taken. For example, the Mesa Directiva strongly recommended a Career Educa-Model for the Spanish Speaking. Dr. Alfredo G. de los Santos Jr., a member of the Mesa Directiva, subsequently submitted a prospectus for such a Career Model. This recommendation was not even acknowledged, let alone considered -- Dr. Alfredo G. de los Santos Jr. has not even received a reply as of this date.
- NIE has already spent about \$750,000 in planning documents and then had the decency to appear before the group of Chicano educators and ask them to produce papers quickly and with no pay.
- 3. After the Chicano educators submitted the papers to NIE was there acknowledgement that these papers had been received by your office?
 . Did you acknowledge the papers you received from: RAND Corporation, Etzioni, Kooi, Mackley & McKinney, Raisen. Am I correct by saying that theirs were the only papers included in your Planning Report No. P101?
- 4. On April 27, 1973, in Albuquerque, New Mexico, when Dr. Aragon brought up the matter of NIE's failure to acknowledge the papers, you said that you had never heard of such papers. Yet, the papers were submitted to NIE in 1972, and you now take the pleasure in sending the papers to me to show how very much interested NIE is in the education of the Chicano.

Believe me, your interest in the papers helps, but what would be more helpful, would be to see NIE implementing the concepts and ideas of-

fered in the papers. Also, it would help if NIE would give these papers equal treatment. By that I mean including these papers in NIE publications. But really, it is the implementation of the contents of these papers that matters and not the papers at this point, since I take it that you are trying hard to impress upon Chicanos that NIE is very much interested in the education of the Chicano.

5. Did NIE request the permission of the Chicano Educatiors prior to publishing the papers as Report #Cl09? Did you request the permission of RAND Corporation, Etzioni, Kooi, Macklely & Mc-Kinney, and Raisen prior to publishing their planning documents?

Furthermore, it has been noticed that your most recent publication, "Grants for Research in Education" avoids mentioning bilingual education. You will find that this is true by reading pages 1-8 of that publication. Why is this so? Who were the Chicano educators invited to participate in the write-up of this important publication which solicits the submittion of prospectuses for research proposals? Was Dr. Acosta involved in the write-up or analysis of the publication? Of the Mexican Americans and Puerto Ricans you listed under Item 2 of your letter who was involved in the write-up and analysis?

In any event, considering the fact that NIE is very much interested — in the education of the Chicano, I feel comfortable in pursuing other questions:

- 1. Why is it that your Task Force on Multicultural Education as you now call it, has not yet come up with something substantial for dealing with the education problems of Mexican Americans?
- 2. Who is presently heading your Multicultural Education Task Force?
- 3. In March, 1973, did you not bring Dr. Acosta all the way from California to administer your Multicultural Education Task Force?

Your letter is interesting, to say the least, and I must not ignore disucssion about Item No. 2 of your letter. Please note that you avoided Dr. Acosta's name and you went on to list three Mexican Americans and three Puerto Ricans. The question in my previous letter, you will recall, was to present to us the names of those educators within NIE who were of Dr. Acosta's caliber. You do not say under Item No. 2 of your letter that these people are of the caliber of Dr. Acosta, but because of the nature of my question, I assume that you have so implied. If this is so, what is your justification for considering these other NIE employees as being of the same expertise in the education of Mexican Americans as Dr. Acosta? In other words, what is your basis for such conclusion and most important what is your rationale for mixing Puerto Ricans and Mexican Americans in the style that you have for answering a justifiable question? Please understand that the problems of

Puerto Ricans are not those of the Mexican American Community. It is, in my opinion, unfair to Puerto Ricans and Mexican Americans for people of your caliber to put these groups in the same box on the basis of Spanish surnames.

Now I would like to get to other specific points mentioned in your letter with respect to three major meetings you have had with Chicano groups. All of these, to me, represent a lot of high salary paid time. Inasmuch as the meetings were "to determine what NIE should do to meet the career education needs of Chicanos," I feel that the following questions are in order:

- 1. How did NIE follow through on all the decisions made at these expensive meetings with regard to the career education needs of Chicanos?
- 2. What should NIE do to meet the career education needs of Chicanos?
- 3. What is NIE's product as a result of all these expensive meetings?

Now, if I may, I would like to go one step further. It was learned at the November, 1973, National Task Force de la Raza Conference in Albuquerque, New Mexico that NIE presently supports only two major R & D plans that relate to the education of Mexican Americans. Of the two, only one (Early Childhood Southwest Educational Development Lab - Austin) has received assurance of funding for 1974. It seems that if NIE is very much interested in the education of the Chicano, that there would be more than two major R & D plans and certainly funding assurance for Bilingual Early Elementary, which is the other major R & D Bilingual plan. Could you please explain why so few Chicano R & D plans are being supported by NIE presently? Also, could you explain why it is that Bilingual Early Elementary has not received funding assurance for 1974? Also, why is it that Dr. Acosta is no longer the Project Officer for the aforementioned R & D plans?

I realize that I have been very candid in this letter, but I just hope that you will appreciate such candor. The only reason I pose all these questions is because of your statement: "NIE is very much interested in the education of the Chicano" which is not in accord with NIE's failure to implement the resolutions as submitted by La Mesa Directiva on behalf of the Mexican Americans who attended the February, 1973 Conference on Career Education - Implication for Minorities. In addition, it is not in accord with:

- Your failure to allow Dr. Acosta to speak at the San Angelo Conference in 1973.
- NIE's failure to recognize and to implement a career education plan that would be specifically designed for serving the needs of the Chicano community.
- NIE's failure to make the existing career education plans appropriate for the education of Mexican Americans.

- 4. NIE's inability to accept or even acknowledge Dr. Alfredo G. de los Santos Jr. proposal on Bilingual Career Education which was proposed as a model possibility.
- 5. NIE's approach to get Mexican American educators to write position papers "quickly without time and without funds."
- NIE's treatment to the papers submitted by Mexican American Educators.
- NIE's failure to implement the major concepts and ideas offered in the papers submitted by Mexican American educators.
- 8. NIE's failure to place Mexican Americans in high level positions.
- NIE's failure to mention bilingual education in the recently published "Grants for Research in Education."
- 10. NIE's Multicultural Task Force failure to produce something substantial for dealing with the education of the Mexican American school population.
- 11. The small number of R & D plans that relate to the education of the Chicano.
- 12. NIE's failure to assure funding for the Bilingual Early Elementary R & D plan which is under the auspices of the Southwest Educational Development Lab in Austin.
- NIE's failure to comply with Sec. 405, Public Law 92-318 which refers to providing an equal opportunity for all.
- 14. NIE's failure to extend an invitation to leading organizations of Mexican Americans to attend the National Council on Education Research meetings (open meetings).
- 15. Your seeing that Dr. Acosta remains as the Project Officer for the two major bilingual R & D plans.

Looking forward to your reply which will be presented to different Mexican American organized groups throughout the nation as well as to Senators who have demonstrated an interest in the advancement and education of the Chicano



Thank you for your letter of May 14 to former Commissioner Ottina on behalf of Aida Barrera concerning the proposals submitted to the Office of Education by KLRN-TV for support of the <u>Carrascolendas</u> program.

As you may know, <u>Carrascolendas</u> was begun in 1970 with a grant under ESEA Title VII, and supported for three consecutive years under that title. In 1973, KLRN decided not to request continued funding under ESEA Title VII, and turned to other funding sources.

The application submitted for the current funding period could not be considered because it was not submitted by a legal applicant. As required by the legislation, legal applicants are one or more local public educational agencies or a local public educational agency applying jointly with an institution of higher education.

In the past, KLRN has received subcontracts through a legal applicant for the <u>Carrascolendas</u> program. For the current funding period, however, the <u>application</u> was submitted directly by KLRN. We regret that it was not eligible for consideration under Title VII.

A second proposal was filed by KLRN-TV with the OE's Division of Technology and Environmental Education. The proposal was hand-delivered to Mr. Clarence Fogelstrom, a DTEE staff member, who gave a written acknowledgement of receipt of the proposal. However, Mr. Fogelstrom also carefully explained that no action could be taken on the proposal at this time as there are no funds available for support of this type of application. The proposal was left and accepted with the understanding that it would be on hand should there be a change in the funding situation.

A third proposal, submitted under the Emergency School Aid Act (ESAA-TV), is now being processed with all other proposals submitted under the "National Cultural" ESAA-TV category. Production awards will be made on the basis of points awarded each proposal by a review panel composed of both Office of Education staff, and non-Government panelists with expertise in areas addressed by the Act.

Announcement of awards will be made sometime before the end of June. You may be assured that all consideration will be given to the proposal submitted by KLRN.

If the Office of Legislation can be of further assistance, please let us know.

Because of your demonstrated interest in and concern for bilingual education, we have taken the liberty of sending you the enclosed materials on CARRASCO-LENDAS, the first nation-wide effort at television for Spanish-speaking children in this country. Although the production of this series is based in Texas, its viewing addience extends throughout the country. Its staff and talent have been recruited from among Puerto Ricans, Cubans and Mexican Americans, as well as from the English-speaking communities. Its recognition has come from international, national, and regional levels. The return, in terms of the federal dollars that have been invested, has been most gratifying. CARRASCOLENDAS has shown beyond any doubt the valuable results that could come from bilingualbicultural education, if this form of education is treated in the right perspective.

Unfortunately, at this moment the funding situation is not very encouraging. Our funds are scheduled to terminate June 30, but all indications are that even if we should be funded, announcements would not come until quite late. This, of course, plays havoc with future plans, maintaining the staff that it has been so painstaking to train, and any recruitment we might want to do. Discretionary funds are available to the Secretary of HEW, and of course, designating a project as worthy of continuation (such as has been done with Children's Television Workshop each year) means that the project is taken out of specific program competition and is assured renewal. At this time, it is our understanding that although Children's Television Workshop has no "official notification" of funding, their office has received the needed "assurance" that \$5 million will be coming their way.

We have enclosed for your information a brochure on the series as well as a copy of the proposal we submitted to the Offcie of Education. This is the third and last proposal which has gone to three different divisions of OE. All are for the same amount of money (approximately \$2 million) and all are for a series of 39 half hour programs. Proposals and their status are as follows:

- 1. Title VII, ESEA, Bilingual Education. Dr. Charles Molina, Director. Submitted February 28 through the Austin Independent School District since proposals in this division are only accepted from local educational agencies and KLRN-TV does not qualify as such. It is our understanding that although the guidelines for grants in this division permit the funding of special programs such as ours, since television is not specifically mentioned, our proposal here doesn't stand much of a chance. Grants in this program generally go to classroom projects. CARRASCOLENDAS was originally funded through this division but our budget has grown considerably larger and since our stature now is national, the project officers here accepted the proposal for review but are offering no hope. We have not heard the results of proposal reviews on this.
- 2. Cooperative Research Fund. Division of Technology and Environmental Education. Walter Bogan, Director. Submitted April 15 directly from KLRN-TV. We were told by this office that \$7 million may become available through this fund. Out of this, some \$5 million have been tentatively committed to Children's Television Workshop for Sesame Street and The Electric Company. Although Children's Television Workshop submit= ted a proposal to this office on the above date, we were told that proposals for the rest of this money were not being solicited. Because of our past history, we went ahead and submitted, making a bid for the amount of money that had no tentative committment. We have not heard from this office as to whether a) they accepted the proposal for review or b) what the outcome of that review may have been.
- 3. Title VII, ESAA-TV. Bureau of Equal Educational Opportunity. Herman Goldberg, Associate Commissioner. Submitted April 29 directly from KLRN-TV after discrepancies were discovered and competition was reopened. We have entered a cultural category in this division and are competing with the California based BC-TV (bilingual-bicultural) and with multicultural proposals for these funds. Proposals are being reviewed and announcement of results may not occur until mid June.

If funding is not assured soon, CARRASCOLENDAS will have to call a halt to its production. Needless to say, that would be most unfortunate. If there is any-

thing you can do to see that the series is refunded for the next fiscal year, we would be most appreciative.
