

My dear Mr. Hill:-

Herewith I enclose for your personal information and guidance a copy of my recent exchange of communications with Mr. Winter regarding a criticism of my action that I found here upon my return from the West.

While I seek, as I think you understand, to accomplish results with the least possible red tape and friction, I have had too long an experience with corporate life not to recognize the important personal responsibility and the value to be obtained by holding each official directly responsible for all that transpires in the Departments over which he has charge.

Referring to the enclosed copy of my letter to Mr. Heidelbach, I would further explain that Mr. McNeil called to see me to-day and gives his positive assurances that he neither has any interests now in this particular scheme of Mr. Wrights nor will he become interested in any enterprise that he would consider antagonistic to the Oregon Railroad & Navigation Company.

Mr. Wright, in an interview here yesterday, declined to pay his acceptance of the draft of G. B. Hunt, which matured December 1st, 1891, and stated his readiness to meet us in

Court for the adjudication of the matter.

We have therefor brought suit in the Supreme Court of this State for the \$75,000 and interest, after having been assured by our expert accountants and by our counsel that the claim is a just one and should be collected.

Dear Mr. WINTER:

Upon my return here I learn that some one has criticized my action in communicating directly with some of the heads of the departments under your administration.

I cannot trace the matter to any definite statement, but wish thus promtpily to inform you that wherever it has been done, it has been pursuant to my understanding with you from the beginning of your administration that you preferred that I tould give my particular attention to matters pertaining to the band and Comptroller's departments.

You may recall my request, in the presence of Mr.Wm.H.Phipps at least, that all my communications should be shown to you, and moreover that copies of my communications to me should be filed in your office for your information and guidance, which latter arrangement you stated on the occasion that I referred to, would be unnecessary.

There has been occasion, of course, from time to time for communications with the legal department, particularly in answer to letters from General Counsel C.W.Bunn, but these have been the exception as my custom has been in most cases to communicate with you directly on all matters requiring the attention of Counsel.

As I confidently believe that if you had an exception to take to my course in this regard, or regretted having arranged this division of attention, you would have mentioned the matter to me, so that your own preferences, even if changed after the experience of a

few months, might prevail, I do not attribute these criticisms to you. I desire, however, to refer to this matter now, so that upon the arrival of Mr. Mellen you can explain to him what has been our custom which is no longer necessary as we now have a Vice President who is expected to give personal attention to many of these matters.
