J.P.M.:

I learned last night through telegrams from President Mellen to parties here that a plan would come up at meeting of Board to exchange two shares Northern Pacific Common for one of Preferred. There are several reasons why this should not be done. First, it would only reduce the stock and bonds to sixty thousand per mile, which is fully ten thousand, or forty five millions, higher than can be defended in any well tried case. Following the Nebraska decision, suits against Iron Range and Rockefeller's roads have been brought in Minnesota to reduce their rates one half. Neither Mellen nor the members of Northern Pacific Board appear to realize the gravity of situation.

We must ask you as our Trustee as shareholders of the Northern Pacific and holders of the agreement made in London two years ago to take steps which will put an end to the consideration of plans which are not desired by the owners of the property nor for its material good. The Company has had one prosperous year, but is still in position where its future could be destroyed. Kindly postpone all discussion, and I will shortly submit for your consideration plan which will be feasible and reduce capital to basis where it can pay six or seven per cent on stock, and I must ask that we be advised reasonably in advance of any important matters to be brought up at Board.
