Dear Sir:-

I enclose herewith statement showing that there is still due us on account of the batteries sold you through Mr. Wm. Hood of Chicago in July 1891, which were duly shipped you in August 1891, a balance of \$4,305.00. By the terms of the agreement of sale we were to receive one half payment upon delivery of the batteries and the balance when same were set up. We received from you in October 1891, \$4,305.00, the cells having been delivered prior to that date, and as we were informed by the Construction Co. having charge of the installation, that they were set up during the week ending February 20th, 1892 payment of the balance should have been made at that time. We so wrote you on February 29th., but received no reply, and we have since that time written you asking you to kindly communicate with us in the matter.

We are very much in need of funds and as five months have elapsed since the final settlement under the agreement of sale should have been made, we feel that payment should not further be

delayed and trust you will kindly favor us with a check covering the balance due February 20th, 1892, at an early date.

As the amount is quite a large one and such a long time has elapsed since its due date of payment, we think settlement should include interest from February 20th, and we hope you will cover same in your remittance.





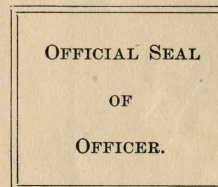
