Dear Mr. Hill:

I wrote briefly last evening and wired you that I had succeeded in making the deposit of \$600,000. in Am. Ex. Nat'l Bank, N. Y. for credit of Merchants National Bank, St. Paul, as directed in your telegrams of October 12th and 14th. The Chase Bank made the deposit. We had \$300,000. there and fortunately about \$100,000. came in from Skinner by cable, making \$400,000, which was all the cash we had in hand, and for the balance of \$200,000. I overdrew our account and will pay one day's interest on the overdraft. This morning Mr. Schiff was away (as usual with him Saturdays) so could not do anything there. I found my unexpected demand on the Chase drew down their reserve, and to put them in fair condition have just borrowed \$180,000. from Tod and \$100,000. from C. T. Co., not having anything to spare in the Manhattan over interest requirements. For convenience, these matters have for the present been arranged in the Company's name but will not appear in the Company's account sent to Mr. Warren until I hear definitely from you how they are to be carried. I may therefore hold back my daily statements for a few days and if Warren wires for them I will refer him to you. You might wire me on receipt

of this whether you wish to carry this transaction in your individual name or in the Company's.

I have no message from you to-day in answer to mine of yesterday, asking how long you are likely to need this money. I think you will do better to make time loans if you are likely to require it very long.

I shall see Mr. Schiff on Monday and will then endeavor to get this business into good permanent shape.

It is rather difficult to arrange a matter like this payment of \$600,000. at 3:30 P. M. on Friday, which is practically the end of our week here, but we managed it.
