From
Higgins & Young
Winnipeg.

To J. J. Hill Esq

June 7. 77 St Paul

Dear Sir

We send by this mail
to Mr. Kittson Esq P/L & claims.
When in St. Paul Mr. Young
had some conversation with
Mr. Kittson about rebate on car
load lots - as flat boats were
offering on such lots, and Mr
Kittson requested him to send
all P/L of car lots - from Canada
as well as St Paul - we have
done so - having three more
car loads in transit at same
time which we will forward as
soon as arrival of P/L them
Many of our merchants had
quantities of heavy goods sent

forward by flat boat, but
 relying on a rebate as did
not do so though offered some
 low figures on heavy loads —
 Will you kindly look into this
 and see Mr. Kittson in reference to
 it. We also send some other claims
 but they are simply tracers more
 than anything else to find out where
 shortages occurred. Can you do
 anything in salt or coal or oil?
 duty on salt is 12 per 100 coal
 oil 6 per win. gallon. We generally
 buy in Duluth — car loads —
 Hoping to hear from you soon.
