Mr. Louis W. Hill. St. Paul, Minnesota My dear Mr. Hill:

I received your letter this morning and was very glad to hear from you. The Indians and myself on this reservation who adopted you some years ago and named you "Fast Bear" begin to think that you have given us the shake entirely but I told them that you had so much to do that you hardly had time to stop off and visit us. An Indian by the name of Feather Ear King who was in the Custer Massacre and had two brothers killed by the Seventh Cavalry still lives on this reservation. He has been painting as near as he can recollect the way the camp was and how the troops charged the camp and Reno's retreat. As soon as he finishes this painting I intend to send it to you to go with the other relics that I have presented to you. It seems that you don't understand what I want you to do for me. I told you once in one of my letters that I may throw my hat in the ring this fall for Office in this county and that I want you to write to some of your railroad men at Wolf Point to do what they can't for me. I am doing very nicely at my old job and Senator Walsh has had my pension increased to \$20.00 per month.

I was the first Indian on the Fort Peck Reservation about six years ago that threw his hat in the ring for constable and I have held this job now for six years with my Government job. A great many of my friends wants me to throw my hat in the ring this fall for sheriff in this little county and I am thinking of doing so on the "Independent or Socialist ticket. Now I don't want you to fail in writing to some of your friends in Wolf Point to leg for me . I must close with kind regards, I am your old friend,

Dear Mr. Grinnell:

Your letter July 17th. If you will give me copy of any Bills that have been passed or presented to Congress that are of the nature covered by your letter, that is, to seriously interfere with the use of the National Parks, I would be very glad to interest myself, but I do not wish to become interested in possibilities of such legislation if there is nothing passed or nothing pending.

Frequently these movements get started when there is nothing to justify them. I expect to meet the House Appropriation Committee at Glacier Park within a week and will then have a good opportunity for bringing this matter up, if there are any bills passed or pending.
