Herewith four photographs showing status of work Waterton Lakes Park Hotel as of February 24th.

You will note roof is not yet completed on the central portion. The work has not progressed as well during the winter as we had hoped it would.

Work on the central part of the building was held up from the middle of September to the end of October by reason of change in plans. This prevented getting the central portion inclosed at the same time the two wings were inclosed early in December.


On December 10th there was a violent wind storm which did considerable damage and set the work back some.

Since December 20th the road to Cardston has been blocked with snow drifts and hauling has been done from Hill Spring, the station nearest to the hotel site from the C. P. R. new extension, Cardston to Glenwoodville.

February 13th to 16th there was a snow fall of about three feet which drifted badly and tied up the road so that no hauling has been done until within a few days past.

All of these things have delayed the work to such an extent that it is doubtful now whether the hotel can be opened at the time expected, about July 1st, all depending upon weather and road conditions from now on.

Mr. Harry Kask:

Referring to your inquiry of this morning in regard to the laundry and power house fire at Glacier Park:

First advice we had in regard to this was a call on the telephone from General Superintendent Smith at 3:15 P. M. on March 18 advising that the power house and laundry were on fire and burning at that location. Subsequently, we were advised that they were a total loss.

Local employees of the railroad were promptly on hand to render every assistance possible, but there was no chance of saving the property once the fire had started, and their efforts were largely devoted to see that the Hotel did not catch afire. We have not as yet been able to locate the cause of the fire.

The buildings and contents were insured for \$33,000.00, which our people feel will fully cover the loss. Arrangements are being made to build a new power house and laundry, the location of which *Mr. Hill* you have been advised through the President.

REGULATION NO. 13

Purchase or Sale of Beer Upon Licensed Hotel Premises.

(a) No license to sell beer in respect of a hotel shall be issued or granted unless the hotel contains, subject to the provisions of the Act, the following number of bedrooms:

In cities having a population of 15,000 or over - 35 or more bedrooms.

In cities having a population of not less than 7,000 and not more than 15,000 - 25 or more bedrooms.

In cities, towns or villages having a population of not less than 1,500 and not more than 7,000 - 20 or more bedrooms.

In towns, villages or other places having a population of not less than 500 and not more than 1,500 - 15 or more bedrooms.

In towns, villages, hamlets or other places having a population of not less than 200 and not more than 500 - 10 or more bedrooms.

In other places - 8 or more bedrooms.

(b) No person under the age of twenty-one years shall be employed in any service in connection with the sale, handling or serving of beer in, on, or about licensed hotel premises.

(c) No application for a beer license in respect of a hotel shall be considered by the Board where the proposed beer salesroom is located in any other portion of the

hotel than on the main or ground floor.

(d) Any cellar used for the storage of beer in connection with the sale of beer by a hotel licensed in respect thereof, shall be immediately below the room where the beer is sold, and such cellar shall have no means of communication with any other room or with other portions of the cellar, but shall be directly connected with the room where beer is sold, and shall form a portion of the premises covered by the license.

(e) No foodstuffs, lunches or meals shall be sold, given or served to any person in any room where beer is sold in or on any part of the premises in respect of which the license is issued:

Provided, however, that the Board may give special authority to a Licensee to serve foodstuffs, lunches or meals in such room or part of the premises in respect to which the license is issued, during certain specified hours, during which hours the Licensee shall not by himself, his servants, agents or employees, sell or permit to be sold or consumed any beer. Such special authority shall be endorsed upon the license, and shall not be effective until so endorsed and signed by the Chairman of the Board.

(2) Subsection (1) of this Regulation shall not apply to such room or part of premises during any period or periods during which the Licensee has such special authority.

(f) No licensee, his or her servant, employee, agent or any member of such licensee's family shall consume beer upon the licensed portion of the hotel premises during the hours and times for which such sale or other disposal of beer is prohibited under the provisions of the Act.

(g) Any licensee shall be held responsible for the acts of his or her family, servants or agents upon the licensed portion of hotel premises.

(h) No female other than a licensee or the wife

of a licensee shall be employed in any service in connection with the sale, handling or serving of beer in, on, or about the portion licensed for the sale of beer in any hotel premises.

(i) No person other than the licensee or the wife or employee of a licensee shall be permitted to be in that portion of any hotel premises licensed for the sale of beer, at any time during the periods from nine o'clock on Saturday night until seven o'clock on Monday morning, and from ten o'clock at night until seven o'clock on the following morning on the other days of the week, nor at any time during any period when the sale of beer is prohibited on such licensed premises, and during such hours and on such days as the sale of beer is prohibited, all shades or other obstructions on the windows of the beer room, must be so arranged as to permit of the whole of the interior of the said room being visible from the exterior by a person standing on the ground level adjacent thereto.

(k) No person shall consume beer, and no person shall be permitted by a licensee or his employees to consume beer, in that portion of any hotel premises licensed for the sale of beer, during any period mentioned in subsection (i) of this regulation.

The loss has been adjusted with the insurance company for \$33,479.72, this company assuming the first \$500.00. We will receive a check for the balance of \$32,979.72.

From the foregoing you will note that the total insurance carried with the exception of \$170.00 on the building was collected. I think we can in addition to the foregoing, recover about \$1,000.00 on salvage equipment remaining.

The building adjustment was made on the basis of a life of 45 years and I think considering weather conditions in Glacier Park that this is a very reasonable depreciation basis.

The equipment has been adjusted on the basis of 3-1/3% depreciation per annum. Authorities on depreciation of machinery say that property of this kind has a life of from 15 to 25 years. It is true that our machinery was used only approximately three months each year, but some obsolescence would also be there so that I think a rate of 3-1/3% has been a very favorable basis for this adjustment.

The adjustment was negotiated by Mr. J. H. Kaufmann, Auditor, Insurance Bureau. He received very valuable assistance from Mr. J. R. W. Davis' office, Mr. H. A. Noble's office and from Mr. Otto Thompson, Engineer for the Hotel Company at Glacier Park, Montana.
