My dear Mr. Donnelly:

Referring to your letter of March 30th, enclosing copy of letter to you from Mr. Hill about taxation in Yellow-stone Park.

When the State of Wyoming was created, the territory comprising Yellowstone Fark within Wyoming was specifically withheld from the State of Wyoming, and exclusive jurisdiction over the Park given to the Federal Government. When Montana was created as a state, the territory lying in the State of Montana was not specifically withheld from the State, but in the first session of the Montana Legislature, after the state was created, the State passed in 1891 an act granting exclusive jurisdiction to the Federal Government over that part of the Yellowstone Park lying within the boundaries of Montana, so that in the case of Yellowstone, the Federal Government has exclusive jurisdiction, and the states have no right to tax personal property. In other words, Yellowstone Park has always been Federal territory.

In the case of Glacier Park and practically every other national park, the land has originally belonged to the state in which the park is located, and in turning the land over to the Federal Government, the state has withheld the right to tax the personal property in the Park.

Trusting this gives you the information desired.
