Ica Jan. 1918. Report for year 1917 MINNESOTA WOMAN SUFFRAGE ASSN. Mrs. Andreas Ueland, Pres. THE MINNESOTA WOMAN SUFFRAGE ASSOCIATION at its Annual CONVENTION held in Minneapolis in December, adopted unanimous resolutions endorsing the policies of the National Association, and declaring its intention of carrying out as far as possible the plans outlined by the National Association in organization, circularization, Congressional work, press and finances. It was voted that we should try to raise the \$30,000 apportioned to Minnesota as its part of the National Budget of One Million, and of that to send \$3,000 to the National. At the Convention luncheon at the Radiscon Hotel, at which Mrs. Nellie Mc Cling was the guest of honor, and the principal speaker. \$8,000 was pledged towards this sum. THE WAR interfered with many of these plans. Our women have been among the foremost in war activities, and have not been able to give as much time to suffrage as heretofore. THE WAR POLICY adopted by the National Council at its meeting in Washington in February was endorsed by our State Board. WAR SERVICE in Minnesota has been co-ordinated under the State Safety Commission and the Woman's Auxiliary Committee and our association has co-operated with these committees. Several of our local associations have opened RED CROSS HEADQUARTERS, among them the Hennepin County Association, and the Faribault Suffrage Club. THE RED CROSS WORK of the Hennepin County Association has been one of the most important in the state. Classes meet daily at their headquarters on Nicollet Avenue. There are sixteen circles working under itsdirection and 14,000 finished articles have been turned out. PRESS WORK. Our Press Chairman, Mrs. Walter Thorp, sends plate matter to 150 papers. She answers all editorials written either for or against suffrage. Bulletins are sent to officers and workers in the state. She takes care of suffrage publicity in Minneapolis continuously; has furnished news to the Woman Citizen and furnished articles and photographs for all important state activities such as the Duluth Conference, Dedication of the Woman Citizen Building, the White Elephant Sale and the Garden Party. We held our first WHITE ELEPHANT S ALE in Minneapolis in November. It was a glorified rummage sale and attracted thousands of people. \$2700 was cleared. St. Paul held a similar one later which was also successful netting about \$1700. It is the intention to make these Annual affairs until suffrage is won. A successful Conference was held in Duluth in April, the women from the Twin Cities going in a chartered car. Mrs. Catherine Waugh Mc Culloch of Illinois wad Professor Maria Sanford were the principal speakers. LEGISLATION. A Presidential Bill was submitted by our Legislative Committee to the Minnesota Legislature. It was defeated by a vote of 31 to 35 in the Senate. A constitutional amendment was introduced by a representative and passed the lower house by a vote of 85 to 41. This amendment was defeated in the Senate by a vote of 14 to 49. EFFIE MC COLLUM JONES in the state for the month of May. She spoke to approximately 10,000 people, succeeded in getting 670 new members and raised \$480.00. She spoke of suffrage and war service in twenty-six towns, often speaking two and three times in one place, and made many enthusiastic friends for our cause. The president and Mrs. Summer T. Mc Knight were delegates to the MISSISSIPPI VALLEY CONFERENCE. in Golumbus, Ohio. A GARDEN PARTY was held at the home of the president in August, at which \$800.00 was raised. WOMAN CITIZEN BUILDING. The Scandinavian Woman Suffrage Association pledged money to build a booth on the State Fair Grounds for the use of suffragists. They were successful in this effort and the very attractive and convenient "Woman Citizen" Building was dedicated and turned over to the State Association. It was decided that as suffrage might be won within a few years that the house should be for the use of the Woman Citizens of Minnesota, and so it was called the "Woman Citizen Building". A tablet in memory of Julia B. Nelson, one of the earliest and most noted Minnesota Suffragists, was placed over the fire place. The chief speakers were Prof. David Swenson of the State University and Professor Maria Sanford. CONGRESSIONAL WORK. The Association has endeavored to Carryfollow as closely as possible, the plan of the National Board for the Federal Amendment Drive. Each congressional district has a chairman and chairmen have been appointed in many counties. Organizers have been working in our four doubtful districts and petitions have been circulated. REGULAR MONTHLY MEETING of the Executive Board of the Minnesota Woman Suffrage Association, January 5, 1918,10:00 A.M. Mrs. Farmer's office, Old Capitol, St.Paul. Present Mmes. Ueland, Noyes, Thorp, Farmer, Burt, Forrestal, Holman, Stockton, Simpson, Paige, Guise and Dr. Hurd.

Minutes of the December meeting were read and approved.

The secretary read the treasurer's report which gave a balance of \$545.57 December 31st.

Bills to the amount of \$239.92 were approved by the Board and ordered paid.

Dr. Hurd seconded by Mrs. Holman, moved that the quarterly pledge of \$375.00 to the National be paid. Carried

A report of the work of Miss Heckrich, the office secretary, for the past month was read. 1058 pieces of mail matter were sent out from state headquarters.

A list of the signers of the Suffrage Memorial sent to Washington was read. The list included only men of Minnesota who have national reputations, and is a splendid one.

Mrs. Thorp reported for the press committee that she had prepared a letter answering Mrs. Wadsworth's charge that the New York victory had been put over by un-American vote, and that this letter had been sent to Minnesota and New York papers. The press committee reported 781 letters sent out in the last month.

a week and was putting out twice as much work as any other unit in Minneapolis. The last week 60 sweaters and 30 pairs of socks were turned in.

Dr. Hurd announced a course of ten lectures at \$1.00 for the course to be given by Dr. Anna Hurd for the benefit of the treasury of the Political Equality Club.

Mrs. Forrestal reported a favorable interview with Mr. Raths concerning the vote of Congressman Van Dyke on the Federal Suffrage Amendment.

Mrs. Ueland reported that as a result of interviews while in Washington with Minnesota legislators she felt that most, possibly all, of the Minnesota delegation, would vote for the amendment. Mrs. Ueland asked the Board members to write Mr. Lynch asking him to use his influence to get the Democrats to work for the Federal Amendment.

Mrs. Stockton reported her activities in the third district getting local men to write Congressman Davis, and work with the petitions. A fine suffrage editorial from a Faribault paper was read.

Mrs. Ueland announced that Minnesota had pledged 100 subscriptions to the Woman Citizen at the convention. Mrs. Ueland told many things of interest from the convention, and suggested that a meeting for reports of delegates would be arranged.

Mrs. Thorp, seconded by Mrs. Simpson, moved that for the present the old year book with corrections attached be used instead of new ones being ordered.

Mrs. Farmer was asked to send copies of the Shafroth speeches to a list of Republican and Democrats furnished her.

The minutes of the January meeting were read and approved.

The treasurer reported a balance of \$309.38 February 1st.

The auditor reported that she had made the quarterly inspection of the treasurer's books, required by the constitution, and had found them correct. Report was accepted.

A report of the office secretary's work for January was read. The early part of the busy month was spent largely in work for the passage of the Federal Amendment. During the month there were sent out from the office approximately 275 pieces of mail matter.

Mrs. Holman reported that the work of the Ramsey County
Suffrage Red Cross Unit is progressing satisfactorily, and that
the Ramsey County Suffrage Association is uniting with other St.
Paul organizations to secure the appearance on Feb.21st of Miss
Helen Fraser to talk of "English Women and War Work."

Mrs. Simpson reported that the Hennepin County Association had voted to keep its quarters on Nicollet, and will soon start the serving of weekly conservation or "Liberty" lunches with patriotic talks to the lunchers.

Dr. Hurd suggested that a Suffrage Pageant and lecture by

Dr. Stevens of the University might be used for propaganda and revenue. It was left for the consideration of the finance committee at some future time.

The secretary read many letters of congratulation to the association through Mrs. Ueland, upon the passage of the Federal Amendment in the House. The present status of the Amendment in the Senate was explained through letters from Mrs. Catt and others. The bill will come up whenever the suffragists are ready, and the outlook for its passage are bright, but suffragists are gists are urged not to neglect doubtful senators.

Mrs. Ueland suggested that if the Amendment passes and
Minnesota has a special session of the legislature to enfranchise
the soldier, our state would be one of the first to vote upon
the amendment.

The secretary was instructed to reply to the invitation of the W.C.T.U. to the State Suffrage Association to become a member of a Dry Federation, that it was the unanimous opinion of the board that it had been a wise policy for the Suffrage Association not to take action upon the issue. Suffragists as individuals will work for the measure.

Mrs.Paige seconded by Mrs.Holman, moved that we revise the Suffrage Advisory Board. Carried. Mrs. Ueland asked Mrs. Stockwell and Mrs.Guise to take care of the revision.

A letter was read from the Board of the Scandinavian

Woman Suffrage Assn., presenting the name of Mrs. Luth Jaeger for Chairman of the State Fair Committee. This was in reply to a letter from this association asking for a suggestion as to this chairmanship.

Mrs. Paige, seconded by Mrs. Stockwell, moved that we defer action upon this for a month. Dr. Hurd amended this to read take under advisement. Accepted. Carried.

At the close of the business meeting the board members were the guests of Mrs. Ueland at luncheon. Adjourned.

Since the last Mational Convention, the Minnesota Woman Suffrage Association has followed the policy and plan of work as outlined by the National American Woman Suffrage Association. ORGANIZATION: In organization work our aim has been to insure the ratification by our legislature of the Federal Suffrage Amendment. In pursuance of this end, while not abondoning the national plan of organization by political divisions, intensive effort has been directed toward securing in every city and village and country township, as far as possible, ratification committees whose function it has been to circulate literature, promote an understanding of what and why the Federal Amendment and to secure the signatures of a majority of the adult members of their communities to petitions to the legislature. During the year four organizers have been employed; Mrs. Jumes Forrestal, Mrs. John M. Guise, Miss Grace Handall and Mrs. Rene E.H. Stevens. Though unprecedented difficulties have confronted our Association in the war's demands, the long distressing siege of influenza and the devastating forest fires of Worthern Minnesota, we have been able to maintain from one to four workers in the field. Every Legislative District is now organized. There are working committees in 480 cities and towns outside the three large cities, Minneapolis, St. Paul and Duluth, where organization is most active. Fifty cities and towns have gone over the top with their quota of petitioners, and the total number of signers to petitions is so far about 90,000. PROTESTS TO UNITED STATES SENATE: A week of protest against the Senate's delay in acting upon the Anthony Amendment was conducted throughout the State in May. More than 100 resolutions were passed by organizations representing Educational, Social, Industrial, Political, Religious and business interests and activities. Scores of letters and telegrams were sent to Washington, and great numbers of editorials, articles, and interviews were published in the newspapers of the State. OVER REAS HOSPITAL: The Minnesota Association pledged \$2,000 to the support of the Women's Oversea Hespitals and on May 29th launched the drive for funds at a luncheon given at the Radisson Hotel. The principal speaker was Mrs. James Morrison of Chicago. Amount pledged \$2,000. Total remitted to the Women's Oversea Hospitals \$2,846.25 No sensational or picturesque campaign of any kind PRESS WORK: has marked the activities of the Press Department of this State for the last year. On the other hand, there has been a steady attack on the country papers in the shape of propaganda for Federal action. At the time of the protests from all over the country on the delay of Federal action six months ago, the country and city press was called into action and responded nobly. It was put over plate or feature suffrage material which was not directly allied with war work. However, plate matter was sent out and widely used on the Suffrage Oversea Rospitals. found necessary, through the time of the war, to desist from any attempt to During the first six months of America's participation in the war, Minnesota's Press Chairman, Mrs. Walter Thorp, acted as Press Director of the Woman's Committee of the Council of National Defense for the State. During the year about 130 papers have been added to the declared prosuffrage and pre-federal amendment file of Minnesota. This was accomplished by a canvass of all papers not already declared. At present, the State roll of pro-suffrage papers is very close to 400 and includes practically every paper worthy of consideration in the State. In the recent fight in this State to avoid a State referendum, a constant stream of material giving reasons for opposition to a State Amendment

Automobile Trip of March 23rd & 24th, 1919.

For the purpose of stimulating and crystalizing suffrage sentiment in some of the rather indifferent counties of Minnesota, an automobile trip was arranged for March 23rd and 24th, 1919. The tour was taken in two cars, one contributed by Mrs. Geo. H. Partridge and the other by Mrs. Augustus Searle.

The personnel of the party was as follows:

The expedition left Minneapolis at 8.00 A.M. arriving at Hastings at 10.00, when a very satisfactory meeting was held in the Community Center hall. Mrs. Ueland giving a general suffrage talk, Miss Wells on Petitions and Mrs. Forrestal a resume of the suffrage work in 1919 Legislature.

The next stop was hed Wing. On arriving there a group of women met the visitors from Lake City when the next stop was scheduled. A luncheon in Red Wing at the St. James Hotel had been arranged by the local Committee and the lobby was crowded by the suffragists and their friends. When the auto party arrived, one hundred women were seated in the beautifully decorated dining room, the same program of speeches was carried out and a gratifying complimentary reception accorded the suffrage leaders. The arrangements were in the hands

SUFFRAGE VICTORY CELEBRATION June 9, 1919.

the suffragists of Minnesota, believing that the passage of the Federal Suffrage Amendment could not well be long delayed, began making plans for a celebration to take place just after its passage. When the vote on the Amendment was set for October 1918, permission was obtained from the State, to use the Capitol steps for staging a simple pageant, to be followed by a program of talks by men and women of note. Speakers were secured and the pageant was rehearsed, only to have the Amendment fail of passage by two votes. Later on, Feb., 10, 1919, a second vote was taken and the bill failed by one vote.

It is interesting to note that our National lobby at this time was optimistic and confident, but that the bulletins from Mrs. Catt and Maud Wood Park never said that a favorable vote was a foregone conclusion. Only in the bulletins issued just before the passage of the Amendment, did the National leaders tell us that the passage was certain. This has been proof of their sound judgment and close grasp of the suffrage situation in Congress.

Suffragists were not napping when the Amendment finally did pass. With the state executive Board as a committee, plans were made that could be carried out

a few days after a favorable vote should be taken. The 68th Congress called in Special Session, passed the Anthony Amendment on June 4, 1919, and on the 9th, suffragists held their jubilation. Chairmen of Committees were:

The plans were for the Minneapolis people to come to the Capitol in a monster auto parade. Mrs. Schwartz worked out a simple uniform decoration for cars, and 250 autos representing almost as many organizations pledged to parade. St. Paul suffragists were to parade in autos to the Capitol to await the Minneapolis delegation. The Capitol was beautifully decorated in yellow and white on its exterior and the steps were marked off for delegations, speakers, bands and crowd.

At five o'clock the heavens opened and the rain came down in torrents! Violent showers alternated by drizzle continued thru the evening. And the remarkable fact to record is not that the parade suffered in size or enthusiasm, but that in spite of rain a big auto parade was staged, and a thrilling celebration held in the rotunda of the Capitol. Of course, the parade lost in the spectacular element since the gay decorations were hanging in rain soaked strings, but the thrill to the real suffragist was increased at seeing that there were 250 autos driven and about 3000 people for whom the joy of the victory was so great that nothing could keep them from the celebration.

REPORT OF OFFICE SECRETARY June, 1919

Much of the work of the Office Secretary during June was in connection with the passage of the Federal Amendment and the celebration held at the State Capitol, June 9th.

A bulletin concerning the celebration was sent workers thruout the state on June 5th. On June 10th, two bulletins were issued to the editors and workers of the state, one on the celebration, and the other on the National Pollicy concerning ratification by the states. A third news bulletin was sent 590 workers in the state in re the ratification by the states, and the work to be done in our own state to create sentiment for a special session. With this last was enclosed a printed leaflet on the League of Women Voters.

Letters were sent all the members of the Legislature, asking their opinion on a special session for ratification, a careful record being made of all replies as they came in.

Besides the regular office routine of writing letters, filing, clipping newspapers, sending out checks andreceipts, and typing minutes of meetings, copies were made of Opinions on the Presidential Bill, the History of the 1919 Legislature typed, and copies of the Resolutions adopted at our Victory Celebration were sent Minnesota Senators and Representatives in Congress, to the Governor, and newspapers.

Approximately 1470 pieces of mail matter were sent out during the month.

HISTORY OF THE 1919 LEGISLATURE

The assembling of the 1919 Legislature found the suffragists of Minnesota in a very hopeful frame of mind regarding the probability of the passing of the Anthony Amendment by Congress, and the subsequent ratification by our state Senate and House.

As the days went by and impatience increased, it was decided to ask the Legislature to memorialize the U.S. Senate urging them to speed up the passing of the Federal Amendment. This was a more serious undertaking than appeared on the surface, for the vote asking Washington to pass the bill, was equivalent to a vote for its ratification, for no man would ask Congress to vote for a bill, he himself would refuse to endorse.

So our State President most carefully planned and executed a poll of both Houses on this measure. As there were 134 in the House and 67 in the Senate, and so many new faces and names, it was no easy task, and had to be done with infinite tact and diplomacy. The result was satisfactory and the resolution was introduced in the House by Theodore Christianson January 13th and passed January 22d by a vote of 100 to 28 and in the Senate January 23rd by a vote of 49 to 7.

Meanwhile it became apparent that a group of women were trying for State Amendment. This was hardly credible in view of the recent failure of a state amendment for Prohibition which seemed to clearly and definitely settle

any doubt there might have been of the possibility of altering our very different state Constitution on any debatable question.

But carried on by the wave of sentiment created by the passage of the Resolution to Congress, the House passed a State amendment bill introduced January 9th by C.H. Warner of Aitkin and passed House January 22nd by a vote of 96 to 26. Suffrage experts agreed we could not win such a measure, and it was reluctantly agreed by the State Board to try to defeat the bill in the Senate. Organizers were sent into many districts to bring pressure to bear on Representatives from the constituency to vote against, what to the uninitiated seemed to be a suffrage measure, but in reality was against the best interests of the cause. It was the most difficult and exasperating task the organization ever confronted altho nothing could have demonstrated the strength of the organization as the result of the campaign did. The bill was defeated in the Senate by indefinite postponement by a vote of 40 to 21, February 28, 1919.

The Presidential bill which had been held in abeyance until all other suffrage measures were clared away, was then brought forward, having been introduced by Theo. Christianson, January 23d and passed the House, March 5th by a vote of 103 to 24.

Up to this point nothing was heard from the Antis. But on the passage by the House of the Presidential bill a hearing was asked for by the Antis before the Senate Elections Committee, hoping to balk the bill in the Senate. The

hearing was granted and an ineffectual effort made to defeat the bill, but on putting it to a vote in the Senate the bill passed March 21st by a vote of 49 to 11. After a few days delay the Governor signed the bill-March 24, 1919.

The lobby at the Capitol covered a period of nearly three months and was conducted by our State President with the greatest tact and diplomacy.

Thankful she lived to see her life work so nearly completed. She has made a great contribution to history of our time. Spend what seems fitting to you for flowers up to \$25.00".

Resignation of Mrs. A.M. Burt from Board was read.

Mrs. Thorp -seconded by Mrs. Bennettmoved that resignation be accepted. Carried.

Mrs. Ueland appointed Miss Wells state chairman of petitions. Mrs. Harrison seconded by Dr. Hurd moved that appointment be approved. Carried.

Mrs. Bennett moved that discussion of petition work be postponed until Miss Wells' return.

Moved by Mrs. Farmer, seconded by Harrison that we send resolutions of sympathy to Miss Shaw's three nieces. Carried. Mrs. Ueland appointed as committee to draw up resolutions: Mrs. Stockwell and Dr. Hurd.

Mrs. Thorpe seconded by Mrs. Holman moved that we return the building at the Fair grounds to the Scandanavian Clubs.

Mrs. Throp withdrew her motion with consent of second.

Mrs. Thorp moved that Mrs. Ueland, with some members of

Board, have a conference with members of Scandanavian Clubs,

regarding disposition of Woman Citizen Building. Carried.

Dr. Hurd seconded by Mrs. Bennett moved that action of president in telling Mrs. Catt that our Association would join other state Associations in backing League of Nations if she thinks wise. Carried.

Meeting adjourned.

Office Secretary's Report July - 1 9 1 9

The attention of the office secretary for the month of
July has been directed toward sending a second letter to
members of the Legislature regarding a special session;
notices were sent persons pledging subscriptions to the
National Association at the St. Louis Convention, and also

at our May Conference. Quite a few have responded to these
letters, either by sending checks or by telling just when

Carried.

Mrs. Forrestal, seconded by Mrs. Simpson, moved that in view of calling a special session, we give up petition work for state. Carried.

Mrs. Forrestal reported the visit of Miss Shuler and Mrs. South of the National Association to Minnesota to interview the Governor and learn results of his telegrams to other governors regarding special sessions. After conference with Governor. Miss Shuler telegraphed Mrs. Ueland:

. "Information (re special session) still confidential.

Governor will make public announcement soon as possible."

for display of handicraft, distribution of literature, etc.

Mrs. Simpson, seconded by Mrs. Farmer, moved that we ask
National to send us 40 booklets of Memorial Service for Dr. Shaw,
and that we order 100 besides.

Mrs. Simpson, seconded by Mrs. Farmer, moved that the State participate in the plan for giving a memorial to Mrs. Catt, to be presented to her at next national convention. Carried.

Mrs. Forrestal, seconded by Mrs. Guise, moved that \$100 be raised for this purpose, -\$40 from Hennepin County, \$30 from Ramsey County, and \$30 from rest of State, and that copy of Mrs. Halsey Wilson's letter explaining the plan for this personal gift to Mrs. Catt, be sent the chairman of each county with an invitation to contribute to fund. Carried.

Mrs. Forrestal, seconded by Mrs. Simpson, moved that Miss Wells be appointed to position of Director in place of Mrs.

Burt who resigned. Carried.

Adjourned.

Ratification of Federal Suffrage Amendment.

On Monday September 8, 1919 the Minnesota Legislature, conveningin special session, made the ratifying
of the Federal Suffrage Amendment its first legislation.
The bill passed was one drawn up by the Attorney General,
Mr. Hilton, at the instigation of Mr. Sageng, Mr. Putnam and Mr. Christianson. It was introduced by Mr.
Christianson in the House and passed 120 to 9.Half an
hour later it passed the Senate 60 to 5, making Minnesota
the 15th state to ratify.

The Minnesota Woman Suffrage Association served a chicken dinner to the legislators in the cafe run in connection with the Capitol.

The passage of the Amendment was so certain that suffragists from all over the state had, in response to invitations from the Minnesota Woman Suffrage Association, come to St. Paul to celebrate. Minneapolis women came in procession of autos gayly decked with yellow flowers. In the rotunda a registration booth for outof town guests was placed. Here also were distributed the yellow flowers worn by the women and legislators.

A dinner complimentary to the out of town guests was given at the St. Paul Hotel at 7 P.M. There were present 108 out of town and 180 St. Paul and Minneapolis guests. Mrs. Ueland presided and the following men and women spoke:

Parts FILE COPY Organization Conference for the Minnesota League of Women Voters Minneapolis, Oct. 28 - 29, 1919 Immediately after the Minnesota Legislature in special session ratified the Federal Suffrage Amendment on September 8th, plans were begun for establishing in this state a branch of the National League of Women Voters. It was decided to have a general conference for the purposes of organization and of arousing public interest, and, after some consultation with national headquarters, the dates were set for October 28th and 29th. A Temporary Committee on Conference and Organization was appointed. Members were: - Mrs. James Paige, Chairman Wead Mrs. Andreas Jeland, Ex-Officio Miss Gladys Harrison, Secretary Mrs. Milton D. Purdy X - Mrs. A.W. Strong - Mrs. Walter Thorp -Miss Marguerite Wells -Mrs. Stiles Burr (Same) Miss Anita Purness X-Mrs. W.T. Coe -Mrs. A.L. Searle -Miss Hope McDonald (?) The first regular meeting of this Committee was held October 7. when preliminary plans for the onference were presented by the Chairman, and chairmen of sub-committees appointed. Calls Preliminary programs of the Conference and letters urging attendance were sent by their respective presidents to the mailing lists of suffrage associations as follows: State Suffrage Association Hennepin County Suffrage Association 1100 Hamsey County Suffrage Association It was felt that this call must reach a far greater number of women in the state than had ever been affiliated with suffrage work. To this end, the interest of the presidents of various organizations was enlisted and the Committee undertook to prepare letters urging attendance and the appointment of delegates. These letters were signed by presidents of organizations and sent to their mailing lists. This plan was followed in the case of the State Federation of Women's Clubs, the Degree of Honor, the Woodmen's Circle, and the W.C.T.U. In addition similar letters were sent to 1200 farmers' clubs scattered throughout the state and to various special lists such as former county chairmen of the Council of Defence, etc. It is estimated that a total of about 5500 calls were sent out. (3600 by state office).

-2-Publicity Mrs. Thorp, Chairman Generous publicity including Sunday feature stories, was given to the new League and to the Conference by the local papers, which also carried full accounts of all sessions throughout the Conference. Notices were also inserted in church, school, and club bulletins, and programs of the onference were placed in branches of the Minneapolis Public Library for distribution. Window cards, to the number of 300, were placed in Minneapolis and St. Paul, and street car cards were carried in Minneapolis and Interurban cars for four days. Local Arrangements Mrs. A.W. Strong, Chairman The work of this committee was carried out through a large number of sub-committees as follows: Station Committee, Mrs. Denman Johnson, Chairman. An Information table was maintained at both stations during Monday and Tuesday, to welcome delegates and direct them to their hotels. had her Hotel Committee, Mrs. Troendle, Chairman. Reservations of rooms for honor guests and for the President of the State Suffrage Association were made in advance at Conference Headquarters, the Radisson Hotel. Reception Committee, Mrs. Horace Lowry. Two hostesses were always present at the Radisson during the sessions of the Conference. - Information Committee, Mrs. Fosseen. An information booth was maintained on the ground floor of the Radisson during the mornings and afternoons of the Conference. House Committee, Mrs. Weiskopf This Committee had general charge of the Conference room during sessions and looked after such details as ventilation, maintaining of quiet, etc. Ushers for Conference Sessions, Mrs. Silverson Ushers were appointed for each Conference and were dressed in white with ribbon badge. Literature, Mrs. Timberlake Tables with literature for free distribution or sale were maintained inside of the Conference room. Books on citizenship and kindred subjects were on sale in an adjoining room, under the direction of Powers' Book Store. Three machines were kept at the Radisson for the convenience of the honor guests.

SUBJECT: YEAR BOOK It is our wish that all possible copy for the Yearbook shall be in the hands of the printer by February 1st so that there will be no unnecessary delay in issuing it this year. To this end, therefore, will you not prepare at once a report covering the period between the last Convention March 24 - 29, 1919, and February 1st, 1920? For those states having a membership in the National Association of 3,000 and upward, the space allotted will be nine hundred words; those having a membership of 1,500 to 3,000 will have six hundred words; those having a membership of 500 to 1,500 three hundred words; those having a membership less than 500 one hundred and fifty words. If any state, not already ratified, should do so after your report has been filed, this statement can be appended later. The main report should come by February 1st.

BULLETIN #89 Issued MRS. FRANK J. SHULER SUBJECT: January 7, 1920. ANNUAL REPORTS Bulletin Number 81 which was issued under date of December 9th, dealt with the subject "The Yearbook." This Bulletin Number 89 also deals with the question of the Yearbook. Bulletin #81 requested that all copy for the Yearbook should be sent to the National office not later than February 1st, 1920. This still holds good as type for state reports must be set up before the convention. Bulletin #81 also dealt with the number of words allowed in each State report. It has been decided that as this is the last Yearbook more words might be allowed and we shall not hold strictly to the allowance of words given you in Bulletin Number 81. As this last report will be a record of what your state Association has done, it should record certain thinks. (1) Ratification - If your State has ratified, please tell how it was done, what the vote was in both Houses, and if ratification has not yet been accomplished what you are doing to bring about ratification. (2) Legislative Action - Please state any successful bills or any bills now pending which your Association has sponsored in your State Legislature. (3) Organization - (a) State also whether your Association has merged into a League of Women Voters, when and where this was done and whether you have organized your departments in accordance with the departments of the League of Women Voters. (b) Give the number of branches in your State Association. (4) Suffrage - If the women of your state have partial suffrage, municipal, primary, etc., state whether the women use it and something of what has been accomplished. (5) Office Holding - If suffragists in your State are holding public office, will you please give their names and a few words about their service? Also give the names of any women who have been elected to the Legislature or to State offices. (6) Education - State what institutes, if any, in your state are closed to women, and whether or not women have the same opportunities for higher education as men. (7) Finally please give us any unusual activities or things accomplished by suffragists without detail and with great accuracy.

Bulletins from Mrs. Catt were read calling for celebration when Secretary of State shall issue proclamation declaring Federal Amendment ratified.

Dr. Hurd, seconded by Mrs. Thorp moved that in consideration of the uncertainty we postpone even the ringing of bells until week from Saturday. Words "even ringing of bells" Pres. ruled out of order as we are asked to do that by the National Board. Motion as stated lost.

Mrs. Sweetser, seconded by Miss Parrington, moved that we have all whistles in addition to bells. Carried.

Mrs. Forrestal, seconded by Miss Farrington, moved that if Tennessee settles ratification Friday August 20th we have whistles blown and bells ring on Saturday August 21st without regard to issuing of proclamation. Rising vote was called for. Sustained.

Miss Farrington moved, seconded by Miss Lusk that store

keepers be asked to use stars and stripes in decoration on day that bells are rung. Carried

Miss Farrington-seconded by Dr. Ulrich, moved that we have no celebration beside bells and blowing of horns. Miss Farrington withdrew her motion.

Mrs. Thorp, seconded by Miss Quinlan, moved that as close to registration day as possible Auditorium meeting for Mpls and St. Paul be held with best possible National speakers obtainable. Carried.

It was recommended that ministers in St. Paul and Mpls be reached in an endeavor to get ratification sermons.

Dr. Ulrich, seconded by Mrs. Thorp, moved that we have slides made announcing that women have the vote. Carried.

It was suggested that mayor be asked to issue a proclamation asking people to display flag on day whistles are blown.

Mrs. Abbot, seconded by Mrs. Thorp, moved that task of asking merchants to display flags be divided among Republican women, Democratic women, League of Women Voters, Womans Party. Carried.

Mrs. Farmer volunteered to see that both Capitols were decorated.
