INTRODUCTION OF HIS EXCELLENCY YEHUDA BLUM, ISRAEL'S AMBASSADOR TO THE UNITED NATIONS, BY MAX M. KAMPELMAN AT ANTI-DEFAMATION LEAGUE ANNUAL MEETING, NEW YORK HILTON, NOVEMBER 17, 1978

MR. CHAIRMAN, DISTINGUISHED GUESTS, LADIES AND GENTLEMEN:

The suggestion that I introduce Ambassador Blum to you today was one that I eagerly accepted. The Hebrew University of Jerusalem is important to us both. He studied and taught there, being one of its most illustrious graduates; and I serve on its Board of Governors and as Chairman of its American Friends. We both have the School of Law at New York University in our backgrounds, he as a visiting professor, and I as a graduate and as a member of its Board of Trustees.

IT IS WITH SPECIAL PLEASURE, THEREFORE, THAT I TALK
TO YOU ABOUT THIS DISTINGUISHED DIPLOMAT AND SCHOLAR, WHOSE
BOOKS AND ARTICLES ON INTERNATIONAL LAW, WRITTEN IN HEBREW,
ENGLISH AND GERMAN, HAVE EARNED FOR HIM AN INTERNATIONAL
REPUTATION.

HAVING EXPERIENCED DETENTION AT BERGEN-BELSEN,
FORCED TO LIVE AS A WAR REFUGEE, YEHUDA Z. BLUM LOOKED TO THE
LAW AS A VEHICLE TO HELP MAN LIFT HIMSELF OUT OF HIS BRUTAL
NATURE, A CHARACTERISTIC OF THE HUMAN CONDITION WHICH HE KNEW
FROM PERSONAL EXPERIENCE WAS A REGRETTABLE REALITY. IN DOING
SO, HE WAS FOLLOWING A JEWISH TRADITION. OUR FOREFATHERS TOLD
US A TRUTH, LATER REDISCOVERED BY FREUD AND NEIBUHR, THAT HUMAN
BEINGS ARE BOTH CHILDREN OF GOD AND CHILDREN OF DARKNESS. IN

EACH OF US THERE IS A YAITZER HARAH AND A YAITZER HATOV. OUR RESPONSIBILITY AS HUMAN BEINGS, SAYS OUR TRADITION, IS TO STRENGTHEN THAT WHICH IS GOD-LIKE WITHIN US. IN JUDAISM THIS HAS BEEN A COMMITMENT TO DO JUSTICE AND TO DEAL JUSTLY, A FAITH IN LAW. THIS IS HOW WE EARNED THE RIGHT TO BE CALLED THE PEOPLE OF THE BOOK.

IT WAS, AFTER ALL, THE ANCIENT JEWISH TRIBES WHO GAVE TO THE WORLD A LEGAL SYSTEM AND A CODE OF LAW WHICH ABOVE ALL RECOGNIZES THE INDISPENSABLE INTERRELATIONSHIP OF LAW AND MORALITY.

It is altogether fitting that the Government of Israel, which seeks to represent and advance that Judaic ethic of learning and justice and peace should today be represented in the United Nations by this man of learning and law. For the United Nations stands today as a sad symbol of the repudiation of these eternal religious and civilized values by most of the governments of the world.

TODAY, IN SHARP CONTRAST TO OUR EARLIER DREAMS, THE UNITED NATIONS TOO OFTEN REPRESENTS THE BASER OF MAN'S NATURE, THE ANTITHESIS OF EQUITY AND JUSTICE, A VOICE OF THE TYRANNIES AND DESPOTS THAT GOVERN AND ENSLAVE MOST OF THE PEOPLES OF THE WORLD:

- A. THE U.N. ECONOMIC COMMISSION OF WESTERN ASIA EXCLUDES ISRAEL, BUT SEATS THE PLO IN VIOLATION OF ITS OWN CHARTER.
- B. THE U.N. HUMAN RIGHTS COMMISSION MEETS IN GENEVA TO CONDOMN ISRAEL FOR "WAR CRIMES," BUT REFUSES TO DISCUSS THE MASS SLAUGHTER OF CIVILIANS IN UGANDA.

- C. IN THE SECURITY COUNCIL, WE WITNESSED THE SPECTACLE OF LIBYA PRESIDING OVER A BODY CHARGED WITH MAINTAINING INTERNATIONAL PEACE AND SECURITY, WITH THE WORLD KNOWING FULL WELL THAT IT SPONSORS AND FINANCES INTERNATIONAL TERRORISM.
- D. THE PLO TAKES CREDIT FOR BOMBINGS AND SLAUGHTERS AND THE UNITED NATIONS RESPONDED BY INVITING ITS REPRESENTATIVES TO SIT AT THE SECURITY COUNCIL TABLE.
- E. Its specialized organizations, UNESCO, WHO, FAO, ILO, have been diverted from their principal social welfare ends into arenas for bigoted politics of hatred and violence, distorting reality to serve extremists Arab elements.
- F. IN BLATANT DISREGARD OF TRUTH AND IN IGNORANT REPUDIATION OF HISTORY, THE UNITED NATIONS, BY RESOLUTION, EQUATES ZIONISM WITH RACISM AND THUS JOINS IN BRUTALIZING THE INTERNATIONAL COMMUNITY AND IN ONCE AND FOR ALL DISQUALIFYING ITSELF AS AN INSTRUMENTALITY FOR PEACE AND FOR THE HIGHER ASPIRATIONS OF MAN.

Senator Pat Moynihan who, while serving as America's Ambassador at the United Nations was indeed a firebell in the Night, once pointed out that foreign policy elites in the United States and in the West remain blind to these hard realities because of a fear of making a scene, a neurotic need to maintain good manners. For too many and for too long our policy has been one of averting the ideological struggle. And yet, Mr. Ambassador, as we in the ADL know, it is the ideology of liberty that unites our two great democracies which serves as a remaining hope for billions all over the world who

LOOK TO ESCAPE THEIR DEGRADATION FOR A TOMORROW OF SALVATION FOR THEMSELVES AND THEIR CHILDREN.

THE UNITED STATES TODAY SUPPORTS THE UNITED NATIONS BY PAYING 25% OF ITS GENERAL BUDGET. WE GIVE NEARLY ONE BILLION DOLLARS ANNUALLY TO AN ORGANIZATION MOST OF WHOSE STAFF AND MORE THAN HALF OF WHOSE MEMBERS ACT IN FASHIONS HOSTILE TO OUR OWN INTERESTS. IN CONTRAST, ALL THE ARAB MEMBERS OF OPEC, THE OIL PRODUCING COUNTRIES, PAY ONLY SLIGHTLY MORE THAN 1%. ISRAEL PAYS 0.23%, ONE-QUARTER OF WHAT THE ARAB OIL EXPORTING COUNTRIES PAY, THE SAME AS SAUDI ARABIA, WHICH ENJOYS A SURPLUS OF \$17 BILLION IN ITS ANNUAL NATIONAL BUDGET.

In this period of Washington Budget-Cutting, I suggest to the President of the United States that if we are to have only one vote, the same as any other of the \$\mathcal{L}49\$ member nations of the United Nations, then perhaps our share should be 1/149th of its national budget; or let our contribution be in proportion to our population among the nations of the world.

THE UNITED NATIONS CAN PLAY A POSITIVE ROLE IN THE STRIVING OF MAN TOWARD A HIGHER DIMENSION IN THE HUMAN EVOLUTION-ARY SCALE. AS A MEETING PLACE FOR DIPLOMATS, IT CAN POTENTIALLY SERVE AS A FORUM FOR NEGOTIATION. IT HAS, HOWEVER, SO DEEPLY CORRUPTED ITSELF THAT THE PROSPECTS FOR ACHIEVING THOSE GOALS APPEAR DIM.

WHAT IS NEEDED IS A DETERMINED EFFORT BY COUNTRIES SUCH AS OURS AND SUCH AS YOURS, MR. AMBASSADOR, TO REKINDLE THE COURAGE AND THE HUMAN SPIRIT WHICH GAVE BIRTH TO THE UNITED NATIONS AND WHICH SAW TO IT THAT THE WORDS OF ISAIH GRACED THE MARBLE WALL FACING THE UNITED NATIONS.

What is needed is a realization that the United Nations today is being used by the Soviet Union as its weapon in an idealogical struggle to undermine the United States and its friends.

WHAT IS NEEDED IS A MOVEMENT BY THOSE OF US WHO PROCLAIM DEMOCRACY, A WAY FROM APOLOGY TO OPPOSITION.

WHAT IS NEEDED IS A DETERMINED EFFORT TO REMIND THE NATIONS OF THE WORLD THAT THE STANDARD BY WHICH HISTORY WILL JUDGE THEM AND THEIR WORK IS THE EXTENT OF THEIR COMMITMENT TO THE PRESERVATION AND EXTENSION OF HUMAN RIGHTS FOR WHITES, FOR JEWS, FOR DISSIDENTS AS WELL AS FOR BLACKS.

What is needed is an articulation of democratic values in the halls of the United Nations constantly, clearly and with conviction. We must have as much confidence in our values as in our weapons.

It is because you and your Government, Mr. Ambassador, share with us that reality and those aspirations that it is with special pride I introduce you to this audience of committed Americans and committed Jews - Ambassador Yehuda Blum.
