NEW YORK

THANK YOU VERY MUCH. MR. CHAIRMAN. I AM CERTAIN YOU KNOW HOW DEEPLY GRATEFUL I AM TO YOU FOR GIVING ME YOUR FIRST HUMAN RIGHTS AWARD. I SHALL CHERISH THAT AWARD. MY PARTNERS. TOO. WILL APPRECIATE THE AWARD. BECAUSE THERE WILL NOW BE AT LEAST SOMETHING TO SHOW FOR MY PROLONGED ABSENCES FROM THE OFFICE DURING THESE PAST TWO AND ONE-HALF YEARS.

SPEAKING OF MY PARTNERS. I WANT TO EXPRESS MY IMMENSE PRIDE IN ROBERT JUCEAM AND AT HIS HAVING HAD THE HONOR OF ELECTION BY YOU AS YOUR NATIONAL PRESIDENT. WE HAVE A RELATIVELY LARGE FIRM AND ONE WHICH IS CONSIDERED SUCCESSFUL BY THE USUAL STANDARDS. FOR MANY OF US. HOWEVER, SUCCESS IS NOT MEASURED IN FINANCIAL TERMS ALONE. IT IS MEASURED BY PUBLIC SERVICE, BY CONTRIBUTIONS TO THE LEGAL PROFESSION AND TO THE COMMUNITY AS A WHOLE, BY LEADERSHIP DEDICATED TO HUMAN AND ETHICAL VALUES, BY A

HIGH DEGREE OF COMPETENCE IN HOW WE PERFORM OUR DUTIES, BY DEDICATION TO THE LAW AS A PROFESSION WITH A CALLING TO PRESERVE OUR DEMOCRATIC SOCIETY THROUGH SERVING WELL THE PEOPLE AND INSTITUTIONS WHO COMPRISE IT. BY ALL THESE CRITERIA, BOB JUCEAM IS A SUCCESSFUL LAWYER AND A MAN WHOM HIS PARTNERS, MANY OF WHOM ARE WITH US TONIGHT, ARE ENTHUSIASTICALLY PLEASED TO EMBRACE AS PARTNER AND FRIEND.

IT IS APPROPRIATE THAT AN ASSOCIATION OF LAWYERS WHO WORK WITH MEN AND WOMEN TROUBLED BY IMMIGRATION PROBLEMS SHOULD IDENTIFY ITSELF WITH HUMAN RIGHTS AND HUMAN VALUES. EMMA LAZARUS, IN ANOTHER ERA, HIGHLIGHTED THE DISTINCTIVE NATURE OF THE NEWLY FLOURISHING AMERICAN DEMOCRACY BY REFERRING TO THE STRENGTH THAT WOULD BE OUR DESTINY AS WE ABSORBED THE "TIRED...POOR...HUDDLED MASSES...THE WRETCHED REFUSE...THE TEMPEST-TOSSED...."

THIS BRILLIANT UNIQUENESS, WHOSE SYMBOLISM HELPED MAKE US THE SHINING HOPE FOR MILLIONS LONGING FOR HUMAN DIGNITY, IS TODAY UNDER STRESS, THESE ARE DAYS OF TURMOIL. THREATENING TO MANY FUNDAMENTALS OF OUR FAITH. BUT WE MUST STRIVE TO PRESERVE THIS UNIQUE CHARACTER OF OUR SOCIETY. THERE ARE ENCOURAGING SIGNS OF AN EMERGING

INTERNATIONAL ETHIC WHICH IS STRENUOUSLY AT WORK TO ESTABLISH A CODE AND PRACTICE OF HUMAN RIGHTS, A STANDARD TOWARD WHICH THE RESPONSIBLE INTERNATIONAL COMMUNITY CAN ASPIRE AND AGAINST WHICH THE BEHAVIOR OF NATION STATES MAY BE JUDGED.

FREEDOM OF MOVEMENT HAS BEEN RECOGNIZED AS AN IMPORTANT HUMAN RIGHT SINCE THE DAYS OF ANCIENT GREECE. IT HAS BEEN CALLED THE FIRST-AND MOST FUNDAMENTAL OF MAN'S LIBERTIES, THE DISREGARD OF WHICH "FREQUENTLY GIVES RISE TO DISCRIMINATION IN RESPECT TO OTHER HUMAN RIGHTS AND FUNDAMENTAL FREEDOMS."

- --THE FIRST WESTERN NATIONAL DECLARATION TO GUARANTEE
 THE RIGHT OF EVERYONE TO LEAVE HIS COUNTRY WAS THE MAGNA
 CARTA OF 1215.
- --THE FRENCH CONSTITUTION OF 1791 ASSERTS THE FREEDOM OF EVERYONE TO GO. TO STAY. OR TO LEAVE WITHOUT BEING HALTED OR ARRESTED.
- --OUR CONGRESS IN 1868 DECLARED THAT "THE RIGHT OF EXPATRIATION IS A NATURAL AND INHERENT RIGHT OF ALL PEOPLE, INDISPENSABLE TO THE ENJOYMENT OF THE RIGHTS OF LIFE, LIBERTY AND THE PURSUIT OF HAPPINESS."

--THE UNIVERSAL DECLARATION OF HUMAN RIGHTS WAS ADOPTED BY THE UNITED NATIONS GENERAL ASSEMBLY IN DECEMBER 1948. It states that "Everyone has the right to leave any country, including his own, and to return to his country." This was reaffirmed and strenghtened in 1965 and 1966 by the International Covenant on Civil and Political Rights and by the International Convention on the Elimination of All Forms of Racial Discrimination.

--THE HELSINKI FINAL ACT OF 1975 IS MORE SPECIFIC. IT DECLARES A CITIZEN'S RIGHT TO REUNITE WITH HIS FAMILY, TO MARRY, AND TO TRAVEL. ITS ULTIMATE GOAL IS "TO FACILITATE FREER MOVEMENT AND CONTACTS ITS SPECIAL CHARACTER IS THAT IT DIRECTLY RELATES THE RIGHT TO EMIGRATE TO THE TOTALITY OF HARMONIOUS RELATIONSHIPS BETWEEN STATES SO ESSENTIAL FOR PEACE.

I HAVE JUST REFERRED TO THE HELSINKI FINAL ACT. YOU, OF COURSE, HAVE TONIGHT GRACIOUSLY RECOGNIZED MY EFFORTS AS HEAD OF OUR COUNTRY'S DELEGATION TO THE MADRID REVIEW MEETING UNDER THAT ACT. LET ME, THEREFORE, SPEND THE REMAINING MOMENTS OF THIS RESPONSE TO SPEAK ABOUT THE MEETING AND WHY I BELIEVE THAT MADRID IS MAKING A NOTEWORTHY CONTRIBUTION TOWARD THE ESTABLISHMENT OF THAT

INTERNATIONAL STANDARD OF HUMAN RIGHTS WHICH I BELIEVE TO BE INDISPENSABLE IF WE AND OUR CHILDREN ARE TO LIVE IN PEACE.

THE SIGNING OF THE HELSINKI FINAL ACT ON AUGUST 1.

1975 WAS A PROMISING DEVELOPMENT. ITS 40,000 WORDS TOOK
TWO YEARS OF WORK BY 35 COUNTRIES (33 EUROPEAN STATES PLUS
THE UNITED STATES AND CANADA) TO PRODUCE. WITH THE WEST
AGREEING TO THE "INVIOLABILITY OF FRONTIERS" SO THAT
BORDER CHANGES COULD ONLY TAKE PLACE PEACEFULLY. THE
SOVIET UNION. STRETCHING ITS INTERPRETATION. FELT IT HAD
ACHIEVED LEGAL RECOGNITION OF ITS PRIMACY OVER EASTERN
EUROPEAN TERRITORY.

IN RETURN, THE EAST AGREED TO "RESPECT...HUMAN RIGHTS

AND FUNDAMENTAL FREEDOMS, INCLUDING THE FREEDOM OF

THOUGHT, CONSCIENCE, RELIGION AND BELIEF," AS ESSENTIAL

FOR THE ACHIEVEMENT OF PEACE IN EUROPE; AND THEY

SPECIFICALLY INCLUDED THE "FREE MOVEMENT OF PEOPLES AND

IDEAS" WAS SPECIFICALLY NOTED.

THE 35 STATES ALL AGREED TO PUBLISH THE TEXT OF THE ACT. PEOPLE BEHIND THE IRON CURTAIN READ ITS PROVISIONS. MANY WITH HOPE. SOME. MORE REALISTICALLY, WITH SKEPTICISM. THEY READ THAT EVERYONE HAS "THE RIGHT TO

KNOW AND ACT UPON HIS RIGHTS." WHICH WERE DRAWN FROM "THE INHERENT DIGNITY OF THE HUMAN PERSON." THEY NOTED THAT LEONID BREZHNEV. IN SIGNING THE ACT ALONG WITH PRESIDENT GERALD FORD. PROMISED THAT HIS COUNTRY "WILL IMPLEMENT THE UNDERTAKINGS" OF THE ACCORD. WITH THAT ENCOURAGEMENT. A FEW COURAGEIOUS MEN AND WOMEN CREATED HELSINKI MONITORING GROUPS.

AMONG THE ORIGINAL FOUNDING MEMBERS OF THE HELSINKI GROUP IN MOSCOW WAS YURI ORLOV, A PHYSICS PROFESSOR AND MEMBER OF THE ARMENIAN ACADEMY OF SCIENCES, NOW SERVING A TERM OF 7 YEARS IN A STRICT REGIMEN LABOR CAMP TO BE FOLLOWED BY 5 YEARS IN EXILE: ELENA BCNNER, A PEDIATRICIAN AND WIFE OF THE NOBEL PRIZE WINNER ANDREI SAKHAROV, NOW IN EXILE: ANATOLI SHCHARANSKY, A MATHEMATICIAN AND COMPUTER SPECIALIST NOW SERVING A 13-YEAR SENTENCE.

SIMILAR GROUPS WERE FOUNDED IN THE UKRAINE, LITHUANIA, GEORGIA AND ARMENIA. A WORKING COMMISSION TO INVESTIGATE THE USE OF PSYCHIATRY FOR POLITICAL PURPOSES WAS FORMED; AS WERE THE CHRISTIAN COMMITTEE FOR THE DEFENSE OF BELIEVERS' RIGHTS; THE GROUP OF THE ALL-UNION CHURCH OF FAITHFUL AND FREE SEVENTH DAY ADVENTISTS; THE CATHOLIC COMMITTEE FOR THE DEFENSE OF BELIEVERS' RIGHTS; AND THE ACTION GROUP FOR THE DEFENSE OF INVALID RIGHTS IN THE USSR.

IN CZECHOSLOVAKIA, 300 INTELLECTUALS SIGNED A "CHARTER 77" MANIFESTO IN JANUARY 1977, A HUMAN RIGHTS DOCUMENT BASED ON THE HELSINKI FINAL ACT. IN POLAND, A COMMITTEE ON WORKERS' SELF-DEFENSE (KOR) WAS CREATED, ALSO BASED ON THE HELSINKI ACCORDS, WHICH LATER MERGED WITH SOLIDARITY, ONE OF WHOSE DEMANDS WAS THE REPRINTING OF THE HELSINKI FINAL ACT AND ADHERENCE TO IT.

WHEN OUR MADRID MEETING OPENED IN NOVEMBER 1980, UNDER A PROVISION OF THE 1975 AGREEMENT WHICH PROVIDED FOR FOLLOW-UP MEETINGS, THE USSR HAD ARRESTED AND IMPRISONED OR EXILED 45 OF THE ORIGINAL 71 MONITOR ORGANIZERS. THERE ARE TODAY 50 IN JAIL. IN RESPONSE TO MY SEVERE CRITICISMS OF THESE BRUTAL HELSINKI VIOLATIONS, MY SOVIET COLLEAGUE HAS CALLED THESE HEROIC VICTIMS "CRIMINALS" AND "SCUM."

LAST SEPTEMBER. THERE WERE 3 REMAINING MOSCOW MONITORS STILL OUT OF JAIL: A 72-YEAR OLD PHYSICIST. NAUM MEIMAN. WHOSE EFFORTS TO JOIN HIS DAUGHTER IN ISRAEL ARE STILL REBUFFED BY THE AUTHORITIES: SAKHAROV'S WIFE. ELENA BONNOR, WHO, WITH HER HUSBAND, HAS BEEN SUFFERING INTENSE HARASSMENT AND HUMILIATION: AND A 75-YEAR OLD LADY. A LAWYER. SOFIA KALLISTRATOVA, WHO WAS THEN BEING THREATENED

WITH PROSECUTION. WITH THAT THREAT, THE GROUP DECIDED TO DISBAND, STATING THAT SAVAGE PERSECUTION MADE ITS SURVIVAL IMPOSSIBLE.

RESPONDING TO THAT DECISION, LUDMILLA ALEKSEEVA, A FOUNDING MEMBER OF THE MOSCOW HELSINKI GROUP NOW IN OUR COUNTRY, OFFERED A MOVING ELEGY. SHE WROTE:

"THE MOSCOW HELSINKI GROUP LIVED A NOBLE LIFE AND HAS ENTERED THE HISTORY OF CIVIL RESISTANCE AS ONE OF ITS BRIGHTEST CHAPTERS. THE CONTRIBUTION OF THE MOSCOW HELSINKI GROUP IN UNFETTERING THE SPIRITS OF ITS FELLOW CITIZENS IS IMMEASURABLE AND INVALUABLE. FOR IN OUR ABSOLUTE AND HARSH WORLD. IT IS STILL THE WORD OF GOODNESS AND TRUTH THAT IS MOST INVINCIBLE."

THE QUESTIONS MIGHT WELL, THEREFORE, BE ASKED: WHY ARE WE IN MADRID? WHY DO WE REMAIN THERE? WHAT IS THE SENSE IN TALKING ABOUT A DOCUMENT WHOSE PROVISIONS ARE BEING BLATANTLY DEFIED BY THE SOVIET UNION?

EAST-WEST PROBLEMS AND TENSIONS ARE SERIOUS. BASIC.

AND DEEPLY IMBEDDED IN OUR RESPECTIVE VALUES AND NATIONAL

INTERESTS. WE CANNOT EXPECT SHORT-RUN SOLUTIONS TO THEM.

THE TOTALITARIAN SYSTEM WHICH THE USSR IS

SYSTEMATICALLY ATTEMPTING TO INSTALL AND CONTROL IN

DIFFERENT PARTS OF THE WORLD. INCLUDING OUR OWN. IS

ANATHEMA AND THREATENING TO US AND OUR VALUES. TO THE

SOVIET AUTHORITIES. POLITICAL DEMOCRACY. DEFENDED AND

REPRESENTED BY THE STRENGTH AND STABILITY OF OUR SOCIETY.

IS A THREAT TO THEIR POWER AND A DIRECT CHALLENGE TO

LENINIST-MARXISM. WHICH IS THEIR IDEOLOGICAL AND HISTORIC

REASON FOR BEING.

LENINIST TEACHING THAT "JUST WARS" ARE INEVITABLE TO RESOLVE THE "IRRECONCILABILITY" OF OUR TWO SYSTEMS IS A HISTORIC ANACHRONISM IN THIS AGE OF POTENTIAL NUCLEAR DEVASTATION. YET, IT EXPLAINS WHY MOSCOW TRAINS AND FINANCES TERRORIST AND GUERRILLA GROUPS AND STIMULATES VIOLENCE UNDER THE GUISE OF "WARS OF NATIONAL LIBERATION."

THOSE OF US WHO UNDERSTAND THE URGENCY OF PEACE, SO LONG AS IT IS ACCOMPANIED BY LIBERTY RATHER THAN THE PEACE OF THE DEAD OR THE LIVING DEAD. MUST DO EVERYTHING IN OUR POWER PATIENTLY TO PURSUE THAT PEACE UNTIL THE CULTURE AND IDEOLOGY OF WAR AND VIOLENCE ARE UNIVERSALLY REJECTED.

MORE THAN UNILATERAL DECLARATIONS OF NOBLE INTENTIONS BY US ARE CALLED FOR.

IN MADRID. WE TALK AND WE FACE REALITY. I HAVE HAD MORE THAN 300 HOURS OF PRIVATE TALKS WITH MY SOVIET COLLEAGUES, IN ADDITION TO TIME SPENT AT HUNDREDS OF FORMAL SESSIONS. IT IS IMPORTANT THAT WE TRY TO UNDERSTAND EACH OTHER. IT IS WORTH THE TIME IT TAKES TO DO SO.

IN MADRID, FURTHERMORE, WE HAVE ARRANGED FOR THE MOST THOROUGH REVIEW OF THE SOVIET UNION AND ITS TRANSGRESSIONS THAT HAS TAKEN PLACE IN ANY INTERNATIONAL FORUM. A UNITED WESTERN GROUP OF NATIONS, SPEAKING IN MANY LANGUAGES BUT IN ONE VOICE, HAS DOCUMENTED THE SOVIET RECORD OF SLAVE LABOR CAMPS: THE USE OF PSYCHIATRIC HOSPITALS FOR POLITICAL PUNISHMENT: ANTI-SEMITISM: ARMED AGRESSION IN AFGHANISTAN AND POLAND; RELIGIOUS PERSECUTION OF EVANGELICAL CHRISTIANS, BAPTISTS, SEVENTH DAY ADVENTISTS, PENTECOSTALS, CATHOLICS: SUPPRESSION OF SCIENTIFIC FREEDOM; THE DECIMATION OF CULTURAL AND NATIONALITY HERITAGES: THE DEFIANCE OF AGREEMENTS AGAINST THE USE OF CHEMICAL AND BIOLOGICAL WEAPONS.

OUR UNIFORM MESSAGE TO THE SOVIET AUTHORITIES HAS BEEN: COMPLY WITH THE AGREEMENT YOU SIGNED IN 1975 IF YOU WISH TO BE ACCEPTED AS A RESPONSIBLE MEMBER OF THE

INTERNATIONAL COMMUNITY. How can you expect us to enter into new agreements with you when you violate the existing promises that you made?

WHEN MOSCOW IS READY TO SEEK WESTERN ACCCOMMODATION.

IT WILL KNOW WHAT IS REQUIRED. WE, THEREFORE, ATTEND,

TALK, MEET, DEBATE, NEGOTIATE, ARGUE, DINE, CONDEMN, TALK

SOME MORE. NEW AGREEMENTS ARE BEING FASHIONED AND PUT ON

PAPER. THE WORDS GO FAR IN MEETING OUR NEEDS. WE NOW

AWAIT THE DEEDS. THERE ARE SOME. THERE MUST BE MORE.

THE UNITED STATES HAS LEARNED IN MADRID THAT
SUPERPOWER STATUS DOES NOT NECESSARILY CONFER
SUPER-WISDOM. WE HAVE SELF-INTERESTS. AND WE MUST DEFINE
AND ADVANCE THEM. WE HAVE VIEWS. AND IT IS OUR RIGHT TO
ASSERT THEM. BUT OTHER COUNTRIES ALSO HAVE THEIR NATIONAL
INTERESTS WHICH MUST BE RESPECTED IF WE ARE TO ACHIEVE
UNDERSTANDING. WE HAVE MUCH TO GAIN FROM LISTENING: AND
WE HAVE BEEN LISTENING IN MADRID.

WE HAVE LISTENED AND THAT IS WHY WE ARE WHOLEHEARTEDLY NEGOTIATING ARMS CONTROL ISSUES IN GENEVA AND VIENNA. AND THAT IS WHY THE UNITED STATES EARLY JOINED FRANCE AND ITS OTHER NATO ALLIES IN SUPPORTING IN MADRID THE COVENING OF

A SECURITY CONFERENCE TO DEAL WITH THE THREAT OF SURPRISE MILITARY ATTACK.

MADRID IS A VEHICLE TO HELP RESOLVE THE EAST-WEST
TENSIONS IF THE SOVIET UNION WILL COME TO LEARN FROM OUR
WORDS AND OUR BEHAVIOR THAT WE SEEK PEACE; THAT WE HAVE NO
WISH TO THREATEN THEIR NATIONAL SECURITY; AND THAT WE
CANNOT CONDONE AND WILL NOT IGNORE THEIR AGGRESSIONS UNTIL
THEY WITHDRAW FROM THEM. JUST AS THEIR DEEDS HAVE
UNDERMINED OUR CONFIDENCE IN THEIR INTENTIONS, SO MUST
THEIR DEEDS, AND NOT JUST THEIR WORDS, BEGIN TO RESTORE
THAT CONFIDENCE.

THE HELSINKI FINAL ACT IS A WISE STANDARD FOR PEACE.

THE PROCESS IT CREATED IT IS STRONG AND HAS BEEN

STRENGTHENED BY MADRID. WE ARE COMMITTED TO CONTINUE THAT

PROCESS AND TO SEEK OBSERVANCE OF ITS STANDARDS. THAT

ALSO REQUIRES US. BY OUR WORDS AND OUR WORKS. BY FAITH AND

DEEDS. TO REDEDICATE OURSELVES TO HUMAN DIGNITY AS A WAY

OF OUR LIFE. THAT IS WHY IT IS FITTING THAT YOU WHO PLAY

SUCH A VITAL ROLE IN THE STRUGGLE FOR HUMAN DECENCY

TONIGHT IDENTIFY YOURSELVES. THROUGH YOUR AWARD. WITH THE

BROADER. INTERNATIONAL MOVEMENT TOWARD THAT GOAL.

IT IS A PRIVILEGE TO BE WITH YOU TONIGHT AS WE TOGETHER REAFFIRM OUR COMMITMENT TO THAT GOAL. THE STAKES ARE HIGH. OUR AIM IS PEACE AND LIBERTY. IT IS WORTH OUR TIME. OUR ENERGY. AND OUR TALENT.


