A TRIBUTE TO MORRIS I. LEIBMAN

Washington, D.C.

October 29, 1992

Morrie Leibman was proof of the reality that it is not the years in one's life but the life in one's years that count in the evaluation of our short stay in this world. He was an example and a lesson for all of us who were touched by his friendship and concerns. Regret never took the place of his dreams and so he escaped old age in his energetic more than 80 years of travel from birth to death.

During an 80th birthday celebration we had for Morrie in this city, I told him that when we take a careful look at him, his life, and his many contributions to the lives of all of us, I concluded that if we subtracted from his own age the hours which he gave to other people's lives and careers and difficulties, we would find that we were celebrating the birthday of an infant prodigy. The outpouring of love and praise and friendship for Morrie that followed his death and continues through our tribute dinner this evening reaffirms that observation.

Morrie never lost interest in tomorrow and neither must we. He kept young in spirit and in enthusiasm and so must we. He understood that we cannot control the length of our lives, but we can control the width and depth of our lives. We must never forget that lesson and the example Morrie set for us.

Morrie has been our dear friend and an inspiration to all of us here. He was in on the creation of many new ideas and many new movements. We have a duty to see that they flourish. He demonstrated the essence of American patriotism and citizen responsibility. We must follow his example. He was a credit to the legal profession and we intend to keep his name alive in its annals. I was proud of our friendship and I know that pride is shared by thousands living in all parts of our country.

Mary, all of Morrie's friends know how important you were to him and to his happiness. You helped give him vitality and energy and inspiration. For that, you have our appreciation and our love.

As I look over this room, I have a strong feeling that Morris is hovering about, moving from table to table. I know this is so because you couldn't keep him away from a party such as this. He, therefore, joins all of us here in loudly and gratefully proclaiming "Mary, thank you and God bless you."

MAX M. KAMPELMAN BIOGRAPHICAL SUMMARY

Max M. Kampelman, a lawyer, diplomat and educator, was Counselor of the Department of State and Ambassador and Head of the United States Delegation to the Negotiations on Nuclear and Space Arms in Geneva, before returning in January, 1989, as a partner in the Washington, New York, Los Angeles and London law firm of Fried, Frank, Harris, Shriver & Jacobson. He was recently appointed by President Bush and confirmed by the U.S. Senate as a Board Member of the United States Institute of Peace. He serves as Chairman of Freedom House, Chairman of the Board of Governors of the United Nations Association, and Chairman of the Jerusalem Foundation. He also serves as a member of the Executive Committee of the American Bar Association Special Committee on the Central and Eastern European Law Initiative, designed to provide assistance to the emerging democracies of Europe. His new book, Entering New Worlds: The Memoirs of a Private Man in Public Life, was published by HarperCollins.

On January 18, 1989, President Reagan awarded him the Presidential Citizens Medal, which recognizes "citizens of the United States who have performed exemplary deeds of service for their country or their fellow citizens". He has also been the recipient of the Knight Commander's Cross of the Order of Merit of the Federal Republic of Germany.

He was appointed by President Carter and reappointed by President Reagan to serve as Ambassador and Head of the U.S. Delegation to the Conference on Security and Cooperation in Europe, which met in Madrid from 1980 to 1983. He has served, by Presidential appointment, as Head of the U.S. Delegation to the CSCE Copenhagen Conference on the Human Dimension in June 1990; as Ambassador and Head of the United States Delegation to the CSCE Geneva Conference on National Minorities in July 1991; and in September 1991 as Head of the U.S. Delegation to the CSCE Moscow Conference on the Human Dimension. He previously was a Senior Advisor to the U.S. Senator Hubert H. Humphrey.

An educator, he received his J.D. from New York University and his Ph.D. in Political Science from the University of Minnesota, where he taught from 1946 to 1948. He has also served on the faculties of Bennington College, Claremont College, the University of Wisconsin, and Howard University. He lectures frequently here and abroad and has written extensively in scholarly and public affairs journals. He served on the governing boards of a number of universities and has received ten honorary Doctorate degrees.

Ambassador Kampelman was the founder and moderator of the public affairs program on public television, "Washington Week in Review." He was chairman of the Washington public broadcasting radio and television stations from 1963 to 1970. He and his wife, Marjorie, are the parents of five children and live in Washington, D.C.

On behalf of the American Bar Association Standing Committee on Law and National Security and the Center for National Security Law at the University of Virginia School of Law, it is my pleasure to invite you to participate in a conference on "National Security Law: Second Annual Review of the Field--A Tribute to Morris I. Leibman" which will be held at the International Club of Washington, 1800 K Street, N.W., Washington, D.C., on Thursday and Friday, October 29-30, 1992.

Last year the American Bar Association Standing Committee on National Security Law and the Center for National Security Law of the University of Virginia School of Law co-sponsored the first annual review of the new field of National Security Law. "Democracy and Deterrence: Toward a New Central Paradigm in International Relations and International Law," which will explore the extent to which new theory about the role of totalitarianism in major wars and mass democide may serve as the basis for a new central paradigm to guide international relations and international law,
