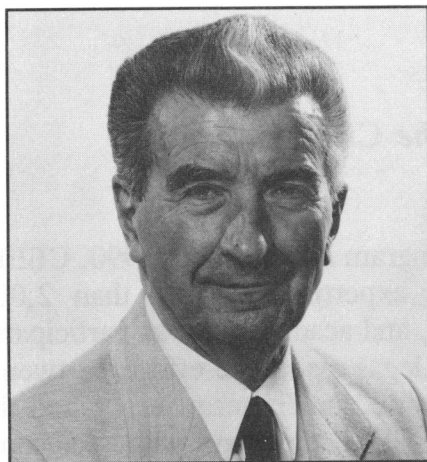

Through various programs, CEELI makes available U.S. legal expertise and assistance to emerging democracies that are in the process of modifying or restructuring their laws or legal systems.

The CEELI Award

Since its first program in November 1990, CEELI has tapped the expertise of more than 2,000 lawyers, judges, and academicians as participants in its *pro bono* legal assistance efforts in twenty countries in Central and Eastern Europe and the NIS. Through CEELI, they have witnessed some of the most significant social, legal, economic and political transformations of this century. We wish to recognize all those who have devoted their time and energy to the pursuit of democratic reform.

Also apparent in all of CEELI's projects has been the tremendous personal sacrifice and extraordinary achievements of individual leaders in participating countries. CEELI also wishes to honor those leaders and their countries for their willingness to take bold steps toward introducing democratic reforms and market economies.

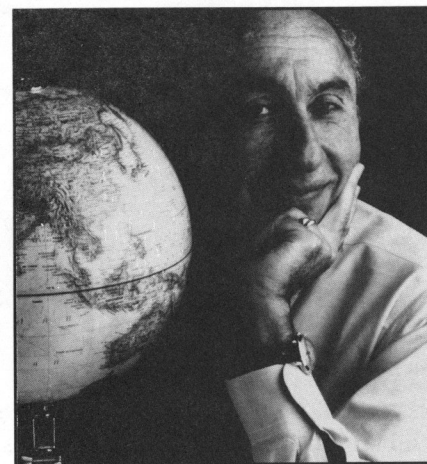
This year, His Excellency Kiro Gligorov, President of the Republic of Macedonia will be presented the first Annual CEELI Award in recognition of his extraordinary leadership in advancing the rule of law in Macedonia.

President Kiro Gligorov is a model of statesmanship and moderation in a region in which there is not an oversupply of far-sighted leadership. President Gligorov was

born on May 3, 1917. He is a 1939 graduate of the Faculty of Law in Belgrade and, subsequently, became a professor at Belgrade University. He was a respected political figure and a force for economic and democratic reform in the former Yugoslavian government. In 1991, the newly constituted Assembly of Macedonia voted to appoint Kiro Gligorov as President. He has since propelled the office of the president from a largely ceremonial role to the center of national decision-making. President Gligorov peacefully led Macedonia to independence, making Macedonia the only republic of the former Yugoslavia to do so without bloodshed. Through his determination and pragmatism, President Gligorov has held Macedonia together. He has negotiated inter-ethnic peace among the different groups within his country and neutralized potential conflict without using force. Under President Gligorov's leadership, Macedonia has worked to establish a free-market economy, protect human rights, and uphold the principles of democratic reform. Through his administration, Macedonia has repaid its debts despite its start as the least developed of the former Yugoslav republics. President Gligorov has helped negotiate Macedonia's admission to the U.N. and other international organizations. He has secured commitments of foreign aid and garnered U.S. recognition and support for his country. In these volatile times, President Gligorov's leadership has been a stable, hopeful force within Macedonia and a shining example within the international community.

Max M. Kampelman, a lawyer, diplomat and educator, was appointed by President Carter and reappointed by President Reagan to serve as Ambassador and Head of the U.S. Delegation to the Conference on Security

and Cooperation in Europe (CSCE), which met in Madrid from 1980 to 1983. He has served, by Presidential appointment, as Ambassador and Head of the U.S. Delegation to the CSCE Copenhagen Conference on the Human Dimension in June 1990, the CSCE Geneva Conference on National Minorities in July 1991, and the CSCE Moscow Conference on the Human Dimension in September 1991. He was the Counselor of the Department of State and Ambassador and Head of the United States Delegation to the Negotiations on Nuclear and Space Arms in Geneva, before returning in January 1989, as partner in the law firm of Fried, Frank, Harris, Shriver & Jacobson. Ambassador Kampelman was appointed by President Bush to the Board of the United States Institute of Peace, which he serves as Vice Chairman. He is the Chairman Emeritus of Freedom House, and Honorary Chairman of the Jerusalem Foundation. On January 18, 1989, President Reagan awarded him the Presidential Citizens Medal, which recognizes "citizens of the United States who have performed exemplary deeds of service for their country or their fellow citizens." He is also the recipient of the Knight Commander's Cross of the Order of Merit of the Federal Republic of Germany. Ambassador Kampelman received his J.D. from New York University and his Ph.D. in Political Science from the University of Minnesota, where he taught from 1946 to 1948. His book, Entering New Worlds: The Memoirs of a Private Man in Public Life, was published in 1991.


I am pleased to forward the letter from H.E. Kiro Gligorov, President of the Republic of Macedonia.



CURRICULUM VITAE

KIRO GLIGOROV

President of the Republic of Macedonia

Kiro Gligorov was elected President of the Republic of Macedonia by the newly constituted Assembly on 27 January 1991.

During the post-war period Kiro Gligorov held many positions including:

1974-1978	President of the Assembly of the Federal Republic of Yugoslavia
1967-1969	Professor, Belgrade University
1962-1967	Federal Secretary of Finance
1955-1962	Secretary of Economic Affairs in the Federal Executive Council
1952-1955	Deputy Director of the Federal Administration for Economic Planning and Development
1947-1952	Assistant to the Minister of Finance of the Government of the Federal People's Republic of Yugoslavia

President Gligorov was one of the architects of the Yugoslav market economic reforms of the 1960's.

Under the Markovic government, President Gligorov was in charge of economic reform.

A 1939 graduate of the Faculty of Law in Belgrade, President Gligorov joined the progressive students' movement before World War II and actively participated in the National Liberation War from 1941 forward.

A member of the Antifascist Assembly of the People's Liberation of Yugoslavia (AVNOJ), Secretary of the Initiative Committee for convocation of the Antifascist Assembly for the People's Liberation of Macedonia (ASNOM) and a member of the Presidium of the Temporary Government of the Democratic Federation of Yugoslavia.

Born in Stip on May 3, 1917, President Gligorov has been awarded many Yugoslav and foreign decorations.

President Gligorov understands English and Russian.
