Robert B. Zoellick

Robert B. Zoellick is Executive Vice President, General Counsel, and Corporate Secretary of Fannie Mae. He serves as the principal legal officer of the corporation and supervises the company's National Housing Impact division, which brings together various programs for low- and moderate-income homebuyers. Mr. Zoellick also manages offices dealing with regulatory affairs, government relations, and international housing financial services.

Fannie Mae, a federally chartered and stockholder-owned corporation, is the largest housing finance investor in the U.S. At the end of 1993, the company held \$190 billion in mortgages in its portfolio and had another \$496 billion in outstanding, guaranteed mortgage-backed securities.

From August 1992 to January 1993, Mr. Zoellick served as Deputy Chief of Staff of the White House and Assistant to the President.

Mr. Zoellick was sworn in as Under Secretary of State for Economic and Agricultural Affairs in May 1991, while continuing to serve as Counselor of the Department (Under Secretary level). He was confirmed by the Senate as Counselor in March 1989, where he was responsible for policy planning, the executive secretariat, and a wide range of political, security, and economic projects. Mr. Zoellick also served as the President's personal representative, or Sherpa, for the G-7 Economic Summits in 1991 and 1992.

Mr. Zoellick received the Distinguished Service Award, the Department of State's highest honor. The German Government awarded him the Knight Commanders Cross for his role in developing the U.S. strategy toward German unification and as the senior U.S. official in the "2 plus 4" negotiations.

From July 1985 to July 1988, Mr. Zoellick served at the Department of the Treasury in various positions, including Counselor to Secretary James A. Baker, III, Executive Secretary of the Department, and Deputy Assistant Secretary for Financial Institutions Policy. Mr. Zoellick received the Alexander Hamilton Award, the Department of the Treasury's highest honor.

Prior to joining the Treasury Department, Mr. Zoellick was Vice President and Assistant to the prior Chairman and CEO of Fannie Mae, David O. Maxwell, from 1983 to 1985. Mr. Zoellick clerked for Judge Patricia M. Wald on the U.S. Court of Appeals for the District of Columbia Circuit during 1982-83, practiced law in Washington from 1981 to 1982, served as Special Assistant to the Assistant Attorney General (Criminal Division) at the Justice Department during 1978-79, and worked at the Council on Wage and Price Stability in the Executive Office of the President from 1975 to 1976.

In 1988, Mr. Zoellick was the Issues Director of the Bush for President Campaign, where he supervised the national security, economic, domestic policy, and speechwriting staffs.

Raised in Naperville, Illinois, Mr. Zoellick received a J.D. magna cum laude from the Harvard Law School and a Master of Public Policy degree from Harvard University's Kennedy School of Government in 1981. He is a 1975 Phi Beta Kappa graduate of Swarthmore College.

In 1980, Mr. Zoellick lived in Hong Kong as a recipient of a fellowship from the Luce Foundation.

He currently serves on the boards of the Council on Foreign Relations, the Congressional Institute, the German Marshall Fund of the U.S., the European Institute, the National Bureau of Asian Research, the American Council on Germany, and the Overseas Development Council. Mr. Zoellick is also a member of the Advisory Committee of the Institute for International Economics, the Aspen Institute's Foreign Policy Strategy Group, the Director of Central Intelligence's Advisory Committee on Economics, the Steering Committee of the Intelligence and Policy Project at Harvard, the Australian-American Leadership Foundation, the Center for Strategic and International Studies (CSIS), the Trilateral Commission, and the D.C. Bar.

INTRODUCTION OF ROBERT B. ZOELLICK WASHINGTON INSTITUTE OF FOREIGN AFFAIRS

The Cosmos Club Washington, DC

April 25, 1995

I realize that an introduction is neither an affidavit nor a eulogy.

Nevertheless, I will use what some may call excessive language as I introduce Robert Zoellick to you this afternoon. I do so because the words accurately reflect my judgment.

Those of us who have been in Washington and in government for a long period of time have seen many extraordinarily talented young men and women appear on the scene. I know of very few who equal Bob in judgment, skill, competence, energy and capacity to both lead and follow. We first met when he succeeded me as Counselor of the State Department in 1989. It did not surprise me when the additional responsibility of becoming Under Secretary of State for Economic and Agricultural Affairs was added to his tasks. He also served as personal representative of President Bush at the G-7 summits of 1991 and 1992. Bob later served as Deputy Chief of Staff at the White House and as Assistant to the President.

In appreciation for his outstanding service Mr. Zoellick received the State Department's Distinguished Service Award, its highest honor. He also received the German Government's Knight Commanders Cross for his vitally constructive role during the course of German reunification. Before joining the State Department, he received the Treasury Department's Alexander Hamilton Award, its highest award, for serving as its Counselor, Executive Secretary and Deputy Assistant Secretary.

Today, Robert Zoellick is Executive Vice President, General Secretary and Corporate Secretary of Fannie Mae, the largest housing finance investor in our country. We have every expectation that his success in the business world will be equivalent to his many successes in government service. That will produce the riches he merits which will permit him to pay the dues necessary to join our Washington Institute.

Harvard and Swarthmore and all of us who have worked with him have every reason to be proud of Robert Zoellick, whom I now present to this distinguished audience.
