We are confident that the two events in Chicago will establish an USIP presence with key Chicago leaders and lead to a base for contributions in the future.

To follow up on the conference call held Wednesday, October 22:

The time-schedule for the dinner is revised. I have attached the schedule for your information.

We have 22 acceptances for the dinner and we anticipate 3-4 additional responses. The dinner total will be at 30, the original goal. A list of attendees with affiliations is attached.
