REMARKS BY MAX M. KAMPELMAN AMERICAN ACADEMY OF ACHIEVEMENT

Minneapolis, Minn.

July 6, 1984

The advance notices refer to my career in the law and my recent experiences in diplomacy. My mind, however, goes back to earlier days as a college and night law student. My daytime work was selling magazines and Fuller brushes, perspiring in a steel factory, and steaming sweaters in a garment manufacturing plant.

This is a program dealing with awards for "Excellence".

But I recall the afternoon I was fired as a waiter at a summer resort in the Catskill Mountains. It took quite a bit of effort to persuade the hotel owner to keep me on as a busboy and dishwasher.

Achievement for me was reached during my last year in college with jobs as a bookstore clerk, running the coat room concession at the weekly Saturday night dances, and representing on campus The New York Times and a local merchant renting tuxedos for the junior and senior proms.

Mine has been a fortunate life and an extensively varied one. Moving from the factory into the trade unions, organizing and arranging union education classes while studying law at night, opened up stimulating vistas. I recall going into scores of homes and interviewing women who were taking work

home from factories and sewing buttons on sweaters at rates far lower than the prevailing legal minimum wage. These were fine hard working folk who had turned their homes into factories to help support their families.

The war period broght with it soil conservation work, serving as an attendant in an institution for feeble-minded children, and volunteering to be a human guinea pig in a starvation experiment which brought my weight down to under 100 pounds -- all of this leading to my becoming a teacher here at the University of Minnesota, with its immense satisfactions. This introduced me to the then mayor of this beautiful city, Hubert Humphrey and the most enrighing relationship of my life (other than my marriage to my wife). Our association and friendship deepened as this cherished friend and teacher moved on to become a United States Senator, Vice-President of the United States and candidate for President of the United States. He was a politician who understood that in a democracy the political process was the primary educational experience of the body politic. Always a teacher he used to say "You tell 'em what your gonna tell them; you tell them; and you then tell them what you told them." Seeing these green, yellow and red lights on here governing my time, I recall Muriel's admonitions to Humphrey: "Hubert, a speech does not have to be eternal to be immortal." To the time-keeper I say Humphrey had a great influence on my life!

It is, however, to today and tomorrow rather than to yesterday that I look. Let me, therefore, share a few experiences with you about my three years as an Ambassador representing our country at an East-West conference in Madrid. I was appointed to that task by President Carter and reappointed by President Reagan. During that period I spent close to 400 hours of private negotiations with my Soviet counterparts. These were serious talks by serious people dealing with serious subjects. But the memories are human.

I will long remember a brief coffee session that I arranged for a visiting Congressional group with the head of the Soviet delegation, then a 75-year old Deputy Foreign Minister, a member of the Communist Party Central Committee and former editor of Pravda and Izvestia. The brief coffee period became two and one half hours. Its theme was set by one member of Congress, a Catholic priest, wearing his collar, talking with vehemence, conviction and eloquence about the persecution of Soviet Jews. I frequently contemplate the impression Father Drinan made on the Soviet delegation that day.

I remeber an intense conversation with Avital Scharansky who had come to Madrid to urge the release of her husband from a Soviet prison. His crime was that he took the Helsinki Final Act, about which we were talking in Madrid, at its face value and formed a group to monitor compliance with its human rights provisions, something he had a right to do under the accords.

Mrs. Schransky and I talked in the delegates lounge because we

cowboys, the fact that we had never fought a war against each other. My talk, in some ways a lecture on political philosophy, was a plea for humanizing our relations. A few weeks later, at a dinner, an ambassador from one of the Communist countries, with more vodka in him than was prudent, took me aside to acknowledge the speech and to say he was taking it home for his son to read.

I conclude these brief and human recollections of one phase of an active public life by suggesting to you that you are indeed highly fortunate young men and women. You are fortunate not only because you have special gifts, proved by your presence here today. You and I are most particularly fortunate because we live in a great country, a free and democratic country.

There is a continuing struggle in civilization to enhance that part of the human process that is represented by light rather than by darkness. No matter what we do with our lives, each of us will have the opportunity to make a contribution toward strengthening the forces of light — in our families, our communities, our country, and in the world. We can express our gratitude for the good fortune that is ours by making certain that our children and future generations will be part of a world in which people can live in peace, freedom, and dignity.

IN THINKING ABOUT MY CAREER IN THE LAW AND MY RECENT EXPERIENCES IN DIPLOMACY, MY MIND GOES BACK TO EARLIER DAYS AS A COLLEGE AND LAW STUDENT, ATTENDING CLASSES AT NIGHT. MY WORK THEN ENCOMPASSED SELLING MAGAZINES AND FULLER BRUSHES, PERSPIRING IN A STEEL FACTORY, AND STEAMING SWEATERS IN A GARMENT MANUFACTURING COMPANY.

This is a program dealing with awards for "Excellence".

But I recall the afternoon I was fired as a waiter at a summer resort in the Catskill Mountains. It took quite a bit of effort to persuade the hotel owner to keep me on as a busboy and dishwasher.

Success for me was reached during my last year in college with jobs as a bookstore clerk, running the coat room concession at the weekly Saturday night dances, and representing on campus The New York Times and a local merchant renting tuxedos for the junior and senior proms.

MINE HAS BEEN A FORTUNATE LIFE AND AN EXTENSIVELY VARIED ONE. MOVING FROM THE FACTORY INTO THE TRADE UNIONS, ORGANIZING ON PICKET LINES AND ARRANGING UNION EDUCATIONAL CLASSES WHILE STUDYING LAW AT NIGHT, OPENED UP STIMULATING VISTAS.

I RECALL GOING INTO SCORES OF HOMES AND INTERVIEWING WOMEN WHO WERE TAKING WORK HOME FROM FACTORIES AND SEWING BUTTONS ON SWEATERS AT RATES FAR LOWER THAN THE PREVAILING LEGAL MINIMUM WAGE. THESE WERE FINE HARD WORKING FOLK WHO HAD TURNED THEIR HOMES INTO FACTORIES TO HELP SUPPORT THEIR FAMILIES.

The war period brought with it soil conservation work in tree reforestation, being an attendant in an institution for feebleminded children, serving as a human guinea pig in an experiment which brought my weight down to about 100 pounds -- all of this leading to my becoming a teacher here at the University of Minnesota, with its immense satisfactions. This introduced me to the then mayor of this beautiful city, Hubert Humphrey. Our association and friendship deepened as this cherished friend and teacher moved on to become a United States Senator, Vice-President of the United States and candidate for President of the United States.

IT IS, HOWEVER, TO TODAY AND TOMORROW RATHER THAN TO YESTERDAY THAT WE MUST DWELL. LET ME, THEREFORE, SHARE A FEW EXPERIENCES WITH YOU ABOUT MY THREE YEARS AS A DIPLOMAT REPRESENTING OUR COUNTRY AT A THIRTY-FIVE NATION CONFERENCE IN MADRID. OUR TASK WAS TO COVER THE GAMUT OF EAST-WEST RELATIONS. DURING THAT PERIOD I SPENT CLOSE TO 400 HOURS OF PRIVATE NEGOTIATIONS WITH MY SOVIET COUNTERPARTS.

THESE WERE SERIOUS TALKS BY SERIOUS PEOPLE DEALING WITH SERIOUS SUBJECTS. BUT THE MEMORIES ARE HUMAN.

I WILL LONG REMEMBER A BRIEF COFFEE SESSION THAT I ARRANGED FOR A VISITING CONGRESSIONAL GROUP WITH THE HEAD OF THE SOVIET DELEGATION, THEN A 75-YEAR OLD DEPUTY FOREIGN MINISTER, A MEMBER OF THE CENTRAL COMMITTEE AND FORMER EDITOR OF PRAYDA AND IZVESTIA. THE BRIEF COFFEE PERIOD BECAME TWO AND ONE HALF HOURS. ITS THEME WAS SET BY ONE MEMBER OF CONGRESS, A CATHOLIC PRIEST, WEARING HIS COLLAR, TALKING WITH VEHEMENCE, CONVICTION AND ELOQUENCE ABOUT THE PERSECUTION OF SOVIET JEWS. I FREQUENTLY CONTEMPLATE THE IMPRESSION FATHER DRINAN MADE ON THE SOVIET DELEGATION THAT DAY.

I REMEMBER AN INTENSE CONVERSATION WITH AVITAL SCHARANSKY WHO HAD COME TO MADRID TO URGE THE RELEASE OF HER HUSBAND FROM A SOVIET PRISON. HIS CRIME WAS THAT HE TOOK THE HELSINKI FINAL ACT, ABOUT WHICH WE WERE TALKING IN MADRID, AT ITS FACE VALUE AND FORMED A GROUP TO MONITOR COMPLIANCE WITH ITS HUMAN RIGHTS PROVISIONS, SOMETHING HE HAD A RIGHT TO DO UNDER THE ACCORDS. MRS. SCHRANASKY AND I TALKED IN THE DELEGATES LOUNGE BECAUSE I WANTED THE OTHER DELEGATES TO SEE HER. HER HUSBAND IS STILL SUFFERING IN JAIL.

AND THERE IS THE EXCHANGE WITH AN EASTERN EUROPEAN AMBASSADOR DURING WHICH I TALKED ABOUT THE 1200 FAMILIES SEEKING TO LEAVE HIS COUNTRY FOR OURS WHOSE APPLICATIONS HAD NOT BEEN ACTED UPON. A WEEK OR TEN DAYS LATER HE CAME TO ME WITH 600 NAMES, SAID THEIR VISAS HAD BEEN ISSUED AND THE REMAINING FAMILIES ON THE LIST WOULD BE ACTED UPON WITHIN A MATTER OF WEEKS. THEY WERE.

There comes to mind a day I delivered a statement documenting the terrifying growth of offensive Soviet military power. At the conclusion of our session that morning, the head of a Warsaw Pact delegation came to me and quietly said: "I did not know any of that." He did not question my facts.

I WILL REMEMBER A SPEECH IN WHICH I QUOTED EARLIER SOVIET AND EASTERN EUROPEAN STATEMENTS BY THEIR DIPLOMATS COMPLETELY CONTRADICTING THAT WHICH THEY WERE THEN TELLING US IN MADRID. AT THE CONCLUSION OF THAT SESSION, I WENT OVER TO ONE EASTERN EUROPEAN COLLEAGUE AND SAID: "I HAD ONE MORE QUOTATION THAT I LEFT OUT." HE LOOKED AT ME, TOOK MY HAND, AND WHISPERED: "THANK YOU VERY MUCH, MY GOOD FRIEND." MY BIRTHDAY WAS A FEW DAYS LATER; AND IN MY HOTEL ROOM THAT DAY WAS A CASE OF WINE FROM HIS COUNTRY.

AND I WILL LONG REMEMBER THE TALK I MADE SETTING FORTH
THE PROFOUND DIFFERENCES BETWEEN THE TOTALITARIAN SYSTEM OF
THE SOVIET UNION AND AMERICAN DEMOCRACY. I HAD FIRST

NOTED THE GREAT SIMILARITIES BETWEEN OUR COUNTRIES, THE COSSACKS AND THE COWBOYS, THE FACT THAT WE HAD NEVER FOUGHT A WAR AGAINST EACH OTHER. MY TALK, IN SOME WAYS A LECTURE ON POLITICAL PHILOSOPHY, WAS A PLEA FOR HUMANIZING OUR RELATIONS. A FEW WEEKS LATER, AT A DINNER, AN AMBASSADOR FROM ONE OF THE COMMUNIST COUNTRIES, WITH MORE VODKA IN HIM THAN WAS PRUDENT, TOOK ME ASIDE TO ACKNOWLEDGE THE SPEECH AND TO SAY HE WAS TAKING IT HOME FOR HIS SON TO READ.

I CONCLUDE THESE BRIEF AND HUMAN RECOLLECTIONS OF ONE PHASE OF AN ACTIVE PUBLIC LIFE BY SUGGESTING TO YOU THAT YOU ARE INDEED HIGHLY FORTUNATE YOUNG MEN AND WOMEN. YOU ARE FORTUNATE NOT ONLY BECAUSE YOU HAVE GREAT TALENT, PROVED BY YOUR PRESENCE HERE TODAY. YOU AND I ARE MOST PARTICULARLY FORTUNATE BECAUSE WE LIVE IN A GREAT COUNTRY, A FREE AND DEMOCRATIC COUNTRY.

THERE IS A CONTINUING STRUGGLE IN CIVILIZATION TO
ENHANCE THAT PART OF THE HUMAN PROCESS THAT IS REPRESENTED
BY LIGHT RATHER THAN BY DARKNESS. No MATTER WHAT WE DO
WITH OUR LIVES, EACH OF US WILL HAVE THE OPPORTUNITY TO
MAKE A CONTRIBUTION TOWARD STRENGTHENING THE FORCES OF
LIGHT -- IN OUR FAMILIES, OUR COMMUNITIES, OUR COUNTRY,
AND IN THE WORLD. WE CAN EXPRESS OUR GRATITUDE FOR THE GOOD
FORTUNE THAT IS OURS BY MAKING CERTAIN THAT OUR CHILDREN

AND FUTURE GENERATIONS WILL BE ABLE TO LIVE IN A WORLD IN WHICH PEOPLE CAN LIVE IN PEACE, FREEDOM, AND DIGNITY.







Millionaire Mall Man Has His Own

Builds \$90-Million Palm Desert Town Center for Himself

PALM DESERT—Let's talk malls.
With Ernest W. Hahn, the multimillionaire developer of more than 40 regional shopping centers nationwide, it's a topic that colors all conversation.
More than just a retail genius or department-store architect, Hahn is one of the founding fathers of Southern California's shopping malls, the downtown of vestervear.

yesteryear.

He's been instrumental in building the Fox Hills Mall, Hawthorne Plaza, Los Cerritos Center, Santa Anita Fashion Park and Santa Monica Place, among others. Eighteen years ago, as a fledgling general contractor, Hahn built his first shopping center—Le Cumbre in Santa Barbara. He said it came just a few years after the "start of the industry"—the first regional shopping mall ever built in Minneapolis in 1957.

Since then, Hahn has created an unparalleled shopping center and development empire. Hahn is king in a world bounded by Morrow's Nut House, J.C. Penney, Waldenbooks, May Co. and See's Candy.

At 64, Hahn, whose net worth was estimated at roughly \$120 million in a recent issue of Forbes magazine, has slowed down. Though still chairman of the board of the Hahn Co., he sold the firm to a Canadian corporation a few years ago and is now less involved in the day-to-day activities of the company.

Approaching retirement, Hahn's last few years have been spent in pursuit of a prit project, but in his case, nothing as sedentary as stamp collecting or bird watching.

And so the recent opening of the \$90-million Palm

Desert Town Center, the only such shopping complex in the Coachella Valley.

Says Hahn "It's nice having a mall in my own backyard."

Hahn lives a few miles down the street from the center in the tuny, moneyed enclave of Indian Wells. He says the Town Center is for both the locals in the Palm Springs area, who up until now have been an hour away from the nearest major shopping complex, and the movers and shakers who inhabit the desert on a part-time basis.

In an area where the street names ring with the sounds of the celebrities that inhabit them—Bob Hope Drive, Gerald Ford Road, Frank Sinatra Drive—and even medical care is tinged with glamour—the Betty Ford Center, the Annenberg Center for Health Science—Hahn is leaving his own legacy: a personalized shopping mall.

For example, his favorite local restaurant, Cleve's in Palm Desert, was born again at the mall as Cleve's Too, chanks to urging from Hahn, and his favorite tobacco shop from Solana Beach was reincarnated in Hahn's new Ittle city as Palm Desert Tobacco.

Road Began in Hawthorne

A man whose conversation consists in large part of talk about square footage, parking spaces, demographics, trade areas and other mall-ese, Hahn finds it difficult to describe his lifework in the abstract.

"Obviously, I'm very sentimentally involved with this project," he says. "If it were just a business venture, I wouldn't have built it at a time when the mortgage market was at an all-time high. This area is a special place for me. I have many friends here.

"I've never missed (playing in) a Bob Hope Desert

The road toward Hahn's eventual status as a shopping-center magnate and friend to celebrities began in a corner of a used furniture store in Hawthorne in the late 1940s. Hahn, who left high school to work as a messenger for the Bank of America, formed his company in 1946 with a friend and then took it over completely 10 years later.

Married 43 years to a woman he has known "since fifth grade in Hawthorne," Hahn built an empire founded on "family, everything I do is family" and prides himself on counting some of the same employees on his payroll today as when he first began.

"When I started out I had no money and it was a constant struggle," Hahn says. "But you never stop. You

still have to constantly fight and compete, but at the same time that's what keeps me going. The business has always stimulated me."

As the fourth largest developer of shopping malls in the world, Hahn sees himself as more than just an entrepreneur.

"Shopping malls fill a great void today," he says. "I think it's the only way we have now for people to go out and enjoy social and cultural activities.

"I'm just glad I had the money to spend on this one," says Hahn, who bought the mall from his parent corporation. "It's very satisfying to look around and see that it's all finally here."

A bread-&-butter business

AUL H. SMUCKER, 66, who looks and sounds like actor Jimmy Stewart, is showing a visitor around Orrville, Ohio (pop. 7,511), about an hour's drive south of Cleveland. "That's my grandfather's house," says the proud chairman of the J.M. Smucker Co. as he pulls out of corporate headquarters on Strawberry Lane. "Grandfather's farm,

where it all began, was out back. We use the house for special meetings now." He turns left onto Main Street and about five blocks later points to a large white house on a hill. "That was my father's house. Tim [Smucker's eldest son and company president] and his family live there now." Another couple of turns and Smucker points out his own home, a California contemporary, five minutes from the office.

"We like it here in Orrville," Smucker says. "It has been good to us."

Sure has. Smucker's, which got its start when Paul Smucker's grandfather, Jerome, began selling his homemade apple butter 87 years ago, is now the nation's leading producer of jams, jellies and preserves. Fiscal 1983 sales of \$200 million included roughly \$150 million from jams and jellies-almost a third of the market. Other major product lines include fruit syrups, ice cream toppings and a mixture of peanut butter and jelly called Goober Jelly. The business has produced consistently

sweet profits. Its five-year average return on equity is 15.7%. The first half of fiscal 1984 promises another good year. Sales of \$107 million were up 9% over last year, and net income of \$6.4 million rose 11%.

But Paul Smucker is not all smiles. There is the future to worry over. "You know," he says, "we are having the hardest time finding a company to join us." Smucker's needs a good acquisition. There is little growth, may-

be 2% a year, in sight for the jam-andjelly market. The main competitors-Welch's, Borden's Bama brand and Kraft-fight hard, both nationally and regionally, as do generic and private label producers.

Smucker's has had its share of lousy acquisitions. A packaging plant, a gourmet gift business and a line of pickles all eventually had to be sold. Smucker's has more successfully strengthened itself internally. It is lean and mean. Sales have doubled since 1973, but the work force has shrunk by 15%. The company is competing harder, too, in places such as the Deep South, where its share of the market now is only 15%. In places such as San Francisco, where Smucker's has won nearly two-thirds of the market, it intends to increase profit by selling more exotic, highermargin jams and jellies.

Still, the company needs diversity. "We have met a lot of good people and made a lot of friends, and I have even been buying this one guy's lunch for 12 years," Paul Smucker says of his search for an acquisition, "but nothing has happened."


Smucker's recently bought the Dickinson Family, Inc., producers of gourmet jams and jellies, and the

Magic Shell line of ice cream toppings from Foremost-McKesson. Although those products make a neat fit and are starting to perform much better, they account for only 5% of Smucker's sales.


Other small and mediumsize companies commonly experience Smucker's difficulty in expanding and diversifying without compromising the bread-and-butter business. Luckily for shareholders, the Smuckers are dealing with the problem while the company's finances are in top shape. The family, which controls 30% of the stock, enjoys the luxury of not being forced to sell out. (If the Smuckers did sell at recent stock prices, they'd get about \$45 million.)

"One of the reasons I showed you Orrville is that I wanted you to understand where we come from," Paul Smucker tells his guest. "How we believe in treating the other fellow as we would like to be treated, and putting out the very best product we can. I am not sure we could do that working for someone else." ■

Ivan Boesky: A Crafty Wall Street Trader Looks West

NEW YORK-Among the telephone calls that deserve a place in Wall Street legend, consider one that a Paine Webber executive named James W. Miller made on June 12, 1980, to

the office of Ivan F. Boesky.

As a result of the activities that call set in motion, trading in the stock of a New York wood-and-paper company called Diamond International Corp. became so chaotic that it was suspended on two stock exchanges. Paine Webber itself was later cited by the Securities and Exchange Commission for aiding in an illegal tender offer, but an administrative law judge handling the case chose not to impose sanctions.

And Ivan Boesky, standing serenely over the anarchic market in Diamond stock, managed to sell Miller almost all the Diamond he had to offer for \$12.9 million.

The substance of Miller's call was simple. He represented an

The substance of Miller's call was simple: He represented an unidentified client that wanted to purchase slightly less than 10% of Diamond International's shares that day or not at all.

Did Boesky have shares to sell, Miller asked. And could he put the word out on Wall Street that Paine Webber was buying?

Paine Webber need not have been surprised that its overture to Boesky produced a selling stam-pede:For at the time, as now, Ivan F. Boesky was perhaps the most F. Boesky was perhaps the most influential and widely watched member of a tiny cadre of traders known as "risk arbitrageurs."

Enviable Reputation

By buying and selling shares in companies embroiled in takeovers or other major corporate reorganizations, risk arbitrageurs have sculpted an image for themselves as the financial community's smartest, craftiest, and frequently richest members

Able to commit vast amounts of capital, much of it borrowed, to takeover stocks, risk arbitrageurs have been known to make 100% to 1,000% on their investments.

The "risk" element need be taken seriously as well:On one celebrated deal, the collapse of Gulf Oil Corp.'s 1982 bid for Cities Service Co., losses among Wall Street traders are estimated to have run as high as \$500 million.

Boesky was the first to establish a "boutique" arbitrage firm, a small independent firm devoted a limited number of clients. Today, he heads a network of trading companies that under the umbrella of the Ivan F. Boesky Corp. manage more than \$500 million in assets.

His personal wealth, reportedly seeded in part from the less than \$700,000 staked him in 1975 by his wife's wealthy family—her father, Ben Silberstein, founded the Beverly Hills Metal her weeter. erly Hills Hotel-has grown to \$150million, according to a recent-

Forbes magazine estimate.
Through Beverly Hills Hotel-Through Beverly Hills Hotel-corp., Boesky controls Vagabond Hotels, a San Diego-basedchain of medium-priced inns thatlast fall in a public offering of securities raised \$35 million incapital for Boesky's arbitrage and "merchant banking" activities (essentially the nuchous activities (essentially the purchase of interests in companies with reorganization potential).

Boesky's California holdings point up Boesky's skill at "leverage," the art of using other peoples money to enhance the potency of one's own capital. In fact, there are those who say that Boesky's true genius lies not in arbitrage but in

verage.
When Vagabond Hotels made a \$96-million public offering of stock and debentures last fall, fully \$35 million of the total wasearmarked not for the hotel business but for Boesky's merchant banking and risk-arbitrage trading—an extraordinary application of public investors'

funds but an opportunity, as Vagabond contended at the time, for the public to ride Boesky's arbitrage coattails.

As for Financial Corp. of Santa Barbara, parent of the ailing Santa Barbara Savings & Loan Assn., of which Vagabond has agreed to purchase 56%, observers of California's S&L community see less value for Boesky in the institution's financial results—which are dismal compared to many other S&Ls in the state—than in the extraordinary investment and leverage powers that state-chartered S&Ls receive this year.
Under provisions of California S&L law in effect this year,

those institutions can concentrate nearly 25% of their assets in investments outside the traditional range of savings and loan associations.

loan associations.

While S&Ls have generally been limited to mortgage-type loans, California associations now can originate commercial and corporate loans (up to 7.5% of their assets, with an increase next year to 10%), buy such loans from other California banks (another 10%), and even invest in outside corporations' common stock (up to 5% of the S&L's assets).

Federally chartered S&Ls can

Federally chartered S&Ls can make only a fraction of those investments. And while federal regulators say they won't allow any newly chartered associations to make more than 10% of their investments outside the traditional fields, existing institutions such as Santa Barbara Savings will be subject only to the state law's broader limitations.

Bargain Money

S&L money is extraordinarily well-leveraged and priced at bargain rates. For \$1 of capital, the S&L can invest more than \$32 of depositors' money, a degree of leverage unmatched at any other type of financial institution. By comparison, commercial banks can only invest up to \$19 of depositors' money for every \$1 in capital, depending on their size and nature. (Before Boes-ky's purchase. Santa Barbara Savings had about \$97 million in net capital and \$1.3 billion in depos-its.)

And the average California S&L's cost of funds is about 9%, compared to the prime rate for bank borrowings, a conventional supply of lev-erage for Boesky and other traders, of 11%. The deposi tors' money, of course, is also federally insured.

Boesky scoffs at such conjecture over his plans for Santa Barbara Savings. "We plan to run Santa Barbara as a traditional savings and loan," he says.

But California-based observers see inescapable logic in Boesky's move. "The acquisition of financial institutions has been almost exclu-Institutions has been almost exclusively based on the expansion of investment rights," says Edward Carpenter, a Newport Beach-based S&L consultant. "My view is that the major benefit of having an S&L is leveraging public funds. It is an insured source of investment capital."

ROBERT A. WEINBERG, Ph.D.

Lawrence, inventor of the Cyclotron) ... her "pioneering and outstanding contributions" to our understanding of Beta Decay, Lepton Conservation and Exotic Atoms are heralded ... along with her discoveries and other "landmark experiments" ... she is the recipient of the first Wolf Prize in Physics from Israel, The Cyrus B. Comstock Award of the National Academy of Sciences ... plus 15 honorary degrees from Princeton, Yale, Harvard and other outstanding universities around the world ... and the National Medal of Science, the "the highest honor America bestows upon its scientific pioneers."







THE SIGNIFICANCE OF THE GOLDEN PLATE AWARD AND THE "SALUTE TO EXCELLENCE"

Since the beginning of recorded history, man has honored outstanding performance with various forms of award. The ancient Greeks bestowed the laurel wreath as a mark of victory or merit. After his voyage around the world, Sir Francis Drake received the jewelled star and badge. Via sponsorship, recruited by the Academy...including complimentary round-trip plane tickets plus deluxe weekend lodging and meals...the young people attend a series of symposiums with the Captains of Achievement, the Banquet of the Golden Plate, and the Sunday farewell brunch where they chat informally with the honorees of their personal and career interests.

The annual "gathering of the greats" is thus a dramatic relay point in the eternal struggle for progress — as the Leaders of Today proudly ignite the torches of dedication for America's Young Leaders of Tomorrow in life's most exciting challenge: the Pursuit of Excellence.

WHAT IS THE ACADEMY:

Each year, the American Academy of Achievement invites fifty men and women of exceptional accomplishment - 10 distinguished past awardees and 40 new guests of honor - to share a weekend with one another and 350 of the nation's most outstanding high school honor students. During the three-day "gathering of greats," these Young Leaders of Tomorrow have a chance to meet and discuss issues with eminent adult achievers from every facet of American life...the sciences, business, the professions, sports, literature, entertainment, the military, and public service.

The highlight of the weekend program is the spectacular Banquet of the Golden Plate where each guest of honor is presented with the Golden Plate Award as a "representative of the many who excel" in his chosen profession.

WHY AND HOW:

The Academy was founded in 1961 "to inspire youth with new dreams of achievement in a world of boundless opportunity." Since its creation, more than 5,000 of America's most outstanding students have participated in the Salute to Excellence program.

The event can best be described as the "before and after" of the American Dream. The honored guests are those who have already reached the pinnacle of success in their chosen field. The roster of past awardees reads like a "Who's Who" of Twentieth Century America, and includes many Nobel, Pulitzer, Oscar, Emmy, Grammy, Lasker, Heisman and Horatio Alger winners.

And then there are the students — by any measure, the cream of the crop — who hope to follow in their footsteps.

The electricity and excitement of the program grows throughout the three days as the students gain inspiration from the honorees and the honorees see the promise represented by this group of future leaders. Adults and students alike come away revitalized,

with a new sense of purpose. Helen Hayes describes it as "...one of the most exhilarating and gratifying occasions in my lifetime of occasions."

Student reaction to the "unforgettable" experience is reflected by this comment from Gail Casteel, "Miss Future Business Leader of America":

WHO ARE THE HONOR STUDENT PARTICIPANTS:

In the name of each honor student sponsor recruited by the Academy, a winner in either state or national scholastic competition is chosen for the complimentary invitation to the "gathering of the greats."

The prestigious organizations which stage these national youth competitions — and are allied with the Academy — include Veterans of Foreign Wars (and its Auxiliary), Science Talent Search, Future Business Leaders of America, Commission on Presidential Scholars, National Merit Scholarship Corporation, Future Farmers of America, Quill & Scroll Society, Elks Foundation, Music Teachers National Association, America's Junior Miss, Boys' Clubs of America, Hearst "U.S. Senate Youth Leaders," President's Committee on Employment of the Handicapped, National 4-H Council, Soroptimist Foundation, Junior Engineering Technical Society, Academy of Applied Science, National Exchange Club, and Junior Achievement.

In nearly 100 cities across the country where the Academy has pre-recruited a sponsor, the two "Teenagers of the Year" — one most outstanding boy and one most outstanding girl — are designated on behalf of the Academy, by a local selection panel under the coordination of the Superintendent of Schools, as honor delegates to the Banquet weekend.

The Salute program is an "endorsed activity" of the National Association of Secondary School Principals.


