Meeting called to order by Vice President , Vijay Balakrishnan.

Corrections to December 18 minutes: Delete Ganapathy Swami from Marketing and Liaison Cmtes; add Pranab Lahiri to Membership Cmte. Approved as corrected.

Treasurer's Report: Ramanik Shah is filing a report with the IRS, he will make a report to the Board at that time, possibly end of Feb.

Long Range Planning Cmte: Atul Shroff

Objective: to formulate short range and long range goals. Urged increased membership on the cmte to reflect consensus of the larger group, encouraged volunteers from the other cmtes to encourage communication between the various cmtes and to bring the Long Range Planning Cmte to a workable size. Mentioned the need for a list of India Club members. (Zeke is working on this). Asked Board members to submit comments/ideas for India Club goals. First task of the cmte will be to increase to a workable size using the membership list provided by Zeke. Mission of this larger cmte will be: ① Define goals of India Club in 5 years, including but not limited to the issue of a scholarship fund and competition with sister organizations. ② Develop strategies to achieve these goals within current limitations of time and resources.

Membership Cmte: Vinu Patel

Minutes from cmte meeting distributed and discussed. Need for brochure emphasized. Treasurer will issue statements to 1985 members for 1986 renewal when information is available from Zeke. Tally will be kept regarding the number of members each Board member brings in.

Marketing Cmte: Vijay Balakrishnan

Cmte goal is to promote India Club to the Indian community <u>and</u> to the community at large; to develop strategies to achieve this goal. Work of the cmte has been divided as follows: Daljit Sikka- concentration on business community; Shirin Fristedt-concentration on women in the Indian community; Zeke Zdenek- concentration on the American "establishment" (gov't, institutions, foundations, etc); Carla Prakash-communications (brochure, newsletter, etc.) Cmte action items-- Mock up of a brochure for short range use, preparation of newsletter for distribution to India Club mailing list, kick-off plan for approach to business community, plan for approach to women in Indian community, plan for approach to organizations that currently help India Club, and those that India Club can help.

Liaison Cmte: Ram Gada

Goal of cmte: Establish communication channels with other organizations and develop strategies to promote India Club to those organizations. List of key organizations distributed, additions/corrections welcomed. Cmte will send letters to the president of each organization and follow up with phone calls asking for opportunity to attend a meeting as a representative of India Club + inquiring about space in the various newsletters to promote India Club. Calendar of events will be developed based on information gathered from these contacts. In establishing links with the student organization(s) emphasis will be on how India Club can be useful to the students, especially new students.

Program Cmte: Sudhansu Misra

Members- Ganapathy Swami, Sarat Mohapatra, Anoop Mathur, Rakesh Agarwala, Mukul Ganguli. Objective is to assess and evaluate programs that are candidates for being taken up by India Club, present cmte approved programs to Board for necessary action, generate ideas about programs that India Club might participate in, and act as clearinghouse for India Club sponsorship of cultural programs/events.

Festival of Nations: Apr 25-26-27

As Neena Gada will be in India for the next few months, Shanti Shah will be the contact person. Stefan Peterson is coordinating the cafe. Day captains and volunteers are needed. Harshad Bhatt will be day captain for Saturday.

Other business: Kashmira Irani described her plan for sending toys to India, asked for India Club support. Requires a non-profit organization as her fiscal agent in this project. Passed unanimously for India Club to be the non-profit organization as long as there would be no financial obligation on the part f India Club. Kashmira will work with the Program Cmte on details.

Board members asked to write down thoughts on India Club- what they hope to get from membership, why others might consider membership, benefits of membership, etc. and send to Carla Prakash for use in brochure.

I very much appreciate the consideration of the members of India Club for having me in the board for the last year.



President's message

As my term as President of the India Club comes to an end, it is gratifying to look back at the last two years' progress and look forward to the future. The events of the last two years are well enough known, ranging from India Day, to getting interviews with our congressional delegation for voicing our opinion on the Simpson-Mazzoli Bill. Some activities have been of a service nature and some of a cultural nature. Like any other group, we have sometimes veered away from our main mission of being a service organization and of developing a scholarship fund. Two years ago our treasury had only a meager operating capital. Now there are enough funds to think about isolating the scholarship funds and starting to invest those funds. Our membership, which we have not pressed actively, approaches 75 or so families, and that I hope will rise more rapidly in the future.

It has been a privilege for me to serve the last two years. All the activities of the club, from their conception through execution, are the direct results of the efforts of some very talented people that have worked hard to serve both the Indian community and the broader community of our city, state, and nation. My own role in these activities was minor compared to theirs. If I were to thank each of those that contributed so much here, this newsletter would need another ten pages. Those same people will continue to serve and a few bright young people are joining to bring new viewpoints

and talents to the club.

Now, I'd like to look to the future and your involvement in the club. First, this is an outward looking service club. We are not here to sponsor professional music and dance. Events have proved that the Indian Music Society is very accomplished at such cultural events and our role should be only supportive. More recently a new association, Natyakala, has also made its mark to foster South Asian dance. Social events are ably handled by each of several clubs and our role there should also be only supportive.

The India Club can best serve by hewing closely to our published long range goals of educational funding by scholarships; interfacing with the broader community to present Indians as Americans, and India as a fellow democracy, not an adversary; and to share that rich 5000 or more years of heritage with our

neighbors of other heritages.

Now the avenue to those ends is involvement-your involvement. As one of the board members put it, "Let's not become an old boys club, let's have new blood and youth in the club to direct it!" It's good advice, and the broader the base of activities, the broader and more complete the abilities of the club.

The club works by consensus and your consensus counts! Let's put some numbers to that concept of volunteerism. Let's say that each of the two thousand families here adds an hour of work for the community each week for each member of the family. How many manhours is that? Let's also say that each member of those families puts away the price of a coke each day for community service. How much would that total in a year? Would the combination of the manhours and the funds bring within reach some of the projects you hold dear?

As the new board takes over, I am looking forward to you becoming an active member of the club, with its modest dues of \$10.00 per family, \$5.00 per individual, gratis to students, and contributing your talents to the club and the community.

Thank you for the last two years.

All the candidates were asked if they were willing to serve prior to being placed on the slate.

There are two opportunities to add names to this slate. First at the November meeting, and again at the December meeting. If

no names are added, the slate is voted on as it stands. If names are added, then a secret ballot is used at the December meeting to elect the 21 members of the board recommended by the bylaws.

Once elected, the board selects its own executive. The incumbent vice president is usually asked to assume the presidency.

With the start of the new year, the various committees welcome new input, and new members. Committee chairpersons do not have to be on the board and anybody is welcome to serve and have a say in the destiny of the club. Some of the committees are long range planning, program, scholarship fund, membership, publicity and publications.

There is ample scope for you to put in a little time on a special skill you have which could benefit the club and the community. Some of the areas that need manpower and skill are: database and mailing management; special event management; graphics; newsletter publishing; event publicity; presentation of the culture and heritage of India to schools, churches, and adoption agencies; scholarship program.

Come to the meeting. You might end up giving a change to your dormant talents.

The agenda for the December meeting also includes allocation of funds for the resource center and selection of the chairperson for 1985 Festival of Nations program.

CLUB ACTIVITIES

PANIGRAHI PRESENTS ODISSI DANCE: On October 7, 1984, Mrs. Sanjukta Panigrahi and troupe presented a well-received performance of Odissi Dance at the St. Anthony High School.

With an attendance of over 250, the program was an artistic success, with Mrs. Panigrahi exhibiting the skill and finesse that has earned her and her troupe world renown in this classical dance form. S.K. Dash acted as manager of the event.

The Indian Music Society and the India Club, with the support of other clubs, cooperated in the sponsorship of this program.

SECOND ANNUAL INDIA DAY: Under the management of Shanti Shah, the second annual India Day, at the St. Anthony High School on October 13, 1984 was a rousing success, with nearly 400 adults and children in attendance for the afternoon. A stage show, organized by Vijay Balakrishan, included a wide variety of music and dance to the delight of the audience. Among the exhibits, an India information booth organized by Padu Arimilli featured an outstanding computer quiz about India, programmed by Godam Nambudripad's son. Neena Gada's sari wrapping booth, and Rajan Patel's and Neena's hand and face painting booth proved popular among our guests. Preeti Mathur coordinated the exhibition with the theme "Cuisine of India." An outstanding menu was provided by Suman Shenoi, Asha Nath, Bash Singh, and several others much to the delight of the trenchermen in the crowd.

INDIAN COMMUNITY SPONSORS GANDHI MEMORIAL: A remembrance evening in honor of the late Mrs. Indira Gandhi was held at the International Institute on Sunday, November 18, 1984. Friends of the community who spoke in honor of Mrs. Gandhi were Marlene Johnson, the lieutenant governor of Minnesota, John Derus of the Hennepin County Board and a former Peace Corps volunteer in Haryana, Dr. Paul Singh, an elder of the Sikh community, Dr. Rao, Anita Raturi, Preeti Mathur, Sabir Hasan, and Dr. Raj Dutt. The central theme by all the speakers was that of conciliation and responsibility to the democracy in India.

The people of India are struggling to overcome the shock of the death of Mrs. Gandhi and of the innocent people that followed. And now the tragedy at Bhopal stares at us. Nothing can redeem the lives that were lost and suffering that was borne. But one could look to the future with courage to overcome the obstacles.



MINUTES OF THE MEETING DECEMBER 19,1983

These are more formal than usual minutes to report the results of the by_laws change vote and the result of the Annual Election.

The meeting was called to order at 7:45 pm at the International Institute with a sufficient quorum to conduct the business at hand.

The first order of business was to review the results of voting by the 1983 board on the motion:

"The maximum number of the Board of Directors shall not exceed 21 and the minimum number for the Board of Directors shall be five."

The results of voting was 11 Ayes, 1 nay, and 3 abstentions, so the motion carried.

The second order of business was the election of the Board of Directors as proposed by the Nominating Committee and amended at the meeting of November 17, 1983 in accordance with the by-laws.

The Board then elected its executive as follows:

Zeke Zdenek, President Neena Gada, Vice President Ella Baldwin, Secretary Mohan Amberker, Treasurer The January 18th meeting of the India Club was called to order at 7:30 pm by the president Zeke Zdenek.

The first order of business to be discussed was the Festival of Nations. Vinay Garg has agreed that the India Club will receive 10% of the sales after the initial fee is paid in the bazar. Sathy Kumar discussed the food to be prepared and sold in the cafe. Possible alternatives to chicken in the meat dish became the main topic, but a decision was not reached at that time. Sales expectations are 3000 meat plates, 2000 mango shakes, and 1000 pakoras, creating a gross income of \$6000. The festival will open one hour earlier on Friday, and close one hour earlier on Saturday. Buses of school children are expected on Friday. Tickets will be available for advance sales on February 24th. Price is \$5.00 in advance for adults, \$6.00 at the door. The price for childrens tickets is \$4.00 regardless of when they are bought.

The second order of business was a discussion of committee chairs.

Dear Friends,

The mills of certain artistic gods grind exceedingly slowly, so this letter is not accompanied by the long awaited membership brochure. However, it is timely to report to the community at large on the status of the India Club.

What is the India Club. The club was originally founded as a non-profit organization in 1973 and was from before the legalities, associated and active with the International Institute. The club was involved in a variety of functions like "India Days" at the International Institute, the Festival of Nations, and a variety of small service projects, receptions for Indian dignitaries and other activities. The club was and remains a non-sectarian, non-partisan, non-linquistic organization. It is not to be an "umbrella" club nor to compete with any existing religious, regional or specialized group. If you like labels, service and support are nice words.

Times, and needs change, and the India Club entered a phase of lowered activities. Since flux, rather than stasis is the rule, the consensus of a decent sample of the community was to revitalize the club as an independent service organization serving the entire community and interfacing closely with the European-American community. The underlying principle is matrix management by the consensus of the Indian Community at large, in a supporting role.

The club has a number of interesting projects accomplished or in process. Some of the activities of the Festival were handled by the club, while others did the Bazaar, Food Stall, and performances. The club has been actively presenting a position regarding restrictive immigration legislation to Minnesota's Congressional Delegation, both by letter and personal visits. At each meeting, we have a speaker of interest-The last was Mike Paige from the University who defined the needs of the IndoAmerican Association and the new student.

In the immediate future, we are planning to have the president of the Association of Indians in America and the Consul-General visit with us in July. In October, we are planning an India Day and a welcoming reception for the new students in the state. The latter will be a fundraiser aimed at the American Community. Other works in the mill include a review of the by-laws, planning for publications such as a directory of musical artists, a community directory, a professional directory, a media resource center, and interfacing with the various clubs and linquistic groups. A membership brochure, letterhead and envelopes are at the printer.

What about the future? I am attaching a copy of the first report from our long range planning committee, which succinctly describes some of the goals thus far in consensus. Please review it carefully and think about the ideas you have that would have an ideal forum in the India Club. Come join us—we and the community need your ideas, input, and wisdom.

Dues are modest \$10.00 for families, \$5.00 for individuals, and free for students.

Our meetings, for the summer, are the third thursday of the month, and our next meeting is July 21 at 7:30 pm, at the International Institute, 1694 Como Ave. Do join us as meeting are open.

A check for \$600 was received from Mr. Agarwal for the Bazaar. Board suggests we negotiate prior to next year's Festival for the Bazaar arrangements and that those arrangements be given in writing to the Bazaar participant. This suggestion is not the result of any difficulty in the past, but rather to create some formal records of India Club's activities at the Festival.
