Neena Gada has advance tickets to sell. The India Club received 50¢ for each advance ticket sold.

Fred Dresser from the Minneapolis Aquatennial Committee gave a presentation, suggesting ways in which the India Club could get involved, as each year they try to focus on a particular country.

The second July 11th meeting of the India Club was called to order by the president Zeke Zdenek.

Minutes of the June 20th meeting were approved.

Treasurers Report: The treasurer is working on the audit to submit for tax purposes to file for non-profit status.

A mailing list of board members was distributed.

A telephone list of real and prospective India Club members was distributed.

Cricket Team:

The Indo-American Association lost \$250.00 on the Cricket game. The India Club was asked to make up the difference, however, it was agreed that before doing that the India Club would first assist the Indo-American Association in collecting on unpaid pledges for the support of the Cricket Team.

Questions about why the India Club continually helps the Indo-American Association were explained through the long standing historical relationship which exists since most of the people who are presently in the current Indian Community here, came as students and were members of the Indo-American Association. It is the first frame of reference for new students coming from India to the Twin Cities and therefore very important to the well being of the community.

Dr. S.K. Dash presented the following statement:

"On behalf of the India Club I will set aside personally \$1000.00 to assist students of India for their higher studies. This money can be used to assist the students at the initial period of their program. Details will be worked out for the loan program."

There was mention of an Indian Christian Fellowship group beginning - no specific details.

It was decided that the India Club would pursue a licence to sell food at the State Fair for 1986, allowing each linguistic group to have one day apiece and to specify their own menu and prices.

The Riverfest project suggested by the Kabbi Restaurant conflicts with the Indo-American Associations Independence Day Picnic. This conflict will have to be resolved when the degree of participation of the Indian Community in Riverfest ps determined.

Dr. Dash suggested some sort of retreat for the Indian Community at some future date. Nothing definite came of this short discussion, although Labor Day weekend was suggested. Dr. Dash suggested a Baptist Camp located on Green Lake in Wisconsin, as being a suitable place for such a retreat.

Stefan Peterson reported on the trip he and Shanti took to Washington D.C. involving the Festival of India, events and exhibits, primarily sponsored by the Smithsonian.
