### INDIA ASSOCIATION OF MINNESOTA ORAL HISTORY PROJECTS

### A COMMENT

In 1993 I was introduced to Godan Nambudiripad and Ram Gada of the India Association of Minnesota. The Minnesota Historical Society's new Minnesota History Center building had opened the previous autumn, and in touring the building exhibits and its Library, neither Godan nor Ram had found much on the history of Minnesotans who had come to the state from India. They asked to meet with me to discuss how that reality might be addressed.

The result of that meeting became the first oral history project of the India Association of Minnesota. The sixteen narrators in that project, chosen with an eye to diversity of birthplace in India and religion, provided remarkable perspective on their lives and on the many facets of adjustment to American life and culture, and to settlement in Minnesota. The success of that project, and the rich historical information it provided, launched a joint effort of the Society and the India Association to ensure ongoing documentation of Minnesota's important and growing Indian community. The first project was funded with grants from The Pillsbury Company and the Minnesota Historical Society's Research Program and Oral History Office.

The second project to come from this joint effort contained fifteen interviews with the second generation – the largely born in the U.S. generation of Indian-Americans. A third oral history project dealt with another group of Minnesotans of Indian descent, and a fourth project covered the history of the School of India for Languages and Culture – one of the finest such institutions in the United States. A fifth project will begin shortly to chronicle this history of the India Association of Minnesota. The advisory group for these project has grown to include Preeti Mathur, who organized the SILC oral history project, and Dilip Mallick, who is leading the IAM project.

It remains a great pleasure for me to work with members of the India Association of Minnesota's Oral History Committee, and with other members of the Indian community as well. Their ready appreciation of history, exceptional organizational skills, and generous commitment of time and talent have made the accomplishment of both projects a genuine delight. On behalf of the Minnesota Historical Society and its mission to document all Minnesotans, I am especially grateful for the productive and supportive relationship which these projects have made possible.

### **Minnesota Historical Society Facts & Information**

The Minnesota Historical Society puts history at your fingertips. - a state-wide network of 23 historic sites.

### From the President's Desk

### Vipin Gopal

The first half of 2001 has been one of significant accomplishments for IAM. A lot of volunteer work has gone into these activities, and I would like to thank each and every one of these individuals who helped make all our endeavors during this period a huge success.

Our first major event for the year, the Annual Dinner held on February 18, was a roaring success. About 150 people attended the Dinner at the Airport Marriot, the largest attendance ever for an IAM Annual Dinner. Mayor Norm Coleman of St. Paul delivered the keynote speech for the evening. State Senator Satveer Choudhary was awarded the IAM Annual Achievement Award. State Senator Randy Kelly and Prof. Bruce Corrie also addressed the audience. The event received significant coverage in the Indian American press. Also, many of you were active participants in the Festival of Nations held at the Touchstone Energy Place (formerly River Center), in St. Paul on May 3-6. As in the previous years, we were deeply involved in the Festival through our participation in the Café, Cultural Exhibit, Dance Programs, Bazaar, and the Fashion Show.

Personally, I had the opportunity to visit the earthquake-affected areas in Gujarat during the first week of April, as part of the Indian American team that accompanied former President Bill Clinton during his recent visit to this area. While I was devastated to see the damage inflicted by the massive earthquake, I was heartened by the initiatives taken up by the Indian American Community to help the people of Gujarat in this hour of need. I am proud to say that our community in Minnesota has been extremely active in demonstrating our share of support. India Association has been working with Gujarati Samaj and other community organizations towards the "India Earthquake Relief Fund", which has raised about \$275,000. We will adopt the village of Vijaypar for rehabilitation of all families and work with the organization CARE towards implementing this project. Special words of appreciation to a large number of volunteers who have dedicated countless hours, and the individuals and corporations who have contributed generously, towards this effort. Without their support, the largest fundraising activity of its kind for our community in Minnesota, would not have been possible.

The recent census data has shown that Indians are the fastest growing Asian group in the United States, and is now the third largest. In Minnesota, the Asian-Indian population has more than doubled to 16,887. With the increased numbers come better visibility and stature as well as bigger responsibilities, for the community as a whole. The Indian American community in Minnesota is making great strides in various spheres of life. IAM is an integral part of such community endeavors: the recent extensive media coverage of our activities is a testimony to our contributions to the community, and our long history in acting as an umbrella organization. I would encourage you all to become active participants of IAM, if you are not doing so already. If you would like to learn more about the organization, you are welcome to come to the monthly Board Meetings of IAM, held on the second Wednesday of every month, at 7 p.m. at the International Institute of Minnesota. Also, please mark your calendars - the Summer Picnic will be held on August 19, at Snail Lake Park.

### THE ANNUAL DINNER HAS ARRIVED!

The India Association of Minnesota's Annual Dinner (held on February 18 at the Hotel Airport Marriott) can go down in IAM history as one of the most successful and best-attended. A record number of people who came that evening were treated to a very tasty and elegant Indian dinner and to an impressive array of speakers, including the Honorable Norm Coleman, Mayor of St. Paul.

Welcoming the audience, IAM President, Vipin Gopal reviewed the contributions of the Indian-American community and gave a history of IAM. He also expressed his sadness at the devastation in Gujarat after the earthquake and pledged to donate 50% of the proceeds

from the dinner towards the Earthquake Relief Fund. He reviewed the other fund-raising efforts made by the Gujarati Samaj and other organizations, and appealed to everyone to contribute generously - a message echoed by all the speakers.

Keynote speaker, Norm Coleman, the Honorable Mayor of St. Paul, with his characteristic humorous and relaxed speaking style, extolled the positive examples set by both U.S. and India in their roles as world's largest democracies. He remarked on how they have demonstrated that it is the power of people and not necessarily of the government that makes the economy move forward.

Satveer Chaudhary, the youngest member and only Asian-American in the Minnesota State Senate, was honored with the "2001 Achievement Award." Thanking his supporters and well-wishers, he said that he would do his best to work on matters of importance to the Indian-American community.

Dr Bruce Corrie, recipient of the 2000 Asian-Pacific Council Award, and a professor of Economics at Concordia University, shared his views with examples of how ethnic minorities and new immigrants could contribute positively to the state and the nation. He mentioned the venue and the ethnic food for the dinner as examples of how local businesses (such as the Mariott) were recognizing the growing economic power of the Indian community in the Twin Cities – a few years earlier, such venues would have insisted on providing their own selection of western food.

State Senator Randy Kelly (who was present as a guest of Senator Choudhary) spoke of his appreciation for the opportunity of seeing the community first-hand. He expressed his sympathy for those affected by the Gujarat earthquake, and his support for the Indian-American community in its effort to help the victims.

The evening ended with a vote of thanks from Ashoke Mandal, (Vice-President of IAM) to the IAM Board members who organized the event, and to all the guests who attended to make the dinner such a grand success.

### FESTIVAL OF NATIONS: A FEAST OF TRADITIONS

The Festival of Nations was held at the RiverCentre in St. Paul, May 3-6,2001. This is an annual event organized by the International Institute of Minnesota to stimulate awareness and understanding of ethnic groups in Minnesota, through ethnic cultural exhibits, cafes, bazaars and dances. This program began in 1932 at the suggestion of Alice Sickels, the International Institute's first director. The International Institute of Minnesota is a non-profit organization, which supports programs to teach English as a second language and holds free classes for USA citizenship. It also offers the use of its facilities for meetings and other events to non-profit organizations, e.g. IAM, at little or no cost. The Festival of Nations is the main fund-raiser for the International Institute to support its activities.

IAM coordinated the participation of the Indian community in the Festival of Nations under the chairmanship of Dilip Mallick. We fielded a full offering of an adult dance, a children's dance, a fashion show, a cultural exhibit booth, as well as the India Café and participation in the bazaar.

The special theme of the festival his year was 'costumes and accessories'. The Indian cultural exhibit showcased Indian dance costumes form different regions of India. The following people lent items for the exhibit: Rita Mustaphi (Katha Dance Theater) - Kathak and Manipuri costumes and adornments; Aparna Mandal - Bharat Natyam costume and adornments; and Nina Gada - Garba costume and adornments. Numerous volunteers helped to set up the booth and staffed it during the festival to answer questions from the visitors. Sanghamitra Sahu and Sunil Menon coordinated the organization of the booth. It was judged as one of the best exhibits at the Festival this year!



Thirty-four students from The School of Indian Languages and Culture (SILC) performed a Kashmiri folk dance. Rajinder & Nina Singh, and Manpreet Kaur, choreographed the dance. The girls in the picture above are from the SILC dance group, wearing their dance costumes. The adult dance was a ladies' folk dance from southern India. ## A HISTORY OF ... THE ORAL HISTORY PROJECT

### Vidhya Shanker, IAM-Oral History Project liaison

"We do not need to proselytise either by our speech or by our writing. We can only do so really with our lives. Let our lives be open books for all to study." M.K. Gandhi

In 1991, members of the Indian community raised the lack of Asian Indians' representation at the History Center, even in exhibitions supposedly documenting the history of Asians in Minnesota, with the Minnesota Historical Society. By 1994, the Oral History Project had begun.

Phase I, which began in 1996, consisted of the selection of 16 Indians – from diverse religions, professions, genders, and regions within the diaspora – who had immigrated to Minnesota, to be interviewed. The interviews were taped, transcribed, and then bound. This process was funded through a \$500 donation from Pillsbury and a contribution of approximately \$3500 from the Historical Society.

In 1999, Phase II began. Fifteen additional people from the next generation of Indians, many of whom are children of those interviewed in the 1996 batch, were interviewed. This Phase was funded primarily through allocations from the India Association of Minnesota and the Hindu Society, as well as through smaller donations from throughout the community. Records and relics of the past generously contributed by Surendra Chaudhury and SILC added to the richness of this history of Minnesota's Indian community.

Those working in occupations outside the professions included in the first phase (particularly software professionals), as well as those living outside the metropolitan area, have been interviewed in Phase III (which is now nearing completion), and these interviews are being transcribed and bound. This Phase was funded through an allocation from IAM and a grant from the Historical Society.

Additionally, somewhat separately from these 3 phases, current and former students and teachers from SILC have been interviewed, and this process was funded through SILC itself. Bound copies of the transcriptions of these interviews are expected in the near future.

The next phase of the Oral History Project will detail the origins and evolution of IAM. This involves compiling names of people to be interviewed and assembling all documents and records (e.g. minutes, newsletters, clippings, etc.). Anyone in the community who would like to participate in this process by being interviewed or contributing documents that would shed light on the history of IAM is encouraged to contact Vidhya Shanker at 612-341-6566. Keep in mind that the results of this Oral History project are

available to members of the public at the History Center, whose motivation consists largely of encouraging the Indian American community to visit and participate in its programming. IAM's motivation in helping fund the last two phases and in serving as the subject of the upcoming fourth phase is to help our community and the general public gain a deeper understanding of Indians' history in Minnesota.

### INDIANS SHOULD PARTICIPATE MORE

\*\*\*\*\*\*\*\*

### **Mukhtar Thakur**

There is a great and ongoing need for Indians to participate in various ways to get their voice heard in the cacophony of voices that permeate the American sociopolitical system. What is often forgotten is that we came here to obtain "freedom" in many ways - politically, socially, culturally - freedom to live our lives in our own way. This is precious and needs to be guarded, maintained and nurtured while living and assimilating in a foreign land. We are participating in American society by working here, earning income, paying taxes, and raising our children here: in short, we are living our lives here. Many also vote in elections; many more SHOULD register to vote.

However, we need to do more! In East Africa, and other parts of the world, resident Indian communities did not choose to participate in the political processeven after being offered opportunities by the departing colonial powers; the result is there for all to see. Idi Amin's expulsion of the Asians in Uganda is the very extreme of what is happening in many parts of the world. Not participating in all levels of the "local" society to share views and get your views heard could cause long term hurt to the community.

We have a right to determine how our tax dollars are used – in education, transportation or healthcare for example. Does our community need more ethnically acceptable education - vegetarian or special meals in schools, colleges; and old people's homes? We are going to get old here! That much is guaranteed. Do we need bi-lingual translators in hospitals and nursing homes? If we say we do – and increasing numbers of Indians are realizing that we do - then we have to organize and participate: make our case for our needs, and then we may stand a chance. Individually we cannot deliver every service the community might need; collectively we stand a chance.

These comments were a result of sitting in on a 'visioning' session held by the state body of the Council on Asian-Pacific Minnesotans. Some 50 Asians attended this important session but very few of those attendees were Indians. Indians have to carry their share of the burden of responsibility so that appropriate entities are

informed of the needs of our community - whether cultural, linguistic, food, or other aspects. Multicultural food and hospital translators were some of the top stated needs.

Another important consideration for our community is a better streetscape and snow maintenance for Central Avenue - how are we going to achieve that? How often do you visit the stores to rent that new video or buy chapatti flour and oil and lenga choli and have to walk through slush and snow to get to the store? Would better street lighting help? How about smoother walkways? The key here is to differentiate our specific needs, bring a focus and priority to them, and then lobby appropriately for the needs from the respective entities - sometimes it may mean joining forces with other ethnic communities to do so. Remember that we have to participate - the squeaky wheel gets oiled!

There are many ways to get involved - volunteers are constantly needed: announcements regularly go out at temples, mosques, gurdwaras, and on SANGAM radio program about events - listen and turn up to help. Participate in other 'global' community needs - Red Cross, hospitals, libraries, school boards and so on. Start your own group if you feel that this is necessary - then join forces with others. Join and give your time to the India Association of Minnesota.

The successful local response to recent events in Gujarat- the human tragedy created by the earthquake- provides a clear example of what the community can achieve when it chooses to focus on a common goal and sets aside any regional differences.





### History of IAM History Project (Godan Nambudiripad) Dec. 7, 2002

#### A Brief History of the History Project

In the summer of 1991 we happened to see a traveling display of Asian Immigrants to Minnesota which was borrowed from the Minnesota Historical Society. India was not represented. We approached the Minnesota Historical Society. First we met with David Nysteun of the Extension services of the Society. After much discussion with him he introduced us to Jim Fogerty who heads acquisitions and curatorial department. He advised that oral history would be one of the most valuable contributions we can make for this cause. This will be available forever for

researchers. The Historical Society also provided us with training, which stretched over a few nights.

This effort was lot of supported by Board of India Club (predecessor to IAM) especially Rahim Rahiman who made the initial contacts with the Minnesota Historical Society. Ram Gada, Ella Baldwin and Polly Sonifer were some of the people came to many meetings and the training.

In 1994 Godan Nambudiripad got a grant of \$500 and soon Polly Sonifer got a grant from the Historical Society. Thus we started the effort of writing the Oral History in 1994. Questionnaires were developed and narrators were selected. Selecting the narrators was tough. How does one select about 20 people to represent the cross section of those immigrated to Minnesota. Our criteria of people of Indian origin included people whose ancestors had migrated to other parts of the world, besides the people who came direct from India. Polly was the interviewer and transcriber. We were learning the logistics. We lost a few interviews because of misunderstandings. Some of the people earmarked for the first interviews passed away or otherwise became unavailable. During 1994 and 1995 Polly Sonifer interviewed 19 people which yielded 16 narrations.

In September of 1996 we had a special celebration to mark the completion of this series. That was grand event attended also by the Consul General of India at Chicago, Mr. K. R. Sinha.

Since then we have done oral history 16 people who grew up here capturing their struggles in growing up in two cultures. We are in the process of completing another series, which include the short timer computer professionals, and people who live out state, away from the Twin Cities. Their experience is different from the professionals and businessmen who first came here in the late 60's and early 70's.

The project of the youth was funded mainly by money raised from the public by the History Committee. On major donor was the Hindu Society with a grant of \$500. IAM had pledged \$750 and we used about \$400 of that, the remainder was small donations from the public. Again Polly Sonifer was the interviewer, but Minnesota Historical Society helped with transcription, which is a very tedious job. We celebrated this on Oct. 2, 1999.

IAM received a grant of \$2000 from the Minnesota Historical Society for the next phase of our project. IAM committed \$500. We also used another interviewer, Diana Kenny. This Phase 3 project is now completed.

Besides all the people who volunteered to be the narrators and the History Committee of IAM, the very committee effort of Polly Sonifer over the years and now Diana Kenny; and help, encouragement and counsel of Jim Fogerty, grants from the Pillsbury Company, The Minnesota Historical Society the Minnesota Historical Society, donation from the Hindu Society are all the factors that has made this project possible. Rahim Rahiman for initial contacts with the Minnesota Historical Society, Ella Baldwin in helping compile the initial list of questions and Preeti Mathur for publicity all have contributed.

Along with its 20 Th. anniversary celebrations SILC raised enough money to an oral history. This is also completed.

We celebrated the SILC and IAM phase 3 this October.

IAM Board has committed to writing its' history and this will be started as the next project.

# **Oral History Project celebration**

INNESOTA - India

Historical Society (MHS) celebrated
the completion of the joint project of
recording and preserving the history
and rich heritage of Minnesota's
Asian-Indian communities.

The function was held at the Minnesota Historical Society and was attended by a large number of members of Indian community and students of SILC. It started with "Vande Matram," sung by the students of SILC. Michael J. Fox, Assistant Director of Minnesota Historical Society-Library and Archives, welcomed the guests with inspiring words and a promise for future project cooperation and support from the MHS.

James Fogerty gave background information about the Society. He said that the Society was founded in 1849 and is the nation's premier state

historical society. It collects, preserves, and tells the story of Minnesota's past through innovative museum exhibits, its extensive collections, libraries and educational programs, historic sites, and book publishing.

It was way back in 1991, when Godan Nambudripad who happened to see a traveling display of "Asian Immigrants to Minnesota" by MHS without any reference or mention of Asian-Indian immigrants, that he decided to do something about it. He proposed to the India Club (predecessor of IAM) to set up a History Committee who would outline objectives and an action plan to start a history project. Guided by Jim Fogerty and David Nysteun of MHS, Godan and Rahim pursued the project of recording experiences of Asian-Indian Immigrants to Minnesota,

After receiving a grant of \$500 from Pillsbury Company and \$3,500 from MHS in 1994, the Committee was joined by Polly Sonifer to identify



about 15 to 20 narrators from the local Indian community whose experiences would convey their trials and tribulations of coming to Minnesota

and settling in. "The task of selection was very difficult," said Ram Gada of the History Committee, "because we have many religions, speak over 15 by Haridas Gori\*

languages, and have over 22 states and territories." These 16 oral histories (tapes and transcripts) are preserved as permanent records at MHS for public reading, research projects, and for the future generations.

A set each of the Transcripts was presented to Ashok Mandal, President, IAM and to Chitra Subramanian, President, SILC by Michael J. Fox of MHS. Preeti Mathur of SILC presented an old electronic gadget to MHS for their archives, which she used to use for typing, cutting, and pasting SILC programs, way back in the early '90s.

The program ended with a beautiful Bharatnatyam dance recital by the students of Ragamala Music & Dance Theater—Parvathi Jithendranathan, Pallavi Kannan, and Sarah Gerdes—and a solo Kathak dance by Rita Mustaphi, Founder of Katha Dance Theater.
