My dear President,

You would be aware that the 40th Anniversary of India's Independence and the Pandit Jawaharlal Nehru Centenary will be commemorated in a big way in India over the next two years. The commemoration of the 40th Anniversary will commence on August 15, 1987 and end on August 15, 1988. A National Committee under the Chairmanship of the Vice-President of India, with the Prime Minister as Vice Chairman, and a Steering and Coordination Committee under the Chairmanship of the Prime Minister have been set up to select ideas and suggestions emanating from the National Committee for these commemorations.

2. The National Committee has put forward a number of ideas and programmes to commemorate these two highly significant events in a fitting manner. These, inter alia, have included suggestions for observance of these events outside India as well, through the involvement of non-resident Indians living abroad as well as people of Indian origin. The active cooperation of the ethnic media and the various ethnic associations in this effort would naturally be very helpful. It is also intended that the organisation of such events by Indian communities abroad should be suitably publicised in India.

3. I would accordingly invite your association to participate in these commemorations in an appropriate manner. You may already be organising a special function on or about August 15, 1987 which would mark the 40th Anniversary. Apart from this, the 40th Anniversary commemoration theme could also be used during other major functions organised by your Association during 1987-88 for the benefit of the members. We would greatly appreciate receiving from you as soon as possible details of such functions being organised by your Association for the 40th Anniversary in August 1987, as well as some indication, if possible, of any further activities planned during the rest of the year till August, 1988. It would also be very useful if we could receive timely information providing some details of these functions after they take place so that we can try to arrange for their appropriate publicity in India wherever possible.

4. I look forward to hearing from you.

Tagore Aniversary Program:

Directions:

Eastbound on I-94: Take 35-W to the University and 4th Street Exit. Take a right onto University Avenue, then an almost immediate right onto 10th Avenue (less than a block.) Go over two bridges -- one over the river and one over Washington Avenue. Just as you come to the end of the bridge over Washington Avenue you will be able to see the Center on your left.

Westbound on I-94: Take the Riverside Exit and take a right. Go to 19th Avenue South (it's the second or third stoplight.) Parking is available on 4th Street.

University Parking Space:

There is parking available for University and non-University visitors to the Humphrey Center in the West Bank Ramp, located on the corner of 4th Street and 21st Avenue. The charge is 55 cents for the first hour, and 55 cents for each hour thereafter up to \$4.05. On weekends, the maximum fee is reduced to \$1.05 per day. The capacity of this ramp is 350 vehicles.

For University staff or student visitors, there are two C coupon lots adjacent to and diagonal from the building. Coupons are 70 cents, and can be purchased from all student unions, Bursar's offices, University police departments, or at Como & 29th Street in Minneapolis.

Please note that after 4:30 p.m. on weekdays, the coupon lots convert to cash lots, and parking is available for 70 cents.

It is possible to reserve parking space for conferences, but you must contact the Public Education Office at the Humphrey Center at least two weeks prior to the event. The telephone number is 625-1806.


