Deliver art to the Bloomington Art Center Thursday, May 26, 9:00 A. M. - 8:00 P. M. or Friday, May 27, 9:00 A. M. - 5:00 P. M.

Art must be finished and ready to exhibit:

- * Canvas must be dry and framed or have edges finished.
- * Watercolors, prints and drawings must be protected with plexi-glass or glass.
- * No work may exceed 50 pounds in weight or 7 feet in any dimension.
- * Wall pieces must be wired for hanging.
- * All work must have been completed within the past two years.

Artists planning to ship work, please contact the BAC by phone to make shipping arrangements.

Sales and Insurance

The BAC collects 25% commission on all sales from the gallery, and any sale resulting from the exhibition of an artwork in the gallery. Artist must list sales price including this commission.

* Payment for additional insurance is due immediately upon notification of selection.

* Total insurance value may not exceed 75% of sales

Rejected Work: Artist must pick up work on or before June 3. A \$5 per day storage fee will be charged for late pick-up starting June 4.

Selected Work: Art will be exhibited until July 17. Artist must pick up work Sunday, July 17, 3:00 - 5:00 P. M. or Monday, July 18, 9:00 A. M. - 4:30 P. M. A \$5 per day storage fee will charged for late pick-up starting July 19.
