This exhibition is open to any artist. There are no residency restrictions. Art must be original and must have been completed in the last two years. Art must NOT have been exhibited in a juried show in California.

Rules of Entry

HOW MANY? Up to two works of art may be submitted per artist.

FEES: Each artist will pay a non-refundable entry fee of SIO (SDAI member) or SI5 (non-SDAI member). This fee entitles the artist to enter up to two works.

ENTRY: All entries will be by 35mm 2" x 2" SLIDES. Mark each slide as shown. One slide per work may be entered, except for 3 dimensional work. Up to 3 slides of ONE 3 dimensional work (showing differing views) may be submitted.

MEDIA: Work may be two or three dimensional. All media are welcome except crafts.

SIZE RESTRICTIONS: No 2 dimensional work shall exceed 6' vertical and 8' horizontal, including frame, nor shall weigh more than 50 lbs. All frames must have screw eyes or track mounting clips and heavy wire attached securely for hanging. Wire should be attached to the frame at a point 1/5th of the vertical measurement. All works on paper must be framed or under protective coating: glass, plexiglass or plastic spray coat. Glass must NOT be used with metal frames if any one side exceeds 25'. Three dimensional work shall be a minimum of 10' and a maximum of 84' in height; no more than 6' in length. Three dimensional work shall not exceed 100 lbs. in weight. UNACCEPTABLE: Electrical works, wet paintings, works needing special hooks, any work considered unsafe, unframed canvases with staples exposed. NO SPECIAL HANDLING OR SPECIAL INSTALLATIONS.

Shipping instructions will be sent after initial acceptance of slides. There will be an additional handling fee of \$20 for works shipped. (No fee for hand-delivered.)

Slides

Non-accepted sides will be returned if a SELF ADDRESSED STAMPED ENVELOPE is included. Accepted slides will be retained for the permanent slide collection of SDAI.

Sales

All work must be for sale. A commission of 35% will be paid to the SDAI upon sales. On credit card sales, a 3½% service charge will be borne by the artist. The gallery offers a 90 day Layaway Plan, with a 30% deposit. Artists checks are mailed on the 10th of the month, in the month after completion of a sale.

Insurance

The SDAI carries limited insurance for loss or damage to artwork in the gallery. No coverage exists of work in transit. Artists whose work exceeds \$900 in value should consider carrying additional coverage.



Rules of Entry

ENTRY: All entries will be by 35mm 2" x 2" SLIDES. Mark each slide as shown. One slide per work may be entered, except for 3 dimensional work. Up to 3 slides of ONE 3 dimensional work (showing differing views) may be submitted.

MEDIA: Work may be two or three dimensional. All media are welcome except crafts.

SIZE RESTRICTIONS: No 2 dimensional work shall exceed 6' vertical and 8' horizontal, including frame, nor shall weigh more than 50 lbs. All frames must have screw eyes or track mounting clips and heavy wire attached securely for hanging. Wire should be attached to the frame at a point 1/5th of the vertical measurement. All works on paper must be framed or under protective coating: glass, plexiglass or plastic spray coat. Glass must NOT be used with metal frames if any one side exceeds 25". Three dimensional work shall be a minimum of 10" and a maximum of 84" in height; no more than 6' in length. Three dimensional work shall not exceed 150 lbs. in weight.

UNACCEPTABLE: Electrical works, wet paintings, works needing special hooks and special handling, any work considered unsafe, unframed canvases with staples exposed.
