To the Deans: -

Owing to the new law which requires that a copy of the inventory of the University of Minnesota be filed with the Public Examiner, it will be necessary this year for the departments to make a copy of the inventory for the Public Examiner and one for the Comptroller in addition to those needed in the departments. Inventories should include all property acquired up to August 1st and should be submitted not later than August 15th. It is customary for most departments to take their inventory the later part of May or the first of June, as all purchases for the fiscal year have been received by that time.

Only property belonging to the University of Minnesota should be listed in the inventories. Such items as window shades, electric light fixtures (except desk lights), black-boards (built in) and built in shelving should not be included in the inventories. Such items as beakers, test tubes, flasks and bottles should be listed under Class "I" Laboratory Supplies.

All libraries are under the jurisdiction of the General Library and will hereafter be inventoried by the Librarian with the exception of those of the Department of Agriculture.
