Dear Amnon:

Further to the matter of your discussion with the Vice President on our behalf just to give you an idea of what the invitation itself would look like I am sending a very rough dummy. The cover would consist of a painting created especially for the occasion by either William Earl Singer or Gregory Glucksman, both of them internationally noted artists. The invitation would be, without any question, the most elaborate we have ever done.

The more we examine the situation the more convinced I am that the State of Israel Commendation Dinner should take place in June or September, not in the earlier part of the year. We need months of preparation because worldwide correspondence is involved. You may assure the Vice President that were he to agree to come to Los Angeles to present the Medallions of Valor lists of the nominees would be submitted to him for approval before invitations are issued to such nominees to come to Los Angeles. Thus we would avoid even the remotest possibility of embarrassment resulting from the presence of any Medalist who would be persona non grata to Mr. Humphrey.

As you may know the list of nominees is compiled from many sources upon the recommendation of distinguished members of our community. In every case, the nominees for Medalists of Valor must be individuals who in one way or another have made a significant contribution to the growth and welfare of the State of Israel. After the primary culling of the list of nominees the list is submitted to our National Office for approval. That list is then sent to the Ambassador of the State of Israel for review. We would, of course, in the case of Mr. Humphrey's acceptance, also submit the list to his office for review and approval.

You are at liberty to tell the Vice President that we have never had fund raising at a State of Israel Commendation Dinner. Attendance is limited to those who, prior to the event, have completed the purchase

in that year of not less than \$1,000. Thus the event is, in effect, presold.

A list of those who now hold the Medallion of Valor was earlier sent to you. I am sure the Vice President would find the Medalists to be among the most illustrious personages of the world. He could have every assurance that the 1967 list would be no less distinguished.

We have waited for a long time before deciding to go ahead with a 1967 State of Israel Commendation Dinner because there is no point in doing this event unless it is done superlatively well. The entire capability of this organization would be at work to make sure that the 1967 dinner would be one to reflect glory and dignity upon all who participate. I shall look forward to word from you and if the opportunity presents itself please do give the Vice President my personal greeting.


