

W. 3888 dated February 28, 1938, by which the Northern Pacific Railway Company granted the State of Washington permission to construct two grade crossings for Primary State Highway No. 18 across portion of the unoperated Ritzville Branch right of way in Section 29, Township 19 North, Range 35 East, and Section 25, Township 19 North, Range 34 East, W. M.

This easement has been filed in the Right of Way Department as Ritzville Branch Deed #198.

The NORTHERN PACIFIC RAILWAY COMPANY, a Wisconsin corporation, does hereby, in consideration of the agreements herein contained, permit the STATE OF WASHINGTON, in common with the use by said Railway Company for railroad purposes, to use for highway purposes only and to construct thereon a public road known as Primary State Highway No.18, those portions of the railroad right of way of said Railway Company for the proposed extension of its Ritzville Branch between the stations of Schrag and Ritzville in the County of Adams and State of Washington, described as follows, to-wit:

Those portions of the one hundred foot right of way of said Railway Company in the southeast quarter of northwest quarter (SE) of NW1) and in the northeast quarter of southwest quarter (NE) of SW1) of section twenty-five (25) in township nineteen (19) north of range thirty-four (34) east of the Willamette Meridian shown colored in RED on the plat attached hereto and made a part hereof identified as Exhibit "A"

Also those portions of the one hundred foot right of way of said Railway Company in the southeast quarter of northwest quarter (SEt of NWt), the northeast quarter of southwest quarter (NEt of SWt), the southwest quarter of northeast quarter (SWt of NEt) and the northwest quarter of southeast quarter (NWt of SEt) of section twenty-nine (29) in township nineteen (19) north of range thirty-five (35) east of the Willamette Meridian shown colored in GREEN on the plat attached herete and made a part hereof identified as Exhibit "B"

This grant being made without any consideration other than as hereinafter stated, the Railway Company reserves the right to use said right of way for railroad purposes and to cross said Primary State Highway No.18 with one or more tracks in both iccations, and the State agrees to bear all expense of future changes in said highway which may become necessary should the Railway Company at some future time elect to construct said track or tracks on its right of way; it being understood and agreed between the parties hereto that the Railway Company shall not be assessed or liable for any expense in connection with the construction and/or maintenance of said crossings so that the Railway Company will be placed financially in the same position as it would have been had the highway not been constructed.

The State also agrees to bear any expense that may be caused in making the highway grade meet the railway grade when established and in the event that the construction of said crossings interferes with the drainage conditions on the Failway Company's property, the State shall at its sole cost and expense make such changes in its drange as shall be deemed necessary by the Failway Company.




