

" FAMILY of FAMED EXPLORER ONCE LIVED AN BRANDON "

Why was Carver Street in Brandon village so named? The answer will not be difficult to one who delves a little into the early history of the town. For the Carvers were numerous and prominent here in the latter part of the 18th century and beginning of the 19th.

Captain Jonathan Carver was born in Massachusetts in 1710. He magried Abigail Robbins in 1746, and moved to Montague, Mass, in 1749. He served in the Colonial Army throughout the French and Indian War (1755-1763) being a captain at capture of Fort Fort william Henry, where he was wounded. At the end of the war he resolved to explore the territory east of the Mississippi acquired by Great Britain from France, and started on his expedition in June 1766. In all he travelled as much as 7,000 miles, making friends of the Indians, with whom he spent much time. This was a tremendous feat, considering the means of transportation then, first by stage, then by canoes, boats, horseback and on foot. He returned to civilization in 1768 and, having spent his entire fortune in his explorations, he sailed for ngland in 1769, where he petationed the Government for reimbursement. He received nothing , except permission to publish an account of his travels. He passed the remainder of his life in ingland, where the first edition of his book, (London, 1778) appeared with the title "Three Years Travels through the Interior Parts of North America " . For this he received nothing beyond the expense of publication, and in 1780 he died in London in poverty. No trace of his grave remains today, as the graveyard wherein he was buried was built over and disappeared. After his death there arose a great demand for his book, and many editions were published in England, Ireland and America. It became and was for many years the great source of information on the regions which he explored. Early editions are now scarce and command good prices. My copy was published in Philadelphia in 1796. An edition published in Tutland has practically disappeared. A copy turned up some years ago and was bought abyothen merican Antiquarian Society of Worcester, Mass, for \$50. A biographical sketch may be found in the Encyclopedia of American Biography. The portrait shows a soldierly figure, attired in costume, with a prepossessing countanance, indicating intelligence and culture.

Capt. Carver had nine children, seven by his first wife, and two by his second wife, whom he married in London. Of the children by his first wife, all but the first two were born in Montague, Mass. His second daughter, Abigail, married Joshua Goss of Montague, in 1774, and some time after the outbreak of the Revolutionary was they came to Brandon, where Goss bought a tract of 110 acres, located on the road now leading to the Arnold District, a little north of the present Brandon State School. Here he built his log house and remained till 1796, when he sold his land and bought a farm of 180 acres, which is now the town farm, where he built a frame house, on the site of the present farm house and kept tavern there for many years, it being on the stage route between Boston and Montreal.

Rufus, son of Capt. Jonathan Carver, was born in 1754, and married Pricilla Cummings in 1780. He was a soldier in the Revolutionary war, and took part in the battle of Bunker Hill and in the campaign in which Burgoyne and his troops were taken prisoners. He and his wife moved to Brandon, where his wife died in 1832, aged 73 years, as her gravestonein the cemetery at the Congregational church attests. Rufus had nine children, of whom the following lived in Brandon: Fanny, born 1781, married 1795 Seth Keeler at Brandon; Sally, born 1788, married at Brandon 1815 Ebenezer Warner; Abigail, married at Brandon David R. Beal in 1811; Olive, married at Brandon Walter Cooley in 1813; Mindwell (a good name for a child, also for a married woman) married Henry Ambler at Brandon in 1826; Polly, died at Brandon 1827, aged 30; Lucy, died at Brandon 1803, aged 14 months. At some date not known Capt Jonathan Carver's wife Abigail came to Brandon and died here in 1802 at the age of 72. That she was a woman who occupied a place in the affections of those who knew her is shown by the inscription on her stone in the aforesaid cemetery:

- "Abigail carver. Died Nov. 9th, 1802, in the 73d year of her age.
 A virtuous wife, a mother dear, To friends & neighbors very near,
 She left them all in peace and love, We trust whe's gone to dwell above."
- "It is known that she was here in 1800, as in that year her son-in-law, Joshua Goss, conveyed to "widow Abigail Carver" a tract of 77 acres of land in consideration of \$500.

There seems to be no record of what Capt. Carver was doing during the nine or ten years between his arrival in England and the publication of his book. He seems to have been a little careless about his marital obligations, as he married a woman in England, in spite of the fact that he had a wife living in America. He may have revisited this country, and if so may have come to Brandon to see his daughter and son-in-law. At any rate a man of his fame, and having so many of his family here, must have been well known here by reputation, at least, and Carver Street may have been named in his honor particularly, and that of the family in general, or perhaps as a joint memorial to him and his son Rufus, the Revolutionary soldier. At any rate it perpetuates the name and memory of the famous traveller, explorer and author, and so far as known is the only such memorial in existence.

A daughter of Joshua Goss married Dr. Adoniram Smalley, the father of Orange Smalley, who collaborated with Thomas Davenport in his invention of the electric motor, and so the Carvers and the Smalleys became intermingled. The only descendant of these two families now living in town is Carver Smalley, who is the great-great grandson of Captain Jonathan Carver.

Martha Carver, Daughter of Captⁿ Jonathan Carver by his wife Mary (maiden name Burgess of Froome, Somersetshire, & widow of Capt Charles Harris of the Royal Navy) born 12. August.1779 & Baptized in Lambeth - married to John Pope 30 Jan 7, 1779 at St Ann's Lymhouse - have a daughter, named Martha Mary, born at Dover 6 December 1802 & Baptized at St Mary's - in Dover.

John Jonathan Carver, son of Capth Jonathan Carver and Mary Carver his wife born in Goswell Street 1775 and died in Tooley (?) Street 3 November 1790 & buried at St. Mary's Overburough in 15th year of his age. His mother died, same time, and was buried with him.

Capt Jonathan Carver, born at Stillwater 1732 in the State of New York & died in HolywellMount Shoreditch Parish, London on 31 January 1780 and buried in Baptist Burying Ground in Hollywell Mount & Gravestones erected by his widow - in the following Words - "Here lie the remains of Captain Jonathan Carver

who departed this life January 31st A.D 1780 aged 48 years, many years Commander of a Company of Foot in America. a Man greatly respected and lamented by all his acquaintances. This Stone is erected by his disconsolate Widow as a Small Tribute to the Memory of an affectionate and loving Husband and tender Father to his Children.

No 53 Westsmithfield London March 5th 1805

Dear Sir (M^r Sam^{ll} Harrison, of hittenden Verdmont)

I have sent you two parcels of letters in Jany & February, via, NewYork to the care of M^r Albert(?) Ryekman, and W^m Birdseye Peters Esqr. March (?) respecting Capth Carver and the Indian Deed of Land adjoining to the East End Of St Anthony's Falls in the River Mississippi 125 miles N.W. of Chipeway River which falls into the South End of Lake Pepin through which runs the Mississippi. Carver's Grant extends E. up the hipeway River 100 miles - this you see the Location of Carver's Land. Mr. Matthew Cox informed me that the Documents respecting Carver's Grant were in possession of Mr. John Coles of New York, but has not told me that the original Deed given by the Sachens to Carver is with M^r Coles - W.B.Peters, Esq^r will be a

proper Person for you to employ to enquire of Mr Cole . . I fear Capth Carver has sold more than the 3,000,000 Acres to R. Smith Esqr. New Reports reach me daily and I suspect such Tricks have been plaid off against the Daughter here & Children there of Capth Carver that will render their Interest in the Land if recovered precarious, while the Expense with ongress and the Indian Sachems will be certain & great. If "ufus Carver & his Brother & Sisters are not rich Eno(?) to carry on the Search I should advise them to make use of an Assistant to find the Money Etc. Etc. &tto accept a Share of the Land on its being recovered. I wish the Children of Capth Carver may defeat the Machinations of their Enemies. I perceive that Matthew cox has done all in his Power by help of Mr John oles, Mr Rufus King & Mr Pinekney (?) and others to obtain the President's Approbation of the Indian Deed in favor of Mr & Mrs Pope only, as they took Letters of Administration on Capth Carver's Estate at Doctors Commons, and as such empowered Cox to act for them in England & America, not knowing or Suspecting Capth Carver had any Children in America - It seems to me that Cox & and his Connections had a design to obtain the Land for themselves & not for Mr & Mrs Pope, as they held up the Idea that Capth Carver had sold most of the Land in Sundry Parcels to Rd Smith & others whose Deeds are held in Patto(?) to be used against Pope & his wife when the Lands are recovered under Mr Cox is not willingt to believe ufus ,etc,etc, are their names & Power. Children of Capt Jonathan Carver but hold them up as Children of a Brother of Capth Carver - Those things should not discourage Qufus etc.etc. from Speedy Exertions toward securing their Claim. Rest assured that the State of New York will oppose the Claim of Carver because that state claimed all the Western Territory between Lat 41 - and Lat45 to the Western Ocean by Royal Instructions excepting only what has been taken out by Royal Charters - on this Ground the \$ tate of New York ceded (?) their Right and Claim to the Western Territory to Congress & so vested Congress with their hight & Claim to the Land granted to Capth Carver. this idle Claim of NewYork will be used against Carver's Grant with a view to prevent those who bought shares in Carver's Grant being benefitted & to give Congress the sole right to purchase the fee of the hipeway Tribe for a trifle & then to Sell it for two dollars per Acre. If you have not Strength & Policy enough to bear down such National Arguments at Congress, Carver's hildren will lose their Claim Nevertheless I advise them to do all in their Power to gain their Right. and after putting before ongress their Claim & Petition; a Man well skilled should be Sent with a Copy of the Original Deed to the Indian hieffs to gain their approbation of their Ancestors Grant to Capth Carver which will be a Strong Argument for a confirmation of it by the President &oof Congress. The extent of Carver's Grant is said to amount to 12,000,000 Acres & by others 6,000,000 Acres . the least makes it to be larger than the State of Vermont. The Presents Sachems undoubtedly know its bounds by Tradition tho Mrcox says the heiffs of the Chipeways and of the Noudowiss (?) never heard of Capt J. Carver Name or of any Deed granted to him - he would not tell me that he or Mr Coles had sent a Messenger to make the Enquiry of the Indians - but I find a Man named Clark was sent with (goods) to them some years ago who was murdered & and Robbed on the way by some white unters whatever you do in this concern use Speed and caution and as much Privacy as Possible. My Son W.B. Peters Esqr would make you the best Messenger among the Indians if you can prevail on him to undertake the Journey . Adieu S. Peters.

Addressed to Mr Samuel Harrison, Chittenden, County of Rutland, Vermont.

London 22 d April 1805

My dear Sir.

I wrote you on Jany 12, Feb6th & 26. again onthe 5 of March 1805 respecting the Land granted to Capth Carver by the two Sachems & have been searching for the original Deed withour finding it - I find Capth Carver sold a Quarter of the whole to R. Smith and two thirds of the whole to A.B.C. and D and gave Deeds accordingly. which left only one 12th to his Heirs. and People here from N. York tell me Rufus and Jonathan Carver & their Sisters Sold the greater part on Speculation since 1792. The People who bought on this side of the Atlantic will not sell their Rights, but intend to Claim after Carver's hildren have been at the Expense of getting the Deed ratified by ongress & the present Sachems of the Nowdowisies. . whether Congress will allow the printed copy is a Question but suppose they do - it is doubtful whether the Indians will allow it. if they should the Expenses will rise to a great Height. Those Deeds given by Capt Carver were not in Law because he had no right to the Land until his Deed was ratified by the King which was never done & Carver's Children's Deeds since are not for the same Reason - because Congress have not ratified the Deed -Carver's Children ought not to bear the Expense if able while Strangers Claim the Land as theirs -

You will find what number of Acres have been Sold by the hildren of Capth Carver in America & then you will be able to give them advice whether to go on or Stay where they are - I will advise them to give one General Quitclaim Deed of the whole to A.B. which warrants against the Claims of all the Heirs of Junathan Carver deceased - and under the General Quitclaim Deed let A.B. pay all Expenses at ongress & with the Indians and if A.B. gets possession of the Territory, then A.B. to be held to give a number of Acres to each Son and Daughter of Capth Carver.

But mind this, Rufus Carver his isters & Brother must suffer A.B. to use their Names in the Petition, as if they alone were concerned in sueing for the Land - because the Name of Carver will be the Strongest Argument you have to succeed with Congress & the Indians. When Possession has been gained by A.B. & A.B. has given Deeds to Children as per ontract then Carver's Children must go & Settle on the Land and each build a House in Carversville near the mouth of Chippewaw River in a limited Time, & the first Settler shall have his choice of a Block of Land in said ity to build on, & So the Second comer to have the next Claim until 400 ouses are erected. the City Lots should not exceed half an Acre Each - all made in right Angles.

to shun all Claimants A.B. must have the Indians ratify their Deed to Capt Carver by giving a new Deed to A.B. the Asignee of Carver's hildren and the Title beenew and to a different Person - then all old things will be done away.

If my Ideas strike yours, I hope to meet you at Carversville with Mr & Mrs Pope & all the Children of Capth Carver in 1806.

I wish you to consult usus Carver etc.etc. and advise them how to act & if agreeable to see my son, William Birdseye PetersEsqr of Stratford in Connecticut, or at Mr Albert Ryekman's "ouse in New York, a Merchant there, who will be better able to communicate matters to you than I can write & will be your best Guide I know of in America in this uncertain concern. The Carvers under existing circumstances I think will never receive Benefit from that Land only in the way I have above hinted. My on is capable & will be ready to advise and assist in raising the money to try the will & pleasure of ongress where the first step is - & the second is to go to the Indians. Silence & Expedition is the Safty of your Application. it will prevent opposition & future Law uits, if my plan is successful - You will note the Fall of St Anthony is West of "iagara Fall 450 miles & the Climate is much milder than Vermont or Detroit. Please write to my on the result of your doings with Carver's 'hildren. I dispair of ever finding the original Deed. The --- of L --- ('ondon !) under Capt Carver are not honest enough to do any Justice to the Children of Carver in America pretending

Dear Sister

Last week I recd an invitation from Saml Harrison in Chittenden to pay him an immediate visit accompanied by my son-in-law - Mr Harrison's Wife's Nephew S. Keeler. What could occasion the pressure for attendance immediately I could not devise For the card was not sufficiently intelligible to admit explanation. I think it was in nearly in these words 'Chittenden May 2(?) 1805 he pleasure of a Visit is immediately expected from S. Keeler on the receipt this and your wife's Father Rufus Carver Esqr I hope will not fail bearing you company - The charm is broken - the gloom dispells - Farewell Your affectionate uncle S. Harrison.'

We accordingly attended but what was my surprise when I beheld soon after my arrival a letter from the Revd Dr S. Peters a letter in answer to Mr Harrison giving me the much desired information I had been so long seeking in vain. I had the intelligence

My Brother and sisters all with me join in love and respects to you, my dear ister, you my Brother and your lovely Infant hoping it will not be long before we shall meet you in America and unitedly share with our Posterity the Land of our common Father and benefactor Till then I shall subscribe myself your

Chittenden Vt June 13th 1805

His Ex - T - J - P - - U. S.

Sir

Having the temerity to approach your Exec -y four weeks ago I beg leave to again solicit your attention to ---- unknown individual on the subject of Capt Carver's Indian Claim. I then mentioned to your Exellency that I was employed by a son of the late Capt in behalf of his children to pursue every legal measure to validate the claim to his posterity their (word lost) and assigns. I besought your advice on the same But have no answer - And since I have ventured to embark on the ocean " I have attempted to navigate the Supernumerary Stream." I informed your Excellency I had written to a gentleman in London (?) capable of dispelling the mysterious gloom which had involved in obscurity the affair of Capt CarverAnd that I was hourly & anxiously expecting a return. I wrote to your Excellency on the 15th of May, and on the 22nd I received a letter frommy correspondent dated Feb. 12 centaining-much (marked out) it gave me some information and giving intelligence of a Packet sent to me Six days before containing all he was pleased to express himself - all he yet knew on the subject. The Packet I have not yet received. His intelligence correborated what I before surmised and had hinted to your Exellency that Capt Carver married again after he had heard the Death of his Wife and had one

Daughter born in England. (words gone, think # "that she") married and had one child-That many people imagined her to be an only child not knowing Capt Carver had been married in America. And many had tried to deceive and marry her for the sake of her Mississippi property thinking her heiress to the whole - That both Englishmen and Americans had practised the Deception and intimated that R.C. (Rufus Carver) and his brother and sisters were impostors (?) endeavoring to rob her of her legal rights and had not (too finewriting cannot decipher) The Lady's name is now Martha Pope and is convinced that Capt Carver was married in America and is willing her transatlantic relatives should share with her and has employed S.P - LLD (Samuel Peters, Vermont Clergyman) to negotiate her business and assist me in obtaining from your exellency together with the present sachems a confirmation of their claim. Dr. Peters has desired me to make no delay but give immediate information

to Mr Smith (a Vermont Senator) whom he calls one of your members of Congress. For fear some sly trick &manoeuvre should give into the hands of Mr Cox and his party at Philadelphia some undue advantage.

As I had before made communication to your Excellency I waited some time expecting the Packet but my expectations are yet frustrated and I cannot yet gain any intelligence of its Fate. On the (4th Inst?) I wrote back an answer to the Gentleman that I had already addressed your Excellency and though I respected Mr Smith with our other Vermont Member, as Inhad with any of them an intimate acquaintance I should not attempt to introduce myself (to) them to make intercession for another introduction - (I)find myself embarrassed for want of the Packet that I cannot lay before your Excellency those Particulars I expect it contains but I expect the Claim was not ratified by the British Government by this clause in the octor's (Peters) letter "That Mr and Mrs Pope are well disposed toward Capt Carvers American children and that they had rather have a ninth of the. land than the whole if her brother and sisters would meet her there when informed by the President of the United tates and the present Sachems"

But had informed your Excellency of the subject myself withour the round of formalities practised in Europe That I was emboldened to do it by the advice of an old Legislator in Massachusetts and I (?) it would be the most ready way to a completion. However had I received his letter a week sooner I should have complied with his instructions and not thus have teased you with my audacious intrusion.

I now feel more importunate for advice than when I before addressed your Excellency though employed to negotiate for others I find myself unequal to the Task - I desire to be informed whether your Excellency has Constitutional power as Executive to validate the claim on the part of the United states, admitting you have the disposition. Or whether it must come before the Territorial(!) Legislature before it can receive your Excys sanction. Or whether it must be a Judiciary Question

I find in 8 Section of the first Article of the onstitution the Legislative Powers defined but cannot find a definition which answers my question unless "To regulate commerce etc and with the Indian Tribes." And in Sect 9 "No bill - - or expost facto law, or law imairing obligation of contracts."

For the 2nd Article I cannot find my question answered. The 2nd Sect demonstrates "That the executive powers shall be vested in a President"

The 2nd Section defines his Power but the Problem is yet to me unslolved. Neither can I find the 3^d Article any satisfaction. In the (?) Ar (ticle?) I discover that "Full faith and credit shall be given to public acts records" and in Sect 3" The Congress shall have power to dispose of and make all needful rules and regulations respecting the Territory and nothing shall be (-tern)should read so construed) as to prejudice any claims etc."

Thus Sir my interrogations are yet unanswered. I find no one amongst acquaintances able to give me the desired information how to proceed. I have exposed my ignorance and again implore your exellency's advice and assistance.

Perhaps S.H. left out some of the above - seems to repeat himself in the next few lines-

I have examined the ^Constitution but cannot find a solution to the Problem - my interrogations are there unanswered and I find no one among my acquaintances able to give me the desired information. I have exposed my ignorance and again implore your extensive advice and protection and assistance.

Sensible it is an object of your Excellency's attention to extinguish the Native right of soil over such considerable portion of Territory would it not be expedient to appoint some proper person to explore the country and discover the dispositions of the present (torn, probably Sachem) whether they are willing to ratify their engagement with Capt Carver and would not the 16th of next June, 1806 be a proper time to have the persons concerned in the mission on the premises. The previous to the Solar Eclipse their credulity might be wrought upon and they would discover a great degree of superiority in the Genius(?) of the White People than those of their own Complexion.

But I hope I shall be excused in attempting to hint any addition to your superior Wisdom. my proper sphere is to negotiate for the Heirs of Capt Carver - I cannot help fostering a secret confidence that you will be pleased to write in answer to my request and confer perpetual obligation upon your Excellency's unworthy though humble

Letter to Mr Joshua Goss from Samuel Peters

No. 144 Water Street, Newyork 29 Nov. 1805

My dear Sir :

I arrived here in good health on the 18th & after consulting with my son, it was found necessary for Samuel Harrison Esqr as agent from Mr Rufus Carver, Administrator on the Extate of Capth Jonathan Carver, Decd to come and go with us to Congress, at our Expense & to be here by the 15th od Decr 1805.

Last Monday I wrote to Mr Harrison & you - and fearing that Letter may miss its way I write this - to request you to apply to Mr Harrison & to beg his attendance here as soon as possible - if I am out of the way my Son will receive him & afford him the necessary Article & Clothes. He will bring the Letter of Administration, the Power of Attorney from Rufus - the Deed from him & the Heirs to my son & all Letters & Affidavits on the Subject - all things being prepared on your side, I hope for Success - from the Character of the member of Congress from Vermont.

The Quantity of Land from the Indian Deed to Capth Carver no doubt will be a bar in our way & may cause a wish with Congress to give a part to the Heirs & retain a part to Congress - their Proposal, be it what it may, must be omnipotent, & the Heirs must comply with it - thus we stand on a needles point - but I will try it at 5000 Dollars Expense if Mr Harrison and the Heirs fail not on their part.

Mr Harrison should have a Power from Rufus Carver perfectly full to act as circumstances turn up before Congress etc.etc. - and to act for the Heirs as he would act for himself & to Sell or give up all Right and Claim of the Heirs to Said Land for such cummutation in money, in goods or in Land as shall be proposed by Congress & its Agents. Many Bars & Difficulties lie before us - yet I doubt not of Some kind of Success adequate to our Expenses. Mr Harrison can come here on Horseback & return the Horse, or go on with him to Congress - otherwise go with us in the Stage - he has his option. Your Senators & Members in Congress would know Mr Harrison & the Heirs of Captr Carver

and this is no small advantage. Be of Good Cheer and exert your Abilities now or be Silent as to hope in future. It is now 25 years since Capt Carver died - this Bar we must surmount or we cannot succeed. If the presence of Rufus before Congress is required he must be ready to attend on Receipt of a Letter, at our Expense

Notation on above letter

Written by Samuel Harrison - "In my letter to Dr P - of July 12th 1806 after some salutations etc I wrote - I have not seen any of C -s since I wrote to you on the 16th of June but expect Rufus at my house every day. I am surprised that Mr B - should not furnish you with the money for to me to go to the distant Heirs as you know it was agreed it was to be sent on the saturday after I left NYork - that he need not think his impatience has exceeded mine. I want to know the result - I feel a determination to pursue the claim if my health permit and my Debt to Nature" do not interrupt - But I cannot feel willing to do much more on uncertainty. If he concludes to give all up tell me so, if he concludes to go on as agreed I am ready and willing to exert my influence—But money is the Sinews of War & Peace And money is wanting and must be had - If he will furnish it I shall be glad t- But if not I shall look on the situation (torn) I have not money myself But have that which will promise it - (torn)

Wrote Wm B. Peters Aug 19, 1806 again Sept 5th

To Samuel Harrison from S. J. Peters My dear Sir,

Albany , October 23d 1806

I wrote to you from Newyork after having several Interviews with Mr Broome to acquaint you that he was obliged to return to London on Business & expects to be back in Philadelphia next June & has promised then to visit the Fall of St Anthony with Rufus Carver Esqr yourself and me in great style, provided the Heirs have compleatly Signed Said Papers of Conditions which you carried with you, So as my Son & all Parties can finish the Contract - and provided also William Hull, Govr of Michigan Territory & the Superintendent of Indian Affairs in that part of the Country where Capth Carver's Claim lies shall have given a proper Passport to Rufus Carver & company which his Lawyers tell him Govr Hull cannot, or will not give, notwithstanding what Genl Dearborne told you and me at Washington. I have written to Govr Hull the whole State of the case & referred him to Mr Justice Woodword for further Information& onfirmation of my story & requested Mr Hull to send the Passport to me at Yorktown in Upper Canada, and also, to send a Letter addressed to me at Newyork to the care of William B. Peters Esqr at Newyork - which my Son will open & communicate the contents to you, whether he has sent or will send or give a Passport to Rufus Carver & com(pany) "to go & obtain a Confirmation of the Deed given to Capth Johathan Carver, Dec, by two hiefs of the Nowdowissie Tribes on May 1st 1767 at Great Cave " hould Mr Hull refuse a Passport he will assign his reason for refusing & then it may be necessary for you to write General Dearborne or Mr Jefferson for a Passport which they cannot refuse with any Decency. You & all know we cannot go without a Passport in the Sense of Law: and the ill Temper of the Spainard now reigning will render it dangerous to go at this Time with the President's Passport. I have been lame for four weeks since my return from Connecticut by means of the

Gnatts & Musquatoe biting my Legs - I was like Mephiboshth the Grandson of Saul the first King & greatest Curse that befel the Jews for their Rebellion against Theocracy; ; & adopting what is called Democracy- i.e. the overnment of all or many. Israel, we read, was wretched in the time when she had no King, because every man & Woman did what was right in their opinion - that is, they were not governed by any fixed Law - or Laws - except Private opinions - his was the case of Germany, England, Switzerland . , Holland & America and all Protestants now behold & see the end of Luther & Henry 8th Reform from Roman Laws to private opinions - or Liberty . Memphis swallowed up the Jews & Bonneparte and Paris shall swallow up all Tongues & Nations

(Am not sure about the punctuation of above. Dots and dashes all over !) I have not heard who is Governor of Vermont nor who were voted for in your district in Lieu of Judge Olin - If you had not a good share of Votes my Friends & yours have been Negligent or not sincere in their promises. Many Prophecy that Senator Israel Smith is elected your ovr & that ovr Tichenor is dropped for the Sin of Federalism - a System the 17 States must soon adopt, or obey France & Spain. The Day is lowering & dark clouds hang over America, while the Light of Bonneparte illuminates & Governs all Europe - Helah !

I am now on my way to Rome, thence by water down the Wood Creek & the Onoida Lake to Oswego; thence in a Ship over Lake Ontario to Yorktown where my Daughter Hannah Deloenna(?) Jarvis lives with six children - When I am there I shall provide Indian Interpreters & hoats to go with us from Lake Limcoe(?) to Misittimaakinah (?) thence to Michigan Lake, thence cross 3 miles over to Ouisconsin River which runs west to the Mississippi River, thence up 200 miles to Lake Pepin.

I shall write to you as soon as I hear from MT Hull& have Discovered anything worth the Postage I shall expect to hear from you while I reside in Canada, So write my Son at Newyork - I hope Mr Goss, Mr Rufus Carver & all the Heirs & Connections are well & happy - I have not written yet to Mrs Pope at Dover, England. & shall not until I know the result of the Passport & the Decision of Congress on the laim. Mr. Scott is on his way to poston thence he will go to Vermont & call on you to find out what has been dincovered by you & your Friends respecting the ways of Gen. (I.A. (?) -

Mr Broome is doing great things & will succeed unless Bonneparte prevents him by Starving poor old ingland, who owes L800.000.000 and cannot pay L500.000.000 of it -Let all bless William Pitt for all these things -

Bonneparte, or 666 (?) is soon to be Crowned Emperor of Germany in Room of Francis lately resigned - Russia, Prussia & France are soon to take possession of Constantinople Egypt & the Red Sea - Eeec ! (?) the Consequences! East Indies are to be lost to England; tho , my Friend Simcoe is there - commander - in- Chief in Lieu of Cornwallis. Mr Ryckman has sailed for Madaira, -----(cannot make out the word) & River -- (?) All in Newyork were well & those who know you sent respects to you & wonder you have not published your Poems. our letter I expected to receive at this Postoffice is (if?) The Season & want of Health stops my Journey to upper Canada.

The Season being late & I haveing ill Health I apprehend I must return to Newyorkh & write to Mr Jarvis in upper Canada to do all things & that we hear from him soon Health & Respects to you all - My Health is yet bad but I an yet your Fidet(?) Letter to Samuel Harrison from Samuel Peters

No 50 Essex Street Newyork March 9th 1807

My dear Sir:

The hard winter is past and the raths are over and gone. & I am yet alive to hear to See & hear of many, very many Sorrows in urope & Myriads of Fooleries & a thousand & one Degrees of Insincerities in the United tates; where Self Interest, discord and Want of Union promise every Evil that came out of Pandora's Your letter of October 7th 1806 reached me in due time, but Mr Goss' of 26 April 1806 never came to me until December 2d 1806 & I had to send to Mr Granger for it, who seems to be the only honest man in Columbia for which reason Jn.º (1) Randolph of Indian Memory & all Rogues must Persecute him for doing right . . . Genl Dearborn told us that Govr Hull was the proper Person to give you & Mr Rufus Carver a License to visit St Anthony's Fall - therefore I wrote to Govr Hull at Detroit to send his License to you - having received no answer I wrote to Judge Masters at Washington to apply to Dearborn for a License to St Anthony's Falls - he applied & Wrote the Words following to me Feby 27, 1807 - "Govr Hull is at Detroit -It is not usual customary or necessary for any public officer to give Pass ports unless for Foreign countries - neither can a formal Treaty be held with the Indians by our Constitutions , unless under Direction of a commissioner appointed by the President " Ergo - you or Mr Rufus Carver will see it necessary to write to the President & obtain from him a proper Passport to visit St Anthony's Falls - herein you will lose no time - as Jefferson may be inclined to do Justice to Carver's Heirs because he must go out of his present Station at the next Election, otherwise he and his present Adherents will do nothing for Carver's Heirs. fearing they may not, like Olin, help the Revinue which is necessary to build a Bridge over Potomack, Bribe(?) Conneparte, & form a turnpike to Ohio -I communicate mow the opinion of the Committee viz, " that a Confirmation of Carver's Deed by the present Sachems or Chiefs of the Nowdowissee Tribes of Indians would not induce the 'ommittee to report in favor of the Claim of Carver; for they consider the Claim, in toto, bad , & that no movements on the part of the Claimants can make it good - The usiness was laid over from the last Session of Congress without making a Report - Nothing further will be done unless moved by Mr Harrison or some other Agent for the Claim " I. S th (Israel Smith (?) Thus far we have gone , & know, from the Present Congress - governmed by Olin & such as fear the prople at large who are taught to believe every Acre is worth two Bollars to the Treasury of Congress that lies West of the Allegeny Mountain, or of the Mississippi River to Nootka Sound. Oh ! how rich is Olina his Congress & the United States ? - in Idea, design & Cunning to dupe the Multitude & keep themselves in Place & on Pensions ? A Revolution of Policies is near & new men will produce new Measures - the old are not worth a nitch in human Memory. the New will leave all the old at home & Appoint better men than ever disgraced America in Congress -I am not afraid to try again the Claim of Capth Carver's Heirs before a ongress not composed of Men who have bought Ohio State, Indiana etcetc, to make themselves rich & noble without paying one Cent for what they have promised to pay 200 Cent -

Verbum Sat tibi ! I pray you to write to Jefferson for a Passport & to name Stephen Thorn Esqr to be his ommissioner to go to St Anthony with R Carver Esqr & yourself & others in order to produce a Ratification of the Deed given to Capt Carver by the Nowdowissee Phiefs in 1767 - his answer will decide our movements, until Jefferson is out of office & an honest man is placed in his Room which may be Burr or the Devil -Mr Broome is in Europe but we have not yet received Letters from him- yet daily expect to - Thank God, the Congress arose on the 4th Current on Nothing but 6 Dollars per diem for every 20 miles until they reached their respective Dens - Israel Smith, A Graham Baldwin & John Smith might have told you what they designed to report on Carver's Claim but they had a purpose to serve Interesting to their Party they now suppose the Dye is cast & the trap has Sprung & they are Safe & they see no danger in letting out the Cat -If you have not Succeeded withe the Heirs of Capth Carver & obtained a Deed according

to Mr Broome's Statements, he, nor my Son, nor I myself Shall Ever trouble ourselves more about the Land conveyed by the Nowdowissee Chieffs to Capth Carver -If you have succeeded, we will pursue the Claim under a new President & a new Congress which Thank God is near at hand -

My Son is at Stratford & next week I expect he will be here - by the first of pril I shall be at tratford - & soon after be at Albany on my way to upper Canada - from which Place you shall hear from me - my on will be happy to see

you or hear from you at Stratford -

Last week Govr Hull was her & by his advice and directions I stated the whole affair consisely from first to last in a Letter to Govr Hull which he took & enclosed to the New Secretary of War. I prayed him to lay the same before the Secretary of state and the new President & then to give him their Directions & orders respecting the Concern of Carver's just & equitable Claim & he would in next July treat with the Nowdowisse Chiefs respecting that Deed who would be at the Convention of the Indians at Michillimackinac as already fixed & agreed worn- Govr Hull added " if the present

Sachems should allow their Predecessors Deed to Carver in 1767 Congress would not have

to purchase the Indian Title to that large Parcel of Land " Govr Hull requested the order to be forthwith Sent to him at Detroit by the "ime of his Arrival there ,i.e. about the 15th of May present, & said he doubted not but the order would be there as soon as he was - & if So , he would write to his Son, A F. Hull Esqr , attorney of Law in this ity whom I have made Agent for you & Carver's Heirs to conduct this Business with his Father EtcEtc. By the Govrs Letters his Son & I shall know whether it will be necessary for you & Rufus Carver Esqr to go to Detroit next July - if so , the Govr will write to you & to his Son what must be done - - in short it must be proved that Rufus EtcEtc are Heirs and Children of Capth Carver - an attested copy of the original Deed must be there & the Governor has desired the Secretary (Mr Otis) to give one to the Secretary of War - for Govr Hull. Hull will give the Nowdowissee Chiefs a Present & charge it to me thus are matters fixed & if the Secretary of ar does not fail Govr Hull the Heirs of Carver & you & I are sure of success - as ovr Hull is certain the present Sachems will confirm their Ancestor's Deed to Carver, if they ever gave thattDeed of Mayl, 1767 "be-"cause the Indians are the most honorable People on Earth " Besides the above - Col' Mathew Lyon has been here for three weeks, seen & read the whole tory about Captn Carver's Claim & is Sanguine that Congress will ratify & Confirm the original Deed ,on the Allowance of it by the present Sachems - and Says he will do all in his Power in ongress for the Benefit of Carver's Heirs, being convinced that the laim is genuine & much due to his Heirs - But Col Lyon is of opinion that Congress will insist on having Some Part of the Territory, as they have trouble & Expense to form it into a Government & support the Governor EtcEtcEtc. I asked whether half would content the Congress - the col said he believed it would. I calculate that next winter Congress will decide the fate of Carver's Claim. Mr. Broome is yet at Paris & by late News he will not soon be here. should claim half of Carver's Right the Heirs ought not to have so much as 150000 Acres, Therefore I request you to draw your bond direct (torn, probaly, to) me & my bond to you as Agent of Carver for as much less as you judge proper. please then to send both of them to the (address of) Stephen Thorn at Granville & request (him) to Send my Bond to you, to me at New(york) I will then sign & Seal it & return to gone but sentences can be deduced fairly well) I gave a short history of you in my vindication of the Rev (?) Whatever you intend pray let me know by return of post& also forward said bonds to Mr Buell at Troy or to Judge Graham or to whom you think proper, with speed that all things proper may be done & made ready-If you neglect npw all future Endeavors will be vain & idle - Col Lyon is on the spot & will not fail to assist the Claim of Carver - Thus will A A also many others in the middle of the northern States. Health & respects is the valuation of your fidet (?) S.A.P.

Though Mr Jefferson has done his best to destroy the claim of Capt Carver by purchasing 20 miles (lat ?) or wide on Carver's Claim next to the river of an Indian of one of the tribes of the Nosdowissee tribes & Dr Mitchel was one of the ommittee of that purchase for 2 or 300 dollars I fear not if Hull gives a ratification of the present Sachems of Carvers Deed As Madison & the ongress will not dare to bring that purchase against Carvers Claim, which was laid before Congress in 1806 - We are free of Jefferson & our Committee, I Smith. A Baldwin & Ir (?) Smith, all of whom were enemies to Carvers Claim & they have received proper payments - Yet I am sorry for the insanity of Israel Smith who was at best but a friend to himself during his sanity (3) or he would have provided for you as I requested & he promised to do . our new overnor Galusha is Bother-in Law to ol Lyon & to Mr Chittenden of ongress, you may obtain letters & their interest & others of your members in ongress at this Critical period. I trust you & Captn Carver's Heirs will meet me next Spring near Lake Pepin and then begin our Halcyan Days after many Troubles. My Health & Spirits are good & high & doubt not of perfect Success by going to that promising Land where the Gentiles are become friendly to the White People, who have built a Saw & Grist Mill on the West side, or End of St Anthony&s Fall -I pray you to offer my kind respects to your Lady & Family& to the hildren of Captn Jonathan Carver & to tell them to make ready to take Possession of their respective Townships, ach Six Miles Square & to be called after their respective Names -Carvers Port is to be the Capitol - formed in Square Blocks, Each containing half an Acre - If you send me soon an Attested Copy of the Heirs Deed to me, Samuel Peters, I intend to outfit you in Vermont before august next, for I think Rufus Carver Esqr or yourself will see it necessary to go with me to the Great Cave . Let not your Magistrate's ommission make you forget to answer me effectually & Soon as all matters will rest as they now are till that Copy reaches me. I have lost four years depending on othersmen to do my Business. I wish I had gone with you & Rufus instead of Sending others to the Nowdowissee Chiefs. I now am resolved to go & make my own way while the Sun shines & I know your Exertions will not be wanting in this important Concern to yourself, Capth Carvers Heirs and me. Letter to Mr. Joshua Goss from Samuel Peters
Addressed -Gentlemen: Rufus CarverJoshua Goss, & amuel Harrison

Gentlemen,

Elisabeth Street Corner of Grand ,Newyork
August 22, 1812 ,New date

I now write to you, Rufus Carver & Joshua Goss now August 24 1812 instead of writing to Samuel Harrison Esqr of Chittenden to whom I have written six Letters respecting the Carver Claim adjoining the Fall of St Anthony; but cannot a d have not received Any Answers from him; tho' I often hear he is yet living -- I suppose Mr Hgrison's Letters to me have lost their way, as well as mine to him, by some perverse means. I have no doubt of the validity of the Indian Deed to Captn Jonathan Carver - I have full Faith in the present Chiefs of the Nowdowissee Tribes will ratify their Ancestor's Deed to Capth Jonathn Carver & permit His Heirs & their Assigns to Settle on & occupy the said Territory conveyed to Captn Carver, his Heirs and Assigns forever - To comply with the Directions of the Committee of Congress to obtain from the Chiefs of Nowdowissie I have sent three Messengers to them. The two first went no further than Missillimackinac Fort, the third reached the Fall of stAnthony but as yet has made me no returns , whether he is dead or living I know not. Therefore last Spring I sent the fourth Person, as yet I have had no News . Thus five years have gone by and all to no effect; except what was done at Congress in 1806. I see that nothing will be done until I go in Person to the Nowdowissies - I have determined to Set off on that Journey So soon (this "utumn) As Mr. Harrison shall Send to me his Certificate "that he has in his Possession" & keeping a Deed, or Deeds from Rufus Carver & wife, and all the legal Heirs of Captn Jonathan Carver , deceased, conveying their Right & Interest in & to Said Territory , to the Revd Samuel Peters , L. L. D his Heirs and Assigns forever"

When I have his Said Certificate here I will let you & Mr. Harrison know the Time I will

meet you at Ballston. I now tell you that Rufus Carver or Mr Harrison must go with me to the Indian Chiefs with proper vouchers of their being legal hildren of Captn Jonathan Carver, decd - MT Harrison knows how to have that Business properly fixed - When we meet at Ballston, I will give Proper Deeds to the Heirs of Capth Carver according to my Bond - and receive the Deed or Deeds from Capth Carver's Heirs as by their Bond. The Reason why I need the foregoing Certificate is - viz, a number of Gentlemen have verbally agreed to assist me in Settling said Territory on reading Mr Harrison's tatements and Arguments before the Committee of Congress which they say are Masterly and invincible and prove the Energy of his "ind and Memory - thus far they are Satisfied -mand want a Certainty of Capth Carver's Heirs, and that they have conveyed their Right & Title to Said Territory to Samuel Peters & his Heirs and assigns by a Deed or Deeds in the keeping of Samuel Harrison Esqr of Chittenden in the County of utland & tate of Vermont - When thei Point is established by Mr Harrison those Gentlemen will forthwith be Satisfied and enable me to set off to visit the hiefs of the Nowdowissies. our Interest and Wisdom will compel you without loss of time to call on Samuel Harrison, Esqr your Agent and mine with this Letter and urge him to forthwith Send his said Certificate directly to Samuel Wright Esqr , Vesey Street, Newyork -This Direction is necessary - lest our City Land Jobbers should detain his Letter should it be directed to Samuel Peters -Thus you see the necessity of your Speedy Esertions by Striking whilst the Iron is hot " Fail not of doing well to yourselves and to me, and make due Return to this Letter in manner as already pointed out by your living Friend and Father (by Promise made to Captn Carver on the Day he departed from human life to live with the Eternal Spirit - (on January 31, 1780 at London / - Samuel Peters N.B. No 1 The Sales & eeds of Mr John King appear to be numerous and Cover more Land than is contained in the Patent to Capt Carver . - and Land jobbers have decried (?) and almost ruined the Claim of Captn Carver's other Heirs - those outcries of the many Landjobbers in five years more will kill & obsolete the Deed given to Capth Carver by the Sachems on May 1, 1767 - as 50 years limits the Power of eeds of Land unoccupied then Carver's Heirs will lose their Interest and ongress Will ,or may, Purchase the Territory of the Sachems. Thus Gentlemen learned in the Law tell me -" Caveat Vendor - Caveat Emptor " is a law Maxim that is : "take care Seller - take care Buyer " & See your Title is good -The War with England will drive on Many Settlers, & Prompt Exertion at this time will give us "Possession of the Land of Promise " he Motto is "Now, or Never" - for Death may Come. Soon & will not Stop me nor you"from Seeing the Land of Promise " - before next"Dog
Days" -)

Harrison Esq^r dated at hittenden August 12, 1812 which gave me mush Joy & Satisfaction - & was glad to know he was yet living and has found out the Treachery of

Mankind as I have also done. No Letters will direct henceforth to Samuel Harrison Esqr

with my Pen and he will not Address any Letter to Dr Samuel Peters in his handwriting

& So we will prevent rhe Landjobbers tormenting us any more by Stealing our Letters
Yet Mr Harrison must Send the Said Certificate as above Pointed out to Samuel Wright Esq

Letter to Samuel Harrison from Samuel Peters

Nº 79 Vesey Street, Newyork March 27, 1813

My dear Sir & ousin,

Your Communications via Samuel Wright Esqr camesafe & we endeavored to have your Letter to Mr Keeler printed in our Newspapers - but all refused to insert it because it being Just and true did not uit either Party of our Politicians - Faction & Quarrels are Deemed better than the onstitution & the Glorious Rights of the United tates - owever your Letter was read in Tammany Hall & Washington Hall & was highly approved by all & the uthor greatly applauded with Huzza. Your tatement of the deeds Signed, Sealed & acknowledged by Capth Carver's Heirs to Samuel Peters being in your Possession to be delivered by you whenever Dr Peters should fulfil his Contract by giving his eeds to Capth Carver& Heirs & to Samuel Harrison was satisfactory to Mr Wright & all Concerned, & has ilenced Clamour raised by those Impostors, called Kings, all of whom had acted as Sonsin Law of Capth Jonathan Carver:

Yet those Gentlemen who have proposed to purchase Lands of me & Settle them so soon as Detroit is recovered & upper Canada is subdued by the Troops of ongress, as that will put the Indians on Terms of Peace with the United States, require of me to have the Deeds of Captn Carver's Heirs in my Possessionand put on Record in this City before they will buy any Land of me. I am ready to sign the Deeds to the Heirs of Captn Carver & to you according to ontract any Day you Shall Please to appoint & so give up our respective Bonds; to do this I believe the best way will be for you to send the Deeds I am to sign down to Troy or to Albany to the care of some Person you know where I(?) will go and Sign Seal & acknowledge them and receive the eeds of the Heirs of Captn Jonathan Carver. But I will leave the usiness to you to appoint the timeaand Place where we shall meet to close all former Bonds and Contracts between Samuel Peters & the Heirs of Captain Jonathan Carver - I request this Concern may be Speedily finished as I cannot proceed to act with those Gentlemen before those Deeds are here & recorded.

I shall wait for your Answer to this Letter and then follow your Directions - tho it will be very inconvenient for me to go further than Troy.

Property of Carver's Heirs - or - of the Nowdowissie Tribes - otherwise no White

Last week General Hull was with me here and Said he advised me to Settle on Carveras Territory & he warranted that the Nowdowissie Tribes would ratify the Deed their Chiefs had given Capth Carver in 1767 and defend the Heirs against all other Claimants — that ongress had not urveyed that Land & could not until Congress had bought the Land of the Indians; who being Gentiles not hristians had not learned to Cheat, Capth Carver's Heirs & Assigns by selling Said Land to ongress — that said Hull was & is Superintendent over the Nowdowissies & Peters and other Settlers would need nothing more than to deal Justly with them to preserve Eternal Peace with them — Col Burr gave me the same opinion So did Dr Mitchell and advised me & the Heirs of Capth Carver to Settle the Said Land so soon as Possible without troubling ongress any further who had no Claim to any Part of the Soil, because it is the Bona Fide

COPY OF LETTERS CONCERNING CARVER CLAIM

Letter to Samuel Ratrison from Samuel Peters continued

March 27, 1813

People in America had any fee simple Title to one foot of Land in North America - Thus I will act & dispuse the expost facto Law of Congress - I hope you will be ready to go on Said Land with me by next June or July - I have sent 60 Families to Settle said Land - Samuel Wright Esqr was about to answer you Letter when a Blood vessel in his Atomachtbursted and in a few Days put an End to his mortal Life and God the God took his goul to Heaven - You will please to direct your Letters to me thus: Solomon Wright Esqr 70 Vesey Street Newyork.

Samil Wright answered Capth Bowden. I have heard no more of him.

Solomon Wright Esqr is Brother Samuel & is my Agent. Jonas Wright Esqr is in the country & not related to Samll or Solomon.

The River will be clear of Ice to Troy very soon So that I can meet you there if you Chuse.

Please accept my Love and best Respects & offer them to your Lady & Family; & tell the Heirs of Captn Jonathan Carver I am with Pride & veneration their adopted Father and will continue So until the Candle of Life has burnt below the Socket & then we will Live forever with our blessed Dead - which will Charm us all - Adieu my beloved Friend & Cousin Samuel Peters

Chittenden Sept 7, 1812

My dear Sir:

Your letter of the 22nd, 23rd, and 24th all in one sheet to R.C., J.G., and (torn, probable word- myself) are received as also one from you to me of the 23rd of July, together with one from J. Wright, Esqr (torn, date missing) of July all requesting me to send certificate that I have in my possession, a conveyance (torn, probable word - from) the Heirs of Carver, & (aptn) Jon , deced, their Right and Title to the Land given to him by the Nowdowissie (too fine to read) to the Revd Saml Peters L.L.D - (torn - probable word - you) are sensible Dear Sir of the embarrassment to which I shall be subjected should I Bo (torn) give such a Certificate without the onditions are first complied with, being placed myself in a critical situation - first as em(torn, could be employed) irrevocable Attorney to Carver's Heirs and Secondly being employed as Agent to yourself, Son & Mr. Broome to accomplish the signature by the Heirs of C - of the Instruments Committed to my charge at N York 1806 - The Instruments a(torn, could be are) (the next line is ed, so it is probably -) signed , sealed and certified but are to remain in my hands until certain conditions are complied with (Torn, could be or) I shall suffer myself to be implicated by my first employers. You have not forgotten, I dare say, the promise you made to me and your Som made to me and likewise Mr S. B...e (probably Broome) made to me that pecuniary aid should be allowed and a specified Sum was to be remitted to me in June 1806. It is now Sept and the money (cannot decipher) which had been previously expected to bring about that business (cannot decipher) (now the other side of sheet and the torn edge) ____ and I have not received it. of my friends to prosecute the accomplish (torn, must be ment) of the business, some of which was from some of the Heirs, particularly Mr G. . T - when he signed I promised (torn, probably him) never to deliver the Papers until I received money enough to pay him. I had some more (torn, probably from) Mr G. s to whom I made the same promise. I hired some from some friendly persons at (torn) for which I have paid yearly an interest of 15 percent and expended agreat deal for (torn) of my own. It has cost me not less than 1000 in money (cannot decipher) of which I borrowed, exclusive of my Time to bring matters to their (torn, probably - pre) sent bearing in the Carver Claim All at my own expense excepting from Stra tford to Washington and from thence home. (torm, probably - the) se ,Sir, are some of the Reasons I gave J. Wright Esqr . term , could be If) I could receive CCL or CCC dollars to pay where I have borrowed I should not hesitate then to cannot decipher) peremptorily all that I can and wait until the claim of Carver is determined for the rest of my past expenses. You may safely send it to me in B.B., enclosed in a Letter directed to me in Pittsford -When you direct to me at hittenden the Letter stop at utland and I have either to get it from that office or after some delay it may be ixd (?) and forwarded and perhaps never - But directing it to Pittsford it never stops until it comes to that P office, and O T E is w particular friend and I generally receive it intarfew hours after he receives it. Your N.B. No 1 to Mr J.C.G. and me "that the Deeds of Mr John King appear to be numerous and cover more Land than is contained, etc" I answer - Mr Jno King amy sell the Moon if he pleases, it will be nothing to you nor me. No Mr King, to my knowledge, was ever connected with the Carver Family - Mr Samson(?) King is married to Mary, the Eldest daughter of Mapth Jonn Carver. I informed you often that he had conveyed away some of the Land, and the probability is that many of the speculators have succeeded in defrauding honest men by a spurious title predicated on Jno. King. You say " 50 years will kill and obsolete a Deed " You recollect that Mr Jefferson when P - US wrote to me ,S.H. in answer to my request to him May 15, 1805 for to have liberty for C Heirs to settle that Territory - In his answer ,dated June 15, 1805 he says no recognition of itle can be had nor any settlement permitted." from May 1765 to 1805 = 38 years that 12 years must expire after a settlement is permitted before the Deed of Carver can become obsolete for being unoccupied for 50 years. "Caveat emptor" - Caveat" vendor = need to frighten either buyer or seller-Your N.B. No 2 says If Mr. Harrison had received & answered any one of my Letters

since May 1st 1812 I might and Should have been to Detroit with overnor Hull etc"
Since I began to write this Letter I have recd a Statesman's office extra from N.Y
from some person unknown dated Aug 29, 3 oclock press stating Gov Hull has taken
Fort Malden Aug 1, 1812 in UP With a Nomination for D. W. C. for next President
- and have likewise a Bennington Letter Extra dated Aug 29, 11 oclock press, stating
that ov Hull is taken and his whole Army at Detroit to which place he had retired for
want of supplies. this is what I expected and what I predicted in a Letter I
sent to Mr Madison dated May 11, 1812 advising him not to declare War in the present
unprepared, defenseless situation of the S. I begged him not to declare War
himself for I am certain that the War will be unpopular. It will terminate dishonorably. it will end in disgrace.

(From "this is what I expected " to "end in disgrace" letter is marked)
(with criss crosses - Perhaps he didn't send that part!)
It was not so in 1777 - the American Arms were not so disgraced at B-- on Aug 16nor at Stillwater in Sept - nor at Saratoga in Oct 1777 nor at Yorktown 1781.
It grows dark -ean-net-decipher -----
