Staples proposes 'life-long' educational system for all

Emily Staples, DFL-Labor endorsed candidate for State Senate from District 43 (Golden Valley) said she wants to see a "life-long" educational system accessible to persons of

"People should be able to drop in and out of the educational system as they want," Staples explained, after recently receiving the endorsement of the Minnesota Federation of

Teachers.

"Job retraining is especially essential. Middle-aged persons should be able to learn new job skills whether they are unexpectedly, unemployed, entering the job market for the first time, or just developing new interests."

Staples said she would like to see more scholarships available, especially to persons older than traditional college age. She feels that the state colleges should continue to expand into the communities and offer classes at flexible hours so that more persons can take advantage of existing educational opportunities.

'We can only achieve these goals through a long-term comprehensive funding program for the state universities, community colleges, and vocational schools," Staples explained. "But this doesn't have to be done entirely by state funds. This is a good opportunity for private industry and education to work together. I hope businesses will continue to allow their employees time off and partial financing so that they may upgrade their education in all fields, 21-year Plymouth resident stated.

Staples has also worked at the University of Minnesota as a staff member of the Women's Center. There she did employment advising

for women in mid-career.

Staples said she feels it is equally important to increase the number and availability of counselors in high schools and colleges so that students can have assistance in developing

their goals and potential.

"More counselors are needed so that students will consider the careers and educational opportunities right for them," continued Mrs. Staples. "Students should be steered away from overcrowded fields."

Staples says increased funds are

essential in this area.

"Too often counselors are considered a financial frill," explained the DFL-endorsed candidate from District 43. "They are an integral part of the education we are providing. Both school districts and higher education institutions should seriously consider this."

SENATOR ROLF NELSON HAS REPRESENTED DISTRICT 43 IN THE MINNESOTA STATE SENATE FOR THE LAST FOUR YEARS. WE'VE HAD A CHANCE TO SEE WHAT KIND OF REPRESENTATION HE CAN GIVE US.

IS HE WORKING FOR YOU?

During the last three days of the 1976 session, Sen. Nelson missed every vote taken on the Senate floor. These included, the Stadium Bill . . . Omnibus Energy Bill . . . Bill establishing Community Mental Health Pilot Program . . . the Campaign Disclosure Bill . . . an Executive and Judicial Branch Salary Adjustment Bill . . . the BWCA/Mineland Reclamation Bill . . . the Bill Expanding Corrections Ombudsman Powers . . . Council on Economic Status of Women . . . Electronic Funds Transfer Bill . . . the Item Pricing Bill . . . and other pieces of Legislation.

From the votes taken during the 1976 session as a whole, the AFL-CIO selected 22 key votes to tabulate as a representation of the voting record of every state senator. The Senator missed 10 of 22 votes. Only 1 of 67 Senators missed as many. The question is not whether one Senator should have agreed with the AFL-CIO position on these issues, but whether he should have cast a vote for the people of his district.

SHOULD A SENATOR ATTEND MEETINGS OF THE COMMITTEES TO WHICH HE IS APPOINTED?

Good legislation comes from good committee meetings!

In the 1973-74 session the senator missed 39% of his committee meetings, the second worst attendance of 67 senators. In 1975 the senator had the worst attendance record at committee meetings of any state senator . . . In 1976 the senator had the 12th worst attendance record.

SHOULD A SENATOR HAVE THE RESPECT OF THOSE WITH WHOM HE WORKS?

In March 1976 MPLS Magazine published the results of a survey evaluating the perceived effectiveness of Minnesota State Senators. Senator Nelson was rated the second least effective of 67 State Senators. The people surveyed (Legislative staff and Lobbyists) are those who work the closest with all state senators and have the experience to evaluate the day to day effectiveness of each of these senators.

In the campaign preceding the November elections, those of the 67 members of the Minnesota State Senate who choose to run for reelection will stump their districts telling the voters all they have accomplished as senators in the past four years. During the campaign, the senators will stress to their constituents how effective they were in dealing with the questions they faced in the state legislature.

But the way the senators will define effectiveness may differ from the way the voters define the term. Effectiveness is an elusive but essential quality. To aid voters in evaluating their senators, *Mpls.* magazine set out to establish a realistic criterion to measure the senators' effectiveness. . . .

But since effectiveness is, in great part, a subjective impression, we decided to ask opinions of those who come into contact with the senators on an almost daily basis — the permanent members of the senate staff, the lobbyists and the members of the capitol press corps. By relying on their judgment of the initiative, leadership and desire to serve not only their constituents but all the people of Minnesota, it is possible to arrive at a fairly valid measure of the effectiveness of the individual members of the senate. This we did. . . .

The questionnaires also asked members of the permanent senate staff, lobbyists and press to list the least effective senators. In this category, the problem of effectiveness and the respondents' personal feelings are especially important.







SCOPE

The world, western culture, this country, our state, and you, are presently in the midst of the most dramatic transition of all time....from living in an industrial and goods era to that of a communication and human services era. And there are many who say that in this new era there is nothing that individuals and humankind cannot achieve if we have strong images of the future.

Fred Polak, noted Dutch historian/sociologist says, however, that in the middle of this transition and "for the first time in three thousand years of Western civilization, there has been a massive loss of capacity, or even will, for renewal of images of the future." He and others go on to say that when a culture loses its capacity to dream of its future it will fall. Individuals as well as society become what they image their future to be. And when individuals have no images of the future, we are in serious trouble.

The workshop is to explore the implications of that notion in terms of certain of our primary social institutions such as the family, the church, government, business, media, and education. It is further to examine what it means for the individual as well as the public policy.

The American Bi-Centennial calls attention to our heritage in many ways. It is our assumption that the most important way is how our heritage provides resources and direction for our future. This workshop is a celebration of those resources, that direction, and our many futures. We will look therefore at our ability to image positive alternative futures and the uniqueness of Minnesota.

GENERAL FORMAT: Each presenter will speak approximately 12-15 minutes. Following each presentation there will be opportunity for discussion initiated by the audience. After each of the major sections - media, family, education, business and government, and belief systems, there will be opportunity for panel interaction and concluding statements. The audience's role will be taken very seriously in helping us to raise and clarify important questions for this research.

To the editor:

I was extremely disappointed by your editorial of May 30. In most other publications, this session of the Minnesota Legislature was commended for the amount of business which was conducted and for its responsiveness to the citizens of Minnesota. That was certainly apparent in tax legislation - the largest cut in the history of the state.

You indicate that important business is done at the last minute. That is true, but building an a tremendous amount of effort which has been spent since the first day of the session in January. Long hours of work are not reserved for May, as committee members and those who observed and testified will tell you.

As you should know, legislation is considered by numerous committees in each body. Usually it is not until the final few weeks that both bodies have acted on major bills because of that process. What makes the last few weeks of the session extremely busy is meeting in conference committees to work out compromises between the Senate and House versions. That is a result of good pacing and management - not a lack of it.

Further complicating this session was the fact that departmental bills from the Governor's office were extremely late in arriving for legislative consideration.

You state that Senate Majority Leader Nick Coleman cried during the last few days of the session. If that is true certainly none of his collegues or any other media people were aware of it.

Senator Coleman did cry, as did I believe almost every member of the Senate, the morning the death of Senator Robert Lewis was announced. Had it been the first day of the session it would have been no different. Apart from that I was not aware of emotionalism on the Senate floor - And I was present for every session.

My greatest concern over your editorial is the lack of knowledge it displays and the cynicism it perpetuates. Legitimate criticism of the legislature is necessary and productive. Yours is distructive and I believe harmful.
