Virtually all of the business organizations have indicated that they are providing a variety of services to meet the specialized needs of their members. For example, the **Minnesota Association of Commerce and Industry** through its Small Business Council offers various services to its more than 2,000 members throughout Minnesota. Write: M.A.C.I. Chambers of Commerce throughout the state have developed numerous programs to assist in the growth and development of small business. Contact your local Chamber of Commerce for help.

GOVERNMENT RESOURCES

Over 20 state agencies surveyed were able to locate within their budgets \$882,520.00 earmarked for direct program assistance to small business.

Some of the agencies having an impact on small business persons include: Commerce Department, Economic Security, the Department of Education, Energy Agency, Housing Finance Agency, Labor and Industry Department, Public Service Department, Department of Public Welfare, Department of Revenue and the State Planning Agency.

SMALL BUSINESS CONCERNS ALL OF US

Why Senator Staples is Concerned . . .

- Between 1969 and 1979 small business accounted for virtually all of the new private sector employment in this country. The largest firms in our economy, as listed in the "Fortune 1000", contributed less than 2% of the growth in new jobs. The impact of small business on employment is almost 66 times greater than that of large, corporate business.
- Since 1960 the small and medium-sized businesses' share of corporate manufacturing assets has declined by more than 20%. If this trend is not reversed, we may soon be in a situation where a very small group of people control the bulk of corporate wealth.

SMALL BUSINESS CONCERNS ALL OF US

Why Senator Staples is Concerned . . .

- Between 1969 and 1979 small business accounted for virtually all of the new private sector employment in this country. The largest firms in our economy, as listed in the "Fortune 1000", contributed less than 2% of the growth in new jobs. The impact of small business on employment is almost 66 times greater than that of large, corporate business.
- Since 1960 the small and medium-sized businesses' share of corporate manufacturing assets has declined by more than 20%. If this trend is not reversed, we may soon be in a situation where a very small group of people control the bulk of corporate wealth.
- **Emily Staples understands the problems of small business men and women in her district.** She is ViceChair of the Senate Employment Committee and has served as Chair of the Economic Development Subcommittee for three years. She was a Minnesota delegate to the White House Conference on Balanced National Growth in 1978. - Supported the Governor's appointment of James Otto as a Workers Compensation Judge (Appeals Court).

- Reduce workers compensation rates.

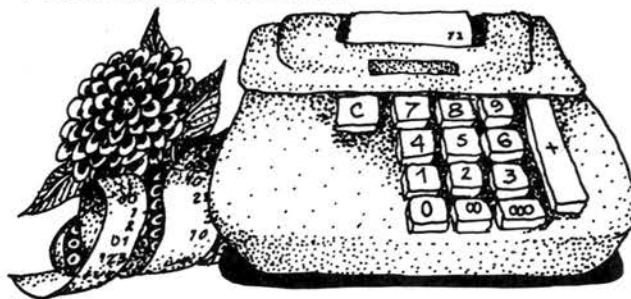

Hopefully, by the time you receive this letter, you will have completed the route-reverse directory survey of your precinct. It is our hope that this will be the first step in an organization that will elect Emily Anne Staples as State Legislator from 43A, along with other County and State DFL candidates. In addition, this type of "grassroots" organization will continue beyond this election year and go a long way toward building a strong party in our area.

I want to take a minute to bring you up to date on the Staples campaign. Our first piece of literature has been completed and is being used by Emily as she door-knocks. In addition, we are working on a "name identification" card; an "issue" piece; and a "get-out-the-vote" door hanger. We are also going to have literature for apartment distribution. Nancy Lux and Mary Gallagher have "identified" all the apartments in our district and are busy finding volunteers in each complex. "Keg" parties in the apartments will start in September.

Gene Sander has agreed to work on a fund raiser for the campaign. Final plans are not complete but the "target" date is the first week in October. Preliminary thoughts are to follow the successful "Mitterhaus" format.

Once school starts, we hope to recruit students to work on the campaign. Both Armstrong and Wayzata have programs that encourage student participation in politics. With the students help, we hope to blanket the area with a successful campaign.

The success of our campaign depends on our organization. Our organization is our precinct organization supplemented by our "routes." The next step is to find a volunteer to "captain" each route in your precinct. For example: Precinct 6, Plymouth, has 10 routes of from 50-75 homes. By having 10 captains, no one person is burdened with an impossible task. We want to use the route system for three literature drops; a door-to-door canvas; and a "blitz" door knock. This may sound like a lot of work, but by breaking down the areas, we are asking for about 5-10 hours' work from now until election to elect Emily. This averages out to 10 minutes per day, and if the captains have additional workers, this time is reduced. In addition, we hope that the captains will know the people and locations for our lawn signs in their area. I am asking that each of you do your best to find captains for your routes. Our first literature drop is scheduled for September 14th, and

we want to be ready by then. I will be contacting each of you after Labor Day to see how we are progressing.

It is our intent to knock on every "walkable" home in our area between September 1st and November 5th. To do so, we have set up a rigid schedule for door knocking by Emily. Emily will be in each precinct during the week listed: September 1st, Plymouth 3; September 8th, Plymouth 4; September 15th, New Hope 1; September 22nd, New Hope 2; September 29th, Plymouth 5 and Medicine Lake; October 6th, Golden Valley and Plymouth 7; October 13th, Golden Valley and Plymouth 7; October 20th, Plymouth 6; October 27th, Plymouth 1 & 2. The Wednesday of the week following Emily's door-knock in your precinct will be a "precinct blitz" with the "issue" piece of literature. We will provide volunteers to aid in the "blitz" of your precinct, depending on your needs. We would also like as many volunteers as possible to walk with Emily when she is in your area.

Between now and October 15th, we hope that a door-to-door canvas can be completed on the route forms so that we may target our mailings and phoning during the last week of the campaign. This could be done in conjunction with a literature drop or separately.

I sincerely hope that we can all work together for a successful campaign. The more people involved, the less work for each of us. We know that we have an outstanding candidate. We feel that victory is within our grasp. The State DFL agrees and is supporting us financially as well as morally. Everyone who meets Emily agrees that she should be our next legislator. If you have any questions or problems, please call me at home (544-7591) or work (333-1341). The time is now. We can have a DFL Legislator represent us, but a large number of people must be willing to volunteer a small amount of time. I am asking you to help set up that volunteer staff.

In the campaign preceding the November elections, those of the 67 members of the Minnesota State Senate who choose to run for reelection will stump their districts telling the voters all they have accomplished as senators in the past four years. During the campaign, the senators will stress to their constituents how effective they were in dealing with the questions they faced in the state legislature.

But the way the senators will define effectiveness may differ from the way the voters define the term. Effectiveness is an elusive but essential quality. To aid voters in evaluating their senators, *Mpls. magazine* set out to establish a realistic criterion to measure the senators' effectiveness. . . .

But since effectiveness is, in great part, a subjective impression, we decided to ask opinions of those who come into contact with the senators on an almost daily basis — the permanent members of the senate staff, the lobbyists and the members of the capitol press corps. By relying on their judgment of the initiative, leadership and desire to serve not only their constituents but all the people of Minnesota, it is possible to arrive at a fairly valid measure of the effectiveness of the individual members of the senate. This we did. . . .

The questionnaires also asked members of the permanent senate staff, lobbyists and press to list the least effective senators. In this category, the problem of effectiveness and the respondents' personal feelings are especially important. . . .

One of the gadflies of the Senate is Rolf Nelson. He has a tendency to play the devil's advocate, but detractors say he spends too much time nit-picking rather than concentrating on the larger issues before the senate. Detractors also accuse him of demagoguery. . . .
