Report of the Four Quarter School Year Committee to the Board of Education of School District #284, for review on Monday, December 14, 1970

The members of this committee approached the question of the advisability of a four quarter school year from one, or both, of these premises: 1) as a means of providing better education for our children, and 2) as a means of saving taxpayer money.

At the outset of our series of six meetings, many members of this committee were in favor of starting some form of four quarter, forty-five fifteen, or other elongated school year plan as soon as possible. As our research, reading, meetings, and discussions progressed, this attitude underwent considerable change. We can see many advantages of some form of elongated school year, but we can also see many disadvantages to any of the many plans we have investigated. Therefore, we do not feel that any elongated school year plan should be rushed into at this point in time.

We should note that we were under no pressure from anyone either on, or outside, this committee, to come to this conclusion.

Simply because we are not recommending a four quarter school year at this point, we do not want our conclusion misinterpreted. We are not recommending, by default, that an addition to the senior high school is the answer to our present space problem. When all the committee reports are received, and evaluated, by the Board of Education, we feel that some one, or combination, of these reports may have some answer to the current situation of dwindling space and dwindling dollars. With more time, and considerably more work, we feel that further study should be given to all the committees'

partial investigations, preliminary conclusions, and possibilities for the future. We recommend that a new committee be established to continue investigation of some form of an elongated school year for possible use by District #284. This committee should be selected as soon as possible, begin work no later than March 1, 1971, and complete its work by December 1, 1971. We suggest that this committee be composed of some appointees, some volunteers, and some education professionals; each person should have some serious interest in this question and be willing to spend considerable time and effort working with this question. This committee should have a budget established for it to enable it to adequately poll or survey the community's reactions and to be able to meet with other school districts facing similar questions. It should also be granted authorization to secure cost estimates, as needed. Secretarial assistance should be supplied to this committee.

We encourage this committee to meet with any other similar committees which may be recommended by the other groups submitting reports at this time. We feel that the elongated school year question, and its possible answers, will be closely related to the findings of the other groups and the subjects they have covered. This committee should not function as an isolated group.

Based on our research and discussion, we found that one of the primary problems of school districts making changes of this type was inadequate community communication. We recommend that this new committee work out a satisfactory system of keeping the public informed of their work, and that they secure public support for any changes they recommend in the present

educational system. This public support must be secured prior to any implementation of their conclusions.

Finally, we recommend that this report, and the reports of the other existing committees, be disseminated to the general public living in District #284.
