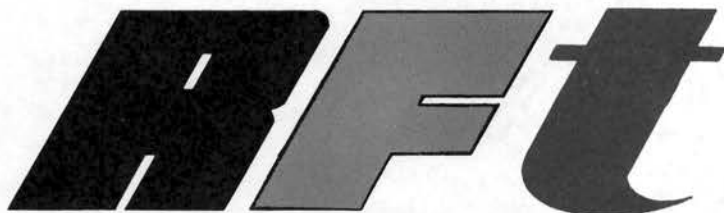

Dear Senator Staples:

At its last meeting the IMPACE-MEA Executive Committee voted to support your candidacy. Your campaign committee will be receiving a check from teachers in your district in the amount of \$800.

The IMPACE-MEA Executive Committee has had to fund most races below the legal limit. Your IMPACE-MEA funding may possibly reflect that decision.

On behalf of IMPACE-MEA I wish to thank you for your votes last session regarding tort liability, school aids increases, school district self insurance and higher education teacher mobility.

In future sessions it is our hope that the question of expressing the state's legitimate interest and responsibility in securing changes in class sizes in the K-3 primary grades will be dealt with favorably so that all Minnesota's youngsters at those levels may not only reach out for but obtain their maximum level of competency in the 3Rs. Studies in class size reduction have proven to make that difference possible. It is now time for all of us to act to bring reality out of the rhetoric.

Although needed changes in PELRA have been achieved, IMPACE-MEA takes note of the fact that some level of inconsistency exists in some cases between a legislator's vote on the final passage of such PELRA changes and the votes on various amendments to that legislation while it was in progress. Our hope is that over time the present PELRA law will prove of real benefit to the whole collective bargaining process for Minnesota's public employees.

Of course, our continued total opposition to voucher bills, non-public school aid and tuition tax credits for private schools remains steadfast.



Next year we are going to need your support in several vital areas. Our teachers have discussed with you the problems public education faces with regard to school finance, teacher retirement, class size, due process, lack of adequate representation of part-time teachers in higher education and censorship. We will seek to remedy those deficiencies.

We wish you good luck in your campaign. We look forward to working with you on behalf of Minnesota's public schools and colleges in the coming year.


