



(Lender or authorized agent)

CONDITIONS GOVERNING LOANS TO GALLERY SAINT PAUL

Gallery Saint Paul will exercise the same care in respect to loans that it does in the safekeeping of its own property.

Unless arrangements to extend the loan have been made by Gallery Saint Paul, objects lent to it shall remain in its possession for the time specified on the face of this form, plus a reasonable time required for receiving and returning the work to the lender. Loans will re returned only to the owner or lender or his duly authorized agent (verified in writing). When returned, borrowed materials shall be packed in exactly the same way as received and with the same cases, packages, pads, and other furnishings when possible.

Borrowed objects will not in any way be treated, cleaned, unfitted, repaired, remounted, reset, dissected, or submitted to any examination or application which would tend to alter the condition except as such treatment may be specifically authorized by the lender.

Unless the lender expressly elects to maintain his own insurance coverage, Gallery Saint Paul will insure this loan wall-to-wall under a fine arts policy, for the amount indicated on the face of this loan agreement, against all risks of physical loss or damage from any external cause while in transit and on location during the period of the loan. The Gallery's fine arts policy contains the usual exclusions for loss or damage due to war, invasion, hostilities, rebellion, insurrection, confiscation by order of any Government or public authority, risks of contraband or illegal transportation and/or trade, nuclear damage, wear and tear, gradual deterioration, moths, vermin and inherent vice, and for damage sustained due to and resulting from any repairing, restoration or retouching process unless cause by fire and/or explosion.

If the lender chooses to maintain his own insurance, the Gallery must be supplied with a certificate of insurance naming the Gallery (and the Commodore Partners) as an additional assured or waiving subrogation against Gallery Saint Paul. If the lender shall fail to supply the Gallery with such a certificate, this loan agreement shall constitute a release of the Gallery from any liability in connection with the loaned property. The Gallery cannot accept responsibility for any error or deficiency in information furnished to the lender's insurer or for any lapses in coverage.

Unless notified to the contrary, Gallery Saint Paul assumes the right to photograph and reproduce the work on loan for educational, catalog, and publicity purposes.

Gallery Saint Paul shall indicate the ownership of the object(s) lent by suitable labels, mention in exhibition catalogs, and press releases in such a form as the lender may direct.

If the work is for sale and is sold during the period of this loan, it is understood that the selling price includes a handling fee of _____percent to be retained by the Gallery.

Hunter Associate Curator Interpretation, Collections Minnesota Museum of Art Jemne Building St. Paul, Minnesota 55102 Dear Jean: Thank you for your letter of March 4 and for the enclosure of the gift certificate for April 6. I am looking forward to the Opening of the Japanese Print Collection. INFORMATION ON Ruth Tanbara's kimono Color: Wistaria blue (deep powder blue) Floral design of Botan (Tree Peony flower in pastel) popular design of the 1920 period. TYPE OF FABRIC: Chiri men (Heavy silk crepe) History of garment: approximately 60 years old In 1926 went to Osaka, Japan with Mother and we ordered the kimono and obi (sash) at the Daimaru Store in Osaka. It was the custom to order the kimonoa in white silk and the store dyed it to the customers selection. The kimono has my father's family Crest in 5 places on the kimono...one in back, 2 in front and 1 on each sleeve. Since the Crest is in white that is the reason the kimono has to be ordered in white material. The Obi (sash) was also ordered by design. It is Heavy silk brocade and is a Maru-obi (design on both sides. Type of occasion: This is the formal Kimono with long sleeves to the hem of kimono and worn on special occasions, receptions, weddings, etc. I wore it at my wedding reception after being married in an American Bridal dress with veil. In the early days in order to have it cleaned, we sent it to Tokyo with a friend who was going over thereoon a trip and they had it cleaned and returned with the Kimono. It had to be taken all apart and cleaned and re-sewed by hand again. Now we can have it cleaned at a good Cleaners here. All Japanese kimonos are sewn by hand. (very fine stitches). RT

Dear Friend:

I am sure that by now you are aware that President Reagan has signed into law legislation providing redress and compensation to Japanese-Americans interned during World War II.

Earlier this year, the redress legislation passed the Senate and the House by overwhelming margins giving clear evidence that this was an issue of principle and not politics.

The legislation offers an official U.S. government apology to all of those illegally interned in the 1940's. Further, it appropriates \$20,000 in tax-free money to every individual or to the heirs of those individuals who suffered through the internment.

I want to thank all of you who helped us enact this measure into law by your letters, phone calls and input to your Senators and Congressional Representatives. I hope that redress and monetary compensation help bring to a close this tragic, painful chapter of American history. I realize that neither redress nor compensation will erase the memories or the pain or the indignity that the 66,000 Americans alive today who survived this experience have suffered.

Nevertheless, I hope that all Americans learn from this legislation that discrimination can never be a part of the fabric of American society. It may take generations to correct gross, incomprehensible mistakes. But, a democracy as strong and caring as ours will eventually understand and attempt to heal the deep suffering that these injustices create.

Contribution December 2, 1991 Mr. Ronald Reed President Family Service of Greater St. Paul 166 East Fourth Street St. Paul, Minnesota 55101 Dear Ronald Reed: In 1992, it will be exactly fifty years since we relocated in St. Paul during World War II and the evacuation of Japanese Americans from our homes on the West Coast. Earl Tanbara and I were living in Berkeley, California and we were given the option of either going to one of the Relocation Centers or to move voluntarily to the Midwest and help resettle the Japanese Americans and their parents from the internment Centers. Since we had a family friend in St. Paul who loaned us his home and my brother was stationed at Fort Snelling in the U.S. Military Intelligence Language School, we arrived here in August 1942. In the beginning, we helped the evacuees from our small home, but the numbers increased beyond our expectations, so a Resettlement committee and the Council of Human Relations were organized by the YWCA, YMCA, Family Service, the International Institute, the Churches and Macalester College. Through these organizations, we were able to build community acceptance for the Japanese Americans and help them resettle. Chief Justice Warren Burger was an outstanding attorney in St. Paul at that time and he served as our first Chairman. Dr. Charles Turck, President of Macalester College was our second chairman and Macalester College was the first to accept Nisei students and Rev. Arthur Foote of Unity Unitatian Church served on the committee. I will always remember the role Family Service played in helping the Resettlement committee lease a small Hotel(where the Civic Center now stands) and help the evacuees in providing lodging, meals at a nominal fee, employment, medical care and contact colleges for the students. Historically, we were a new group of U.S. citizens of Japanese extraction to resettle in Minnesota. In comparison to other States, Minnesota was outstanding in accepting the groups. Many families returned to their homes in the West after the War, but many have continued to live in Minnesota educating their children and contributing their interests and skills in the community. In remembrance, appreciation and in memory of Earl Tanbara, I am, enclosing a contribution for the Family Service Centennial Endowment Fund to continue its valuable program. COLLECTION POLICY

MISSION: The mission of the Japanese American National Museum is to promote understanding and appreciation of America's ethnic and cultural diversity by preserving, interpreting and sharing the experiences of Japanese Americans.

<u>POLICY:</u> The Museum will collect, document and preserve objects which help illustrate the Japanese American experience and reflect the mission of the Museum. These objects may be three-dimensional in nature, or they may be such documentary objects as personal papers, transcriptions of oral histories, photographic images or audio and visual tapes. These can include objects owned, created by, or primarily used by Japanese Americans from any historical period from the mid-1800s to the present. Objects may also be generic American or Japanese objects which have value for their association to Japanese Americans.

Collection (1.2)

The Museum's permanent collection of objects which are being held in trust by the Museum to be protected and preserved for future generations. These are the finest examples of objects with good provenance or documentation, one-of-a-kind irreplaceable and or fragile and important in the development of an exhibition or exhibition concept. Objects accepted for the collection may not necessarily be exhibited.

Education Collection (1.6)

The collection of objects designated for use in educational and public programs. These objects are not subject to the same preservation standards that are required of the permanent collection. The education collection consists of two categories:

<u>Supervised Handling Collection</u> (1.6.1) may be carefully touched under strict in-house Museum supervision, is weaker in provenance than those in the permanent collection, and are objects which are sturdy enough to easily withstand handling.

Hands-on Collection (1.6.2) are more expendable than those in the supervised handling category and are accessioned for the purpose of inventory only. These objects are usually (but not always) without provenance, replaceable contemporary objects, replicas, and or one of several duplicates of objects in the permanent and supervised handling collection.

Deaccessioning: (The formal process used to remove an object from the collection) (3.0) The Chief Curator, Director of Program Development and Curators will jointly have the authority to recommend the deaccessioning of objects. This decision will be based on the following: if the object is no longer relevant and useful; if it has deteriorated beyond the point of usefulness; if the Museum can no longer care for it adequately; if it is redundant; or if it falls outside the new collection goals. Any member of the curatorial staff may propose that an object be deaccessioned. The recommendations made by staff will be reviewed by the Collections Committee and approved or disapproved. The Collections Committee may refer a final decision if necessary to the Executive Committee through the program Committee Chair.

Appraisals (9.0)

The Japanese American National Museum, in accordance with the American Association of Museums' Code of Ethics does not provide appraisals of the monetary value of materials brought into the Museum for identification or presented as gifts.



Ruth Nomura Tanbara toured Japan with other young
Nisei on a trip sponsored by a Japanese American newspaper
to bolster understanding between America and Japan and, since that
trip, Ruth Tanbara has embraced the understanding of the two cultures
and has constructed many bridges of understanding between the two countries;
and

Whereas, in the Spring of 1942, Presidential Executive Order 9066 removed all Japanese Americans, citizen or not, from West Coast states to interior relocation camps and the Army Military Intelligence Service Language School, composed of Nisei soldier students learning the Japanese language (spoken and written), were also moved that Spring from the San Francisco Presidio to Camp Savage, and later to Fort Snelling; and

Whereas, Japanese Americans could leave the camps and move inland if they could support themselves, and many opted to be near husbands, fathers, brothers and fiancés and requested to settle in the Twin Cities; and

Whereas, Ruth Tanbara and her husband Earl had to leave San Francisco and were asked to help Japanese Americans adjust to Minnesota's climate and to wartime prejudice, and Ruth became active in civic and Japanese organizations, contributing time and talent earning many awards, including the Saint Paul-Nagasaki Sister City Committee Chip Fricke Award and the Japan American Society of Minnesota Mondale Award and Ruth Tanbara is the only living member of the Saint Paul-Nagasaki Sister City Committee, serving six years as President and many more years as Secretary; and

Whereas, when Ruth retired from the Saint Paul YWCA in 1972, where she was affectionately known as "Ambassador without Portfolio," a grateful "Y" dedicated an outside patio of their downtown Saint Paul building and designated it as "The Ruth Tanbara Japanese Garden and the YWCA building is now known as the Paul and Sheila Wellstone Elementary School and the school has restored, upgraded and rededicated the Ruth Tanbara Japanese Garden;
