Know all Men by these Presents,

THAT WE, *Hazen Moores, Dennis Robinson, Henry Ange, Joseph Laro, Augustin Roche, Narcisse Frenier, Joseph Montocille, Henry M. Fisher Joseph Lathamboise, & Robert St. Aub* are held and firmly bound unto the United States of America, or to their certain Attorney, in the penal sum of _____ Dollars, to which payment well and truly to be made, We do bind ourselves, our heirs, executors and administrators, firmly by these presents, sealed with our seals, and dated at MICHILIMACKINAC, this *twenty fourth* day of *July* in the year of our Lord one thousand eight hundred and twenty-*four*

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH,

That whereas the above bounden *persons* _____ this day obtained a License from *George Boyd Esquire* agent for Indian affairs, at MICHILIMACKINAC, until the *first* day of *August* in the year of our Lord one thousand eight hundred and twenty-*five* unless sooner revoked, to sell, barter and exchange with the Indians, at *The River St. Peters & its dependencies* all manner of goods not prohibited by the laws of the United States, or the instructions of the President thereof, prohibiting the sale of spirituous liquors to Indians.

Now therefore, *Firstly*, if the said *Persons* _____ shall truly and faithfully observe such regulations and restrictions as are or may be made for the government of trade and intercourse with the Indian tribes, during the continuance of the said License. AND, *Secondly*, if the Invoice of goods furnished by the said *persons* _____ a copy of which is hereunto annexed, shall be *bona fide* the property of an American citizen or citizens, and if no other property is used in this trade. AND, *Lastly*, if the Foreigners recognized by said License, as interpreters and boatmen, shall only be employed under the same as such, and in no other capacity, then this obligation shall be void and of no effect, otherwise to be and remain in full force and virtue.
