Greeting:

Whereas, You have been appointed Guardian of the estate of the above named ward, by the order of this Court, and have duly qualified according to law to act as such guardian.

Now Therefore, Reposing full faith and trust in your competency, ability and integrity, these Letters of Guardianship are issued to you by the Court, authorizing you to act as the guardian of the estate of the above named Ward, with full powers, duties and responsibilities incident to such trust according to law, during the disability of said Ward, or until the further orders of the Court in the premises.

As such Guardian, you are required to make and file in this Court a full and true inventory of all the property and estate of said Ward, within one month from the date hereof; to take possession and control of all the property and estate of said Ward, both real and personal, and the profits, emoluments and proceeds thereof, and safely keep, care for, manage, and conserve, invest and re-invest the same, as economically as possible; and, so far as necessary, apply the income and profits and personal property thereof to the suitable maintenance and support of said Ward and the payment of all the just debts of said Ward, if the same be sufficient therefor; and if the same be not sufficient, then out of the proceeds of the sale of real estate of said Ward, to be made under the order of this Court. And you are also authorized and required to collect, demand, sue for, and receive, all debts due said Ward, and to represent said Ward in all legal proceedings, and to compound debts due said Ward, with the approval of this Court, and discharge debtors so compounded with.

AFFIDAVIT OF MAILING
ALLOWANCES TO SPOUSE AND/OR CHILDREN

When a decedent dies with or without a will the allowances to the spouse or children are as follows:

- 525.15 ALLOWANCES TO SPOUSE. When any person dies testate, or intestate,
- (1) The surviving spouse shall be allowed from the personal property of which the decedent was possessed or to which he was entitled at the time of his death, the wearing apparel, and, as selected by him, furniture and household goods not exceeding \$2,000 in value, and other personal property not exceeding \$1,000 in value;
 - (2) When, except for one automobile, all of the personal estate of the decedent is allowed to the surviving spouse by clause (1), the surviving spouse shall also be allowed such automobile.
 - (3) If there be no surviving spouse, the minor children shall receive the property specified in clause (1) as selected in their behalf;
 - (4) During administration, but not exceeding 18 months, unless an extension shall have been granted by the court, or, if the estate be insolvent, not exceeding 12 months, the spouse or children, or both, constituting the family of the decedent shall be allowed reasonable maintenance.
 - (5) In the administration of an estate of a non-resident decedent, the allowances received in the domiciliary administration shall be deducted from the allowances under this section.

In all estates where there is a will the following rule applies to the spouse who has not consented to the will:

525.212 RENUNCIATION AND ELECTION. If a will make provision for a surviving spouse in lieu of the rights in the estate secured by statute, such spouse shall be deemed to have elected to take under the will, unless he shall have filed with the court and mailed or delivered to the personal representative, if any, within nine months after the date of death, or within six months after the probate of the decedent's will, whichever limitation last expires, an instrument in writing renouncing and refusing to accept the provisions in such will. For good cause shown, the court may permit an election within such further time as the court may determine. No devise to a surviving spouse shall be considered as adding to the rights in the estate secured by sections 525.145 and 525.16 to such spouse, unless it clearly appears from the contents of the will that such was the testator's intent.



NOTICE OF RIGHT TO PETITION
FOR ANNUAL RELIEF

If you wish to have the guardianship/conservatorship modified then file a petition explaining why you believe those changes should be made.

To petition you may secure the proper form at the Probate Division Office and file it there. The address of the Probate Office is Room #105, Stearns County Courthouse.

After a petition is filed the Court will schedule a hearing. You have a right to be present at that hearing and to have a lawyer represent you. If you cannot afford a lawyer, the Court will appoint one for you.

- A. Attach Schedules where designated or where anything needs explaining, viz.: Omissions in inventory, rent, increases, decreases, etc.
- B. File vouchers for all devises shown paid and distributed.
- C. File executed Self Assessed Inheritance Tax Return with this Account and Petition, unless filed earlier. Send the original Self Assessed Return with tax payment and all necessary copies of proceedings to the Commissioner of Taxation. If the Self Assessed Return is to be waived, waivers are available from Probate Court.
- D. Items of advances to estate, after cash in the estate is exhausted, usually are for the purpose of having cash to cover disbursements in the account. The items of advances are not an increase to the estate subject to inheritance tax.
- E. When Federal Estate Tax is allocable under M.S.A. 525.521, the tax has to be either actually advanced by distributee or withheld from the distributee's share of the estate.
- F. The property on hand for distribution should be adequately described and any variance from the Inventory should be explained.
- G. In any line of descent where any issue takes the interest of a predeceased parent, list parent and date of death. Heirship can be by blood or adoption only.
- H. Distributions to residuary beneficiaries are properly deductible in the Account only if partial distribution has been granted by the Court by Decree.
- I. The decedent's interests in contracts for deed as vendor are personal property and should be included in "personal estate described in inventory". Such contracts must be fully described together with legal descriptions covering the real estate held as security for the Court to make a proper Decree. Current balances on all contracts and notes should be used for the property shown on hand for distribution as any payments thereon during administration are included in cash on hand for distribution unless expended as credits in the Account. The Account should then balance.
- J. Claims allowed and NOT paid for any reason have to be so designated preferably by listing on referenced Schedule.
- K. Formal allowance of this account by the Court is obtainable by petitioning therefore using Form 524.3-1001 #2 and the appropriate notice forms under 524.3-1001 and 524.3-1002.
