





- State law requires that the Commissioner of Public Welfare determine: (1) the cost of providing care to patients in the state institutions, and, (2) how much the patient or his relatives can pay. This letter is to notify you of the Commissioner's determinations:
 - a. That the average daily cost (percapitacost) of providing the care, treatment, and maintenance for patients at institutions of this type in the fiscal year ended June 30, 1981, as prescribed by law is \$ 7/4,05 per day.
 - b. That after investigation, you have been determined to have the financial ability to pay \$ 11.98 per day, effective January 1, 1981.

SPECIAL NOTE TO GUARDIANS, CUSTODIANS OR RECEIVORS OF PATIENTS OR PATIENTS' FUNDS

The determination has been made that your ward has the ability to pay the amount specified in Paragraph 1b, above, and you are directed to pay this amount from the patient's assets when you receive your next statement.

- 2. This rate is subject to review at all times and may be adjusted according to law or change in your financial condition.
- The acceptance by the Commissioner of partial rates, or partial payments or amounts less than the per capita
 rate, shall not be construed to release a patient or his estate from liability for the difference and shall by
 law constitute a claim against the patient's estate.
- 4. 

For good cause shown, the court may permit an election within such further time as the court may determine. No devise to a surviving spouse shall be considered as adding to the rights in the estate secured by sections 525.145 and 525.16 to such spouse, unless it clearly appears from the contents of the will that such was the testator's intent.

NOTICE OF RIGHT TO PETITION FOR ANNUAL RELIEF

You have a right to petition the Probate Division of County Court for restoration to capacity, discharge of the guardian/conservator or modifications of the orders of guardianship/conservatorship.

If you wish to have the guardianship/conservatorship modified then file a petition explaining why you believe those changes should be made.

To petition you may secure the proper form at the Probate Division Office and file it there. The address of the Probate Office is Room #105, Stearns County Courthouse.

After a petition is filed the Court will schedule a hearing. You have a right to be present at that hearing and to have a lawyer represent you. If you cannot afford a lawyer, the Court will appoint one for you.
